1	In line 2 of the printed bill, delete the period and insert "; and declaring an emergency.
2	"Whereas by 2030, the number of Oregonians aged 65 and older is projected to grow to over a
3	million, with older adults comprising 21 percent of Oregon's population, representing a seven per-
4	cent increase over a 20-year period; and
5	"Whereas rural counties are already leading the way with more than 30 percent of residents
6	being older adults; and
7	"Whereas Oregon faces an historic, unprecedented and permanent demographic shift and by
8	2034, there will be more residents over the age of 65 than children 18 years of age and under; and
9	"Whereas Oregon's older population is also becoming more racially and ethnically diverse with
10	over 45 percent of older adults projected by 2050 to be people of color by 2050; and
11	"Whereas the change in this state's demographics provides the state with a unique opportunity
12	to use the skills and experience of older adults to benefit all generations; and
13	"Whereas the aging of this state's population will have significant long-term impacts on the
14	state's workforce, housing, homelessness, caregivers, behavioral and physical health care services
15	providers and infrastructure; and
16	"Whereas Oregon is not sufficiently prepared to address the financial costs of our changing de-
17	mographics, including the financial strain on individuals and families, as well as community and in-
18	stitutional needs around living longer; and
19	"Whereas Oregon families, communities, businesses and civic and public institutions would
20	benefit from the development of a long term multi-sector plan on aging and recommendations for
21	becoming an age-friendly state where people of all ages and abilities thrive; now, therefore,".
22	Delete lines 4 through 10 and insert:
23	"SECTION 1. (1) The President of the Senate and the Speaker of the House of Repre-
24	sentatives shall appoint a work group to develop a framework for a multi-sector plan for
25	aging to be administered by the Department of Human Services.
26	"(2) The President and the Speaker shall jointly appoint up to 25 members of the work

"(a) Post-secondary education providers;

"(f) An organization that advocates for older adults and that has broad membership in this state;

- "(f) Conduct an analysis of the landscape of services for older adults in this state. 23
- "(4) The work group shall consult with the following agencies in developing the plan: 24
- 25 "(a) The Oregon Health Authority;
- "(b) The Department of Consumer and Business Services; 26
- 27 "(c) The division within the Department of Consumer and Business Services responsible for providing aging services; 28
- "(d) The Oregon Business Development Department; 29
- "(e) Business Oregon; 30
- "(f) The Department of Education; 31
- "(g) The Department of Transportation; 32
- "(h) The Bureau of Labor and Industries; 33
- "(i) The Housing and Community Services Department; 34
- "(j) The Department of Land Conservation and Development; and 35
- "(k) The Department of Veterans' Affairs. 36
- "(5) The Department of Human Services shall provide staff support to the work group. 37
- "(6) The department shall: 38
- "(a) Not later than December 1, 2023, provide an initial report to the interim committees 39 40 of the Legislative Assembly related to human services on the progress of the work group.
- 41 "(b) During the 2024 regular session of the Legislative Assembly, provide to the committees of the Legislative Assembly related to human services a second report on the progress of the work group.
- 44 "(c) Not later than July 1, 2024, provide a final report, in the manner provided in ORS 45 192.245, on a framework for developing a multi-sector plan for aging to the interim commit-

"SECTION 2. This 2023 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect on its passage.".
