

# House Bill 3102

Sponsored by Representative OWENS (at the request of Nick Schott)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Eliminates daylight saving time standard of time, and requires State of Oregon to remain on standard time for entirety of calendar year.

## A BILL FOR AN ACT

2 Relating to standards of time; amending ORS 187.110.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 187.110 is amended to read:

5 187.110. (1) The standard of time for the State of Oregon shall be the United States standard  
6 of time as established by the Congress of the United States for any particular area of the state un-  
7 der 15 U.S.C. 261], *except that from 2 a.m. on the second Sunday in March until 2 a.m. on the first*  
8 *Sunday in November the standard of time for any area of this state shall be one hour in advance of*  
9 *the standard established for that particular area by the Congress of the United States under 15 U.S.C.*  
10 *261].*

11 (2) No department of the state government and no county, city or other political subdivision  
12 shall employ any other time or adopt any statute, ordinance or order providing for the use of any  
13 other standard of time.

14 **SECTION 2.** ORS 187.110, as amended by section 1, chapter 421, Oregon Laws 2019, is amended  
15 to read:

16 187.110. (1) The standard of time for the State of Oregon shall be [*one hour in advance of*] the  
17 United States standard of time as established by the Congress of the United States for any partic-  
18 ular area of the state under 15 U.S.C. 261.], *except that:*]

19 [*(a) The standard of time for that portion of the State of Oregon that is in the Mountain Time Zone*  
20 *shall be the United States standard of time as established by the Congress of the United States for that*  
21 *area under 15 U.S.C. 261; and]*

22 [*(b) From 2 a.m. on the second Sunday in March until 2 a.m. on the first Sunday in November the*  
23 *standard of time for that portion of the State of Oregon that is in the Mountain Time Zone shall be*  
24 *one hour in advance of the standard established for that area by the Congress of the United States*  
25 *under 15 U.S.C. 261.]*

26 (2) No department of the state government and no county, city or other political subdivision  
27 shall employ any other time or adopt any statute, ordinance or order providing for the use of any  
28 other standard of time.

29 **SECTION 3.** ORS 187.110, as amended by sections 1 and 4, chapter 421, Oregon Laws 2019, is  
30 amended to read:

31 187.110. (1) The standard of time for the State of Oregon shall be the United States standard
