

HOUSE AMENDMENTS TO HOUSE BILL 3103

By COMMITTEE ON AGRICULTURE, LAND USE, NATURAL RESOURCES, AND
WATER

March 24

1 On page 1 of the printed bill, delete lines 4 through 29 and delete pages 2 through 4 and insert:

2 **“SECTION 1. The Oregon State University Extension Service and the Oregon State Uni-**
3 **versity Agricultural Experiment Station shall jointly establish an agricultural water man-**
4 **agement technical assistance program. The technical assistance program shall be a**
5 **voluntary, nonregulatory and incentive-based program that may include the following ele-**
6 **ments:**

7 **“(1) Staffing of agricultural water management specialists based in different regions of**
8 **this state who will be responsible for:**

9 **“(a) Building collaborative relationships with water and land managers; and**

10 **“(b) Developing research-based water management programs that utilize data collected**
11 **under subsection (6) of this section to provide publicly available statewide and regional tools**
12 **for water and land managers that foster regionally specific knowledge and expertise.**

13 **“(2) Connecting agricultural producers to information, resources, tools, programs, part-**
14 **ners, funding opportunities and other incentives to improve on-farm water management**
15 **practices and outcomes for the producers’ operations and water resources.**

16 **“(3) Creating a voluntary demonstration network of willing agricultural producers to de-**
17 **velop on-farm demonstration projects featuring water-related management practices that**
18 **yield quantifiable water quality and quantity benefits for the producers’ operations and water**
19 **resources and to promote the uptake of effective practices, including, but not limited to:**

20 **“(a) Modification of irrigation equipment;**

21 **“(b) Measurement and monitoring of water diversions and water use;**

22 **“(c) Use of data in decision-making;**

23 **“(d) Irrigation management practices;**

24 **“(e) Soil management practices;**

25 **“(f) Dryland farming practices;**

26 **“(g) Crop rotations and rotational grazing practices;**

27 **“(h) Temporary or permanent voluntary in-stream flow restoration, such as in-stream**
28 **leasing and split-season leasing, as described in ORS 537.348;**

29 **“(i) Use of the program for the allocation of conserved water established under ORS**
30 **537.455 to 537.500;**

31 **“(j) Novel water sharing agreements or arrangements that benefit other in-stream and**
32 **out-of-stream water uses;**

33 **“(k) Water reuse;**

34 **“(L) Effective use of the state and federal programs;**

35 **“(m) Practices that restore and protect fish and wildlife habitat;**

1 “(n) Practices that reduce energy use and costs;
2 “(o) Fish screening and fish passage; and
3 “(p) Experimentation with alternative crops and drought-resistant crops.
4 “(4) Identifying, studying and mitigating the effects of projects and practices imple-
5 mented under subsection (3) of this section on in-stream and out-of-stream water users and
6 uses, and conducting related outreach.
7 “(5) Organizing workshops and tours to promote innovative agricultural water manage-
8 ment practices.
9 “(6) Establishing and maintaining or supporting publicly available weather and irrigation
10 information systems designed to collect, process and make publicly available climate and
11 weather-related data and provide to agricultural producers tools that support increased
12 production, increased resilience to drought and flood events and the efficient management
13 of water resources.
14 “(7) In consultation with the Water Resources Department, contracting with an organ-
15 ization that provides publicly accessible, reproducible, satellite-based evapotranspiration data
16 using open science methods, open data services and an ensemble of well-established
17 evapotranspiration models to:
18 “(a) Support ongoing and reliable evapotranspiration data production and platform
19 maintenance for public use across this state;
20 “(b) Support data collection and technical analyses to improve the accuracy of the data
21 for different regions in Oregon; and
22 “(c) Conduct outreach to agricultural producers and other subject matter experts to
23 verify accuracy and increase usability of the data.
24 “(8) Partnering with agricultural producers and other subject matter experts to check
25 the accuracy of data, develop new tools, adapt available tools, experiment with new technol-
26 ogies and approaches and identify best management practices.
27 “(9) Performing and publishing research related to agricultural water management.
28 “(10) Developing and updating Oregon-specific guides, manuals and other resources, with
29 a focus on resources that will increase the likelihood of securing federal funding and assist-
30 ance for agricultural water management and increase the effective delivery of desired out-
31 comes.
32 “(11) Providing technical assistance to small farmers or ranchers in accessing state and
33 federal assistance programs, including but not limited to disaster assistance programs.
34 “**SECTION 2.** (1) To carry out the technical assistance program described in section 1 of
35 this 2023 Act, the Oregon State University Extension Service and the Oregon State Univer-
36 sity Agricultural Experiment Station may:
37 “(a) Support the acquisition and maintenance of equipment necessary for the collection
38 of weather data, climate data and data related to agricultural water use and management,
39 including equipment that measures or monitors water supply, water diversions, water use
40 and evapotranspiration. Equipment may include, but need not be limited to:
41 “(A) AgriMet weather stations;
42 “(B) Other weather stations;
43 “(C) Eddy covariance stations;
44 “(D) Lysimeters;
45 “(E) Stream gauges;

1 “(F) Soil moisture meters; and
2 “(G) Water use measuring devices.

3 “(b) Form partnerships with agricultural producers to site data collection equipment and
4 use the data collected in on-farm management practices, with preference given to producers
5 that agree to develop on-farm demonstration projects, as described in section 1 (3) of this
6 2023 Act.

7 “(c) Form partnerships and enter into cost-sharing agreements with institutions capable
8 of maintaining data collection equipment and processing data, including, but not limited to,
9 the United States Geological Survey, the United States Bureau of Reclamation, the Natural
10 Resources Conservation Service of the United States Department of Agriculture, the Na-
11 tional Weather Service of the National Oceanic and Atmospheric Administration, the State
12 Department of Agriculture, the Water Resources Department, the State Department of Fish
13 and Wildlife, the Department of Environmental Quality, the Oregon Watershed Enhancement
14 Board, the Oregon Climate Service and soil and water conservation districts.

15 “(d) Convene statewide or region-specific advisory groups or working groups to advise
16 on any aspect of the program.

17 “(2) All data collected under subsection (1) of this section using public funds must be
18 made publicly available.

19 “(3) In establishing and maintaining the voluntary demonstration network described in
20 section 1 (3) of this 2023 Act, the Oregon State University Extension Service and the Oregon
21 State University Agricultural Experiment Station:

22 “(a) May receive and expend funds from any source to:

23 “(A) Design and implement demonstration projects under section 1 (3) of this 2023 Act;
24 or

25 “(B) Provide stipends to agricultural producers participating in the voluntary demon-
26 stration network described in section 1 (3) of this 2023 Act for time, equipment and related
27 expenses.

28 “(b) Shall prioritize projects that have the potential to increase drought resiliency and
29 provide quantifiable water quantity and quality benefits to other in-stream and out-of-stream
30 water users or uses.

31 “SECTION 3. (1) The Oregon State University Extension Service and the Oregon State
32 University Agricultural Experiment Station shall jointly:

33 “(a) Prepare an annual report describing climate-related impacts on agricultural pro-
34 ducers, including, but not limited to, flood and drought impacts, and recommendations to
35 increase agricultural resilience; and

36 “(b) Submit the report in the manner provided by ORS 192.245 to the interim committees
37 of the Legislative Assembly related to agriculture no later than September 15 of each year.

38 “(2) The Oregon State University Extension Service and the Oregon State University
39 Agricultural Experiment Station shall jointly report on the progress of the technical assist-
40 ance program established under section 1 of this 2023 Act in the manner provided by ORS
41 192.245 to the interim committees of the Legislative Assembly related to agriculture no later
42 than September 15 of each even-numbered year.”.
