House Bill 3187

Sponsored by Representatives OWENS, HELM (at the request of Oregon Water Resources Congress)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Makes individuals employed seven or more years by certain types of districts eligible to apply for certification as water right examiners.

(1) As used in this section: 5 6 (a) "District" means: (A) An irrigation district formed under ORS chapter 545; 7 8 (B) A drainage district formed under ORS chapter 547; 9 (C) A water improvement district formed under ORS chapter 552; or (D) A water control district formed under ORS chapter 553. 10 (b) "Registered geologist" has the meaning given that term in ORS 672.505. 11 12 (c) "Registered professional engineer" and "registered professional land surveyor" have the meanings given those terms in ORS 672.002. 13(2) The Water Resources Commission by rule shall establish criteria for [the] certification [of 14 registered, professional land surveyors and engineers and geologists practicing as defined in ORS 15672.005 and 672.505, respectively,] under ORS 537.798 to conduct surveys to determine whether a 16 17 permittee has completed all work necessary to perfect an appropriation of water under ORS 537.230, 537.630 and 540.530. 18 (3) An individual may apply for certification under ORS 537.798 if the individual meets the 19 criteria established by rule by the commission and is a: 20 (a) Registered professional engineer; 2122(b) Registered professional land surveyor; (c) Registered geologist; or 23 (d) District employee who has been employed by the district for seven or more years. 2425SECTION 2. ORS 537.798 is amended to read: 537.798. (1) The State Board of Examiners for Engineering and Land Surveying may issue a 2627water right examiner certificate to [a registered professional land surveyor, registered professional 28 engineer or registered geologist who meets the criteria established by the Water Resources Commission under] an applicant described in ORS 537.797. The board shall require an applicant for the certif-29icate to pass an examination establishing the qualification of the applicant to be a water right ex-30 aminer. The Water Resources Department shall prepare, administer and score the examination. 31

1 (2) The board shall establish fees for the examination, certification and renewal of certification 2 of water right examiners. The fees shall be based upon the expenses of the board and the department 3 in conducting the certification program. The board shall reimburse the department for department 4 expenses related to the preparation, administration and scoring of the examination.

5 (3) The board may adopt rules to regulate persons certified as water right examiners. The rules 6 may include, but need not be limited to, rules establishing standards of professional conduct and 7 rules establishing professional development or continuing education requirements.

8 (4) Upon receipt of a complaint, or upon its own initiative, the board may investigate any al-9 leged or suspected violation by a water right examiner of ORS 672.002 to 672.325, the criteria es-10 tablished under ORS 537.797, **Water Resources** Commission rules or a board rule adopted under 11 this section or ORS 672.255. If the board finds that a violation has occurred, in addition to any other 12 disciplinary or regulatory authority of the board, the board may suspend, revoke or modify a cer-13 tificate issued under this section. Board action to suspend, revoke or modify the certificate is subject 14 to the provisions of ORS chapter 183 relating to contested cases.
