SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Repeals Department of Environmental Quality's dry cleaner environmental program. Prohibits use of perchloroethylene and n-propyl bromide as dry cleaning solvents. Provides that prohibition becomes operative January 1, [2027] **2028**. Takes effect on 91st day following adjournment sine die.

9	<u>SECTION 1.</u> ORS 465.500, 465.503, 465.505, 465.507, 465.517, 465.520, 465.523, 465.525, 465.527,
10	465.531, 465.536, 465.545 and 465.992 are repealed.
11	SECTION 2. ORS 465.510 is repealed on January 1, 2025.
12	SECTION 2a. (1) The Dry Cleaner Environmental Response Account established under
13	ORS 465.510 is abolished on January 1, 2025. Any moneys remaining in the account on Janu-
14	ary 1, 2025, that are unexpended, unobligated and not subject to any conditions shall be
15	transferred to the General Fund and made available for general governmental purposes.

If a dry cleaning fa-10 cility is operated without a business license, both the dry cleaning owner and any person directing the 11 operations shall be considered the dry cleaning operator and shall be jointly and severally liable for 12 the fees and duties imposed on dry cleaning operators.]

[(8) "Dry cleaning owner" means a person who owns or owned the real property underlying a dry
 cleaning facility.]

[(11) "Dry store" means a facility that does not include machinery using dry cleaning solvents, including but not limited to a pickup store, dropoff store, call station, agency for dry cleaning, press shop, and pickup and delivery service not otherwise operated by a dry cleaning facility.]

26 [(12)] (5) "Environment" includes the waters of the state, any drinking water supply, any land 27 surface and subsurface strata and ambient air.

[(13)] (6) "Facility" means any building, structure, installation, equipment, pipe or pipeline including any pipe into a sewer or publicly owned treatment works, well, pit, pond, lagoon, impoundment, ditch, landfill, storage container, above ground tank, underground storage tank, motor vehicle, rolling stock, aircraft, or any site or area where a hazardous substance has been deposited, stored, disposed of, or placed, or otherwise come to be located and where a release has occurred or where there is a threat of a release, but does not include any consumer product in consumer use or any vessel.

[(14)] (7) "Fund" means the Hazardous Substance Remedial Action Fund established by ORS

39 [(16)] (9) "Hazardous substance" means:

(b) Any substance defined as a hazardous substance pursuant to section 101(14) of the federal
Comprehensive Environmental Response, Compensation and Liability Act, P.L. 96-510, as amended,
and P.L. 99-499.

1 [(17) "Inactive dry cleaning facility" means property formerly used, but not currently used, for 2 providing dry cleaning services.]

3 [(18)] (10) "Natural resources" includes but is not limited to land, fish, wildlife, biota, air, sur-4 face water, ground water, drinking water supplies and any other resource owned, managed, held in 5 trust or otherwise controlled by the State of Oregon or a political subdivision of the state.

6 [(19)] (11) "Oil" includes gasoline, crude oil, fuel oil, diesel oil, lubricating oil, oil sludge or re-7 fuse and any other petroleum-related product, or waste or fraction thereof that is liquid at a tem-8 perature of 60 degrees Fahrenheit and pressure of 14.7 pounds per square inch absolute.

9 [(20)] (12) "Owner or operator" means any person who owned, leased, operated, controlled or 10 exercised significant control over the operation of a facility. "Owner or operator" does not include 11 a person, who, without participating in the management of a facility, holds indicia of ownership 12 primarily to protect a security interest in the facility.

[(21)] (13) "Person" means an individual, trust, firm, joint stock company, joint venture, consortium, commercial entity, partnership, association, corporation, commission, state and any agency thereof, political subdivision of the state, interstate body or the federal government including any agency thereof.

[(22)] (14) "Release" means any spilling, leaking, pumping, pouring, emitting, emptying, discharging, injecting, escaping, leaching, dumping or disposing into the environment including the abandonment or discarding of barrels, containers and other closed receptacles containing any hazardous substance, or threat thereof, but excludes:

(a) Any release that results in exposure to a person solely within a workplace, with respect to
 a claim that the person may assert against the person's employer under ORS chapter 656;

(b) Emissions from the engine exhaust of a motor vehicle, rolling stock, aircraft, vessel or pipe line pumping station engine;

(c) Any release of source, by-product or special nuclear material from a nuclear incident, as those terms are defined in the Atomic Energy Act of 1954, as amended, if the release is subject to requirements with respect to financial protection established by the Nuclear Regulatory Commission under section 170 of the Atomic Energy Act of 1954, as amended, or, for the purposes of ORS 465.260 or any other removal or remedial action, any release of source by-product or special nuclear material from any processing site designated under section 102(a)(1) or 302(a) of the Uranium Mill Tailings Radiation Control Act of 1978; and

32 (d) The normal application of fertilizer.

[(23)] (15)(a) "Remedial action" means those actions consistent with a permanent remedial action taken instead of or in addition to removal actions in the event of a release or threatened release of a hazardous substance into the environment, to prevent or minimize the release of a hazardous substance so that it does not migrate to cause substantial danger to present or future public health, safety, welfare or the environment.

(b) "Remedial action" includes, but is not limited to:

39 [(a)] (A) Such actions at the location of the release as storage, confinement, perimeter pro-40 tection using dikes, trenches or ditches, clay cover, neutralization, cleanup of released hazardous 41 substances and associated contaminated materials, recycling or reuse, diversion, destruction, segre-42 gation of reactive wastes, dredging or excavations, repair or replacement of leaking containers, 43 collection of leachate and runoff, on-site treatment or incineration, provision of alternative drinking 44 and household water supplies, and any monitoring reasonably required to assure that the actions 45 protect the public health, safety, welfare and the environment.

1 [(b)] (B) Offsite transport and offsite storage, treatment, destruction or secure disposition of 2 hazardous substances and associated, contaminated materials.

3 [(c)] (C) Such actions as may be necessary to monitor, assess, evaluate or investigate a release
4 or threat of release.

5 [(24)] (16) "Remedial action costs" means reasonable costs which are attributable to or associ-6 ated with a removal or remedial action at a facility, including but not limited to the costs of ad-7 ministration, investigation, legal or enforcement activities, contracts and health studies.

[(25)] (17) "Removal" means the cleanup or removal of a released hazardous substance from the 8 9 environment, such actions as may be necessary taken in the event of the threat of release of a hazardous substance into the environment, such actions as may be necessary to monitor, assess and 10 evaluate the release or threat of release of a hazardous substance, the disposal of removed material, 11 12 or the taking of such other actions as may be necessary to prevent, minimize or mitigate damage 13 to the public health, safety, welfare or to the environment, that may otherwise result from a release or threat of release. "Removal" also includes but is not limited to security fencing or other measures 14 15 to limit access, provision of alternative drinking and household water supplies, temporary evacuation and housing of threatened individuals and action taken under ORS 465.260. 16

17 [(26) "Retail sale or transfer" means a transfer of title or possession, exchange or barter, condi-18 tional or otherwise, for a purpose other than resale in the ordinary course of business.]

[(27)] (18) "Transport" means the movement of a hazardous substance by any mode, including pipeline and in the case of a hazardous substance that has been accepted for transportation by a common or contract carrier, the term "transport" shall include any stoppage in transit that is temporary, incidental to the transportation movement, and at the ordinary operating convenience of a common or contract carrier, and any such stoppage shall be considered as a continuity of movement and not as the storage of a hazardous substance.

[(28)] (19) "Underground storage tank" has the meaning given that term in ORS 466.706.

SECTION 4. (1) The repeal of ORS 465.500, 465.503, 465.505, 465.507, 465.517, 465.520,
 465.523, 465.525, 465.527, 465.531, 465.536, 465.545 and 465.992 by section 1 of this 2023 Act and

43	SECTION 5. (1) As used in this section and section 6 of this 2023 Act:
44	(a) "Dry cleaning facility" means any facility located in this state that is engaged in dry
45	cleaning apparel and household fabrics for the general public other than a:

1 (A) Facility located on a United States military base; or

2 (B) Prison or other penal institution.

3 (b) "Dry cleaning solvent" means a nonaqueous solvent used for the cleaning of garments

(c) "N-propyl bromide" means the substance known as n-propyl bromide or nPB, or by
the CAS Registry Number 106-94-5.

 8 tetrachloroethylene, or by the CAS Registry Number 127-18-4.

9 (2) A person may not use perchloroethylene or n-propyl bromide as a dry cleaning solvent

(3) The Environmental Quality Commission may adopt rules as necessary to enforce the provisions of this section.

13 <u>SECTION 6.</u> (1) The Department of Environmental Quality may enter upon and inspect, 14 at any reasonable time, any dry cleaning facility for the purpose of investigating either an 15 actual or suspected violation of section 5 of this 2023 Act or rules adopted under section 5 16 of this 2023 Act.

(2) The department may require the owner or operator of any dry cleaning facility to
furnish to the department information related to the use of perchloroethylene or n-propyl
bromide as a dry cleaning solvent.

(3) The department may, at any reasonable time, inspect and copy a dry cleaning
 facility's documents or records related to the use of perchloroethylene or n-propyl bromide
 as a dry cleaning solvent.

(4) Whenever it appears to the department that any person is engaged or about to engage in any acts or practices that constitute a violation of section 5 of this 2023 Act or any rules or orders adopted or entered under section 5 of this 2023 Act, the department may, without prior administrative notice or hearing, institute actions or proceedings for legal or equitable remedies to enforce compliance with section 5 of this 2023 Act or to restrain further violations of section 5 of this 2023 Act.

SECTION 7. ORS 466.990 is amended to read:

466.990. (1) In addition to any other penalty provided by law, any person who violates ORS 466.005 to 466.385 and 466.992, a license condition or any Environmental Quality Commission rule or any order of the commission or Department of Environmental Quality pertaining to the generation, treatment, storage, disposal or transportation by air or water of hazardous waste, as defined by ORS 466.005, shall incur a civil penalty not to exceed \$25,000 for each day of the violation.

(2) The civil penalty authorized by subsection (1) of this section shall be imposed in the manner
 provided by ORS 468.135.

(3) In addition to any other penalty provided by law, any person who violates a provision of ORS
466.605 to 466.680, or any rule or order entered or adopted under ORS 466.605 to 466.680, shall incur
a civil penalty not to exceed \$25,000. Each day of violation shall be considered a separate offense.

(4) The civil penalty authorized by subsection (3) of this section shall be imposed in the manner
provided by ORS 468.135, except that a penalty collected under this section shall be deposited to the
fund established in ORS 466.670.

(5) In addition to any other penalty provided by law, any person who violates a provision
of section 5 of this 2023 Act, or any rule or order entered or adopted under section 5 of this
2023 Act, shall incur a civil penalty not to exceed \$25,000 for each day of violation.
