

A-Engrossed House Bill 3395

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Requires Housing and Community Services Department to study housing. Directs department to submit findings to interim committees of Legislative Assembly related to housing no later than September 15, 2024.]

Allows affordable housing on lands zoned for commercial uses within urban growth boundaries.

Allows local governments to extend decision-making period for application to develop residential structures within urban growth boundary or to reconsider land use decision for development of residential structures.

Makes permanent requirements that local governments allow siting of certain emergency shelters, conditioned upon latest estimates of percentage of individuals experiencing homelessness. Awards attorney fees for certain appeals of emergency shelter application.

Requires Department of Consumer and Business Services to update Oregon Structural Specialty Code to allow additional single-exit residential occupancies.

Exempts certain affordable housing from Oregon Planned Community Act.

Restricts local governments' ability to regulate condominium form of ownership.

Requires cities or counties to accept funding letters to affordable housing developers as sufficient assurances needed to approve subdivision plat.

Requires local governments to allow certain single room occupancies in residential zones. Amends definition of "needed housing" to include single room occupancies.

Requires more cities to allow duplexes on certain lands zoned to allow single-family dwellings. Updates deadlines for compliance by affected cities and appropriates moneys from General Fund to Department of Land Conservation and Development to provide grants for support.

Provides process and form by which associations may amend declarations and bylaws of planned community or condominium to remove unlawfully discriminatory provisions. Extends until December 31, 2024, deadline by which associations must review declarations and bylaws.

Allows Public Utility Commission to allow public utility to sell or convey real property for affordable housing.

Requires Department of Human Services to provide financial support to nonprofits to provide affordable housing for low-income college students. Sunsets January 2, 2026.

Requires Housing and Community Services Department to provide grants for urban community housing supporting agricultural employees. Sunsets January 2, 2028.

Requires Oregon Department of Administrative Services to provide grants for regional housing coordination and to local governments to support development of needed housing. Sunsets January 2, 2034.

Requires Housing and Community Services Department to make grant to Network for Oregon Affordable Housing to provide low-interest loans to purchasers of homes with limited equity. Sunsets January 2, 2026. Requires department to report on use of loan fund to interim committee of Legislative Assembly by September 15, 2025, and September 15, 2027.

Requires Housing and Community Services Department to provide grants for housing. Sunsets January 2, 2026.

Amends allowable purposes of Emergency Housing Account to include account moneys to be used for grants to assist companion animals of individuals experiencing or at risk of homelessness.

Declares emergency, effective on passage.

7 **RESIDENTIAL USE OF COMMERCIAL LANDS**

8
9 **SECTION 1. Section 2 of this 2023 Act is added to and made a part of ORS 197.286 to**
10 **197.314.**

11 **SECTION 2. (1) Notwithstanding an acknowledged comprehensive plan or land use regu-**
12 **lations, within an urban growth boundary a local government shall allow, on lands zoned to**
13 **allow only commercial uses and not industrial uses, the siting and development of:**

14 (a) **Residential structures subject to an affordable housing covenant as provided in ORS**
15 **456.270 to 456.295 making each unit affordable to a household with income less than or equal**
16 **to 60 percent of the area median income as defined in ORS 456.270; or**

17 (b) **Mixed use structures with ground floor commercial units and residential units subject**
18 **to an affordable housing covenant as provided in ORS 456.270 to 456.295 making the proper-**
19 **ties affordable to moderate income households, as defined in ORS 456.270.**

20 (2) **The local government may only apply those approval standards, conditions and pro-**
21 **cedures under ORS 197.307, that would be applicable to the residential zone of the local gov-**
22 **ernment that is most comparable in density to the allowed commercial uses.**

23 (3) **Development under this section does not:**

24 (a) **Trigger any requirement that a local government consider or update an analysis as**
25 **required by a statewide planning goal relating to economic development.**

26 (b) **Apply on lands where the local government determines that:**

27 (A) **The development on the property cannot be adequately served by water, sewer, storm**
28 **water drainage or streets, or will not be adequately served at the time that development on**
29 **the lot is complete;**

30 (B) **The property contains a slope of 25 percent or greater;**

31 (C) **The property is within a 100-year floodplain; or**

32 (D) **The development of the property is constrained by land use regulations based on**
33 **statewide land use planning goals relating to:**

34 (i) **Natural disasters and hazards; or**

35 (ii) **Natural resources, including air, water, land or natural areas, but not including open**
36 **spaces.**

37 (c) **Apply on lands that are vacant or that were added to the urban growth boundary**
38 **within the last 15 years.**

40 **RESIDENTIAL APPROVAL PROCEDURES**

41
42 **SECTION 3. ORS 215.427 is amended to read:**

43 215.427. (1) Except as provided in subsections (3), (5) and (10) of this section, for land within an
44 urban growth boundary and applications for mineral aggregate extraction, the governing body of a
45 county or its designee shall take final action on an application for a permit, limited land use deci-

1 sion or zone change, including resolution of all appeals under ORS 215.422, within 120 days after the
2 application is deemed complete. The governing body of a county or its designee shall take final
3 action on all other applications for a permit, limited land use decision or zone change, including
4 resolution of all appeals under ORS 215.422, within 150 days after the application is deemed com-
5 plete, except as provided in subsections (3), (5) and (10) of this section.

6 (2) If an application for a permit, limited land use decision or zone change is incomplete, the
7 governing body or its designee shall notify the applicant in writing of exactly what information is
8 missing within 30 days of receipt of the application and allow the applicant to submit the missing
9 information. The application shall be deemed complete for the purpose of subsection (1) of this sec-
10 tion and ORS 197.311 upon receipt by the governing body or its designee of:

11 (a) All of the missing information;

12 (b) Some of the missing information and written notice from the applicant that no other infor-
13 mation will be provided; or

14 (c) Written notice from the applicant that none of the missing information will be provided.

15 (3)(a) If the application was complete when first submitted or the applicant submits additional
16 information, as described in subsection (2) of this section, within 180 days of the date the application
17 was first submitted and the county has a comprehensive plan and land use regulations acknowledged
18 under ORS 197.251, approval or denial of the application shall be based upon the standards and
19 criteria that were applicable at the time the application was first submitted.

20 (b) If the application is for industrial or traded sector development of a site identified under
21 section 12, chapter 800, Oregon Laws 2003, and proposes an amendment to the comprehensive plan,
22 approval or denial of the application must be based upon the standards and criteria that were ap-
23 plicable at the time the application was first submitted, provided the application complies with
24 paragraph (a) of this subsection.

25 (4) On the 181st day after first being submitted, the application is void if the applicant has been
26 notified of the missing information as required under subsection (2) of this section and has not sub-
27 mitted:

28 (a) All of the missing information;

29 (b) Some of the missing information and written notice that no other information will be pro-
30 vided; or

31 (c) Written notice that none of the missing information will be provided.

32 (5) The period set in subsection (1) of this section or the 100-day period set in ORS 197.311 may
33 be extended for a specified period of time at the written request of the applicant. The total of all
34 extensions, except as provided in subsection (10) of this section for mediation, may not exceed 215
35 days.

36 (6) The period set in subsection (1) of this section applies:

37 (a) Only to decisions wholly within the authority and control of the governing body of the
38 county; and

39 (b) Unless the parties have agreed to mediation as described in subsection (10) of this section
40 or ORS 197.319 (2)(b).

41 (7) Notwithstanding subsection (6) of this section, the period set in subsection (1) of this section
42 and the 100-day period set in ORS 197.311 do not apply to:

43 (a) A decision of the county making a change to an acknowledged comprehensive plan or a land
44 use regulation that is submitted to the Director of the Department of Land Conservation and De-
45 velopment under ORS 197.610[.]; or

1 **(b) A decision of a county involving an application for the development of residential**
2 **structures within an urban growth boundary, where the county has tentatively approved the**
3 **application and extends these periods by no more than seven days in order to assure the**
4 **sufficiency of its final order.**

5 (8) Except when an applicant requests an extension under subsection (5) of this section, if the
6 governing body of the county or its designee does not take final action on an application for a
7 permit, limited land use decision or zone change within 120 days or 150 days, as applicable, after
8 the application is deemed complete, the county shall refund to the applicant either the unexpended
9 portion of any application fees or deposits previously paid or 50 percent of the total amount of such
10 fees or deposits, whichever is greater. The applicant is not liable for additional governmental fees
11 incurred subsequent to the payment of such fees or deposits. However, the applicant is responsible
12 for the costs of providing sufficient additional information to address relevant issues identified in
13 the consideration of the application.

14 (9) A county may not compel an applicant to waive the period set in subsection (1) of this sec-
15 tion or to waive the provisions of subsection (8) of this section or ORS 197.311 or 215.429 as a
16 condition for taking any action on an application for a permit, limited land use decision or zone
17 change except when such applications are filed concurrently and considered jointly with a plan
18 amendment.

19 (10) The periods set forth in subsections (1) and (5) of this section and ORS 197.311 may be ex-
20 tended by up to 90 additional days, if the applicant and the county agree that a dispute concerning
21 the application will be mediated.

22 **SECTION 4.** ORS 227.178 is amended to read:

23 227.178. (1) Except as provided in subsections (3), (5) and (11) of this section, the governing body
24 of a city or its designee shall take final action on an application for a permit, limited land use de-
25 cision or zone change, including resolution of all appeals under ORS 227.180, within 120 days after
26 the application is deemed complete.

27 (2) If an application for a permit, limited land use decision or zone change is incomplete, the
28 governing body or its designee shall notify the applicant in writing of exactly what information is
29 missing within 30 days of receipt of the application and allow the applicant to submit the missing
30 information. The application shall be deemed complete for the purpose of subsection (1) of this sec-
31 tion or ORS 197.311 upon receipt by the governing body or its designee of:

32 (a) All of the missing information;

33 (b) Some of the missing information and written notice from the applicant that no other infor-
34 mation will be provided; or

35 (c) Written notice from the applicant that none of the missing information will be provided.

36 (3)(a) If the application was complete when first submitted or the applicant submits the re-
37 quested additional information within 180 days of the date the application was first submitted and
38 the city has a comprehensive plan and land use regulations acknowledged under ORS 197.251, ap-
39 proval or denial of the application shall be based upon the standards and criteria that were appli-

41 (b) If the application is for industrial or traded sector development of a site identified under
42 section 12, chapter 800, Oregon Laws 2003, and proposes an amendment to the comprehensive plan,
43 approval or denial of the application must be based upon the standards and criteria that were ap-
44 plicable at the time the application was first submitted, provided the application complies with
45 paragraph (a) of this subsection.

1 (4) On the 181st day after first being submitted, the application is void if the applicant has been
2 notified of the missing information as required under subsection (2) of this section and has not sub-
3 mitted:

4 (a) All of the missing information;

5 (b) Some of the missing information and written notice that no other information will be pro-
6 vided; or

7 (c) Written notice that none of the missing information will be provided.

8 (5) The 120-day period set in subsection (1) of this section or the 100-day period set in ORS
9 197.311 may be extended for a specified period of time at the written request of the applicant. The
10 total of all extensions, except as provided in subsection (11) of this section for mediation, may not
11 exceed 245 days.

12 (6) The 120-day period set in subsection (1) of this section applies:

13 (a) Only to decisions wholly within the authority and control of the governing body of the city;
14 and

15 (b) Unless the parties have agreed to mediation as described in subsection (11) of this section
16 or ORS 197.319 (2)(b).

17 (7) Notwithstanding subsection (6) of this section, the 120-day period set in subsection (1) of this
18 section and the 100-day period set in ORS 197.311 do not apply to:

19 (a) A decision of the city making a change to an acknowledged comprehensive plan or a land
20 use regulation that is submitted to the Director of the Department of Land Conservation and De-
21 velopment under ORS 197.610[.]; or

22 (b) **A decision of a city involving an application for the development of residential struc-**
23 **tures within an urban growth boundary, where the city has tentatively approved the appli-**
24 **cation and extends these periods by no more than seven days in order to assure the**
25 **sufficiency of its final order.**

26 (8) Except when an applicant requests an extension under subsection (5) of this section, if the
27 governing body of the city or its designee does not take final action on an application for a permit,
28 limited land use decision or zone change within 120 days after the application is deemed complete,
29 the city shall refund to the applicant, subject to the provisions of subsection (9) of this section, ei-
30 ther the unexpended portion of any application fees or deposits previously paid or 50 percent of the
31 total amount of such fees or deposits, whichever is greater. The applicant is not liable for additional
32 governmental fees incurred subsequent to the payment of such fees or deposits. However, the ap-
33 plicant is responsible for the costs of providing sufficient additional information to address relevant
34 issues identified in the consideration of the application.

35 (9)(a) To obtain a refund under subsection (8) of this section, the applicant may either:

36 (A) Submit a written request for payment, either by mail or in person, to the city or its designee;
37 or

38 (B) Include the amount claimed in a mandamus petition filed under ORS 227.179. The court shall
39 award an amount owed under this section in its final order on the petition.

40 (b) Within seven calendar days of receiving a request for a refund, the city or its designee shall
41 determine the amount of any refund owed. Payment, or notice that no payment is due, shall be made
42 to the applicant within 30 calendar days of receiving the request. Any amount due and not paid
43 within 30 calendar days of receipt of the request shall be subject to interest charges at the rate of
44 one percent per month, or a portion thereof.

45 (c) If payment due under paragraph (b) of this subsection is not paid within 120 days after the

1 city or its designee receives the refund request, the applicant may file an action for recovery of the
2 unpaid refund. In an action brought by a person under this paragraph, the court shall award to a
3 prevailing applicant, in addition to the relief provided in this section, reasonable attorney fees and
4 costs at trial and on appeal. If the city or its designee prevails, the court shall award reasonable
5 attorney fees and costs at trial and on appeal if the court finds the petition to be frivolous.

6 (10) A city may not compel an applicant to waive the 120-day period set in subsection (1) of this
7 section or to waive the provisions of subsection (8) of this section or ORS 197.311 or 227.179 as a
8 condition for taking any action on an application for a permit, limited land use decision or zone
9 change except when such applications are filed concurrently and considered jointly with a plan
10 amendment.

11 (11) The periods set forth in subsections (1) and (5) of this section and ORS 197.311 may be ex-
12 tended by up to 90 additional days, if the applicant and the city agree that a dispute concerning the
13 application will be mediated.

14 **SECTION 5.** ORS 197.830 is amended to read:

15 197.830. (1) Review of land use decisions or limited land use decisions under ORS 197.830 to
16 197.845 shall be commenced by filing a notice of intent to appeal with the Land Use Board of Ap-
17 peals.

18 (2) Except as provided in ORS 197.620, a person may petition the board for review of a land use
19 decision or limited land use decision if the person:

20 (a) Filed a notice of intent to appeal the decision as provided in subsection (1) of this section;
21 and

22 (b) Appeared before the local government, special district or state agency orally or in writing.

23 (3) If a local government makes a land use decision without providing a hearing, except as
24 provided under ORS 215.416 (11) or 227.175 (10), or the local government makes a land use decision
25 that is different from the proposal described in the notice of hearing to such a degree that the notice
26 of the proposed action did not reasonably describe the local government's final actions, a person
27 adversely affected by the decision may appeal the decision to the board under this section:

28 (a) Within 21 days of actual notice where notice is required; or

29 (b) Within 21 days of the date a person knew or should have known of the decision where no
30 notice is required.

31 (4) If a local government makes a land use decision without a hearing pursuant to ORS 215.416
32 (11) or 227.175 (10):

33 (a) A person who was not provided notice of the decision as required under ORS 215.416 (11)(c)
34 or 227.175 (10)(c) may appeal the decision to the board under this section within 21 days of receiving
35 actual notice of the decision.

36 (b) A person who is not entitled to notice under ORS 215.416 (11)(c) or 227.175 (10)(c) but who
37 is adversely affected or aggrieved by the decision may appeal the decision to the board under this
38 section within 21 days after the expiration of the period for filing a local appeal of the decision es-
39 tablished by the local government under ORS 215.416 (11)(a) or 227.175 (10)(a).

40 (c) A person who receives notice of a decision made without a hearing under ORS 215.416 (11)
41 or 227.175 (10) may appeal the decision to the board under this section within 21 days of receiving
42 actual notice of the nature of the decision, if the notice of the decision did not reasonably describe
43 the nature of the decision.

44 (d) Except as provided in paragraph (c) of this subsection, a person who receives notice of a
45 decision made without a hearing under ORS 215.416 (11) or 227.175 (10) may not appeal the decision

1 to the board under this section.

2 (5) If a local government makes a limited land use decision which is different from the proposal
3 described in the notice to such a degree that the notice of the proposed action did not reasonably
4 describe the local government's final actions, a person adversely affected by the decision may appeal
5 the decision to the board under this section:

6 (a) Within 21 days of actual notice where notice is required; or

7 (b) Within 21 days of the date a person knew or should have known of the decision where no
8 notice is required.

9 (6) The appeal periods described in subsections (3), (4) and (5) of this section:

10 (a) May not exceed three years after the date of the decision, except as provided in paragraph
11 (b) of this subsection.

12 (b) May not exceed 10 years after the date of the decision if notice of a hearing or an adminis-
13 trative decision made pursuant to ORS 197.195 or 197.797 is required but has not been provided.

14 (7)(a) Within 21 days after a notice of intent to appeal has been filed with the board under
15 subsection (1) of this section, any person described in paragraph (b) of this subsection may intervene
16 in and be made a party to the review proceeding by filing a motion to intervene and by paying a
17 filing fee of \$100.

18 (b) Persons who may intervene in and be made a party to the review proceedings, as set forth
19 in subsection (1) of this section, are:

20 (A) The applicant who initiated the action before the local government, special district or state
21 agency; or

22 (B) Persons who appeared before the local government, special district or state agency, orally
23 or in writing.

24 (c) Failure to comply with the deadline or to pay the filing fee set forth in paragraph (a) of this
25 subsection shall result in denial of a motion to intervene.

26 (8) If a state agency whose order, rule, ruling, policy or other action is at issue is not a party
27 to the proceeding, it may file a brief with the board as if it were a party. The brief shall be due on
28 the same date the respondent's brief is due and shall be accompanied by a filing fee of \$100.

29 (9) A notice of intent to appeal a land use decision or limited land use decision shall be filed
30 not later than 21 days after the date the decision sought to be reviewed becomes final. A notice of
31 intent to appeal plan and land use regulation amendments processed pursuant to ORS 197.610 to
32 197.625 shall be filed not later than 21 days after notice of the decision sought to be reviewed is
33 mailed or otherwise submitted to parties entitled to notice under ORS 197.615. Failure to include a
34 statement identifying when, how and to whom notice was provided under ORS 197.615 does not
35 render the notice defective. Copies of the notice of intent to appeal shall be served upon the local
36 government, special district or state agency and the applicant of record, if any, in the local gov-
37 ernment, special district or state agency proceeding. The notice shall be served and filed in the form
38 and manner prescribed by rule of the board and shall be accompanied by a filing fee of \$300. If a
39 petition for review is not filed with the board as required in subsections (10) and (11) of this section,
40 the board shall award the filing fee to the local government, special district or state agency.

41 (10)(a) Within 21 days after service of the notice of intent to appeal, the local government, spe-
42 cial district or state agency shall transmit to the board the original or a certified copy of the entire
43 record of the proceeding under review. By stipulation of all parties to the review proceeding the
44 record may be shortened. The board may require or permit subsequent corrections to the record;
45 however, the board shall issue an order on a motion objecting to the record within 60 days of re-

1 ceiving the motion. If the board denies a petitioner's objection to the record, the board may establish
2 a new deadline for the petition for review to be filed that may not be less than 14 days from the
3 later of the original deadline for the brief or the date of denial of the petitioner's record objection.

4 (b) Within 10 days after service of a notice of intent to appeal, the board shall provide notice
5 to the petitioner and the respondent of their option to enter into mediation pursuant to ORS 197.860.
6 Any person moving to intervene shall be provided such notice within seven days after a motion to
7 intervene is filed. The notice required by this paragraph shall be accompanied by a statement that
8 mediation information or assistance may be obtained from the Department of Land Conservation and
9 Development.

10 (11) A petition for review of the land use decision or limited land use decision and supporting
11 brief shall be filed with the board as required by the board under subsection (13) of this section.

12 (12) The petition shall include a copy of the decision sought to be reviewed and shall state:

13 (a) The facts that establish that the petitioner has standing.

14 (b) The date of the decision.

15 (c) The issues the petitioner seeks to have reviewed.

16 (13)(a) The board shall adopt rules establishing deadlines for filing petitions and briefs and for
17 oral argument.

18 (b) **The local government or state agency may withdraw its decision for purposes of re-**
19 **consideration** at any time:

20 (A) Subsequent to the filing of a notice of intent; and

21 (B) Prior to:

22 (i) The date set for filing the record[,]; or[,]

23 (ii) On appeal of a decision under ORS 197.610 to 197.625 **or relating to the development of**
24 **a residential structure**, [*prior to*] the filing of the respondent's brief[, *the local government or state*
25 *agency may withdraw its decision for purposes of reconsideration*].

26 (c) If a local government or state agency withdraws an order for purposes of reconsideration,
27 it shall, within such time as the board may allow, affirm, modify or reverse its decision. If the
28 petitioner is dissatisfied with the local government or agency action after withdrawal for purposes
29 of reconsideration, the petitioner may refile the notice of intent and the review shall proceed upon
30 the revised order. An amended notice of intent is not required if the local government or state
31 agency, on reconsideration, affirms the order or modifies the order with only minor changes.

32 (14) The board shall issue a final order within 77 days after the date of transmittal of the record.
33 If the order is not issued within 77 days the applicant may apply in Marion County or the circuit
34 court of the county where the application was filed for a writ of mandamus to compel the board to
35 issue a final order.

36 (15) Upon entry of its final order, the board:

37 (a) May, in its discretion, award costs to the prevailing party including the cost of preparation
38 of the record if the prevailing party is the local government, special district or state agency whose
39 decision is under review.

40 (b) Shall award reasonable attorney fees and expenses to the prevailing party against any other
41 party who the board finds presented a position or filed any motion without probable cause to believe
42 the position or motion was well-founded in law or on factually supported information.

43 (c) Shall award costs and attorney fees to a party as provided in ORS 197.843.

44 (16) Orders issued under this section may be enforced in appropriate judicial proceedings.

45 (17)(a) The board shall provide for the publication of its orders that are of general public in-

1 terest in the form it deems best adapted for public convenience. The publications shall constitute
2 the official reports of the board.

3 (b) Any moneys collected or received from sales by the board shall be paid into the Board
4 Publications Account established by ORS 197.832.

5 (18) Except for any sums collected for publication of board opinions, all fees collected by the
6 board under this section that are not awarded as costs shall be paid over to the State Treasurer to
7 be credited to the General Fund.

8 (19) The board shall track and report on its website:

9 (a) The number of reviews commenced, as described in subsection (1) of this section, the number
10 of reviews commenced for which a petition is filed under subsection (2) of this section and, in re-
11 lation to each of those numbers, the rate at which the reviews result in a decision of the board to
12 uphold, reverse or remand the land use decision or limited land use decision. The board shall track
13 and report reviews under this paragraph in categories established by the board.

14 (b) A list of petitioners, the number of reviews commenced and the rate at which the petitioner's
15 reviews have resulted in decisions of the board to uphold, reverse or remand the land use decision
16 or limited land use decision.

17 (c) A list of respondents, the number of reviews involving each respondent and the rate at which
18 reviews involving the respondent have resulted in decisions of the board to uphold, reverse or re-
19 mand the land use decision or limited land use decision. Additionally, when a respondent is the local
20 government that made the land use decision or limited land use decision, the board shall track
21 whether the local government appears before the board.

- 7 (B) A religious corporation as defined in ORS 65.001; or

6 (6) "Common expenses" means expenditures made by or financial liabilities incurred by the
7 homeowners association and includes any allocations to the reserve account under ORS 94.595.

8 (7) "Common property" means any real property or interest in real property within a planned
9 community which is owned, held or leased by the homeowners association or owned as tenants in
10 common by the lot owners, or designated in the declaration or the plat for transfer to the associ-

38 proved by the city or county surveyor;

39 (B) For a space described in ORS 100.020 (3)(b)(B), the horizontal boundaries of each unit and
40 the common elements to which each unit has access. If the space is located within a structure, the
41 vertical boundaries also shall be shown and referenced to a known benchmark elevation or other
42 reference point as approved by the city or county surveyor;

43 (C) For a moorage space described in ORS 100.020 (3)(b)(C), the horizontal boundaries of each
44 unit and the common elements to which each unit has access; and

45 (D) For a floating structure described in ORS 100.020 (3)(b)(D), the horizontal and vertical

17 picted on the plat are subject to the provisions of ORS 100.005 to 100.627.

21 *[(i)]* (h) If the condominium is a flexible condominium, show the location and dimensions of all
22 variable property identified in the declaration and label the variable property as
23 "WITHDRAWABLE VARIABLE PROPERTY" or "NONWITHDRAWABLE VARIABLE
24 PROPERTY," with a letter different from those designating a unit, building or other tract of vari-
25 able property. If there is more than one tract, each tract shall be labeled in the same manner.

26 (2) The supplemental plat required under ORS 100.150 (1) shall be recorded simultaneously with
27 the supplemental declaration. The supplemental plat shall be titled in accordance with subsection
28 (3) of this section and shall:

40 (e) Include a surveyor's certificate complying with ORS 92.070.

41 (3) The title of each supplemental plat described in ORS 100.120 shall include the complete name
42 of the condominium, followed by the additional language specified in this subsection and the appro-
43 priate reference to the stage being annexed or tract of variable property being reclassified. Each
44 supplemental plat for a condominium recorded on or after January 1, 2002, shall be numbered se-
45 quentially and shall:

1 (a) If property is annexed under ORS 100.125, include the words “Supplemental Plat No.
2 _____: Annexation of Stage _____”; or

3 (b) If property is reclassified under ORS 100.150, include the words “Supplemental Plat No.

2 (d) The unit designation, a statement that the location of each unit is shown on the plat, a de-
3 scription of the boundaries and area in square feet of each unit and any other data necessary for
4 proper identification. The area of a unit must be the same as shown for that unit on the plat de-
5 scribed in ORS 100.115 (1).

6 (e) A notice in substantially the following form in at least 12-point type in all capitals or bold-
7 face:

12 THE SQUARE FOOTAGE AREAS STATED IN THIS DECLARATION AND THE PLAT ARE
13 BASED ON THE BOUNDARIES OF THE UNITS AS DESCRIBED IN THIS DECLARATION AND
14 MAY VARY FROM THE AREA OF UNITS CALCULATED FOR OTHER PURPOSES.

16
17 (f) A description of the general common elements.

18 (g) An allocation to each unit of an undivided interest in the common elements in accordance
19 with ORS 100.515 and the method used to establish the allocation.

20 (h) The designation of any limited common elements including:

21 (A) A general statement of the nature of the limited common element;

22 (B) A statement of the unit to which the use of each limited common element is reserved, pro-
23 vided the statement is not a reference to an assignment of use specified on the plat; and

24 (C) The allocation of use of any limited common element appertaining to more than one unit.

25 (i) The method of determining liability for common expenses and right to common profits in ac-
26 cordance with ORS 100.530.

27 (j) The voting rights allocated to each unit in accordance with ORS 100.525 or, in the case of
28 condominium units committed as property in a timeshare plan defined in ORS 94.803, the voting
29 rights allocated in the timeshare instrument.

30 (k) A statement of the general nature of use, residential or otherwise, for which the building or
31 buildings and each of the units is intended.

32 (L) A statement that the designated agent to receive service of process in cases provided in ORS
33 100.550 (1) is named in the Condominium Information Report which will be filed with the Real Estate
34 Agency in accordance with ORS 100.250 (1)(a).

35 (m) The method of amending the declaration and the percentage of voting rights required to
36 approve an amendment of the declaration in accordance with ORS 100.135.

37 (n) A statement as to whether or not the association of unit owners pursuant to ORS 100.405 (5)
38 and (8) has authority to grant leases, easements, rights of way, licenses and other similar interests
39 affecting the general and limited common elements of the condominium and consent to vacation of
40 roadways within and adjacent to the condominium.

41 (o) If the condominium contains a floating structure described in ORS 100.020 (3), a statement
42 regarding the authority of the board of directors of the association, subject to ORS 100.410, to
43 temporarily relocate the floating structure without a majority vote of affected unit owners.

44 (p) Any restrictions on alienation of units. Any such restrictions created by documents other
45 than the declaration may be incorporated by reference in the declaration to the official records of

1 the county in which the property is located.

2 (q) Any other details regarding the property that the person executing the declaration considers
3 desirable. However, if a provision required to be in the bylaws under ORS 100.415 is included in the
4 declaration, the voting requirements for amending the bylaws also govern the amendment of the
5 provision in the declaration.

6 (2) In the event the declarant proposes to annex additional property to the condominium under
7 ORS 100.125, the declaration also must contain a general description of the plan of development,
8 including:

9 (a) The maximum number of units to be included in the condominium.

10 (b) The date after which any right to annex additional property will terminate.

11 (c) A general description of the nature and proposed use of any additional common elements
12 which declarant proposes to annex to the condominium, if such common elements might substantially
13 increase the proportionate amount of the common expenses payable by existing unit owners.

14 (d) A statement that the method used to establish the allocation of undivided interest in the
15 common elements, the method used to determine liability for common expenses and right to common
16 profits and the method used to allocate voting rights for each unit annexed is as stated in the dec-
17 laration in accordance with subsection (1)(g), (i) and (j) of this section.

18 (e) Such other information as the Real Estate Commissioner requires in order to carry out the
19 purposes of this chapter.

20 (3) Unless expressly prohibited by the declaration and subject to the requirements of ORS
21 100.135 (2) and subsections (9) and (10) of this section:

22 (a) Not later than two years following the termination date specified in subsection (2)(b) of this
23 section, the termination date may be extended for a period not exceeding five years.

24 (b) Before the termination date specified in the declaration or supplemental declaration under
25 subsection (7)(d) of this section, the termination date may be extended for a period not exceeding
26 five years.

27 (c) The general description under subsection (2)(c) of this section and the information included
28 in the declaration or supplemental declaration in accordance with subsection (7)(c), (g) and (h) of
29 this section may be changed by an amendment to the declaration or supplemental declaration and
30 plat or supplemental plat.

31 (4) The information included in the declaration or supplemental declaration in accordance with
32 subsection (2)(a) and (d) of this section and subsection (7)(a), (b), (e), (f) and (k) of this section may
33 not be changed unless all owners agree to the change and an amendment to the declaration or
34 supplemental declaration and, if applicable, the plat or supplemental plat are recorded in accordance
35 with this chapter.

36 (5) The name of the property shall include the word “condominium” or “condominiums” or the
37 words “a condominium.”

38 (6) A condominium may not bear a name which is the same as or deceptively similar to the name
39 of any other, **different** condominium located in the same county.

40 (7) If the condominium is a flexible condominium containing variable property, the declaration
41 shall also contain a general description of the plan of development, including:

42 (a) A statement that the rights provided for under ORS 100.150 (1) are being reserved.

43 (b) A statement:

44 (A) Of any limitations on rights reserved under ORS 100.150 (1), including whether the consent
45 of any unit owner is required, and if so, a statement of the method by which the consent is ascer-

1 tained; or

2 (B) That there are no limitations on rights reserved under ORS 100.150 (1).

3 (c) A statement of the total number of tracts of variable property within the condominium, in-
4 cluding:

5 (A) A designation of each tract as withdrawable variable property or nonwithdrawable variable
6 property;

7 (B) Identification of each variable tract by a label in accordance with ORS 100.115 [(1)(i)]
8 (1)(h);

9 (C) A statement of the method of labeling each tract depicted on the plat in accordance with
10 ORS 100.115 [(1)(i)] (1)(h); and

11 (D) A statement of the total number of tracts of each type of variable property.

12 (d) The termination date, which is the date after which any right reserved under ORS 100.150
13 (1) will terminate, and a statement of the circumstances, if any, that will terminate any right on or
14 before the date specified. Subject to ORS 100.120, the termination date from the date of recording
15 of the conveyance of the first unit in the condominium to a person other than the declarant may
16 not exceed:

17 (A) Twenty years, only if a condominium consists, or may consist if the condominium is a flexi-
18 ble condominium, exclusively of units to be used for nonresidential purposes; or

19 (B) Seven years.

20 (e) The maximum number of units that may be created.

21 (f) A statement that the method used to establish the allocations of undivided interest in the
22 common elements, the method used to determine liability for common expenses and right to common
23 profits and the method used to allocate voting rights as additional units are created is the same as
24 stated in the declaration in accordance with subsection (1)(g), (i) and (j) of this section.

25 (g) A general description of all existing improvements and the nature and proposed use of any
26 improvements that may be made on variable property if the improvements might substantially in-
27 crease the proportionate amount of the common expenses payable by existing unit owners.

28 (h) A statement of whether or not the declarant reserves the right to create limited common
29 elements within any variable property, and if so, a general description of the types that may be
30 created.

31 (i) A statement that the plat shows the location and dimensions of all withdrawable variable
32 property that is labeled "WITHDRAWABLE VARIABLE PROPERTY."

33 (j) A statement that if by the termination date all or a portion of the withdrawable variable
34 property has not been withdrawn or reclassified, the withdrawable variable property is automat-
35 ically withdrawn from the condominium as of the termination date.

36 (k) A statement of the rights of the association under ORS 100.155 (2).

37 (L) A statement of whether or not all or any portion of the variable property may not be with-
38 drawn from the condominium and, if so, with respect to the nonwithdrawable variable property:

39 (A) A statement that the plat shows the location and dimensions of all nonwithdrawable variable
40 property that is labeled "NONWITHDRAWABLE VARIABLE PROPERTY."

41 (B) A description of all improvements that may be made and a statement of the intended use of
42 each improvement.

43 (C) A statement that, if by the termination date all or a portion of the variable property desig-
44 nated as "nonwithdrawable variable property" has not been reclassified, the property is automat-
45 ically reclassified as of the termination date as a general common element of the condominium and

1 any interest in the property held for security purposes is automatically extinguished by the classi-
2 fication.

3 (D) A statement of the rights of the association under ORS 100.155 (3).

4 (m) A statement by the local governing body or appropriate department thereof that the with-
5 drawal of any variable property designated as “withdrawable variable property” in the declaration
6 in accordance with paragraph (L) of this subsection, will not violate any applicable planning or
7 zoning regulation or ordinance. The statement may be attached as an exhibit to the declaration.

8 (8) The plan of development for any variable property included in the declaration or any sup-
9 plemental declaration of any stage in accordance with subsection (7) of this section is subject to any
10 plan of development included in the declaration in accordance with subsection (2) of this section,
11 except that the time limitation specified in subsection (7)(d) of this section governs any right re-
12 served under ORS 100.150 (1) with respect to any variable property.

13 (9) The information included in the declaration in accordance with subsection (7)(j), (k) and (m)
14 of this section may not be deleted by amendment.

15 (10)(a) Approval by the unit owners is not required for a declarant to redesignate withdrawable
16 variable property as “nonwithdrawable variable property” under ORS 100.150 (1) by supplemental
17 declaration and supplemental plat, for any reason, including if the redesignation is required by the
18 local governing body to comply with any planning or zoning regulation or ordinance.

19 (b) If as a result of a redesignation under paragraph (a) of this subsection, the information re-
20 quired to be included in the supplemental declaration under subsection (7)(L)(B) of this section is
21 inconsistent with the information included in the declaration or supplemental declaration in ac-
22 cordance with subsection (7)(g) of this section, an amendment to the declaration or supplemental
23 declaration and plat or supplemental plat approved by at least 75 percent of owners is required.

24 (11) The statement of an interest in property other than fee simple submitted to the condomin-
25 ium form of ownership and any easements, rights or appurtenances belonging to property submitted
26 to the condominium form of ownership, whether leasehold or fee simple, must include:

27 (a) A reference to the recording index numbers and date of recording of the instrument creating
28 the interest; or

29 (b) A reference to the law, administrative rule, ordinance or regulation that creates the interest
30 if the interest is created under law, administrative rule, ordinance or regulation and not recorded
31 in the office of the recording officer of the county in which the property is located.

32
33 **SUBDIVIDING FOR DEVELOPMENT OF AFFORDABLE HOUSING**

34
35 **SECTION 15.** ORS 92.090 is amended to read:

36 92.090. (1) Subdivision plat names shall be subject to the approval of the county surveyor or, in
37 the case where there is no county surveyor, the county assessor. No tentative subdivision plan or
38 subdivision plat of a subdivision shall be approved which bears a name similar to or pronounced the
39 same as the name of any other subdivision in the same county, unless the land platted is contiguous
40 to and platted by the same party that platted the subdivision bearing that name or unless the party
41 files and records the consent of the party that platted the contiguous subdivision bearing that name.
42 All subdivision plats must continue the lot numbers and, if used, the block numbers of the subdivi-
43 sion plat of the same name last filed. On or after January 1, 1992, any subdivision submitted for final
44 approval shall not use block numbers or letters unless such subdivision is a continued phase of a
45 previously recorded subdivision, bearing the same name, that has previously used block numbers or

1 letters.

2 (2) No tentative plan for a proposed subdivision and no tentative plan for a proposed partition
3 shall be approved unless:

4 (a) The streets and roads are laid out so as to conform to the plats of subdivisions and partitions
5 already approved for adjoining property as to width, general direction and in all other respects un-
6 less the city or county determines it is in the public interest to modify the street or road pattern.

7 (b) Streets and roads held for private use are clearly indicated on the tentative plan and all
8 reservations or restrictions relating to such private roads and streets are set forth thereon.

9 (c) The tentative plan complies with the applicable zoning ordinances and regulations and the
10 ordinances or regulations adopted under ORS 92.044 that are then in effect for the city or county
11 within which the land described in the plan is situated.

12 (3) No plat of a proposed subdivision or partition shall be approved unless:

13 (a) Streets and roads for public use are dedicated without any reservation or restriction other
14 than reversionary rights upon vacation of any such street or road and easements for public or pri-
15 vate utilities.

16 (b) Streets and roads held for private use and indicated on the tentative plan of such subdivision
17 or partition have been approved by the city or county.

18 (c) The subdivision or partition plat complies with any applicable zoning ordinances and regu-
19 lations and any ordinance or regulation adopted under ORS 92.044 that are then in effect for the
20 city or county within which the land described in the subdivision or partition plat is situated.

21 (d) The subdivision or partition plat is in substantial conformity with the provisions of the ten-
22 tative plan for the subdivision or partition, as approved.

23 (e) The subdivision or partition plat contains a donation to the public of all common improve-
24 ments, including but not limited to streets, roads, parks, sewage disposal and water supply systems,
25 the donation of which was made a condition of the approval of the tentative plan for the subdivision
26 or partition.

27 (f) Explanations of all common improvements required as conditions of approval of the tentative
28 plan of the subdivision or partition have been recorded and referenced on the subdivision or parti-
29 tion plat.

30 (4) Subject to any standards and procedures adopted pursuant to ORS 92.044, no plat of a sub-
31 division shall be approved by a city or county unless the city or county has received and accepted:

32 (a) A certification by a city-owned domestic water supply system or by the owner of a privately
33 owned domestic water supply system, subject to regulation by the Public Utility Commission of
34 Oregon, that water will be available to the lot line of each and every lot depicted in the proposed
35 subdivision plat;

36 (b) A bond, irrevocable letter of credit, contract or other assurance by the subdivider to the city
37 or county that a domestic water supply system will be installed by or on behalf of the subdivider
38 to the lot line of each and every lot depicted in the proposed subdivision plat[; *and the amount of*
39 *any such bond, irrevocable letter of credit, contract or other assurance by the subdivider shall be*] **in**
40 **an amount** determined by a registered professional engineer, subject to any change in such amount
41 as determined necessary by the city or county; or

42 (c) [*In lieu of paragraphs (a) and (b) of this subsection,*] A statement that no domestic water
43 supply facility will be provided to the purchaser of any lot depicted in the proposed subdivision plat,
44 even though a domestic water supply source may exist. A copy of any such statement, signed by the
45 subdivider and indorsed by the city or county, shall be filed by the subdivider with the Real Estate

1 Commissioner and shall be included by the commissioner in any public report made for the subdivi-
 2 sion under ORS 92.385. If the making of a public report has been waived or the subdivision is oth-
 3 erwise exempt under the Oregon Subdivision Control Law, the subdivider shall deliver a copy of the
 4 statement to each prospective purchaser of a lot in the subdivision at or prior to the signing by the
 5 purchaser of the first written agreement for the sale of the lot. The subdivider shall take a signed
 6 receipt from the purchaser upon delivery of such a statement, shall immediately send a copy of the
 7 receipt to the commissioner and shall keep any such receipt on file in this state, subject to in-
 8 spection by the commissioner, for a period of three years after the date the receipt is taken.

9 (5) Subject to any standards and procedures adopted pursuant to ORS 92.044, no plat of a sub-
 10 division shall be approved by a city or county unless the city or county has received and accepted:

11 (a) A certification by a city-owned sewage disposal system or by the owner of a privately owned
 12 sewage disposal system that is subject to regulation by the Public Utility Commission of Oregon that
 13 a sewage disposal system will be available to the lot line of each and every lot depicted in the
 14 proposed subdivision plat;

15 (b) A bond, irrevocable letter of credit, contract or other assurance by the subdivider to the city
 16 or county that a sewage disposal system will be installed by or on behalf of the subdivider to the
 17 lot line of each and every lot depicted on the proposed subdivision plat[; *and the amount of such*
 18 *bond, irrevocable letter of credit, contract or other assurance shall be*] **in an amount** determined by
 19 a registered professional engineer, subject to any change in such amount as the city or county
 20 considers necessary; or

21 (c) [*In lieu of paragraphs (a) and (b) of this subsection,*] A statement that no sewage disposal
 22 facility will be provided to the purchaser of any lot depicted in the proposed subdivision plat, where
 23 the Department of Environmental Quality has approved the proposed method or an alternative
 24 method of sewage disposal for the subdivision in its evaluation report described in ORS 454.755
 25 (1)(b). A copy of any such statement, signed by the subdivider and indorsed by the city or county
 26 shall be filed by the subdivider with the Real Estate Commissioner and shall be included by the
 27 commissioner in the public report made for the subdivision under ORS 92.385. If the making of a
 28 public report has been waived or the subdivision is otherwise exempt under the Oregon Subdivision
 29 Control Law, the subdivider shall deliver a copy of the statement to each prospective purchaser of
 30 a lot in the subdivision at or prior to the signing by the purchaser of the first written agreement
 31 for the sale of the lot. The subdivider shall take a signed receipt from the purchaser upon delivery
 32 of such a statement, shall immediately send a copy of the receipt to the commissioner and shall keep
 33 any such receipt on file in this state, subject to inspection by the commissioner, for a period of three
 34 years after the date the receipt is taken.

35 **(6) A city or county shall accept as other assurance, as used in subsections (4)(b) and**
 36 **(5)(b) of this section, one or more award letters from public funding sources made to a sub-**
 37 **divider who is subdividing the property to develop affordable housing, that is or will be sub-**
 38 **ject to an affordability restriction as defined in ORS 456.250 or an affordable housing**
 39 **covenant as defined in ORS 456.270, if the awards total an amount greater than the project**
 40 **cost.**

41 [(6)] (7) Subject to any standards and procedures adopted pursuant to ORS 92.044, no plat of a
 42 subdivision or partition located within the boundaries of an irrigation district, drainage district,
 43 water control district, water improvement district or district improvement company shall be ap-
 44 proved by a city or county unless the city or county has received and accepted a certification from
 45 the district or company that the subdivision or partition is either entirely excluded from the district

1 or company or is included within the district or company for purposes of receiving services and
2 subjecting the subdivision or partition to the fees and other charges of the district or company.

3
4 **SINGLE ROOM OCCUPANCIES**

5
6 **SECTION 16.** Section 17 of this 2023 Act and ORS 197.758 are added to and made a part
7 of ORS 197.286 to 197.314.

8 **SECTION 17.** (1) As used in this section “single room occupancy” means a residential
9 development with no fewer than four attached units that are independently rented and
10 lockable and provide living and sleeping space for the exclusive use of an occupant, but re-
11 quire that the occupant share sanitary or food preparation facilities with other units in the
12 occupancy.

13 (2) Within an urban growth boundary, each local government shall allow the development
14 of a single room occupancy:

15 (a) With up to six units on each lot or parcel zoned to allow for the development of a
16 detached single-family dwelling; and

17 (b) With the number of units consistent with the density standards of a lot or parcel
18 zoned to allow for the development of residential dwellings with five or more units.

19 **SECTION 18.** ORS 197.303, as amended by section 27, chapter 13, Oregon Laws 2023 (Enrolled
20 House Bill 2001), is amended to read:

21 197.303. (1) As used in ORS 197.296 and this section, “needed housing” means all housing on land
22 zoned for residential use or mixed residential and commercial use that is determined to meet the
23 need shown for housing within an urban growth boundary at price ranges and rent levels that are
24 affordable to households within the county with a variety of incomes, including but not limited to
25 households with low incomes, very low incomes and extremely low incomes, as those terms are de-
26 fined by the United States Department of Housing and Urban Development under 42 U.S.C. 1437a.
27 “Needed housing” includes the following housing types:

28 (a) Attached and detached single-family housing, middle housing types as described in ORS
29 197.758 and multiple family housing for both owner and renter occupancy;

30 (b) Government assisted housing;

31 (c) Mobile home or manufactured dwelling parks as provided in ORS 197.475 to 197.490;

32 (d) Manufactured homes on individual lots planned and zoned for single-family residential use
33 that are in addition to lots within designated manufactured dwelling subdivisions;

34 (e) Agriculture workforce housing;

35 (f) Housing for individuals with a variety of disabilities related to mobility or communications
36 that require accessibility features;

37 (g) Housing for older persons, as defined in ORS 659A.421; [and]

38 (h) Housing for college or university students, if relevant to the region[.]; and

39 (i) **Single room occupancies as defined in section 17 of this 2023 Act.**

40 (2) For the purpose of estimating housing needs, as described in ORS 197.296 (3)(b), Metro shall
41 adopt findings and perform an analysis that estimates each of the following factors:

42 (a) Projected needed housing units over the next 20 years;

43 (b) Current housing underproduction;

44 (c) Housing units needed for people experiencing homelessness; and

45 (d) Housing units projected to be converted into vacation homes or second homes during the

1 next 20 years.

2 (3) At the time Metro performs the analysis under subsection (2) of this section, Metro shall
3 allocate a housing need for each city within Metro.

4 (4) In making an allocation under subsection (3) of this section, Metro shall consider:

5 (a) The forecasted population growth under ORS 195.033 or 195.036;

6 (b) The forecasted regional job growth;

7 (c) An equitable statewide distribution of housing for income levels described in section 2 (4),
8 **chapter 13, Oregon Laws 2023 (Enrolled House Bill 2001)** [of this 2023 Act].

9 (d) The estimates made under subsection (2) of this section; and

10 (e) The purpose of the Oregon Housing Needs Analysis under section 1 (1), **chapter 13, Oregon**
11 **Laws 2023 (Enrolled House Bill 2001)** [of this 2023 Act].

12 (5) Metro shall make the estimate described in subsection (2) of this section using a shorter time
13 period than since the last review under ORS 197.296 (2)(a)(B) if Metro finds that the shorter time
14 period will provide more accurate and reliable data related to housing need. The shorter time period
15 may not be less than three years.

16 (6) Metro shall use data from a wider geographic area or use a time period longer than the time
17 period described in subsection (2) of this section if the analysis of a wider geographic area or the
18 use of a longer time period will provide more accurate, complete and reliable data relating to trends
19 affecting housing need than an analysis performed pursuant to subsection (2) of this section. Metro
20 must clearly describe the geographic area, time frame and source of data used in an estimate per-
21 formed under this subsection.

22 (7) Subsection (1)(a) and (d) of this section does not apply to a city with a population of less than
23 2,500.

24 (8) Metro may take an exception under ORS 197.732 to the definition of “needed housing” in
25 subsection (1) of this section in the same manner that an exception may be taken under the goals.

26 **SECTION 19.** Section 23, chapter 13, Oregon Laws 2023 (Enrolled House Bill 2001), is amended
27 to read:

28 **Sec. 23.** (1) As used in ORS 197.286 to 197.314, and except as provided in subsection (2) of this
29 section:

30 (a) “Needed housing” means housing by affordability level, as described in section 2 (4), **chapter**
31 **13, Oregon Laws 2023 (Enrolled House Bill 2001)** [of this 2023 Act], type, characteristics and lo-
32 cation that is necessary to accommodate the city’s allocated housing need over the 20-year planning
33 period in effect when the city’s housing capacity is determined.

34 (b) “Needed housing” includes the following housing types:

35 (A) Detached single-family housing, middle housing types as described in ORS 197.758 and
36 multifamily housing that is owned or rented;

37 (B) Government assisted housing;

38 (C) Mobile home or manufactured dwelling parks as provided in ORS 197.475 to 197.490;

39 (D) Manufactured homes on individual lots planned and zoned for single-family residential use
40 that are in addition to lots within designated manufactured dwelling subdivisions;

41 (E) Housing for agricultural workers;

42 (F) Housing for individuals with a variety of disabilities, related to mobility or communications
43 that require accessibility features;

44 (G) Housing for older persons, as defined in ORS 659A.421; [and]

45 (H) Housing for college or university students, if relevant to the region[.]; and

1 (d) Lands that are not zoned for residential use, including lands zoned primarily for commercial,
2 industrial, agricultural or public uses; or

3 (e) Lands that are not incorporated and are zoned under an interim zoning designation that
4 maintains the land's potential for planned urban development.

5 (5) Local governments may regulate siting and design of middle housing required to be permitted
6 under this section, provided that the regulations do not, individually or cumulatively, discourage the
7 development of all middle housing types permitted in the area through unreasonable costs or delay.
8 Local governments may regulate middle housing to comply with protective measures adopted pur-
9 suant to statewide land use planning goals.

10 (6) This section does not prohibit local governments from permitting:

11 (a) Single-family dwellings in areas zoned to allow for single-family dwellings; or

12 (b) Middle housing in areas not required under this section.

13 **(7) A local government that amends its comprehensive plan or land use regulations re-**
14 **lating to allowing additional middle housing is not required to consider whether the amend-**
15 **ments significantly affect an existing or planned transportation facility.**

16 **SECTION 21.** Section 3, chapter 639, Oregon Laws 2019, is amended to read:

17 **Sec. 3.** (1) Notwithstanding ORS 197.646, a local government shall adopt land use regulations

32 **SECTION 34. (1) As used in this section, “community housing supporting agricultural**
33 **employees” means a housing development that:**

34 **(a) Is within an urban growth boundary;**

35 **(b) Is within 20 miles of significant agricultural employment as identified by the Housing**
36 **and Community Services Department;**

37 **(c) Is promoted for residential use by agricultural employees and developed with amen-**
38 **ities suitable for agricultural employees and their families;**

39 **(d) Consists of a multifamily dwelling or a cluster of buildings, including manufactured,**
40 **prefabricated or modular housing, housing produced through a three-dimensional printing**
41 **process or other housing developed using innovative construction types; and**

42 **(e)(A) Is subject to an affordable housing covenant requiring that the units are main-**
43 **tained for a period of no less than 60 years as affordable to rent for low income households,**
44 **as described in ORS 456.270 to 456.295;**

45 **(B) Is operated as a consumer housing cooperative; or**

1 (C) Is operated under a model approved by the department designed to preserve
2 affordability or control of the property by its residents.

3 (2) The Housing and Community Services Department shall provide one or more grants
4 to qualified housing sponsors for the purposes of developing community housing supporting
5 agricultural employees.

6 (3) In awarding grants under this section, the department shall prioritize applications:

7 (a) From a developer that is a nonprofit housing corporation that serves agricultural
8 workers;

9 (b) From a developer that is a nonprofit that promotes housing for agricultural employ-
10 ees or other needs of agricultural employees, or from a developer that has entered into a
11 partnership with a nonprofit housing corporation that serves agricultural workers for the
12 purposes of developing the community housing;

13 (c) Where other funding for the housing development has been dedicated or can be lev-
14 eraged by the grant;

15 (d) Where the housing development will be located close to significant agricultural em-
16 ployment; or

17 (e) Where the housing development will include or will be near specific characteristics
18 or amenities designed to support or attract agricultural employees and their families.

19 (4) Grants awarded under this section may be used for any project costs for the devel-

4 (c) Connecting producers of needed housing with consumers of needed housing; and

5 (d) Working with representatives of historically underrepresented groups to overcome
6 community-specific barriers to obtaining housing.

7 SECTION 38. Section 37 of this 2023 Act is repealed on January 2, 2034.

8 SECTION 39. In addition to and not in lieu of any other appropriation, there is appro-
9 priated to the Oregon Department of Administrative Services, for the biennium beginning
10 July 1, 2023, out of the General Fund, the amount of \$5,000,000, to provide grants under
11 section 37 of this 2023 Act.

13 **AFFORDABLE HOMEOWNERSHIP REVOLVING LOAN FUND**

14
15 SECTION 40. (1) The Housing and Community Services Department shall make a grant
16 to the Network for Oregon Affordable Housing (NOAH) to establish a revolving loan fund
17 that will allow a first-time home buyer who is purchasing a home, including a share of a
18 cooperative or a condominium unit, in which the purchaser's equity will be limited, to es-
19 tablish equity at a faster rate while making monthly payments similar to those described in
20 subsection (3)(a)(A) of this subsection. The department may not make a grant under this
21 section until NOAH has demonstrated that it has dedicated to a loan fund described in this

28 (b) Requires that the purchaser be a low income household as defined in ORS 456.270.

29 (3) Loans made from the loan fund must:

30 (a) Be made only to applicants that have met with an approved or certified housing
31 counseling agency, as described in 24 C.F.R. 214 subpart B, and have a first-time home buyer
32 program offered by the agency;

33 (b) Have a term of 20 years or less; and

34 (c) Have a fixed interest rate that is not more than the greater of:

35 (A) The rate that would allow monthly amortized principal and interest payments under
36 the term of the loan to be the amount that would result from a 30-year fixed-rate amortized
37 mortgage at the national current average rate as published by a reputable financial source;
38 or

39 (B) 0.5 percent.

40 SECTION 41. Section 40 of this 2023 Act is repealed on January 2, 2026.

41 SECTION 42. In addition to and not in lieu of any other appropriation, there is appro-
42 priated to the Housing and Community Services Department, for the biennium beginning July
43 1, 2023, out of the General Fund, the amount of \$7,500,000, to make a grant under section 40
44 of this 2023 Act.

45 SECTION 43. On or before September 15, 2025, and on or before September 15, 2027, the

1 Housing and Community Services Department shall provide a report to an appropriate in-
2 terim committee of the Legislative Assembly, in the manner provided in ORS 192.245, on the
3 use of the loan funds described in section 40 of this 2023 Act, as reported to the department
4 by the Network for Oregon Affordable Housing (NOAH).

6 **AFFORDABLE HOUSING LOAN GUARANTEE FUND**

7
8 **SECTION 44.** Section 45 of this 2023 Act is added to and made a part of ORS chapter 458.

9 **SECTION 45.** (1) The Housing and Community Services Department shall provide grants
10 to one or more nonprofit corporations to develop a fund.

11 (2) The moneys in the fund may be used only to guarantee the repayment of loans to fi-
12 nance the construction of housing subject to an affordable housing covenant for low or
13 moderate income households, as described in ORS 456.270 to 456.295 and as further defined
14 by the Housing and Community Services Department by rule.

15 (3) The term of a loan guaranteed under this section may not exceed five years.

16 (4) The department and the state are not guarantors of any loan guaranteed by a
17 nonprofit corporation under this section.

18 (5) To be eligible for a grant under this section, a nonprofit corporation must:

19 (a) Be exempt from income taxes under section 501(c)(3) or (4) of the Internal Revenue
20 Code; and

21 (b) Demonstrate to the satisfaction of the department that the corporation is a commu-
22 nity development financial institution that operates statewide to support investment in the
23 construction of affordable housing.

24 **SECTION 46.** Section 45 of this 2023 Act is repealed on January 2, 2026.

25 **SECTION 47.** In addition to and not in lieu of any other appropriation, there is appro-
26 priated to the Housing and Community Services Department, for the biennium beginning July
27 1, 2023, out of the General Fund, the amount of \$20,000,000 to provide grants under section
28 45 of this 2023 Act.

32 **SECTION 47a.** Notwithstanding any other provision of law, the General Fund appropri-
33 ation made to the Housing and Community Services Department by section 1, chapter __,
34 Oregon Laws 2023 (Enrolled Senate Bill 5511), for the biennium beginning July 1, 2023, is in-
35 creased by \$529,802, for purposes of administering sections 34, 37, 40, 43 and 45 of this 2023
36 Act.

38 **EMERGENCY HOUSING ASSISTANCE FOR COMPANION ANIMALS**

39
40 **SECTION 48.** ORS 458.650 is amended to read:

41 458.650. (1) The Housing and Community Services Department shall administer the Emergency
42 Housing Account to assist homeless individuals and individuals who are at risk of becoming
43 homeless, through means including the emergency housing assistance program and the state
44 homeless assistance program. Notwithstanding subsection (3)(a) of this section, the state homeless
45 assistance program shall serve individuals experiencing homelessness, especially unsheltered

1 homelessness, without respect to income.

2 (2) The Oregon Housing Stability Council shall develop a policy for the use of program funds
3 with the advice of:

- 4 (a) Persons who have experienced housing instability;
- 5 (b) Tribes;
- 6 (c) The Community Action Partnership of Oregon;
- 7 (d) Continuums of care, as defined in 24 C.F.R. part 578;
- 8 (e) Local governments;
- 9 (f) Nonprofit organizations;
- 10 (g) Homeless services providers;
- 11 (h) Culturally specific organizations;
- 12 (i) Housing providers;
- 13 (j) Veterans' services organizations; and
- 14 (k) Other entities identified by the department by rule.

15 (3) The policy under subsection (2) of this section shall direct that program funds shall be used:

16 (a) To provide to low and very low income individuals, including but not limited to individuals
17 more than 65 years of age, persons with disabilities, agricultural workers and Native Americans:

- 18 (A) Emergency shelters and attendant services;
- 19 (B) Transitional housing services designed to assist individuals to make the transition from
20 homelessness to permanent housing and economic independence;

21 (C) Supportive housing services to enable individuals to continue living in their own homes or
22 to provide in-home services for such individuals for whom suitable programs do not exist in their
23 geographic area;

24 (D) Programs that provide emergency payment of home payments, rents or utilities; *[or]*

25 **(E) Support for individuals with companion animals, as defined in ORS 401.977, that in-**
26 **cludes:**

- 27 **(i) Food for both companion animals and their owners;**
- 28 **(ii) Crates or kennels on-site or off-site that are easily accessible to the companion ani-**
29 **mal owners;**
- 30 **(iii) Basic veterinary services, including behavioral services; and**
- 31 **(iv) Rules of conduct and responsibility regarding companion animals and their owners;**

32 **or**

33 *[(E)]* **(F)** Some or all of the needs described in subparagraphs (A) to *[(D)]* **(E)** of this paragraph.

34 (b) To align with federal strategies and resources that are available to prevent and end
35 homelessness, including the requirement of providing culturally responsive services and using
36 evidence-based and emerging practices effective in ending homelessness, including practices unique
37 to rural communities.

38 (4)(a) The council shall require as a condition of awarding a grant that the organization dem-
39 onstrate to the satisfaction of the council that the organization:

- 40 (A) Has the capacity to deliver any service proposed by the organization;
- 41 (B) Is a culturally responsive organization or is engaged in a process to become a culturally
42 responsive organization;
- 43 (C) Engages with culturally specific organizations; and
- 44 (D) Supports local homelessness system planning efforts.

45 (b) Any funds granted under this section may not be used to replace existing funds. Funds

1 granted under this section may be used to supplement existing funds. An organization may use funds
2 to support existing programs or to establish new programs.

3 (5) The department may expend funds from the account for:

4 (a) The administration of the account as provided for in the legislatively approved budget, as
5 that term is defined in ORS 291.002, for the department in support of directing a statewide policy
6 on homelessness that ensures use of evidence-based and emerging practices, service equity in fund-
7 ing and local planning processes.

8 (b) The development of technical assistance and training resources for organizations developing
9 and operating emergency shelters as defined in ORS 197.782 and transitional housing accommo-
10 dations as described in ORS 197.746.

11 (6) The department shall utilize outcome-oriented contracting processes and evidence-based and
12 emerging practices for account program funds, including evidence-based and emerging practices for
13 serving rural communities.

14 (7) Twenty-five percent of moneys deposited in the account pursuant to ORS 294.187 are dedi-
15 cated to the emergency housing assistance program for assistance to veterans who are homeless or
16 at risk of becoming homeless.

21 **ience of the reader and do not become part of the statutory law of this state or express any**
22 **legislative intent in the enactment of this 2023 Act.**

26 **SECTION 50. Sections 2, 17, 29 and 30 of this 2023 Act and the amendments to ORS 92.090,**
27 **94.550, 100.015, 100.022, 100.105, 100.110, 100.115, 197.303, 197.830, 215.427 and 227.178 and section**
28 **23, chapter 13, Oregon Laws 2023 (Enrolled House Bill 2001), by sections 3 to 5, 9 to 15, 18**
29 **and 19 of this 2023 Act become operative on January 1, 2024.**

30 **SECTION 51. This 2023 Act being necessary for the immediate preservation of the public**
31 **peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect**
32 **on its passage.**
