SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Sexual Misconduct Survey Council. Requires council to biennially distribute base sexual misconduct climate survey and recommendations regarding use of study to each institution of higher education.

Requires each institution of higher education in state to biennially use base survey from council to conduct sexual misconduct climate survey of all students enrolled at institution. Requires each institution to submit aggregate summary of survey results to Higher Education Coordinating Commission and post copy of summary and other reports on institution's website. Requires each institution of higher education to hire certified advocate. Lists exceptions for

when hiring not required. Details duties of certified advocate.

Requires each institution of higher education to enter into and maintain memorandum of understanding with community-based domestic and sexual violence advocacy agency in same county as institution. Establishes exception for smaller satellite or branch campuses. Details requirements of memorandum of understanding.

Prohibits institution of higher education from punishing students who report incidents of sexual misconduct due to stated violations of institution's policies that are discovered during investigation into misconduct.

Requires each institution of higher education to prepare and deliver sexual misconduct primary prevention and awareness training that must be attended annually by each student and employee of institution. Details requirements of training.

Requires each institution of higher education to waive certain academic or any disciplinary re-cord requirements required to demonstrate academic success that are part of institution-provided program or activity identified by institution for students who experience sexual misconduct and ob-

tain waiver in specified manner. Requires each institution of higher education to provide annual report to Legislative Assembly, Higher Education Coordinating Commission and Director of Human Services detailing specified aspects of reported sexual misconduct and institution responses during previous academic year.

Requires Higher Education Coordinating Commission to submit annual report to interim com-mittees of Legislative Assembly related to higher education identifying each instance during previous academic year in which institution of higher education either violated provision of Act or failed to carry out provision of Act.

Appropriates moneys to Higher Education Coordinating Commission for duties relating to Sexual Misconduct Survey Council.

Declares emergency, effective on passage.

for conducting the survey, recommendations for achieving statistically valid response rates 1 and how the survey results should be interpreted. 2 (2) In developing the base survey required under subsection (1) of this section, the 3 council shall: 4 (a) Utilize best practices from peer-reviewed research and consult with individuals with 5 expertise in the development and use of sexual misconduct climate surveys by post-secondary 6 institutions of education; 7 (b) Review sexual misconduct climate surveys that have been developed and previously 8 9 used by post-secondary institutions of education; (c) Provide opportunities for written comment from organizations that work directly with 10 victims of sexual misconduct in order to ensure the adequacy and appropriateness of the 11 12proposed content; 13 (d) Consult with institutions of higher education on strategies for optimizing the effectiveness of the survey; 14 15 (e) Account for the diverse needs and differences of institutions of higher education; (f) Provide opportunities for student feedback through optional comment boxes at the 16 end of the survey and by providing a time and space for students to comment to the council 17 on what could be done to improve the sexual misconduct climate survey described in section 18 4 of this 2023 Act so that the results of the survey convey an accurate representation of 19 happenings on campus; and 20(g) Use a trauma-informed framework. 21 22(3) The base survey shall gather data on topics including but not limited to: (a) The number and type of incidents, both reported and unreported, of sexual miscon-23duct at the institution of higher education; 24(b) When incidents of sexual misconduct occurred, without requiring a specific date or 25time; 2627(c) Whether incidents of sexual misconduct occurred on campus, off campus, overseas or virtually; 28(d) If the sexual misconduct was perpetrated by a student, faculty member, nonfaculty 2930 staff member, third-party vendor to the institution of higher education or other individual; 31 (e) How aware students are of institutional policies and procedures related to campus 32sexual misconduct: (f) Whether a student reported sexual misconduct, with specific follow-up questions re-3334 garding: 35 (A) For students who reported sexual misconduct, whether the report was made to a 36 campus resource or law enforcement agency; and 37 (B) For students who did not report sexual misconduct, why the student chose not to make a report; 38 (g) Whether students who experienced sexual misconduct disclosed the sexual miscon-39 duct to a friend, peer, family member, faculty or nonfaculty staff member, campus resource 40 or law enforcement official; 41 (h) For a student who reported sexual misconduct: 42 (A) Whether the student was informed of or referred to local, state, campus or other 43 resources, or to victim support services, including but not limited to appropriate medical 44 care, mental health counseling and legal services; and 45

(B) Whether the student was provided with protection from retaliation, access to 1 2 institution-based supportive measures or institution-based accommodations and criminal justice remedies; 3 (i) For a student who experienced assault, the types of contextual factors that were 4 present during the assault, including but not limited to the involvement of force, incapaci-5 tation, coercion, drugs or alcohol; 6 (j) Demographic information that could be used to identify at-risk groups, including but 7 not limited to sex, race, ethnicity, national origin, economic status, disability status, gender 8 9 identity, immigration status and sexual orientation; (k) Perceptions of campus safety among members of the campus community; 10 (L) Student confidence in the institution's ability to protect against and respond to inci-11 12 dents of sexual misconduct; 13 (m) Whether students who reported sexual misconduct took a leave of absence from the institution, or considered transferring to another institution or withdrawing; 14 15 (n) Whether students who experienced sexual misconduct withdrew from any classes or were placed on academic probation; 16 (o) Whether students experienced any financial impacts from sexual misconduct or the 17 institution's response to a report of sexual misconduct; 18 (p) Whether students experienced any negative health impacts from sexual misconduct 19 or the institution's response to a report of sexual misconduct, including but not limited to 20post-traumatic stress disorder, anxiety, depression, chronic pain or eating disorders; 2122(q) Community attitudes towards sexual misconduct, including but not limited to students' willingness to intervene as bystanders; and 23(r) Any other questions the council determines would be beneficial. 24 (4) A base survey developed under this section: 25(a) Shall: 26(A) Include a "decline to state" and "not applicable" option for each question; 27(B) Be offered to all students enrolled at the institution of higher education, including 28students who are on a leave of absence or studying abroad; 2930 (C) Be created taking into account all reasonable measures to ensure that an adequate, 31 random and representative sample of students complete the survey; and (D) Be administered online, with reasonable accommodations provided to all students in 32order to ensure accessibility; and 33 34 (b) May not require the disclosure of any personally identifiable information. SECTION 4. (7) If a conflict of interest arises for an institution of higher education in which a certified advocate is advocating for a student's need for sexual misconduct crisis services or for campus resources or law enforcement services, the institution may not discipline, penalize or otherwise retaliate against the certified advocate for representing the interest of the reporting party.

16 <u>SECTION 7.</u> (1) Except as provided in subsection (4) of this section, each institution of 17 higher education shall enter into and maintain a memorandum of understanding with a 18 community-based domestic and sexual violence advocacy agency that is in the same county 19 as the institution.

20 (2) The memorandum of understanding entered into under this section shall ensure that 21 the community-based domestic and sexual violence advocacy agency will:

(a) Assist in developing the institution's policies, programming and training regarding
 sexual misconduct that involves students and employees;

(b) Provide an accessible off-campus alternative where students and employees of the institution can receive free and confidential sexual misconduct crisis services, including but not limited to access to a sexual assault nurse examiner, if available, and to domestic violence crisis services in response to sexual misconduct;

(3)(a) A memorandum of understanding entered into under this section may include an
 agreement, including a fee structure, between the community-based domestic and sexual vi olence advocacy agency and the institution of higher education for the provision of confi dential victim services.

(b) As used in this subsection, "confidential victim services" means case consultation and training fees for certified advocates, consultation fees for the development and implementation of student education and prevention programs, the development of staff training and prevention curriculum and confidential on-site office space for a representative from a community-based domestic and sexual violence advocacy agency to meet with students or employees of the institution of higher education.

1 (4) Notwithstanding subsection (1) of this section:

2 (a) The Higher Education Coordinating Commission may waive the requirements of this 3 section if the commission determines that, despite reasonable efforts, an institution of 4 higher education was unable to enter into a memorandum of understanding with a 5 community-based domestic and sexual violence advocacy agency.

9 <u>SECTION 8.</u> (1)(a) A reporting party or a witness who requests an investigation of sexual 10 misconduct may not be subjected to a disciplinary proceeding or sanction for violating the 11 institution of higher education's student conduct policy related to drug or alcohol use, tres-12 passing or unauthorized entry of school facilities or other violations of a school policy or 13 code of conduct that is discovered in connection with the alleged sexual misconduct unless 14 the institution determines that the report was not made in good faith or that the violation 15 of the policy was an egregious violation.

(b) As used in this subsection, an "egregious violation" includes but is not limited to
 taking an action that places the health and safety of another individual at risk.

(2) If the code of conduct of an institution of higher education prohibits sexual activity
 or certain forms of sexual activity, including but not limited to same-gender relationships
 or sexual activity, the institution may not take disciplinary action against:

(a) Individuals who report sexual misconduct or nonharassing sexual activity related to
 sexual misconduct that is discovered during an investigation into reported sexual miscon duct; or

(b) Other nonharassing sexual activity that is discovered during an investigation into an
 allegation of sexual misconduct.

(3) In any instance in which disciplinary action is taken against an individual who has reported sexual misconduct, the institution of higher education shall review the disciplinary action to determine if there is a link between the disclosed sexual misconduct and the misconduct that led to the reporting party's being disciplined.

30 <u>SECTION 9.</u> (1) In addition to any requirements set forth in ORS 350.253 and 350.255, each 31 institution of higher education shall:

(a) Has experienced sexual misconduct; and

(3) A student may obtain a waiver under this section from the certified advocate employed by the institution, the Title IX coordinator at the institution, a student basic needs coordinator at the institution, any law enforcement personnel at the institution, the student's academic advisor at the institution or any disability resource center personnel.

(4) Each institution of higher education shall maintain confidentiality of all materials
 that contain personally identifiable information for individuals who have requested a waiver
 under this section unless disclosure is required specifically for the purpose of making re quired accommodations or if otherwise required by a court of law.

(5) As used in this section, "institution-sponsored program or activity" includes but is
 not limited to a scholarship provided by an institution of higher education or an institution sponsored academic or extracurricular activity.

40 <u>SECTION 11.</u> (1) No later than October 1 of each year, each institution of higher educa-41 tion shall submit a report in the manner provided by ORS 192.245 to:

42 (a) The Secretary of the Senate and the Chief Clerk of the House of Representatives;

43 (b) The interim committees of the Legislative Assembly relating to higher education;

44 (c) The Higher Education Coordinating Commission; and

45 (d) The Director of Human Services.

(2) Except as provided in subsection (3) of this section, the report shall include: 1

2 (a) The total number of allegations of intimate partner violence, domestic violence, sexual assault, sexual harassment and stalking that were reported to the institution's Title IX 3 coordinator by a student or employee of the institution against another student or employee 4

of the institution during the previous academic year; 5

(b) The number of law enforcement investigations known to have been initiated during 6 7 the previous academic year in response to reports of sexual misconduct that were brought forward by a student or employee of the institution against another student or employee of 8 9 the institution:

10 (c) The number of students and employees at the institution who were found responsible during the previous academic year for violating the institution's policies prohibiting sexual 11 12misconduct:

13 (d) The number of students and employees at the institution who during the previous academic year, faced academic or employment disciplinary action due to having violated the 14 15 institution's policies prohibiting sexual misconduct;

16(e) The number of students and employees at the institution who, during the previous academic year, were investigated, but found not responsible for having violated the 17 18 institution's policies prohibiting sexual misconduct;

19 (f) The number of students at the institution who, during the previous academic year, requested supportive measures; 20

(g) The number of supportive measures requested by each student described in paragraph 2122(f) of this subsection;

23(h) The number of supported measures granted to each student described in paragraph 24 (f) of this subsection; and

25(i) The number of students during the previous academic year who took a leave of absence, transferred to a different institution of higher education or withdrew from the insti-2627tution of higher education.

(3) A report submitted by a community college operated under ORS chapter 341 or a ca-28reer school as defined in ORS 345.010 is not required to include the information described in 2930 subsection (2)(i) of this section.

31 (4) The information provided in the report must be provided in an anonymous and aggregate manner that complies with all state and federal privacy laws. 32

SECTION 12. (1) No later than September 15 of each year, the Higher Education Coordi-33 34 nating Commission shall submit a report in the manner provided by ORS 192.245 to the in-35 terim committees of the Legislative Assembly related to higher education that identifies each instance during the previous academic year in which an institution of higher education has 36 37 either violated a provision of sections 1 to 12 of this 2023 Act or failed to carry out a provision of sections 1 to 12 of this 2023 Act. 38

(2) The commission may adopt rules necessary to implement sections 1 to 12 of this 2023 39 Act. 40

SECTION 13. The Sexual Misconduct Survey Council must submit the first base survey 41 and related recommendations, including but not limited to recommendations on achieving 42statistically valid response rates, to each institution of higher education no later than Jan-43 uary 1, 2024. 44

SECTION 14. Sections 1 to 12 of this 2023 Act first apply to the 2023-2024 academic year.

SECTION 15. It is the intent of the Legislative Assembly that all parts of this 2023 Act 1 $\mathbf{2}$ are independent and that if any part of this 2023 Act is held unconstitutional, all remaining 3 parts shall remain in force. SECTION 16. In addition to and not in lieu of any other appropriation, there is appro-4 priated to the Higher Education Coordinating Commission, for the biennium beginning July $\mathbf{5}$ 1, 2023, out of the General Fund, the amount of \$1,122,544, to establish and provide staff 6 support to the Sexual Misconduct Survey Council, and to conduct rulemaking for the col-7lection, analysis and distribution of the sexual misconduct climate survey results. 8 9 SECTION 17. This 2023 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
