

# House Bill 3558

Sponsored by Representative REYNOLDS (at the request of Early Learning Division of Department of Education)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies definitions related to child care for purposes of implementation and enforcement.  
Modifies statutory structure for governance of child care by changing references of Office of Child Care to references to Department of Early Learning and Care.  
Declares emergency, effective July 1, 2023.

14 **SECTION 1.** ORS 329A.250, as amended by section 6, chapter 90, Oregon Laws 2022, is amended  
15 to read:

16 329A.250. As used in ORS 329A.030 and 329A.250 to 329A.450, unless the context requires oth-  
17 erwise:

18 (1) "Babysitter" means a person who goes into the home of a child to give care during the  
19 temporary absence of the parent, *[or]* legal guardian or custodian.

20 (2) "Certification" means the certification that is issued under ORS 329A.280 *[by the Office of*  
21 *Child Care]* to a family child care home, child care center or other child care facility.

22 (3) "Child" means a child under 13 years of age or a child under 18 years of age who has special  
23 needs or disabilities and requires a level of care that is above normal for the child's age.

25 **sation, of care, supervision and guidance** *[on a regular basis of a child,]* **to a child who is unac-**  
26 **companied by a parent, legal guardian or custodian,** *provided to a child during a part of the 24 hours*  
27 *of the day, in a place other than the child's home, with or without compensation.]* **when that care,**  
28 **supervision and guidance are provided:**

5 (i) The care, supervision and guidance are provided during the location’s regular operat-  
 6 ing hours; and

7 (ii) The location is not the child’s home.

8 (b) “Child care” does not include [*care provided:*] the provision, with or without compen-  
 9 sation, of care, supervision and guidance to a child when that care, supervision and guidance  
 10 are provided:

5 (8) “Parent cooperative” means a child care program in which:

6 (a) Care is provided by parents on a rotating basis;

7 (b) Membership in the cooperative includes parents;

8 (c) There are written policies and procedures; and

9 (d) A board of directors that includes parents of the children cared for by the cooperative con-  
 10 trols the policies and procedures of the program.

11 (9) “Preschool recorded program” means a facility providing care for preschool children that is  
 12 primarily educational for four hours or less per day and where no child is present at the facility for  
 13 more than four hours per day.

14 (10) “Record” means the record that is issued under ORS 329A.255 to a preschool recorded  
 15 program or a school-age recorded program.

16 (11) “Registration” means the registration that is issued under ORS 329A.330 [*by the Office of*  
 17 *Child Care*] to a family child care home where care is provided in the family living quarters of the  
 18 provider’s home.

19 (12) “School age” means of an age eligible to be enrolled in kindergarten or above on or before  
 20 the first day of the current school year.

21 (13) “School-age recorded program” means a program for school-age children:

22 (a) That is not operated by a school district as defined in ORS 332.002;

23 (b) That is not required to be certified under ORS 329A.280 or registered under ORS 329A.330;  
 24 and

25 (c) In which youth development activities are provided to children during hours that school is  
 26 not in session and does not take the place of a parent’s care.

27 (14) “Youth development activities” means care, supervision or guidance that is intended for  
 28 enrichment, including but not limited to teaching skills or proficiency in physical, social or educa-  
 29 tional activities such as tutoring, music lessons, social activities, sports and recreational activities.

32       (b) “Subsidized care” does not include care provided:

33       (A) By the child’s parent, **legal** guardian or [*person acting in loco parentis*] **custodian**;

34       (B) By a sibling living in the same home as the child;

35       (C) By a person on the same subsidized care case of a child in care; or

36       (D) By a provider of medical services, as determined by the [*office*] **department** on a case-by-  
 37 case basis.

38       (15) “Subsidized care facility” means any facility that provides subsidized care to children, in-  
 39 cluding a day nursery, nursery school, child care center, certified or registered family child care  
 40 home or similar unit operating under any name, but not including any program or facility identified  
 41 by the Early Learning Council by rule.

42       (16) “Youth development activities” means care, supervision or guidance that is intended for  
 43 enrichment, including but not limited to teaching skills or proficiency in physical, social or educa-  
 44 tional activities such as tutoring, music lessons, social activities, sports and recreational activities.

DEPARTMENT'S AUTHORITY OVER CHILD CARE

**SECTION 3.** ORS 326.430, as amended by section 11, chapter 631, Oregon Laws 2021, is amended to read:

326.430. (1)(a) The Department of Early Learning and Care is established.

**(b) The functions of the department may be divided into administrative divisions or offices. Each division or office shall be under the supervision of a person appointed by the Early Learning System Director. The appointees serve at the pleasure of the director.**

(2) The purposes of the department are to:

(a) Ensure that every child in this state is given the best opportunity to succeed in school, work and life by providing:

(A) High-quality early childhood education programs for children from birth through five years of age and child care for children from birth through 12 years of age; and

(B) Care for children who have a physical or developmental disability or who require other specialized care from birth through 17 years of age;

(b) Administer laws and perform functions related to early childhood to ensure that children enter school ready to learn and families are healthy, stable and attached; and

(c) Administer programs in a manner that supports parents' and providers' needs and considers the economic security and well-being of parents and providers.

(3) The department shall function under and be coordinated by the Early Learning Council.

(4) The Early Learning System Director appointed under ORS 326.432 shall serve as the administrative officer of the department.

**SECTION 4.** ORS 329A.010, as amended by section 37, chapter 631, Oregon Laws 2021, and section 9, chapter 27, Oregon Laws 2022, is amended to read:

329A.010. [(1) *There is established within the Department of Early Learning and Care the Office of Child Care.*]

[(2) *The Office of Child Care shall comply with directives of the Early Learning Council established in ORS 326.425 in the office's implementation of the provisions of ORS 329A.250 to 329A.450.*]

**(1) For the purpose of implementing the provisions of ORS chapter 329A, the Department of Early Learning and Care shall comply with the rules of the Early Learning Council and may act through any division or office of the department.**

[(3)] **(2)** The [*Office of Child Care*] **department** may maintain information about child care facilities and providers through electronic records systems.

[(4)] **(3)** Except as otherwise prohibited by state or federal law, the [*Office of Child Care*] **department** may share information with[:]

[(a)] other public entities when the [*office*] **department** determines that sharing the information would support the health or safety of children in child care. [; and]

[(b) *Within the Department of Early Learning and Care for purposes of:*]

[(A) *Developing a long-range plan for serving children and families, as provided by ORS 329.165;*]

[(B) *Administering preschool programs, as provided by ORS 329.170 to 329.200; and*]

[(C) *Implementing policies and practices related to early childhood professional development systems, as provided by ORS 329.219.*]

[(5) *There is established in the State Treasury, separate and distinct from the General Fund, the Child Care Fund. The Child Care Fund shall consist of moneys collected, received and administered*

1 by the Office of Child Care and Department of Early Learning and Care pursuant to ORS 329A.310,  
 2 329A.700 to 329A.712, 329A.750 and 329A.992 and such moneys as may be otherwise made available  
 3 by law. Interest earned on the fund shall be credited to the fund. The moneys in the Child Care Fund  
 4 are appropriated continuously to the Department of Early Learning and Care and shall be used in a  
 5 manner consistent with the grant of funds or for the administration of ORS 181A.200, 329A.030,  
 6 329A.250 to 329A.450 and 329A.700 to 329A.712.]

7 **SECTION 5. Section 6 of this 2023 Act is added to and made a part of ORS 329A.250 to**  
 8 **329A.450.**

9 **SECTION 6. (1) There is established in the State Treasury, separate and distinct from the**  
 10 **General Fund, the Child Care Fund.**

11 **(2) The Child Care Fund shall consist of moneys collected, received and administered by**  
 12 **the Department of Early Learning and Care or any divisions or offices of the department**  
 13 **pursuant to ORS 329A.310, 329A.700 to 329A.712, 329A.750 and 329A.992 and such moneys as**  
 14 **may be otherwise made available by law.**

15 **(3) Interest earned by the Child Care Fund shall be credited to the fund.**

16 **(4) Moneys in the Child Care Fund are continuously appropriated to the Department of**  
 17 **Early Learning and Care and shall be used in a manner consistent with the grant of funds**  
 18 **or for the administration of ORS 181A.200, 329A.030, 329A.250 to 329A.450 and 329A.700 to**  
 19 **329A.712.**

20 **SECTION 7. ORS 329A.020 is amended to read:**

21 329A.020. (1) The [*Office of Child Care*] **Department of Early Learning and Care** staff shall  
 22 provide technical assistance, linkage of local agencies, data collection and monitoring **related to**  
 23 **child care.**

24 (2) The [*Office of Child Care*] **department** shall continually monitor and disseminate information  
 25 about federal and charitable **child care** programs for the purposes of ORS 329A.100 to 329A.135.

26 (3) The [*Office of Child Care*] **department** shall maintain a website that provides information  
 27 regarding certified and registered child care facilities and [*regulated subsidy facilities as that term*  
 28 *is defined by rule adopted by the Early Learning Council*] **subsidized care facilities, as defined in**  
 29 **ORS 329A.250.**

30 (4) The Early Learning Council, in consultation with the [*Office of Child Care*] **department,**  
 31 shall adopt rules to implement the provisions of this section.

32 **SECTION 8. ORS 329A.025 is amended to read:**

33 329A.025. The Early Learning Council shall adopt rules, policies and standards to promote in-  
 34 formation sharing between the [*Office of Child Care*] **Department of Early Learning and Care,**  
 35 [*and*] the Department of Human Services **and any other state agency providing support to fam-**  
 36 **ilies and children.**

37 **SECTION 9. ORS 329A.030, as amended by section 1, chapter 90, Oregon Laws 2022, is amended**  
 38 **to read:**

39 329A.030. (1) The Office of Child Care shall establish a Central Background Registry and may  
 40 maintain information in the registry through electronic records systems.

41 (2)(a) A subject individual shall apply to and must be enrolled in the Central Background Reg-  
 42 istry as part of the individual's application to operate a program or serve in a position described in  
 43 subsection (10) of this section.

44 (b) An individual who has been the subject of a founded or substantiated report of child abuse  
 45 shall apply to and must be enrolled in the Central Background Registry prior to providing any of

1 the types of care identified in ORS 329A.250 (4)(b)(A), [(G) or (H)] **(E) or (F)** if:

2 (A) The child abuse occurred on or after January 1, 2017, and involved a child who died or  
3 suffered serious physical injury, as defined in ORS 161.015; or

4 (B) The child abuse occurred on or after September 1, 2019, and involved any child for whom  
5 the individual was providing child care, as defined in ORS 329A.250 (4), or care identified in ORS  
6 329A.250 (4)(b)(A), (C), **(E)**, (F)[.] **or** (G)[.] (H) or (I).

7 (c) Notwithstanding paragraph (a) of this subsection, an individual described in paragraph (b)(B)  
8 of this subsection is not required to enroll in the Central Background Registry if more than seven  
9 years has elapsed since the date of the child abuse determination.

10 (3)(a) Upon receiving an application for enrollment in the Central Background Registry, the of-  
11 fice shall complete:

12 (A) A criminal records check under ORS 181A.195;

13 (B) A criminal records check of other registries or databases in accordance with rules adopted  
14 by the Early Learning Council;

15 (C) A child abuse and neglect records check in accordance with rules adopted by the council;  
16 and

17 (D) A foster care certification check and an adult protective services check in accordance with  
18 rules adopted by the council.

19 (b) In addition to the information that the office is required to check under paragraph (a) of this  
20 subsection, the office may consider any other information obtained by the office that the office, by  
21 rule, determines is relevant to enrollment in the Central Background Registry.

22 (4)(a) The office shall enroll the individual in the Central Background Registry if the individual:

23 (A) Is determined to have no criminal, child abuse and neglect, negative adult protective ser-  
24 vices or negative foster home certification history, or to have dealt with the issues and provided  
25 adequate evidence of suitability for the registry;

26 (B) Has paid the applicable fee established pursuant to ORS 329A.275; and

27 (C) Has complied with the rules of the Early Learning Council adopted pursuant to this section.

28 (b) Notwithstanding subsection (3) of this section and paragraph (a) of this subsection, the office  
29 may enroll an individual in the registry if the Department of Human Services has completed a  
30 background check on the individual and the individual has received approval from the department  
31 for purposes of providing child care.

32 (5)(a) Notwithstanding subsections (3) and (4) of this section, the office may not enroll an indi-  
33 vidual in the Central Background Registry if:

34 (A) The individual has a disqualifying condition as defined in rules adopted by the council; or

35 (B) The individual is an exempt prohibited individual, as provided by ORS 329A.252.

36 (b) If an individual prohibited from enrolling in the registry as provided by this subsection is  
37 enrolled in the registry, the office shall remove the individual from the registry.

38 (6)(a) The office may conditionally enroll an individual in the Central Background Registry  
39 pending the results of a nationwide criminal records check through the Federal Bureau of Investi-  
40 gation if the individual has successfully completed the criminal records check and the child abuse  
41 and neglect records check in this state and in the state of the individual's residence, if other than  
42 Oregon.

43 (b) The office may enroll an individual in the registry subject to limitations identified in rules  
44 adopted by the council.

45 (7) An enrollment in the Central Background Registry may be renewed upon application to the



1 office, payment of the fee established pursuant to ORS 329A.275 and compliance with rules adopted  
 2 by the Early Learning Council pursuant to this section. However, an individual who is determined  
 3 to be ineligible for enrollment in the registry after the date of initial enrollment shall be removed  
 4 or suspended from the registry by the office.

5 (8)(a) A child care facility, preschool recorded program or school-age recorded program may not  
 6 hire or employ an individual if the individual is not enrolled in the Central Background Registry.

7 (b) Notwithstanding paragraph (a) of this subsection, a child care facility, preschool recorded  
 8 program or school-age recorded program may employ on a probationary basis an individual who is  
 9 conditionally enrolled in the Central Background Registry.

10 (9) The Early Learning Council may adopt any rules necessary to carry out the purposes of this  
 11 section, including but not limited to rules regarding expiration and renewal periods and limitations  
 12 related to the subject individual's enrollment in the Central Background Registry.

13 (10) As used in this section, "subject individual" means a subject individual as defined by the  
 14 Early Learning Council by rule, an individual subject to subsection (2)(b) of this section or a person  
 15 who applies to be:

16 (a) The operator or an employee of a child care or treatment program;

17 (b) The operator or an employee of an Oregon prekindergarten program under ORS 329.170 to  
 18 329.200;

(D) Sexual abuse, as described in ORS chapter 163.

(E) Sexual exploitation, including but not limited to:

(i) Contributing to the sexual delinquency of a minor, as defined in ORS chapter 163, and any other conduct which allows, employs, authorizes, permits, induces or encourages a child to engage in the performing for people to observe or the photographing, filming, tape recording or other exhibition which, in whole or in part, depicts sexual conduct or contact, as defined in ORS 167.002 or described in ORS 163.665 and 163.670, sexual abuse involving a child or rape of a child, but not including any conduct which is part of any investigation conducted pursuant to ORS 419B.020 or

1 which is designed to serve educational or other legitimate purposes; and

2 (ii) Allowing, permitting, encouraging or hiring a child to engage in prostitution as described in  
 3 ORS 167.007 or a commercial sex act as defined in ORS 163.266, to purchase sex with a minor as  
 4 described in ORS 163.413 or to engage in commercial sexual solicitation as described in ORS 167.008.

5 (F) Negligent treatment or maltreatment of a child, including but not limited to the failure to  
 6 provide adequate food, clothing, shelter or medical care that is likely to endanger the health or

(7) If a law enforcement officer or the Department of **Human Services**, when taking a child into protective custody, has reasonable cause to believe that the child has been affected by sexual abuse and rape of a child as defined in ORS 419B.005 (1)(a)(C) and that physical evidence of the abuse exists and is likely to disappear, the court may authorize a physical examination for the purposes of preserving evidence if the court finds that it is in the best interest of the child to have such an examination. Nothing in this section affects the authority of the department to consent to physical examinations of the child at other times.

(8) A minor child of 12 years of age or older may refuse to consent to the examination described in subsection (7) of this section. The examination shall be conducted by or under the supervision of a physician licensed under ORS chapter 677, a physician assistant licensed under ORS 677.505 to 677.525 or a nurse practitioner licensed under ORS chapter 678 and, whenever practicable, trained in conducting such examinations.

(9) When the Department of **Human Services** completes an investigation under this section, if the person who made the report of child abuse provided contact information to the department, the department shall notify the person about whether contact with the child was made, whether the department determined that child abuse occurred and whether services will be provided. The department is not required to disclose information under this subsection if the department determines that disclosure is not permitted under ORS 419B.035.

(10) When the Department of Education receives a notification under subsection (1) of this section or a report on the outcomes of an investigation under subsection (3) of this section, the Department of **Education** shall act under, and is subject to, ORS 339.389.
