# House Bill 5031

Introduced and printed pursuant to House Concurrent Resolution 23 (2023) (at the request of Oregon Department of Administrative Services)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Oregon Military Department for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and federal service agreement reimbursements, but excluding lottery funds and other federal funds, collected or received by department for certain purposes.

Limits biennial expenditures by department from federal funds for certain purposes.

Declares emergency, effective July 1, 2023.

### A BILL FOR AN ACT

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> There are appropriated to the Oregon Military Department, for the biennium 6 beginning July 1, 2023, out of the General Fund, the following amounts, for the following

9 (2) Operations..... \$ 14,705,755

10 (3) Community support ..... \$ 1,406,496

11 (4) Debt service ...... \$ 14,162,352

12 <u>SECTION 2.</u> Notwithstanding any other law limiting expenditures, the following amounts

13 are established for the biennium beginning July 1, 2023, as the maximum limits for payment

14 of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and re-

15 imbursements from federal service agreements, but excluding lottery funds and federal funds

16 not described in this section, collected or received by the Oregon Military Department, for

17 the following purposes:

18 (1) Administration...... \$ 3,473,527

19 (2) **Operations..... \$ 7,234,112** 

20 (3) Community support ..... \$ 10,722,533

<u>SECTION 3.</u> Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2023, as the maximum limits for payment of expenses from federal funds, other than those described in section 2 of this 2023 Act, collected or received by the Oregon Military Department, for the following purposes:

- 25 (1) **Operations...... \$117,804,395**
- 26 (2) Community support ..... \$ 18,226,681
- 27 (3) Capital improvement...... \$ 5,578,971

28 <u>SECTION 4.</u> This 2023 Act being necessary for the immediate preservation of the public
