Appropriates moneys from General Fund to Department of Revenue for biennial expenses. Limits certain biennial expenditures from fees, moneys or other revenues, including Miscella-

neous Receipts and federal service agreement reimbursements, but excluding lottery funds and other federal funds, collected or received by department. Declares emergency, effective July 1, 2023.

A BILL FOR AN ACT

2 Relating to the financial administration of the Department of Revenue; and declaring an emergency.

Be It Enacted by the People of the State of Oregon: 3

SECTION 1. There are appropriated to the Department of Revenue, for the biennium

beginning July 1, 2023, out of the General Fund, the following amounts, for the following $\mathbf{5}$ purposes: 6
