House Joint Resolution 29

Sponsored by Representative DIEHL (at the request of Monique DeSpain, Steve Doell)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Proposes amendment to Oregon Constitution to require not guilty criminal jury verdicts in circuit court to be unanimous. Refers proposed amendment to people for their approval or rejection at next regular general election.

JOINT RESOLUTION

2 Be It Resolved by the Legislative Assembly of the State of Oregon:

<u>PARAGRAPH 1.</u> Section 11, Article I of the Constitution of the State of Oregon, is amended
to read:

 $\mathbf{5}$ Sec. 11. Rights of Accused in Criminal Prosecution. In all criminal prosecutions, the accused 6 shall have the right to public trial by an impartial jury in the county in which the offense shall have 7 been committed; to be heard by himself and counsel; to demand the nature and cause of the accu-8 sation against him, and to have a copy thereof; to meet the witnesses face to face, and to have 9 compulsory process for obtaining witnesses in his favor; provided, however, that any accused person, 10 in other than capital cases, and with the consent of the trial judge, may elect to waive trial by jury 11 and consent to be tried by the judge of the court alone, such election to be in writing; provided, 12however, that in the circuit court [ten members of the jury may render a verdict of guilty or not guilty, save and except a verdict of guilty of first degree murder, which] all jury verdicts shall be found only 13 14 by a unanimous verdict, and not otherwise; provided further, that the existing laws and constitutional provisions relative to criminal prosecutions shall be continued and remain in effect as to all 15prosecutions for crimes committed before the taking effect of this amendment. 16

18 <u>PARAGRAPH 2.</u> The amendment proposed by this resolution shall be submitted to the 19 people for their approval or rejection at the next regular general election held throughout 20 this state.
