A-Engrossed Senate Bill 1002

Sponsored by Senator DEMBROW (at the request of Department of Education)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Eliminates State School Fund distributions for facility grants. Carves out amount from State School Fund to be used by Department of Education in supporting school districts, education service districts and public charter schools before, during or after threat or hazard to help improve safety and security of students and staff.

A BILL FOR AN ACT

Declares emergency, effective July 1, 2023.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 327.008 is amended to read:

6 327.008. (1)(a) There is established a State School Fund in the General Fund.

(b) The Department of Education, on behalf of the State of Oregon, may solicit and accept gifts,
grants, donations and other moneys from public and private sources for the State School Fund.
Moneys received as provided in this paragraph shall be deposited into the State School Fund.

(c) The State School Fund shall consist of moneys appropriated by the Legislative Assembly,
 moneys transferred from the Fund for Student Success, moneys transferred from the Education Sta-

bility Fund and the Oregon Marijuana Account and moneys received as provided in paragraph (b)of this subsection.

(d) The State School Fund is continuously appropriated to the Department of Education for the
purposes of ORS 327.006 to 327.077, 327.095, 327.099, 327.101, 327.125, 327.137, 327.348, 327.356 to
327.359, 336.575, 336.580, 336.635, 343.243, 343.533, 343.941 and 343.961.

17 (2) There shall be apportioned from the State School Fund to each school district a State School 18 Fund grant, consisting of the positive amount equal to a general purpose grant [and a facility 19 grant] and a transportation grant and a high cost disabilities grant minus local revenue, computed 20 as provided in ORS 327.011 and 327.013.

(3) For the first school year after a public charter school ceases to operate because of dissolution or closure or because of termination or nonrenewal of a charter, there shall be apportioned from the State School Fund to each school district that had sponsored a public charter school that ceased to operate an amount equal to the school district's general purpose grant per extended ADMw multiplied by five percent of the ADM of the public charter school for the previous school year.

(4) There shall be apportioned from the State School Fund to each education service district a 1 State School Fund grant as calculated under ORS 327.019. 2

(5) All figures used in the determination of the distribution of the State School Fund shall be 3 estimates for the same year as the distribution occurs, unless otherwise specified. 4

(6) Numbers of students in average daily membership used in the distribution formula shall be 5 the numbers as of June of the year of distribution. 6

[(7) A school district may not use the portion of the State School Fund grant that is attributable 7 to the facility grant for capital construction costs.] 8

9 [(8) The total amount of the State School Fund that is distributed as facility grants may not exceed \$3 million in any biennium. If the total amount to be distributed as facility grants exceeds this limita-10 tion, the Department of Education shall prorate the amount of funds available for facility grants among 11 12 those school districts that qualified for a facility grant. If the total amount to be distributed as facility 13 grants does not exceed this limitation, any remaining amounts shall be expended for expenses incurred by the Office of School Facilities as provided in ORS 326.125 (1).] 14

15 (7) Each biennium, the Department of Education may expend from the State School Fund no more than \$3 million for expenses incurred by the department in providing support to 16 school districts, education service districts and public charter schools at any time before, 17 during or after a threat or hazard that may affect a school district, an education service 18 district or a public charter school and for the purpose of helping to improve the safety and 19 20security of students and staff.

[(9)] (8) Each biennium, the Department of Education may expend from the State School Fund 2122no more than \$10 million for expenses incurred by the Office of School Facilities under ORS 326.125 23(2) to (7).

[(10)] (9) Each fiscal year, the Department of Education shall transfer to the Pediatric Nursing 24Facility Account established in ORS 327.022 the amount necessary to pay the costs of educational 25services provided to students admitted to pediatric nursing facilities as provided in ORS 343.941. 26

27[(11)] (10) Each fiscal year, the Department of Education shall transfer the amount of \$55 million from the State School Fund to the High Cost Disabilities Account established in ORS 327.348. 28

[(12)(a)] (11)(a) Each biennium, the Department of Education shall transfer \$39.5 million from 2930 the State School Fund to the Educator Advancement Fund established under ORS 342.953.

31 (b) For the purpose of making the transfer under this subsection:

(A) The total amount available for all distributions from the State School Fund shall be reduced 32by \$6 million; 33

34 (B) The amount distributed to school districts from the State School Fund under this section and ORS 327.013 shall be reduced by \$16.75 million; and 35

(C) The amount distributed to education service districts from the State School Fund under this 36 37 section and ORS 327.019 shall be reduced by \$16.75 million.

38 (c) For each biennium, the amounts identified in this subsection shall be adjusted by the same percentage by which the instructions furnished to state agencies by the Governor under ORS 291.204 39 direct the state agencies to adjust their agency budget requests for special payments under ORS 40 291.216 (6)(a)(C). 41

[(13)] (12) Each biennium, the Department of Education shall transfer \$12.5 million from the 42State School Fund to the Statewide English Language Learner Program Account established under 43 ORS 327.344. 44

[(14)] (13) Each fiscal year, the Department of Education may expend up to \$550,000 from the

1 State School Fund for the contract described in ORS 329.488. The amount distributed to education 2 service districts from the State School Fund under this section and ORS 327.019 shall be reduced 3 by the amount expended by the department under this subsection.

4 [(15)] (14) Each biennium, the Department of Education may expend up to \$350,000 from the 5 State School Fund to provide administration of and support for the development of talented and 6 gifted education under ORS 343.404.

[(16)] (15) Each biennium, the Department of Education may expend up to \$150,000 from the
State School Fund for the administration of a program to increase the number of speech-language
pathologists and speech-language pathology assistants under ORS 348.394 to 348.406.

[(17)] (16) Each biennium, the Department of Education shall transfer \$2 million from the State
School Fund for deposit to the Healthy School Facilities Fund established under ORS 332.337.
Notwithstanding ORS 332.337, the department may expend moneys received in the Healthy School
Facilities Fund under this subsection only as grants for costs associated with testing for elevated
levels of lead in water used for drinking or food preparation.

[(18)] (17) Each biennium, the Department of Education shall transfer an amount not to exceed
\$5,595,000 for the purpose of making tampons and sanitary pads available as provided by ORS
326.545.

[(19)] (18) Each fiscal year, the Department of Education shall transfer the amount of \$2.5
 million from the State School Fund to the Small School District Supplement Fund established in ORS 327.359.

22 327.011. For the purpose of State School Fund distributions for school districts:

23 (1) Local Revenues are the total of the following:

(a) The amount of revenue offset against local property taxes as determined by the Department
 of Revenue under ORS 311.175 (3)(a)(A).

(b) The amount of property taxes actually received by the district, including penalties and interest on taxes.

(c) The amount of revenue received by the district from the Common School Fund under ORS

 may not exceed 2.0.

(2) High cost disabilities grant = the total amount received by a school district under ORS
 327.348 for providing special education and related services to resident pupils with disabilities.

23 (3)(a) Transportation grant equals:

(A) 70 percent of approved transportation costs for those school districts ranked below the 80th
 percentile under paragraph (b) of this subsection.

(B) 80 percent of approved transportation costs for those school districts ranked in or above the
80th percentile but below the 90th percentile under paragraph (b) of this subsection.

(C) 90 percent of approved transportation costs for those school districts ranked in or above the
90th percentile under paragraph (b) of this subsection.

(a) "Education service district extended ADMw" means the sum of the extended ADMw of the
school districts located within the territory of the education service district as computed under ORS
327.013.

(2) Each fiscal year, the Superintendent of Public Instruction shall calculate a State School Fundgrant for each education service district as provided in this section.
