

SENATE AMENDMENTS TO SENATE BILL 1060

4 **“SECTION 1. (1) In a prosecution for an offense that includes, as an element, causing**
5 **physical injury to another person, evidence of physical injury may include but is not limited**
6 **to:**

7 **“(a) Testimony by the person alleged to have been injured;**

8 **“(b) Evidence of physical trauma;**

9 **“(c) Testimony from witnesses indicating that the person alleged to have been injured**
10 **experienced substantial pain or impairment of physical condition; or**

11 **“(d) Expert testimony addressing the effect of the type and amount of force used by the**
12 **defendant.**

13 **“(2) As used in this section, ‘physical trauma’ includes but is not limited to fractures,**
14 **cuts, punctures, bruises, burns or other observable effects.**
