Senate Bill 1062

Sponsored by Senator SMITH DB (at the request of Thomas Dole)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires person who operates website or online service for commercial purposes that collects consumers' personally identifiable information to develop, maintain and implement data management practices policy and post policy or link to policy prominently on website or online service home page. Specifies minimum policy requirements.

Makes violation of Act unlawful practice under Unlawful Trade Practices Act.

- 4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> (1) As used in this section:

(a) "Consumer" means an individual resident of Oregon who seeks to enter or enters into
 a transaction primarily for personal, family or household purposes.

- 8 (b) "Personally identifiable information" means information that can be used to distin-9 guish or trace an individual's identity or, when combined with other personal or identifying 10 information, is linked or linkable to a specific individual.
- (2) If a person operates a website or online service for commercial purposes and the
 website or online service collects a consumer's personally identifiable information, the per son shall:
- (a) Develop, maintain and implement a data management practices policy as described
 under subsection (3) of this section regarding the collection and use of consumers' personally
- 16 identifiable information; and
- (b) Post the data management practices policy or a link to the data management prac tices policy prominently on the website or online service home page.

(3) A data management practices policy developed and maintained under this section
 must, at a minimum:

(a) Identify the categories of personally identifiable information that the website or on line service collects;

(b) Identify the categories of third parties with whom the person may share or shares
 the personally identifiable information that the website or online service collects;

- (c) Contain and describe a process by which a consumer may request to change or change
 how:
- (A) The website or online service collects the consumer's personally identifiable infor mation; or
- 29 (B) The person uses or shares the consumer's personally identifiable information;
- 30 (d) Contain and describe a process by which a consumer may access and view:

(A) The consumer's personally identifiable information that the website or online service has collected; or (B) The consumer's personally identifiable information that the person has used or shared; and (e) Contain and describe reasonable safeguards the person has adopted to protect consumers' personally identifiable information. (4) Violation of this section is an unlawful practice under ORS 646.608. SECTION 2. ORS 646.608 is amended to read: 646.608. (1) A person engages in an unlawful practice if in the course of the person's business, vocation or occupation the person does any of the following: (a) Passes off real estate, goods or services as the real estate, goods or services of another. (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, approval, or certification of real estate, goods or services. (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or association with, or certification by, another. (d) Uses deceptive representations or designations of geographic origin in connection with real estate, goods or services. (e) Represents that real estate, goods or services have sponsorship, approval, characteristics, ingredients, uses, benefits, quantities or qualities that the real estate, goods or services do not have or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the person does not have.

(f) Represents that real estate or goods are original or new if the real estate or goods are deteriorated, altered, reconditioned, reclaimed, used or secondhand.

(g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
or that real estate or goods are of a particular style or model, if the real estate, goods or services
are of another.

(h) Disparages the real estate, goods, services, property or business of a customer or anotherby false or misleading representations of fact.

(i) Advertises real estate, goods or services with intent not to provide the real estate, goods or
 services as advertised, or with intent not to supply reasonably expectable public demand, unless the
 advertisement discloses a limitation of quantity.

(j) Makes false or misleading representations of fact concerning the reasons for, existence of,
 or amounts of price reductions.

(k) Makes false or misleading representations concerning credit availability or the nature of the
 transaction or obligation incurred.

36 (L) Makes false or misleading representations relating to commissions or other compensation to 37 be paid in exchange for permitting real estate, goods or services to be used for model or demon-38 stration purposes or in exchange for submitting names of potential customers.

(m) Performs service on or dismantles any goods or real estate if the owner or apparent owner
 of the goods or real estate does not authorize the service or dismantling.

(n) Solicits potential customers by telephone or door to door as a seller unless the person pro vides the information required under ORS 646.611.

43 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give
44 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of
45 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or

otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate, 1

discount or other value is contingent upon an event occurring after the time the customer enters 2 into the transaction. 3

4 (p) Makes any false or misleading statement about a prize, contest or promotion used to publicize a product, business or service. 5

(q) Promises to deliver real estate, goods or services within a certain period of time with intent 6 7 not to deliver the real estate, goods or services as promised.

8

(r) Organizes or induces or attempts to induce membership in a pyramid club.

9 (s) Makes false or misleading representations of fact concerning the offering price of, or the person's cost for real estate, goods or services. 10

(t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any 11 12 known material defect or material nonconformity.

13 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

(v) Violates any of the provisions relating to auction sales, consignment sales, auctioneers, 14 15 consignees or auction marts under ORS 698.640, whether in a commercial or noncommercial situation. 16

(w) Manufactures mercury fever thermometers. 17

18 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal law, or is: 19

20

(A) Prescribed by a person licensed under ORS chapter 677; and

(B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and 21 22on the proper cleanup of mercury should breakage occur.

23(y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to inform the purchaser that mercury is present in the thermostat and that the thermostat may not be 94 disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the 25mercury does not become part of the solid waste stream or wastewater. For purposes of this para-2627graph, "thermostat" means a device commonly used to sense and, through electrical communication with heating, cooling or ventilation equipment, control room temperature. 28

(z) Sells or offers for sale a motor vehicle manufactured after January 1, 2006, that contains 2930 mercury light switches.

1 (2) A representation under subsection (1) of this section or ORS 646.607 may be any manifesta-2 tion of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact. 3 (3) In order to prevail in an action or suit under ORS 336.184 and 646.605 to 646.652, a prose-4 cuting attorney need not prove competition between the parties or actual confusion or misunder-5 standing.

6 (4) An action or suit may not be brought under subsection (1)(u) of this section unless the At-7 torney General has first established a rule in accordance with the provisions of ORS chapter 183 8 declaring the conduct to be unfair or deceptive in trade or commerce.

9 (5) Notwithstanding any other provision of ORS 336.184 and 646.605 to 646.652, if an action or 10 suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attor-11 ney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney 12 fees.
