Senate Bill 1069

Sponsored by Senators JAMA, ANDERSON; Senators KNOPP, MEEK, WOODS, Representatives DEXTER, HELFRICH, TRAN

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Allows residential landlord and tenant to agree to provide written notices by electronic messages and allow landlord to refund moneys by electronic means.

A BILL FOR AN ACT

Relating to residential tenancies; amending ORS 90.150, 90.155, 90.300, 90.412, 90.414, 90.425, 90.630,
90.632 and 90.675.

4 Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 90.155 is amended to read:

6 90.155. (1) Except as provided in ORS 90.300, 90.315, 90.425 and 90.675, where this chapter re-

7 quires written notice, service or delivery of that written notice shall be executed by one or more 8 of the following methods:

9 (a) Personal delivery to the landlord or tenant[;].

10 (b) First class mail to the landlord or tenant[; or].

(c) If **allowed under** a written rental agreement [so provides], both first class mail and attachment to a designated location. In order for a written rental agreement to provide for mail and attachment service of written notices from the landlord to the tenant, the agreement must also provide for such service of written notices from the tenant to the landlord. Mail and attachment service of written notices shall be executed as follows:

16 (A) For written notices from the landlord to the tenant, the first class mail notice copy shall 17be addressed to the tenant at the premises and the second notice copy shall be attached in a secure manner to the main entrance to that portion of the premises of which the tenant has possession; and 18 19 (B) For written notices from the tenant to the landlord, the first class mail notice copy shall be 20 addressed to the landlord at an address as designated in the written rental agreement and the sec-21ond notice copy shall be attached in a secure manner to the landlord's designated location, which 22shall be described with particularity in the written rental agreement, reasonably located in relation 23to the tenant and available at all hours.

(d) If allowed under a written rental agreement, electronic messages, including electronic
 mail. Written notice from a landlord to a tenant under this paragraph is not valid unless:

(A) The agreement specifies the electronic mail address or electronic location at which
 a landlord agrees to receive electronic message as written notice from the tenant; and

(B) The landlord delivers the notice to all electronic mail addresses of the tenant that are on file with the landlord or to any other electronic location specified in a written rental agreement, including addresses provided by the tenant during the tenancy, from an electronic mail address or electronic location of the landlord that was specified in the written 1 rental agreement.

2 (2) If a notice is served by mail, the minimum period for compliance or termination of tenancy, 3 as appropriate, shall be extended by three days, and the notice shall include the extension in the 4 period provided.

5 (3) A landlord or tenant may utilize alternative methods of notifying the other so long as the 6 alternative method is in addition to one of the service methods described in subsection (1) of this 7 section.

8 (4) After 30 days' written notice, a landlord may unilaterally amend a rental agreement for a 9 manufactured dwelling or floating home that is subject to ORS 90.505 to 90.850 to provide for service 10 or delivery of written notices by mail and attachment service as provided by subsection (1)(c) of this 11 section.

90.150. When this chapter requires actual notice, service or delivery of that notice shall be ex ecuted by one or more of the following methods:

(1) Verbal notice that is given personally to the landlord or tenant or left on the landlord's ortenant's telephone answering device.

[(3) Written notice that is delivered by first class mail to the landlord or tenant. If the notice is mailed, the notice shall be considered served three days after the date the notice was mailed.]

- 27 90.300. (1) As used in this section, "security deposit" includes any last month's rent deposit.

(2)(a) Except as otherwise provided in this section, a landlord may require a tenant to pay a security deposit. The landlord shall provide the tenant with a receipt for any security deposit the tenant pays. The landlord shall hold a security deposit or prepaid rent for the tenant who is a party to the rental agreement. A tenant's claim to the security deposit or prepaid rent is prior to the claim of a creditor of the landlord, including a trustee in bankruptcy.

(b) Except as provided in ORS 86.782 (10), the holder of the landlord's interest in the premises
at the time the tenancy terminates is responsible to the tenant for any security deposit or prepaid
rent and is bound by this section.

36 (3) A written rental agreement, if any, must list a security deposit paid by a tenant or required37 by a landlord.

(4) A landlord may not charge a tenant a pet security deposit for keeping a service animal or
 companion animal that a tenant with a disability requires as a reasonable accommodation under fair
 housing laws.

(5)(a) Except as otherwise provided in this subsection, a landlord may not change the rental agreement to require the tenant to pay a new or increased security deposit during the first year after the tenancy has begun. Subject to subsection (4) of this section, the landlord may require an additional deposit if the landlord and tenant agree to modify the terms and conditions of the rental agreement to permit a pet or for other cause and the additional deposit relates to the modification.

This paragraph does not prevent a landlord from collecting a security deposit that an initial rental 1 2 agreement provided for but that remained unpaid at the time the tenancy began. (b) If a landlord requires a new or increased security deposit after the first year of the tenancy, 3 the landlord shall allow the tenant at least three months to pay the new or increased deposit. 4 5 (6) The landlord may claim all or part of the security deposit only if the landlord required the security deposit for any or all of the purposes specified in subsection (7) of this section. 6 (7)(a) The landlord may claim from the security deposit only the amount reasonably necessary: 7 (A) To remedy the tenant's defaults in the performance of the rental agreement including, but 8 9 not limited to, unpaid rent; and 10 (B) To repair damages to the premises caused by the tenant, not including ordinary wear and tear. 11 12(b) A landlord is not required to repair damage caused by the tenant in order for the landlord 13 to claim against the deposit for the cost to make the repair. The landlord may claim from the remaining prepaid rent only the amount 5 reasonably necessary to pay the tenant's unpaid rent.

6 (12) In order to claim all or part of any prepaid rent or security deposit, within 31 days after 7 the tenancy terminates and the tenant delivers possession the landlord shall give to the tenant a 8 written accounting that states specifically the basis or bases of the claim. The landlord shall give 9 a separate accounting for security deposits and for prepaid rent.

(13) The landlord shall return to the tenant the security deposit or prepaid rent or the portion of the security deposit or prepaid rent that the landlord does not claim in the manner provided by subsections (11) and (12) of this section not later than 31 days after the tenancy terminates and the tenant delivers possession to the landlord. If allowed under a written rental agreement, the landlord may return any amount due under this subsection by electronic means.

(14) The landlord shall give the written accounting required under subsection (12) of this section or shall return the security deposit or prepaid rent as required by subsection (13) of this section by personal delivery or by first class mail or, if allowed under ORS 90.155 (1)(d), by electronic means.

(15) If a security deposit or prepaid rent secures a tenancy for a space for a manufactured dwelling or floating home the tenant owns and occupies, whether or not in a facility, and the dwelling or home is abandoned as described in ORS 90.425 (2) or 90.675 (2), the 31-day period described in subsections (12) and (13) of this section commences on the earliest of:

(a) Waiver of the abandoned property process under ORS 90.425 (26) or 90.675 (24);

24 (b) Removal of the manufactured dwelling or floating home from the rented space;

(c) Destruction or other disposition of the manufactured dwelling or floating home under ORS
90.425 (10)(b) or 90.675 (10)(b); or

(16) If the landlord fails to comply with subsection (13) of this section or if the landlord in bad faith fails to return all or any portion of any prepaid rent or security deposit due to the tenant under this chapter or the rental agreement, the tenant may recover the money due in an amount equal to twice the amount:

(17)(a) A security deposit or prepaid rent in the possession of the landlord is not garnishable
 property, as provided in ORS 18.618.

37 (b) If a landlord delivers a security deposit or prepaid rent to a garnishor in violation of ORS 38 18.618 (1)(b), the landlord that delivered the security deposit or prepaid rent to the garnishor shall allow the tenant at least 30 days after a copy of the garnishee response required by ORS 18.680 is 39 delivered to the tenant under ORS 18.690 to restore the security deposit or prepaid rent. 5 90.425. (1) As used in this section:

6 (a) "Current market value" means the amount in cash, as determined by the county assessor, 7 that could reasonably be expected to be paid for a manufactured dwelling or floating home by an 8 informed buyer to an informed seller, each acting without compulsion in an arm's-length transaction 9 occurring on the assessment date for the tax year or on the date of a subsequent reappraisal by the 10 county assessor.

(b) "Dispose of the personal property" means that, if reasonably appropriate, the landlord may throw away the property or may give it without consideration to a nonprofit organization or to a person unrelated to the landlord. The landlord may not retain the property for personal use or benefit.

(c) "Goods" includes those goods left inside a recreational vehicle, manufactured dwelling or floating home or left upon the rental space outside a recreational vehicle, manufactured dwelling or floating home, whether the recreational vehicle, dwelling or home is located inside or outside of a facility.

(d) "Lienholder" means any lienholder of an abandoned recreational vehicle, manufactured
dwelling or floating home, if the lien is of record or the lienholder is actually known to the landlord.
(e) "Of record" means:

(A) For a recreational vehicle that is not more than eight and one-half feet wide, that a security
 interest has been properly recorded with the Department of Transportation pursuant to ORS 802.200
 (1)(a)(A) and 803.097.

(B) For a manufactured dwelling or recreational vehicle that is more than eight and one-half feet
wide, that a security interest has been properly recorded for the manufactured dwelling or recreational vehicle in the records of the Department of Consumer and Business Services pursuant to
ORS 446.611 or on a certificate of title issued by the Department of Transportation.

(C) For a floating home, that a security interest has been properly recorded with the State
 Marine Board pursuant to ORS 830.740 to 830.755 for a home registered and titled with the board
 pursuant to ORS 830.715.

(f) "Owner" means any owner of an abandoned recreational vehicle, manufactured dwelling or
 floating home, if different from the tenant and either of record or actually known to the landlord.

(g) "Personal property" means goods, vehicles and recreational vehicles and includes manufactured dwellings and floating homes not located in a facility. "Personal property" does not include manufactured dwellings and floating homes located in a facility and therefore subject to being stored, sold or disposed of as provided under ORS 90.675.

(2) A landlord is responsible for abandoned personal property and shall store, sell or dispose of
abandoned personal property as provided by this section. This section governs the rights and obligations of landlords, tenants and any lienholders or owners in any personal property abandoned or
left upon the premises by the tenant or any lienholder or owner in the following circumstances:

(a) The tenancy has ended by termination or expiration of a rental agreement or by
relinquishment or abandonment of the premises and the landlord reasonably believes under all the
circumstances that the tenant has left the personal property upon the premises with no intention
of asserting any further claim to the premises or to the personal property;

1 (f) If the personal property is considered to be abandoned pursuant to subsection (2)(a) or (b) 2 of this section, the landlord may require payment of removal and storage charges, as provided by 3 subsection (7)(d) of this section, prior to releasing the personal property to the tenant or any 4 lienholder or owner;

5 (g) If the personal property is considered to be abandoned pursuant to subsection (2)(c) of this 6 section, the landlord may not require payment of storage charges prior to releasing the personal 7 property;

45 days after personal delivery or mailing of the notice; or

(b) For all other abandoned personal property, not less than five days after personal deliveryor eight days after mailing of the notice.

(7) After notifying the tenant as required by subsection (3) of this section, the landlord:

(a) Shall store any abandoned manufactured dwelling or floating home on the rented space and
 shall exercise reasonable care for the dwelling or home;

(b) Shall store all other abandoned personal property of the tenant, including goods left inside a recreational vehicle, manufactured dwelling or floating home or left upon the rented space outside a recreational vehicle, dwelling or home, in a place of safekeeping and shall exercise reasonable care for the personal property, except that the landlord may:

31 (A) Promptly dispose of rotting food; and

(B) Allow an animal control agency to remove any abandoned pets or livestock. If an animal control agency will not remove the abandoned pets or livestock, the landlord shall exercise reasonable care for the animals given all the circumstances, including the type and condition of the animals, and may give the animals to an agency that is willing and able to care for the animals, such as a humane society or similar organization;

(c) Except for manufactured dwellings and floating homes, may store the abandoned personal
 property at the dwelling unit, move and store it elsewhere on the premises or move and store it at
 a commercial storage company or other place of safekeeping; and

(d) Is entitled to reasonable or actual storage charges and costs incidental to storage or disposal, including any cost of removal to a place of storage. In the case of an abandoned manufactured
dwelling or floating home, the storage charge may be no greater than the monthly space rent last
payable by the tenant.

(8) If a tenant, lienholder or owner, upon the receipt of the notice provided by subsection (3)
or (4) of this section or otherwise, responds by actual notice to the landlord on or before the spec-

ified date in the landlord's notice that the tenant, lienholder or owner intends to remove the per-1 2 sonal property from the premises or from the place of safekeeping, the landlord must make that personal property available for removal by the tenant, lienholder or owner by appointment at rea-3 sonable times during the 15 days or, in the case of a recreational vehicle, manufactured dwelling 4 or floating home, 30 days following the date of the response, subject to subsection (18) of this sec- $\mathbf{5}$ tion. If the personal property is considered to be abandoned pursuant to subsection (2)(a) or (b) of 6 this section, but not pursuant to subsection (2)(c) of this section, the landlord may require payment 7 of removal and storage charges, as provided in subsection (7)(d) of this section, prior to allowing the 8 9 tenant, lienholder or owner to remove the personal property. Acceptance by a landlord of such 10 payment does not operate to create or reinstate a tenancy or create a waiver pursuant to ORS 11 90.412 or 90.417.

12(9) Except as provided in subsections (18) to (20) of this section, if the tenant, lienholder or 13 owner of a recreational vehicle, manufactured dwelling or floating home does not respond within the time provided by the landlord's notice, or the tenant, lienholder or owner does not remove the per-14 15 sonal property within the time required by subsection (8) of this section or by any date agreed to 16 with the landlord, whichever is later, the tenant's, lienholder's or owner's personal property is conclusively presumed to be abandoned. The tenant and any lienholder or owner that have been given 17 18 notice pursuant to subsection (3) or (4) of this section shall, except with regard to the distribution 19 of sale proceeds pursuant to subsection (13) of this section, have no further right, title or interest 20to the personal property and may not claim or sell the property.

(10) If the personal property is presumed to be abandoned under subsection (9) of this section,the landlord then may:

(a) Sell the personal property at a public or private sale, provided that prior to the sale of a
 recreational vehicle, manufactured dwelling or floating home:

(A) The landlord may seek to transfer ownership of record of the personal property by comply ing with the requirements of the appropriate state agency; and

27 (B) The landlord shall:

(i) Place a notice in a newspaper of general circulation in the county in which the recreational

23(15) The landlord is not responsible for any loss to the tenant, lienholder or owner resulting from storage of personal property in compliance with this section unless the loss was caused by the 24 landlord's deliberate or negligent act. In the event of a deliberate and malicious violation, the 25landlord is liable for twice the actual damages sustained by the tenant, lienholder or owner. 26

27(16) Complete compliance in good faith with this section shall constitute a complete defense in any action brought by a tenant, lienholder or owner against a landlord for loss or damage to such 28personal property disposed of pursuant to this section. 29

(17) If a landlord does not comply with this section:

31 (a) The tenant is relieved of any liability for damage to the premises caused by conduct that 32was not deliberate, intentional or grossly negligent and for unpaid rent and may recover from the landlord up to twice the actual damages sustained by the tenant; 33

(18) In the case of an abandoned recreational vehicle, manufactured dwelling or floating home, 41 the provisions of this section regarding the rights and responsibilities of a tenant to the abandoned 42 vehicle, dwelling or home also apply to any lienholder except that the lienholder may not sell or 43 remove the vehicle, dwelling or home unless: 44

(19)(a) In the case of an abandoned manufactured dwelling or floating home but not including 7 a dwelling or home abandoned following a termination pursuant to ORS 90.429 and except as pro-8 9 vided by subsection (20)(d) and (e) of this section, if a lienholder makes a timely response to a notice of abandoned personal property pursuant to subsections (6) and (8) of this section and so requests, 10 a landlord shall enter into a written storage agreement with the lienholder providing that the 11 12 dwelling or home may not be sold or disposed of by the landlord for up to 12 months. A storage 13 agreement entitles the lienholder to store the personal property on the previously rented space during the term of the agreement, but does not entitle anyone to occupy the personal property. 14

(b) The lienholder's right to a storage agreement arises upon the failure of the tenant, owner or, in the case of a deceased tenant, the personal representative, designated person, heir or devisee to remove or sell the dwelling or home within the allotted time.

18 (c) To exercise the right to a storage agreement under this subsection, in addition to contacting the landlord with a timely response as described in paragraph (a) of this subsection, the lienholder 19 must enter into the proposed storage agreement within 60 days after the landlord gives a copy of 20the agreement to the lienholder. Selling the property includes a sale to a purchaser who wishes to leave the dwelling or home on the rented space and become a tenant, subject to any conditions previously agreed to by the landlord and tenant regarding the landlord's approval of a purchaser or, if there was no such agreement, any reasonable conditions

1 by the landlord regarding approval of any purchaser who wishes to leave the dwelling or home on 2 the rented space and become a tenant. The landlord also may condition approval for occupancy of 3 any purchaser of the property upon payment of all unpaid storage charges and maintenance costs.

4 (f)(A) If the lienholder violates the storage agreement, the landlord may terminate the agreement 5 by giving at least 90 days' written notice to the lienholder stating facts sufficient to notify the 6 lienholder of the reason for the termination. Unless the lienholder corrects the violation within the 7 notice period, the agreement terminates as provided and the landlord may sell or dispose of the 8 dwelling or home without further notice to the lienholder.

(g) Upon the failure of a lienholder to enter into a storage agreement as provided by this subsection or upon termination of an agreement, unless the parties otherwise agree or the lienholder has sold or removed the manufactured dwelling or floating home, the landlord may sell or dispose of the property pursuant to this section without further notice to the lienholder.

(20) If the personal property is a manufactured dwelling or floating home and is considered
abandoned as a result of the death of a tenant who was the only tenant and who owned the dwelling
or home, this section applies, except as follows:

(a) The following persons have the same rights and responsibilities regarding the abandoned
 dwelling or home as a tenant:

(A) Any personal representative named in a will or appointed by a court to act for the deceasedtenant.

(B) Any person designated in writing by the tenant to be contacted by the landlord in the eventof the tenant's death.

32 (b) The notice required by subsection (3) of this section must be:

33 (A) Sent by first class mail to the deceased tenant at the premises; and

(B) Personally delivered or sent by first class mail to any personal representative or designated
 person, if actually known to the landlord.

(d) If a personal representative, designated person or other person entitled to possession of the property, such as an heir or devisee, responds by actual notice to a landlord within the 45-day period provided by subsection (6) of this section and so requests, the landlord shall enter into a written storage agreement with the representative or person providing that the dwelling or home may not be sold or disposed of by the landlord for up to 90 days or until conclusion of any probate proceedings, whichever is later. Unless the representative or person corrects the violation within the notice period, the agreement terminates as provided and the landlord may sell or dispose of the dwelling or home without further notice to the representative or person.

(h) Upon the failure of a representative or person to enter into a storage agreement as provided by this subsection or upon termination of an agreement, unless the parties otherwise agree or the representative or person has sold or removed the manufactured dwelling or floating home, the landlord may sell or dispose of the property pursuant to this section without further notice to the representative or person.

(21) If the personal property is other than a manufactured dwelling or floating home and is
 considered abandoned as a result of the death of a tenant who was the only tenant and who owned
 the personal property, this section applies except as follows:

(a) The following persons have the same rights and responsibilities regarding the abandoned
 personal property as a tenant:

33 (A) An heir or devisee.

(B) Any personal representative named in a will or appointed by a court to act for the deceasedtenant.

36 (C) Any person designated in writing by the tenant to be contacted by the landlord in the event 37 of the tenant's death.

38 (b) The notice required by subsection (3) of this section must be:

(23)(a) If an official or agency referred to in ORS 453.876 notifies the landlord that the official 41 or agency has determined that all or part of the premises is unfit for use as a result of the presence 42 of an illegal drug manufacturing site involving methamphetamine, and the landlord complies with 43 this subsection, the landlord is not required to comply with subsections (1) to (22) and (24) to (27) 44 of this section with regard to personal property left on the portion of the premises that the official 45

1 or agency has determined to be unfit for use.

(b) Upon receiving notice from an official or agency determining the premises to be unfit for use, the landlord shall promptly give written notice to the tenant as provided in subsection (3) of this section. The landlord shall also attach a copy of the notice in a secure manner to the main entrance of the dwelling unit. The notice to the tenant shall include a copy of the official's or agency's notice and state:

7 (A) That the premises, or a portion of the premises, has been determined by an official or agency 8 to be unfit for use due to contamination from the manufacture of methamphetamine and that as a 9 result subsections (1) to (22) and (24) to (27) of this section do not apply to personal property left 10 on any portion of the premises determined to be unfit for use;

(e) Except as provided in paragraph (d) of this subsection, the landlord is not responsible for storing or returning any personal property left on the portion of the premises that is unfit for use.

(24) In the case of an abandoned recreational vehicle, manufactured dwelling or floating home that is owned by someone other than the tenant, the provisions of this section regarding the rights and responsibilities of a tenant to the abandoned vehicle, dwelling or home also apply to that owner, with regard only to the vehicle, dwelling or home, and not to any goods left inside or outside the vehicle, dwelling or home.

(A) For a manufactured dwelling, that a security interest has been properly recorded in the re cords of the Department of Consumer and Business Services pursuant to ORS 446.611 or on a cer tificate of title issued by the Department of Transportation prior to May 1, 2005.

(B) For a floating home, that a security interest has been properly recorded with the State
Marine Board pursuant to ORS 830.740 to 830.755 for a home registered and titled with the board
pursuant to ORS 830.715.

(e) "Personal property" means only a manufactured dwelling or floating home located in a facility and subject to ORS 90.505 to 90.850. "Personal property" does not include goods left inside a
manufactured dwelling or floating home or left upon a rented space and subject to disposition under
ORS 90.425.

(2) A landlord is responsible for abandoned personal property and shall store, sell or dispose of
abandoned personal property as provided by this section. This section governs the rights and obligations of landlords, tenants and any lienholders in any personal property abandoned or left upon
the premises by the tenant or any lienholder in the following circumstances:

(a) The tenancy has ended by termination or expiration of a rental agreement or by
relinquishment or abandonment of the premises and the landlord reasonably believes under all the
circumstances that the tenant has left the personal property upon the premises with no intention

(b) The tenant has been absent from the premises continuously for seven days after termination

to a buyer who intends to occupy the property in the facility in which the property is located.

14 (15)(a) Subsection (14)(d) and (e) of this section apply only if:

(A) There exists a lien on the personal property for unpaid property taxes and special assessments owed to a county or to the Department of Revenue and the landlord files an affidavit or declaration with the county tax collector or the Department of Revenue, as appropriate, that states:

A storage agreement entitles the lienholder to store the personal property on the previously rented space during the term of the agreement, but does not entitle anyone to occupy the personal property.

(b) The lienholder's right to a storage agreement arises upon the failure of the tenant or, in the case of a deceased tenant, the personal representative, designated person, heir or devisee to remove or sell the dwelling or home within the allotted time.

38 (c) To exercise the right to a storage agreement under this subsection, in addition to contacting the landlord with a timely response as described in paragraph (a) of this subsection, the lienholder 39 must enter into the proposed storage agreement within 60 days after the landlord gives a copy of 40 the agreement to the lienholder. The landlord shall give a copy of the proposed storage agreement 41 to the lienholder in the same manner as provided by subsection (4)(b) of this section. A storage charge may include a utility or service charge, as described 9 in ORS 90.562, if limited to charges for electricity, water, sewer service and natural gas and if in-10 cidental to the storage of personal property. A storage charge may not be due more frequently than 11 monthly;

(B) The lienholder pay a late charge or fee for failure to pay a storage charge by the date required in the agreement, if the amount of the late charge is no greater than for late charges imposed

(f) During the term of an agreement described under this subsection, the lienholder has the right to remove or sell the property, subject to the provisions of the lien. The landlord may condition approval for occupancy of any purchaser of the property upon payment of all unpaid storage charges and maintenance costs.

(g)(A) Except as provided in paragraph (d)(D) of this subsection, if the lienholder violates the storage agreement, the landlord may terminate the agreement by giving at least 90 days' written notice to the lienholder stating facts sufficient to notify the lienholder of the reason for the termination. Unless the lienholder corrects the violation within the notice period, the agreement terminates as provided and the landlord may sell or dispose of the property without further notice to the lienholder.

The landlord also may condition approval for occupancy of any purchaser, heir or devisee of the property upon payment of all unpaid storage charges and maintenance costs.

(c) The storage agreement may require, in addition to other provisions agreed to by the landlordand the tenant, that:

(A) The tenant make timely periodic payment of all storage charges, as described in subsection 28(7)(b) of this section, accruing from the commencement of the 45-day period described in subsection 2930 (6) of this section. A storage charge may include a utility or service charge, as described in ORS 31 90.562, if limited to charges for electricity, water, sewer service and natural gas and if incidental 32to the storage of personal property. A storage charge may not be due more frequently than monthly. (B) The tenant pay a late charge or fee for failure to pay a storage charge by the date required 33 34 in the agreement, if the amount of the late charge is no greater than for late charges imposed on 35facility tenants.

(C) The tenant maintain the personal property and the space on which the personal property is
 stored in a manner consistent with the rights and obligations described in the rental agreement that
 the landlord currently provides to tenants as required by ORS 90.510 (4).

39 (D) The tenant repair any defects in the physical condition of the personal property that existed 40 prior to the tenant entering into the storage agreement, except repair the float of the home, if the 41 defects and necessary repairs are reasonably described in the storage agreement and, for homes that 42 were first placed on the space within the previous 24 months, the repairs are reasonably consistent 43 with facility standards in effect at the time of placement. The tenant shall have 90 days after en-44 tering into the storage agreement to make the repairs. Failure to make the repairs within the al-45 lotted time constitutes a violation of the storage agreement and the landlord may terminate the

1 agreement by giving at least 14 days' written notice to the tenant stating facts sufficient to notify 2 the tenant of the reason for termination. Unless the tenant corrects the violation within the notice period, the agreement terminates as provided and the landlord may sell or dispose of the property without further notice to the tenant.

(B) After a landlord gives a termination notice pursuant to subparagraph (A) of this paragraph for failure of the tenant to pay a storage charge and the tenant corrects the violation, if the tenant again violates the storage agreement by failing to pay a subsequent storage charge, the landlord may terminate the agreement by giving at least 30 days' written notice to the tenant stating facts sufficient to notify the tenant of the reason for termination. Unless the tenant corrects the violation within the notice period, the agreement terminates as provided and the landlord may sell or dispose of the property without further notice to the tenant.

(C) A tenant may terminate a storage agreement at any time upon at least 14 days' written notice to the landlord and may remove the property from the facility if the tenant has paid all storage charges and other charges as provided in the agreement.

(g) Upon the failure of a tenant to enter into a storage agreement as provided by this subsection or upon termination of an agreement, unless the parties otherwise agree, the landlord may sell or dispose of the property pursuant to this section without further notice to the tenant after providing at least 15 days' written notice to any lienholder to enter into a storage agreement under subsection (20) of this section.

(23) If a governmental agency determines that the condition of personal property abandoned under this section constitutes an extreme health or safety hazard under state or local law and the agency determines that the hazard endangers others in the facility and requires quick removal of the property, the landlord may sell or dispose of the property pursuant to this subsection. The landlord shall comply with all provisions of this section, except as follows:

(a) The date provided in subsection (6) of this section by which a tenant, lienholder, personal
representative or designated person must contact a landlord to arrange for the disposition of the
property must be not less than 15 days after personal delivery or mailing of the notice required by

(24)(a) A landlord may sell or dispose of a tenant's abandoned personal property without complying with the provisions of this section if, after termination of the tenancy or no more than seven days prior to the termination of the tenancy, the following parties so agree in a writing entered into in good faith:

(B) The tenant, or for an abandonment as the result of the death of a tenant who was the only
tenant, the personal representative, designated person or other person entitled to possession of the
personal property, such as an heir or devisee, as described in subsection (21) of this section; and

(C) Any lienholder.

(b) A landlord may not, as part of a rental agreement, as a condition to approving a sale of

(1) Except as provided in subsection (5) of this section, the landlord may terminate a rental agreement for space for a manufactured dwelling or floating home by giving to the tenant not less than 30 days' notice in writing before the termination date designated in the notice, if the tenant:

33 (a) Materially violates a law related to the tenant's conduct as a tenant;

(b) Materially violates a rental agreement provision related to the tenant's conduct as a tenant
 and imposed as a condition of occupancy;

36 (c) Is classified as a level three sex offender under ORS 163A.100 (3); or

37 (d) Fails to pay a:

- 38 (A) Late charge pursuant to ORS 90.260;

(2) A violation making a tenant subject to termination under subsection (1) of this section includes a tenant's failure to maintain the space as required by law, rental agreement or rule, but does

upon the physical condition of a dwelling or home may only occur as provided in ORS 90.632.

31 (4) If the disrepair or deterioration of the manufactured dwelling or floating home creates a risk 32of imminent and serious harm to dwellings, homes or persons within the facility, a landlord may terminate a rental agreement and require the removal of the dwelling or home by giving to the 33 34 tenant not less than 30 days' written notice before the date designated in the notice for termination. The notice shall describe the risk of harm. 35

(9) In order to have the period for correction extended as provided in subsection (8) of this section, a tenant must give the landlord written notice describing the necessity for an extension in order to complete the correction work. The notice must be given a reasonable amount of time prior to the end of the notice for termination period.

(10) A tenancy terminates on the date designated in the notice and without regard to the expiration of the period for which, by the terms of the rental agreement, rents are to be paid. Unless
otherwise agreed, rent is uniformly apportionable from day to day.

(11) This section does not limit a landlord's right to terminate a tenancy for nonpayment of rent
under ORS 90.394 or for other cause under ORS 90.380 (5)(b), 90.396, 90.398 or 90.630 by complying
with ORS 105.105 to 105.168.

(12) A landlord may give a copy of the notice for termination required by this section to any lienholder of the dwelling or home[, by first class mail with certificate of mailing or by any other method allowed by ORS 90.150 (2) and (3)]. A landlord is not liable to a tenant for any damages incurred by the tenant as a result of the landlord giving a copy of the notice in good faith to a lienholder.

(13) When a tenant has been given a notice for termination pursuant to this section and has
subsequently abandoned the dwelling or home as described in ORS 90.675, any lienholder shall have
the same rights as provided by ORS 90.675, including the right to correct the cause of the notice,

- 1 within the 90-day period provided by ORS 90.675 (20) notwithstanding the expiration of the notice
- 2 period provided by this section for the tenant to correct the cause.
