

Senate Bill 1090

Sponsored by Senators THATCHER, STEINER, Representatives LIVELY, CATE, MANNIX; Senators ANDERSON, GOLDEN, LINTHICUM, PATTERSON, PROZANSKI, WAGNER, Representative MORGAN

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Abolishes annual one-hour change in time from standard time to daylight saving time and maintains Oregon on standard time for all 12 months of calendar year, except in portion of Oregon in Mountain Time Zone.

Further amends law to maintain Oregon on daylight saving time, except in portion of Oregon in Mountain Time Zone. Becomes operative at 2 a.m. on second Sunday of first March following enactment of changes in federal law that allow states to adopt daylight saving time as standard of time for all 12 months of calendar year.

Repeals advancement to daylight saving time standard and restores standard time for entirety of calendar year as standard of time in portion of Oregon in Pacific Time Zone if required changes in federal law have not been enacted by December 1, 2033.

A BILL FOR AN ACT

2 Relating to standards of time; creating new provisions; amending ORS 187.110; and repealing
3 sections 2 and 3, chapter 421, Oregon Laws 2019.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Sections 2 and 3, chapter 421, Oregon Laws 2019, are repealed.**

6 **SECTION 2.** ORS 187.110, as amended by section 1, chapter 421, Oregon Laws 2019, is amended
7 to read:

8 187.110. (1) The standard of time for the State of Oregon shall be [*one hour in advance of*] the
9 United States standard of time as established by the Congress of the United States for any partic-
10 ular area of the state under 15 U.S.C. 261, except that:

11 (a) The standard of time for that portion of the State of Oregon that is in the Mountain Time
12 Zone shall be the United States standard of time as established by the Congress of the United States
13 for that area under 15 U.S.C. 261; and

14 (b) From 2 a.m. on the second Sunday in March until 2 a.m. on the first Sunday in November
15 the standard of time for that portion of the State of Oregon that is in the Mountain Time Zone shall
16 be one hour in advance of the standard established for that area by the Congress of the United
17 States under 15 U.S.C. 261.

18 (2) No department of the state government and no county, city or other political subdivision
19 shall employ any other time or adopt any statute, ordinance or order providing for the use of any
20 other standard of time.

21 **SECTION 3.** ORS 187.110, as amended by sections 1 and 4, chapter 421, Oregon Laws 2019, is
22 amended to read:

 4 the standard of time for [*any area of this state*] **that portion of the State of Oregon that is in the**
 5 **Mountain Time Zone** shall be one hour in advance of the standard established for that
 6 [*particular*] area by the Congress of the United States under 15 U.S.C. 261.

7 (2) No department of the state government and no county, city or other political subdivision
 8 shall employ any other time or adopt any statute, ordinance or order providing for the use of any
 9 other standard of time.

10 **SECTION 4.** ORS 187.110, as amended by sections 1 and 4, chapter 421, Oregon Laws 2019, and
 11 sections 2 and 3 of this 2023 Act, is amended to read:

12 187.110. (1) The standard of time for the State of Oregon shall be **one hour in advance of the**
 13 United States standard of time as established by the Congress of the United States for any partic-
 14 lar area of the state under 15 U.S.C. 261, except that:

15 (a) The standard of time for that portion of the State of Oregon that is in the Mountain Time
 16 Zone shall be the United States standard of time as established by the Congress of the United States
 17 for that area under 15 U.S.C. 261; and

18 (b) From 2 a.m. on the second Sunday in March until 2 a.m. on the first Sunday in November
 19 the standard of time for that portion of the State of Oregon that is in the Mountain Time Zone shall
 20 be one hour in advance of the standard established for that area by the Congress of the United
 21 States under 15 U.S.C. 261.

22 (2) No department of the state government and no county, city or other political subdivision
 23 shall employ any other time or adopt any statute, ordinance or order providing for the use of any
 24 other standard of time.

25 **SECTION 5.** The amendments to ORS 187.110 by section 4 of this 2023 Act become oper-
 26 ative at 2 a.m. on the second Sunday of the first March following the enactment of changes
 27 in federal law that allow states to adopt daylight saving time as their time standard for all
 28 12 months of a calendar year.

29 **SECTION 6.** If the amendments to ORS 187.110 by section 4 of this 2023 Act have not
 30 become operative by December 1, 2033, section 5 of this 2023 Act is repealed on December 1,
 31 2033.

32 **SECTION 7.** If section 5 of this 2023 Act is repealed by section 6 of this 2023 Act, the
 33 amendments to ORS 187.110 by section 8 of this 2023 Act become operative December 1, 2033.

34 **SECTION 8.** ORS 187.110, as amended by sections 1 and 4, chapter 421, Oregon Laws 2019, and
 35 sections 2, 3 and 4 of this 2023 Act, is amended to read:
