

## HOUSE AMENDMENTS TO A-ENGROSSED SENATE BILL 217

By COMMITTEE ON BEHAVIORAL HEALTH AND HEALTH CARE

- 1 On page 1 of the printed A-engrossed bill, delete lines 9 and 10 and insert:  
2 **“SECTION 1. Sections 2 and 3 of this 2023 Act are added to and made a part of ORS**  
3 **690.005 to 690.225.”.**
- 4 After line 12, insert:  
5 **“SECTION 3. The Board of Cosmetology shall convene a curriculum requirements advi-**  
6 **sory committee consisting of representatives of schools. The advisory committee shall make**  
7 **recommendations to the board regarding curriculum requirements for a field of practice as**  
8 **described in ORS 690.046. Prior to adopting rules regarding the curriculum requirements, the**  
9 **board shall consult with the advisory committee.”.**
- 10 In line 13, delete “3” and insert “4”.
- 11 On page 3, line 30, after “345.450” insert “including a proficiency-based career school”.
- 12 In line 34, delete “4” and insert “5”.
- 13 On page 4, line 18, delete “5” and insert “6”.
- 14 On page 5, line 8, delete “6” and insert “7”.
- 15 In line 14, delete “education” and insert “curriculum”.
- 16 In line 18, delete “completed the education” and insert “met the requirements”.
- 17 In line 25, delete “education” and insert “requirements”.
- 18 Delete lines 36 through 43 and insert:  
19 “(b)(A) For an applicant who has received education or training outside of this state and does  
20 not hold an active authorization issued by another jurisdiction, the school that provided to the ap-  
21 plicant a skills assessment and practical evaluation:  
22 “(i) Submits to the office evidence that the applicant passed the skills assessment and practical  
23 evaluation; and  
24 “(ii) Attests, on a form prescribed by the office, to having verified the applicant’s prior training  
25 or education.  
26 “(B) An applicant described in this paragraph shall obtain a skills evaluation and practical as-  
27 sessment from a school.”.
- 28 On page 6, line 1, delete “7” and insert “8”.
- 29 In line 18, delete “8” and insert “9”.
- 30 In line 22, delete “Five” and insert “Four”.
- 31 Delete lines 24 through 26 and insert:  
32 “(b) One member shall be a representative of an hourly-based school.  
33 “(c) One member shall be a representative of a proficiency-based school.”.
- 34 In line 27, delete “(c)” and insert “(d)”.
- 35 After line 27, insert:

1 “(2) Of the members described in subsection (1)(b) and (c) of this section, at least one member  
2 must be a practitioner with an active authorization.”.

3 In line 28, delete “(2)” and insert “(3)”.

4 In line 34, delete “(3)” and insert “(4)”.

5 In line 36, delete “9” and insert “10”.

6 On page 7, line 17, delete “10” and insert “11”.

7 In line 27, delete “11” and insert “12”.

8 In line 39, delete “12” and insert “13”.

9 On page 8, after line 2, insert:

10 “(3)(a) The office may not inspect a school unless the Higher Education Coordinating Commis-  
11 sion requests the office’s assistance in carrying out an inspection of a school.

12 “(b) The office may not impose any disciplinary action on a school.”.

13 In line 3, delete “13” and insert “14”.

14 In line 31, delete “14” and insert “15”.

15 On page 9, line 7, delete “15” and insert “16”.

16 In line 8, delete “18” and insert “19”.

17 In line 9, delete “18” and insert “19”.

18 In line 16, delete “16” and insert “17”.

19 In line 20, delete “17” and insert “18”.

20 Delete lines 26 through 39 and insert:

21 **“SECTION 19. (1) Sections 2 and 3 of this 2023 Act, the amendments to ORS 345.010,**  
22 **690.005, 690.015, 690.025, 690.046, 690.047, 690.155, 690.165, 690.195, 690.205, 690.225 and 690.360**  
23 **by sections 4 to 15 of this 2023 Act and the repeal of ORS 345.400, 345.430, 345.440 and 345.450**  
24 **by section 17 of this 2023 Act become operative on July 1, 2024.**

25 **“(2) The Board of Cosmetology, the Higher Education Coordinating Commission and the**  
26 **Health Licensing Office may take any action before the operative date specified in subsection**  
27 **(1) of this section that is necessary to enable the board, the commission and the office to**  
28 **exercise, on and after the operative date specified in subsection (1) of this section, all of the**  
29 **duties, functions and powers conferred on the board, the commission and the office by**  
30 **sections 2 and 3 of this 2023 Act, the amendments to ORS 345.010, 690.005, 690.015, 690.025,**  
31 **690.046, 690.047, 690.155, 690.165, 690.195, 690.205, 690.225 and 690.360 by sections 4 to 15 of this**  
32 **2023 Act and the repeal of ORS 345.400, 345.430, 345.440 and 345.450 by section 17 of this 2023**  
33 **Act.**

34 **“SECTION 20. This 2023 Act takes effect on the 91st day after the date on which the 2023**  
35 **regular session of the Eighty-second Legislative Assembly adjourns sine die.”.**
