SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Modifies proof of parentage required for intestate succession.]

Changes title of "small estate affidavit" to "simple estate affidavit." Modifies eligibility for simple estate affidavit to include estate of decedent dying testate if value of specific bequests does not exceed specified amount and residual beneficiary is decedent's inter vivos trust.

9 **SIMPLE ESTATE AFFIDAVIT**

10
11 **SECTION 2.** ORS 114.510 is amended to read:

12 114.510. (1) A person who meets the requirements of ORS 114.515 may file a *[small]* **simple** es-
13 tate affidavit only with regard to an estate in which:

14 (a)(A) Not more than \$75,000 of the fair market value of the estate is attributable to personal
15 property; and

16 *[(b)]* (B) Not more than \$200,000 of the fair market value of the estate is attributable to real
17 property[.]; **or**

18 (b) **The decedent died testate and:**

19 (A) **Not more than \$75,000 of the fair market value of the estate is attributable to spe-**
20 **cifically devised personal property;**

21 (B) **Not more than \$200,000 of the fair market value of the estate is attributable to spe-**
22 **cifically devised real property; and**

23 (C) **The balance of the fair market value of the estate is attributable to property that is**
24 **devised to the trustee of a trust of which the decedent was a settlor, as defined in ORS**
25 **130.010, and which came into existence prior to the decedent's date of death.**

26 (2)(a) The fair market value of the estate **under subsection (1) of this section** shall be deter-

1 mined [*under this section*]:

2 [(a)] (A) As of the date of death; or

3 [(b)] (B) If the date of death is more than one year before the date of filing of the affidavit, as
4 of a date within 45 days before the filing of the affidavit.

5 [(3)] (b) In determining fair market value under this [*section*] **subsection**, the fair market value
6 of the entire interest in the property included in the estate shall be used without reduction for liens
7 or other debts.

8 **SECTION 3.** ORS 114.515, as amended by section 6, chapter 68, Oregon Laws 2022, is amended
9 to read:

10 114.515. (1) If the estate of a decedent meets the requirements of ORS 114.510, any of the fol-
11 lowing persons may file a [*small*] **simple** estate affidavit with the clerk of the probate court in any
12 county where there is venue for a proceeding seeking the appointment of a personal representative
13 for the estate:

14 (a) One or more of the claiming successors of the decedent.

15 (b) If the decedent died testate, any person named as personal representative in the decedent's
16 will.

17 (c) The Director of Human Services, the Director of the Oregon Health Authority or an attorney
18 approved under ORS 114.517, if the decedent received public assistance as defined in ORS 411.010,
19 received medical assistance as defined in ORS 414.025 or received care at an institution as defined
20 in ORS 179.010, and it appears that the assistance or the cost of care may be recovered from the
21 estate of the decedent.

22 (2) A person may not file a [*small*] **simple** estate affidavit if:

23 (a) The person would be disqualified from acting as a personal representative under ORS
24 113.095; or

25 (b) The person has been convicted of a felony in Oregon or in another jurisdiction.

26 (3) A [*small*] **simple** estate affidavit may not be filed until 30 days after the death of the
27 decedent.

28 (4) A [*small*] **simple** estate affidavit must contain the information required in ORS 114.525 and
29 shall be made a part of the probate records. If the affiant is an attorney approved by the Director
30 of Human Services or the Director of the Oregon Health Authority, a copy of the document ap-
31 proving the attorney must be attached to the affidavit.

32 (5) The clerk of the probate court shall charge and collect the fee established under ORS 21.145
33 for the filing of a [*small*] **simple** estate affidavit, except that a fee may not be charged or collected
34 for the filing of an amended affidavit.

35 (6)(a) Except as provided in subsection (7) of this section, the affiant shall file an amended
36 [*small*] **simple** estate affidavit in the following circumstances:

37 (A) To correct a material error or omission in a previous affidavit.

38 (B) To include property not described in a previous affidavit.

39 (b) The amended affidavit must include all information required under ORS 114.525 and state the
40 value of the property as of the date used to prepare the original affidavit.

41 (7) If the fair market value of the property of the estate exceeds the value limitations for a
42 [*small*] **simple** estate under ORS 114.510 (1)(a) **or the decedent's testamentary bequests do not**
43 **meet the requirements of ORS 114.510 (1)(b)**, an affiant may not file an amended [*small*] **simple**
44 estate affidavit under subsection (6) of this section and the affiant's authority with regard to the
45 estate is terminated, except that the affiant shall deliver assets of the estate in the affiant's pos-

1 session upon request by a personal representative appointed under ORS 113.085. The affiant shall
2 promptly file notice with the court that the estate of the decedent is not subject to ORS 114.505 to
3 114.560 and shall serve a copy of the notice on each person who received a copy of the previous
4 affidavit.

5 (8) The clerk of the probate court may acknowledge a [small] **simple** estate affidavit upon
6 presentation of the identification of the affiant and the affiant's statement under penalty of perjury.

7 **SECTION 3a.** ORS 114.525 is amended to read:

8 114.525. (1) A [small] **simple** estate affidavit must:

9 (a) Contain a notice in substantially the following form, printed in at least 14-point bold type
10 immediately below the caption on the first page of the [small] **simple** estate affidavit:

13 NOTICE OF DUTY TO PAY DEBT OR
14 TURN OVER PROPERTY
15

16 To: Any person to whom a copy of this [small] **simple** estate affidavit is mailed or delivered.

17 Under ORS 114.535, if you owe a debt to the decedent or have personal property of the decedent,
18 you must pay the debt or turn over the property to the affiant. If you refuse, the affiant may ask
19 the court to compel you to pay the debt or turn over the property and you could be responsible for
20 the affiant's attorney fees.

21
22
23 (b) State the name and post-office address of the affiant.

24 (c) State the authority under which the affiant is filing the [small] **simple** estate affidavit, as
25 provided in ORS 114.515.

26 (d) State that the [small] **simple** estate affidavit is made under ORS 114.505 to 114.560.

27 (e) State the name, age, domicile and post-office address and last four digits of the Social Secu-
28 rity number of the decedent.

29 (f) State the date and place of the decedent's death.

30 (g) Describe and state the fair market value of all property in the estate, valued as provided in
31 ORS 114.510, including a legal description of any real property.

32 (h) State that no personal representative of the estate has been appointed in Oregon, that there
33 is no pending petition for appointment of a personal representative of the estate in Oregon and that
34 the estate is not currently being administered in Oregon.

35 (i) State whether the decedent died testate or intestate.

36 (j) List the heirs of the decedent and the last address of each heir as known to the affiant, and
37 state that a copy of the affidavit showing the date of filing and a copy of the will, if the decedent
38 died testate, will be delivered to each heir or mailed to the heir at the last-known address.

39 (k) If the decedent died testate, list the devisees of the decedent and the last address of each
40 devisee as known to the affiant and state that a copy of the will and a copy of the affidavit showing
41 the date of filing will be delivered to each devisee or mailed to the devisee at the last-known ad-
42 dress.

43 (L) State the interest in the property described in the affidavit to which each heir or devisee is
44 entitled and the interest, if any, that will escheat.

45 (m) State that reasonable efforts have been made to ascertain creditors of the estate.

1 (n) List the claims against the estate that are undisputed by the affiant and that remain unpaid
2 or on account of which the affiant or any other person is entitled to reimbursement from the estate,
3 including the known or estimated amounts of the claims and the names and addresses of the credi-
4 tors as known to the affiant, and state that a copy of the affidavit showing the date of filing will
5 be delivered to each creditor who has not been paid in full or mailed to the creditor at the last-
6 known address.

7 (o) Separately list the name and address of each person known to the affiant to assert a claim
8 against the estate that the affiant disputes and the known or estimated amount of the claims dis-
9 puted by the affiant and state that a copy of the affidavit showing the date of filing will be delivered
10 to each such person or mailed to the person at the last-known address.

11 (p)(A) State the mailing address for presentment of claims; and

12 (B) If the affiant wishes to authorize creditors to present claims by electronic mail or facsimile
13 communication, state the electronic mail address or facsimile number for presentment of claims.

14 (q) List anticipated administrative expenses and attorney fees, if any.

15 (r) State that the affiant is not disqualified from acting as an affiant under ORS 114.515 (2).

16 (s) State that a copy of the affidavit showing the date of filing and a copy of the death record
17 will be mailed or delivered to the Department of Human Services or to the Oregon Health Authority,
18 as prescribed by rule by the department or authority.

19 (t) State, to the best of the affiant's knowledge, whether the decedent was incarcerated in a
20 correctional facility in this state at any time in the 15 years before the decedent's death and, if the
21 decedent was incarcerated in a correctional facility in this state at any time in the 15 years before
22 the decedent's death, state that a copy of the affidavit showing the date of filing and a copy of the
23 death record will be mailed or delivered to the Department of Corrections.

24 (u) State that undisputed claims against the estate will be paid as provided in ORS 114.545.

25 (v) State that claims against the estate not listed in the affidavit or in amounts larger than those
26 listed in the affidavit may be barred unless:

27 (A) A claim is presented to the affiant within four months of the filing of the affidavit or
28 amended affidavit at the address, electronic mail address or facsimile number stated in the affidavit
29 for presentation of claims; or

30 (B) A petition for appointment of a personal representative of the estate is filed within the time
31 allowed under ORS 114.555.

32 (w) If the affidavit lists one or more claims that the affiant disputes, state that any such claim
33 may be barred unless:

34 (A) A petition for summary determination is filed within four months of the filing of the affidavit;
35 or

36 (B) A petition for appointment of a personal representative of the estate is filed within the time
37 allowed under ORS 114.555.

38 (2) The affiant shall file a certified copy of the death record of the decedent as a confidential
39 document.

40 (3) If the decedent died testate, the affiant shall file simultaneously with the *[small]* **simple** es-
41 tate affidavit:

42 (a)(A) The original will; or

43 (B) If the original will is filed in an estate proceeding in another jurisdiction, a certified copy
44 of the original will; and

45 (b) Proof of the will meeting the requirements of ORS 113.055.

1 **(4) If the simple estate affidavit is filed under ORS 114.510 (1)(b), the affiant shall also file**
 2 **simultaneously with the simple estate affidavit a copy of the trust instrument or a certi-**
 3 **fication of the trust under ORS 130.860.**

4 **SECTION 4.** ORS 114.537 is amended to read:

5 114.537. (1) If a person who is eligible to file a [*small*] **simple** estate affidavit is aware that the
 6 decedent was the sole lessee or the last surviving lessee of a safe deposit box or was the owner of
 7 the contents of a safe deposit box at the time of the decedent's death, the claiming successor or
 8 other person may not file a [*small*] **simple** estate affidavit until the person requests an inventory
 9 of the box under ORS 708A.655, if the lessor of the box is an Oregon operating institution as defined
 10 in ORS 706.008, or under ORS 723.844, if the lessor of the box is a credit union as defined in ORS
 11 723.008. Upon receiving the request, the lessor of the box shall cause an inventory of the contents
 12 of the box to be made. The lessor shall retain the original inventory in the box and shall provide
 13 a copy of the inventory to the person requesting the inventory. The person requesting the inventory
 14 shall take the contents of the box into consideration in determining whether the estate of the
 15 decedent is within the limits prescribed by ORS 114.510. If the person files a [*small*] **simple** estate
 16 affidavit, the affidavit must contain a statement of the value of the contents of the box.

17 (2) If an affiant becomes aware after the filing of a [*small*] **simple** estate affidavit that the
 18 decedent was the sole lessee or the last surviving lessee of a safe deposit box or was the owner of
 19 the contents of a safe deposit box at the time of the decedent's death, the affiant shall promptly
 20 request an inventory of the box under ORS 708A.655, if the lessor of the box is an Oregon operating
 21 institution as defined in ORS 706.008, or under ORS 723.844, if the lessor of the box is a credit union
 22 as defined in ORS 723.008. Upon receiving the request, the lessor of the box shall cause an inventory
 23 of the contents of the box to be made. The lessor shall retain the original inventory in the box and
 24 shall provide a copy of the inventory to the affiant. If the estate of the decedent remains within the
 25 limits prescribed by ORS 114.510 after consideration of the value of the contents of the box, the
 26 affiant shall file an amended [*small*] **simple** estate affidavit under ORS 114.515 (6). Upon receiving
 27 a certified copy of the amended affidavit, the lessor shall allow the affiant to take possession of the
 28 contents of the box. If the estate of the decedent exceeds the limits prescribed by ORS 114.510 after
 29 consideration of the value of the contents of the box, the affiant may not file an amended [*small*]
 30 **simple** estate affidavit and shall file notice with the court that the estate of the decedent is not
 31 subject to ORS 114.505 to 114.560 and shall serve a copy of the notice on the lessor of the box. The
 32 lessor of the box shall deliver the contents of the box to the personal representative for the
 33 decedent, or to such other person as may be provided for under the terms of the lease of the box.

34 **SECTION 5.** ORS 114.540 is amended to read:

35 114.540. (1)(a) A claim against an estate with respect to which a [*small*] **simple** estate affidavit
 36 is filed may be presented to the affiant within four months after the affidavit was filed. If an
 37 amended [*small*] **simple** estate affidavit is filed under ORS 114.515 (6), claims against the estate may
 38 be presented within four months after the filing of the amended affidavit.

39 (b) Except as provided in ORS 114.550 **or 130.350**, a claim presented after the limitations de-
 40 scribed in paragraph (a) of this subsection is barred.

41 (c) Filing a claim with the court does not constitute presentation to the affiant.

42 (d)(A) Except as provided in subparagraph (B) of this paragraph, a claim is presented to the
 43 affiant when the claim is mailed or personally delivered to the affiant at the mailing address for
 44 presentment of claims included in the [*small*] **simple** estate affidavit under ORS 114.525.

45 (B) If the affiant authorized creditors to present claims by electronic mail or facsimile commu-

1 nication in the [small] **simple** estate affidavit as provided in ORS 114.525, a claim is presented to
2 the affiant when it is sent to the electronic mail address or the facsimile number designated by the
3 affiant for presentment of claims, unless the sender receives a notice that the electronic mail was
4 not delivered or the facsimile communication was not successful. If the affiant denies receiving the
5 electronic mail or facsimile communication, the burden of proof is on the creditor to demonstrate
6 that the electronic mail was properly addressed and sent or that the facsimile communication was
7 properly addressed and successfully delivered or transmitted.

8 (e) Each claim presented to the affiant must include the information required by ORS 115.025.

9 (2)(a) A claim presented to the affiant that was not listed in the [small] **simple** estate affidavit
10 shall be considered allowed as presented unless within 60 days after the date of presentment of the
11 claim the affiant mails or delivers a notice of disallowance of the claim in whole or in part to the
12 claimant and any attorney for the claimant. A notice of disallowance of a claim must state the
13 reason for the disallowance and inform the claimant that the claim has been disallowed in whole
14 or in part and, to the extent disallowed, will be barred unless:

15 (A) The claimant files a petition for summary determination as provided in ORS 114.542; or

16 (B) A petition for appointment of a personal representative of the estate is filed within the time
17 allowed under ORS 114.555.

18 (b) Statement of a reason for disallowance under this subsection is not an admission by the
19 affiant and does not preclude the assertion of other defenses to the claim.

20 **SECTION 6.** ORS 238.390 is amended to read:

21 238.390. (1) If a member of the system dies before retiring, the amount of money, if any, credited
22 at the time of death to the member account of the member in the fund shall be paid to the benefi-
23 ciaries designated by the member. For this purpose a member may designate as a beneficiary any
24 person or the executor or administrator of the estate of the member or a trustee named by the
25 member to execute an express trust in regard to such amount. The termination of a person's mem-
26 bership in the system pursuant to ORS 238.095 (1) or (2) invalidates any designation of beneficiary
27 made by the person before the termination of membership.

28 (2) If a member dies before retiring and has not designated a beneficiary under subsection (1)
29 of this section, the Public Employees Retirement Board shall pay the amount of money, if any,
30 credited at the time of death to the member account of the deceased member to a personal repre-
31 sentative appointed for the estate of the deceased member. *[If a small estate affidavit has been filed*
32 *under ORS 114.505 to 114.560, and the amount of money credited to the account does not exceed the*
33 *maximum amount of personal property for which a small estate affidavit may be filed under ORS*
34 *114.505 to 114.560, the board shall pay the amount to the person who filed the affidavit.] **If a simple***
35 **estate affidavit has been filed under ORS 114.515, the board shall pay the amount to the**
36 **person who filed the affidavit if:**

37 (a) **The estate of the decedent remains within the limits prescribed by ORS 114.510 (1)(a)**
38 **after consideration of the amount of money credited at the time of death to the member**
39 **account; or**

40 (b) **The estate of the decedent meets the requirements of ORS 114.510 (1)(b).**

41 (3) The beneficiary designated under subsection (1) of this section may elect to receive the
42 amount payable in actuarially determined monthly payments for the life of such beneficiary as long
43 as such monthly payments are at least \$200.

44 (4) Accrued benefits due a retired member at the time of death are payable to the designated
45 beneficiary or as provided in subsection (2) of this section. For the purpose of determining accrued

1 benefits due a retired member at the time of death, accrued benefits are considered to have ceased
2 as of the last day of the month preceding the month in which the retired member dies; but if Option
3 2 or Option 3 under ORS 238.305 has been elected as provided in this chapter and the beneficiary
4 survives the retired member, the benefits to the beneficiary shall commence as of the first day of
5 the month in which the retired member dies, and payment of benefits under Option 2 or Option 3
6 shall cease with the payment for the month preceding the month in which the beneficiary dies.

7 (5) If a member dies before retiring and has designated a beneficiary under subsection (1) of this
8 section, but the beneficiary dies before the member, or dies before distribution is made under this
9 section, the Public Employees Retirement Board shall pay the amount of money, if any, that would
10 otherwise have been paid to the beneficiary to a personal representative appointed for the estate
11 of the deceased beneficiary. *[If a small estate affidavit has been filed under ORS 114.505 to 114.560,*
12 *and the amount of money that would have been paid to the beneficiary does not exceed the maximum*
13 *amount of personal property for which a small estate affidavit may be filed under ORS 114.505 to*
14 *114.560, the board shall pay the amount to the person who filed the small estate affidavit on behalf of*
15 *the estate of the beneficiary.]* **If a simple estate affidavit regarding the deceased beneficiary's**
16 **estate has been filed under ORS 114.515, the board shall pay the amount to the person who**
17 **filed the simple estate affidavit if:**

18 (a) **The estate of the deceased beneficiary remains within the limits prescribed by ORS**
19 **114.510 (1)(a) after consideration of the amount of money that would have been payable to**
20 **the deceased beneficiary; or**

21 (b) **The estate of the deceased beneficiary meets the requirements of ORS 114.510 (1)(b).**

22 (6) Interest upon the member account of the member shall accrue until the date that the amount
23 in the member account is distributed. Any balance in the variable account of the deceased member
24 is considered to be transferred to the regular account of the member as of the date of death. The
25 board shall establish procedures for computing and crediting interest on the balance in the member
26 account for the period between the date of death and date of distribution.

27 (7) Payment by the board of amounts in the manner provided by this section completely dis-
28 charges the board and system on account of the death, and shall hold the board and system harmless
29 from any claim for wrongful payment.

34 111.200. (1) As used in this section:

35 (a) "Probate proceeding" means a proceeding under ORS chapter 111, 112, 113, 114, 115, 116 or
36 117 for the administration of a decedent's estate.

37 (b) "Probate proceeding" does not include:

38 (A) A proceeding for summary determination of a claim under ORS 115.145 (1)(b); or

39 (B) A declaratory judgment action under ORS chapter 28.

40 (2) Except as otherwise provided in ORS 111.205, 111.218, 112.588, 113.005, 113.105, 114.720,
41 115.315, 116.083 or 116.253, the Oregon Rules of Civil Procedure and the Oregon Evidence Code do
42 not apply to probate proceedings.

43 (3) Notwithstanding subsection (2) of this section:

44 (a) ORCP 12 applies to any probate proceeding.

45 (b) ORCP 9, 10 A, 16 B, 16 D, 17, 18, 19, 21, 22, 23, 25, 27, 29, 30, 31, 33, 34 A to F, 36 to 43,

1 44 A, B, D and E, 46, 47, 53, 55, 62, 64 A and C to G, 65, 67, 68, 71, 72 and 78 apply to a contested
2 issue in a probate proceeding.

3 (c) The Oregon Evidence Code applies to a contested issue in a probate proceeding.

4 (4) For the purposes of applying the Oregon Rules of Civil Procedure to a contested issue in a
5 probate proceeding:

6 (a) "Plaintiff" means any party asserting a claim for relief, whether by way of petition or motion;
7 and

8 (b) "Defendant" means:

9 (A) Any party against whom the claim is asserted;

10 (B) Any party objecting to the petition or motion; or

11 (C) If the court issues a show cause order, the party subject to the order.

12 (5)(a) For the purposes of this section, an issue in a probate proceeding is contested if it is or
13 arises from:

14 (A) A petition or motion for declaratory judgment, including a will contest;

15 (B) A petition to remove a court-appointed fiduciary;

16 (C) A petition or motion for affirmative relief of any sort against a person;

17 (D) A petition or motion to apportion the proceeds of a wrongful death settlement;

18 (E) If filed by a person other than the personal representative:

19 (i) A motion to increase the amount of the bond of the personal representative, or to require a
20 new bond;

21 (ii) A petition to restrict the powers of the personal representative;

22 (iii) A petition to determine heirship;

23 (iv) A petition for instructions; or

24 (v) A petition to appoint a fiduciary other than the fiduciary nominated in the will admitted to
25 probate;

26 (F) Any other petition or motion to which another person has filed an objection; or

27 (G) Any other petition, motion or show cause order determined by the court to be a contested
28 issue in a probate proceeding.

29 (b) Notwithstanding paragraph (a) of this subsection, unless otherwise determined by the court,
30 the following are not contested issues in probate proceedings:

31 (A) A petition for summary review of administration of a [small] **simple** estate under ORS
32 114.550;

33 (B) A petition or motion for summary determination of a claim as provided in ORS 114.542 or
34 115.145 (1)(a); or

35 (C) An application for an order directing payment of a claim under ORS 115.185.

36 (6) Nothing in this section is intended to affect the burden of proof or standard of proof that is
37 applied in probate proceedings.

38 **SECTION 8.** ORS 113.238 is amended to read:

39 113.238. (1) A person who has knowledge that a decedent died wholly intestate, that the
40 decedent owned property subject to probate in Oregon and that the decedent died without a known
41 heir shall give notice of the death within 48 hours after acquiring that knowledge to the State
42 Treasurer.

43 (2) Except as provided by ORS 708A.430 and 723.466, a person may not dispose of or diminish
44 any assets of the estate of a decedent who has died wholly intestate, who owned property subject
45 to probate in Oregon and who died without a known heir unless the person has prior written ap-

1 proval of the State Treasurer. The prohibition of this subsection:

2 (a) Applies to a guardian or conservator for the decedent; and

3 (b) Does not apply to a personal representative appointed under ORS 113.085 (4) or to an affiant
4 authorized under ORS 114.520 to file a [small] **simple** estate affidavit under ORS 114.515.

5 (3) For purposes of this section, a known heir is an heir who has been identified and found.

6 **SECTION 9.** ORS 114.505 is amended to read:

7 114.505. As used in ORS 114.505 to 114.560:

8 (1) "Affiant" means the person or persons signing a [small] **simple** estate affidavit.

9 (2) "Claiming successors" means:

17 238.390. If a beneficiary has not been designated under ORS 238.390, and a personal representative
18 or a person filing a [small] **simple** estate affidavit under ORS 114.505 to 114.560 fails to make claim
19 for the benefits within one year after the member dies, the benefits shall be forfeited to the Public
20 Employees Retirement Fund in the manner provided by subsection (1) of this section and are subject
21 to reinstatement only upon subsequent appointment of a personal representative or the filing of a
22 [small] **simple** estate affidavit in the manner provided by ORS 114.505 to 114.560. If benefits are paid
23 to a personal representative or a person filing a [small] **simple** estate affidavit under ORS 114.505
24 to 114.560, the personal representative or person filing the affidavit shall return to the board the
25 amount that would otherwise escheat to the state after payment of administrative expenses and
26 claims against the estate. Any amounts returned to the board under this subsection shall be for-
27 feited to the fund.

28 **SECTION 25.** ORS 708A.655 is amended to read:

29 708A.655. (1) This section applies to the safe deposit box of any person who is the sole lessee
30 or last surviving lessee of the box and who has died.

31 (2) Subject to ORS 114.537, upon being furnished with a certified copy of the decedent's death
32 record or other evidence of death satisfactory to the Oregon operating institution, the Oregon op-
33 erating institution within which the box is located shall cause or permit the box to be opened, and
34 the contents of the box examined, at the request of an individual who furnishes an affidavit stating:

35 (a) That the individual believes the box may contain the will of the decedent, a trust instrument
36 creating a trust of which the decedent was a trustor or a trustee at the time of the decedent's death,
37 documents pertaining to the disposition of the remains of the decedent, documents pertaining to

43 (3) For the purpose of this section, "interested person" means any of the following:

44 (a) A person named as personal representative of the decedent in a purported will of the

1 (b) The surviving spouse or any heir of the decedent;

2 (c) A person who was serving as the court-appointed guardian or conservator of the decedent
3 or as trustee for the decedent immediately prior to the decedent's death;

4 (d) A person named as successor trustee in a purported trust instrument creating a trust of
5 which the decedent was a trustor or a trustee at the time of the decedent's death;

6 (e) A person designated by the decedent in a writing that is acceptable to the Oregon operating
7 institution and is filed with it prior to the decedent's death;

8 (f) A person who immediately prior to the death of the decedent had the right of access to the
9 box as an agent of the decedent under a durable power of attorney;

10 (g) If there are no heirs of the decedent, an estate administrator of the State Treasurer ap-
11 pointed under ORS 113.235; or

12 (h) A person who is authorized to file a [small] **simple** estate affidavit under ORS 114.515.

13 (4) If the box is opened for the purpose of conducting a will search, the Oregon operating in-
14 stitution shall remove any document that appears to be a will, make a true and correct copy of it
15 and deliver the original will to a person designated in the will to serve as the decedent's personal
16 representative, or if no such person is designated or the Oregon operating institution cannot, despite
17 reasonable efforts, determine the whereabouts of such person, the Oregon operating institution shall

26 instrument to serve as the successor trustee on the death of the decedent. If no such person is
27 designated or the Oregon operating institution cannot, despite reasonable efforts, determine the
28 whereabouts of such person, the Oregon operating institution shall retain the trust instrument. A
29 copy of the trust instrument shall be retained in the box. At the request of any interested person,
30 a copy of the trust instrument may be given to the interested person.

31 (6) If the box is opened for the purpose of obtaining documents pertaining to the disposition of
32 the decedent's remains, the Oregon operating institution shall comply with subsection (4) or (5) of
33 this section with respect to any will or trust instrument of the decedent found in the box, and may
34 in its discretion either:

35 (a) Make and retain in the box a copy of any documents pertaining to the disposition of the
36 remains of the decedent and tender the original documents to the interested person; or

37 (b) Provide a copy of any documents pertaining to the disposition of the remains of the decedent
38 to the interested person and retain the original documents in the box.

39 (7) If the box is opened for the purpose of making an inventory of its contents, the Oregon op-
40 erating institution shall comply with subsection (4) or (5) of this section with respect to any will or
41 trust instrument of the decedent that is found in the box, and shall cause the inventory to be made.
42 The inventory must be attested to by a representative of the Oregon operating institution and may

1 (8) If the interested person is an affiant of a [small] **simple** estate affidavit filed under ORS
2 114.515 and delivers a certified copy of the affidavit in the manner provided by ORS 114.535, the
3 Oregon operating institution shall provide to the affiant access to the decedent's property. The
4 Oregon operating institution shall comply with subsection (4) or (5) of this section if a will or trust
5 instrument of the decedent is found in the box. Subject to ORS 114.537, the Oregon operating insti-
6 tution shall allow the affiant to take possession of the personal property in the box.

7 (9) The Oregon operating institution may presume the truth of any statement contained in the
8 affidavit required to be furnished under this section or ORS 114.535, and when acting in reliance
9 upon such an affidavit, the Oregon operating institution is discharged as if it had dealt with the
10 personal representative of the decedent. The Oregon operating institution is not responsible for the
11 adequacy of the description of any property included in an inventory of the contents of a box, or for
12 the conversion of the property in connection with actions performed under this section, except for
13 conversion by intentional acts of the Oregon operating institution or its employees, directors, offi-
14 cers or agents. If the Oregon operating institution is not satisfied that the requirements of this
15 section have been satisfied, the Oregon operating institution may decline to open the box.

16 (10) If the interested person or affiant does not furnish the key needed to open the box, and the
17 Oregon operating institution must incur expense in gaining entry to the box, the Oregon operating
18 institution may require that the interested person or affiant pay the expense of opening the box.

19 (11) Any examination of the contents of a box under this section shall be conducted in the
20 presence of at least one employee of the Oregon operating institution.

18 as the successor trustee on the death of the decedent. If no such person is designated or the credit
19 union cannot, despite reasonable efforts, determine the whereabouts of such person, the credit union
20 shall retain the trust instrument. A copy of the trust instrument shall be retained in the box. At the
21 request of any interested person, a copy of the trust instrument may be given to the interested
22 person.

23 (6) If the box is opened for the purpose of obtaining documents pertaining to the disposition of
24 the decedent's remains, the credit union shall comply with subsection (4) or (5) of this section with
25 respect to any will or trust instrument of the decedent found in the box, and may in its discretion
26 either:

27 (a) Make and retain in the box a copy of any documents pertaining to the disposition of the
28 remains of the decedent and tender the original documents to the interested person; or

29 (b) Provide a copy of any documents pertaining to the disposition of the remains of the decedent
30 to the interested person and retain the original documents in the box.

31 (7) If the box is opened for the purpose of making an inventory of its contents, the credit union

34 must be attested to by a representative of the credit union and may be attested to by the interested
35 person, if the interested person is present when the inventory is made. The credit union shall retain

38 (8) If the interested person is an affiant of a [small] **simple** estate affidavit filed under ORS
39 114.515 and delivers a certified copy of the affidavit in the manner provided by ORS 114.535, the
40 credit union shall provide to the affiant access to the decedent's property. The credit union shall
41 comply with subsection (4) or (5) of this section if a will or trust instrument of the decedent is found
42 in the box. Subject to ORS 114.537, the credit union shall allow the affiant to take possession of the
43 personal property in the box.

44 (9) The credit union may presume the truth of any statement contained in the affidavit required
45 to be furnished under this section and ORS 114.535, and when acting in reliance upon such an affi-

1 davit, the credit union is discharged as if it had dealt with the personal representative of the
2 decedent. The credit union is not responsible for the adequacy of the description of any property
3 included in an inventory of the contents of a box, or for the conversion of the property in connection
4 with actions performed under this section, except for conversion by intentional acts of the credit
5 union or its employees, directors, officers or agents. If the credit union is not satisfied that the re-
6 quirements of this section have been satisfied, the credit union may decline to open the box.

7 (10) If the interested person or affiant does not furnish the key needed to open the box, and the
8 credit union must incur expense in gaining entry to the box, the credit union may require that the
9 interested person or affiant pay the expense of opening the box.

10 (11) Any examination of the contents of a box under this section shall be conducted in the
11 presence of at least one employee of the credit union.
