SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Oregon Public Defense Commission within judicial branch. Specifies appointment process for and qualification of commission members and duties of executive director and commission. Abolishes Public Defense Services Commission and transfers duties, functions and powers of commission to Oregon Public Defense Commission.

Transfers Oregon Public Defense Commission to executive branch effective *[January 3, 2025]* **January 1, 2025. Provides that Governor appoints executive director of commission, and executive director and commission members serve at pleasure of Governor until July 1, 2027.** Directs Oregon Department of Administrative Services to issue state public defense population forecasts.

Directs Oregon Public Defense Commission to conduct survey and economic analysis to calculate minimum hourly pay for appointed counsel who are not employed by commission **for contracts entered beginning July 1, 2027.** Specifies required percentage of trial-level appointed counsel who must be employees of commission by January 1, 2031, and January 1, 2035. Effective July 1, 2025, directs commission to establish panel of qualified counsel who may be directly assigned to cases. Specifies types of contracts commission may enter into for purposes of providing public defense services. **Provides that commission members appoint executive director of commission beginning July 1, 2027.**

Directs Oregon Public Defense Commission to provide, to interim committees of Legislative Assembly related to judiciary, no later than May 15, 2024, comprehensive report on plan for providing public defense services. Directs commission to provide updated report on December 1, 2025, **December 1, 2026, and December 1, 2027,** and biennially thereafter until January 2, 2036.

Declares emergency, effective on passage.

1 **SECTION 1.** ORS 151.211 is amended to read:

2 151.211. For purposes of ORS 151.211 to 151.221:

3 [(1) “*Bar member*” means an individual who is an active member of the Oregon State Bar.]

4 [(2)] (1) “Chief Justice” means the Chief Justice of the Supreme Court.

5 [(3)] (2) “Commission” means the [Public Defense Services Commission] **Oregon Public Defense**
6 **Commission.**

7 [(4) “*Director*” means the public defense services executive director appointed under ORS
8 151.216.]

9 [(5) “*Office of public defense services*” means the office established by the commission under the
10 director to handle the cases assigned and to carry out the administrative policies and procedures for
11 the public defense system.]

12 **SECTION 2.** ORS 151.213 is amended to read:

13 151.213. (1) The [Public Defense Services Commission] **Oregon Public Defense Commission** is
14 established in the judicial branch of state government. Except for the appointment or removal of
15 commission members, the commission and employees of the commission are not subject to the exer-
16 cise of administrative authority and supervision by the Chief Justice of the Supreme Court as the
17 administrative head of the Judicial Department.

18 (2)(a) [The commission consists of] Nine **voting members and four nonvoting members shall**
19 **be appointed to the commission** by order of the Chief Justice[. *In addition to the nine appointed*
20 *members, the Chief Justice serves as a nonvoting, ex officio member. The Chief Justice shall appoint*
21 *at least three persons who are not bar members, at least one person who was formerly engaged in the*
22 *provision of public defense services and at least one person who has been formerly represented by a*
23 *public defense provider in this state. All members must have a demonstrated record of commitment to*
24 *public defense. Except for the Chief Justice or a senior judge under ORS 1.300, a member may not*
25 *serve concurrently as a judge, a prosecuting attorney or an employee of a law enforcement agency. A*
26 *person who is primarily engaged in providing public defense services may not serve as a member of*
27 *the commission.*] **as follows:**

28 **(A) The Chief Justice shall appoint:**

29 **(i) One voting member who is a retired judge.**

30 **(ii) Two additional voting members, one of whom has experience as a public defense**
31 **provider in criminal cases.**

32 **(B) The Chief Justice shall appoint, from among persons recommended by the Governor:**

33 **(i) One voting member who has been represented by a public defense provider.**

34 **(ii) Two additional voting members, one of whom has experience as a public defense**
35 **provider in juvenile delinquency or dependency cases.**

36 **(iii) Two nonvoting members who are currently employed as public defense providers in**
37 **this state, one of whom is from an urban area and one of whom is from a rural area.**

38 **(C) The Chief Justice shall appoint, from among persons recommended by the President**
39 **of the Senate:**

40 **(i) One voting member who is a current dean or faculty member of an Oregon law school.**

41 **(ii) One nonvoting member who is a member of the Senate at the time of appointment.**

42 **(D) The Chief Justice shall appoint, from among persons recommended by the Speaker**
43 **of the House of Representatives:**

44 **(i) One voting member who has expertise in juvenile law and criminal defense, or who is**
45 **a juvenile justice or criminal justice reform advocate.**

1 (ii) One nonvoting member who is a member of the House of Representatives at the time
2 of appointment.

3 (E) The Chief Justice shall appoint one voting member from among persons jointly re-
4 commended by the President of the Senate and the Speaker of the House of Representatives.

5 (b) When recommending and appointing members of the commission, the Chief Justice,
6 Governor, President of the Senate and Speaker of the House of Representatives shall:

7 (A) Consider input from individuals and organizations with an interest in the delivery of
8 public defense services.

9 (B) Consider geographic, racial, ethnic and gender diversity.

10 (C) Ensure that members appointed to the commission have significant experience with
11 issues related to public defense or in the case types subject to representation by public de-
12 fense providers.

13 (D) Ensure that members appointed to the commission have demonstrated a strong
14 commitment to quality public defense representation.

15 (c) The following persons may not be appointed to and may not serve as members of the
16 commission:

17 (A) A prosecuting attorney.

18 (B) A judge, magistrate or other person who performs judicial functions.

19 (C) An employee of a law enforcement agency or the Department of Human Services.

20 (d) A person who is primarily engaged in providing public defense services and who has
21 a financial interest in the delivery of public defense services at the state level may not serve
22 as a voting member of the commission.

23 (e) As used in this subsection, “law enforcement agency” means an entity that employs
24 corrections officers, parole and probation officers, police officers, certified reserve officers
25 or reserve officers, as those terms are defined in ORS 181A.355.

26 (3) The term of a member is four years beginning on the effective date of the order of the Chief
27 Justice appointing the member. A member is eligible for reappointment if qualified for membership
28 at the time of reappointment, **but may serve no more than two consecutive four-year terms.**
29 [A member may be removed from the commission by order of the Chief Justice.] **The Chief Justice**
30 **may remove any member of the commission at any time for cause.** If a vacancy occurs for any
31 cause before the expiration of the term of a member, the Chief Justice shall make an appointment
32 **to fill the vacancy, in the same manner as an appointment to a full term,** to become imme-
33 diately effective for the unexpired term. **If the Chief Justice has not filled a vacancy within 45**
34 **days after the vacancy occurs, the remaining voting members of the commission shall, by a**
35 **majority vote, select a member to fill the vacancy for the remainder of the term. The se-**
36 **lected member must meet the requirements for membership described in this section.**

37 (4) A chairperson and a vice chairperson shall be [appointed by order of the Chief Justice]
38 **elected by the voting members of the commission** every two years with such functions as the
39 commission may determine. A member is eligible for [reappointment] **reelection** as chairperson or
40 vice chairperson.

41 (5) A majority of the voting members constitutes a quorum for the transaction of business.

42 (6)(a) **All members of the commission shall:**

43 (A) **Review the policies, procedures, standards and guidelines required by ORS 151.216 and**
44 **provide input before the approval vote described in paragraph (b) of this subsection.**

45 (B) **Review the budget of the commission and provide input before the approval vote de-**

1 scribed in paragraph (b) of this subsection.

2 (C) Meet as needed to carry out the duties described in this subsection.

3 (b) The voting members of the commission shall:

4 (A) Appoint, by a two-thirds vote, an executive director for a term of office of four years.
5 The term may be terminated for cause by a majority vote of the voting members after notice
6 and a hearing. When the term of an executive director ends without termination, the voting
7 members of the commission may reappoint the person currently in the position by a majority
8 vote.

9 (B) Upon the vacancy of the executive director position, immediately designate an acting
10 executive director by a majority vote.

11 (C) Approve by majority vote the policies, procedures, standards and guidelines required
12 by ORS 151.216 before those policies, procedures, standards and guidelines may take effect.

13 (D) Approve by majority vote the budget of the commission before submission to the
14 Legislative Assembly.

15 (7) The members of the commission may not:

16 (a) Make any decision regarding the handling of any individual case;

17 (b) Have access to any case file; or

18 (c) Interfere with the executive director or any member of the staff of the executive di-
19 rector in carrying out professional duties involving the legal representation of public defense
20 clients.

21 [(6)] (8) A member of the commission is [not] entitled to compensation for services as a member,
22 [but is entitled] and to expenses, as provided in ORS 292.495 [(2)].

23 **SECTION 3.** ORS 151.216 is amended to read:

24 151.216. (1) The [*Public Defense Services Commission*] **Oregon Public Defense Commission**
25 shall:

26 (a) Establish and maintain a public defense system that ensures the provision of public defense
27 services consistent with the Oregon Constitution, the United States Constitution and Oregon and
28 national standards of justice.

29 [(b) *Establish an office of public defense services and appoint a public defense services executive*
30 *director who serves at the pleasure of the commission.*]

31 [(c)] (b) Adopt policies for [*contracting for*] public defense providers [*not employed by the office*
32 *of public defense services*] that:

33 (A) Ensure compensation, resources and caseloads are in accordance with national and regional
34 best practices;

35 (B) [*Promote policies for public defense provider compensation and resources that are comparable*
36 *to prosecution compensation and resources*] **Ensure all public defense provider contracts provide**
37 **for compensation that is commensurate with the character of service performed;**

38 (C) Ensure funding and resources to support required data collection and training requirements;
39 and

40 (D) Recognize the need to consider overhead costs that account for the cost of living and busi-
41 ness cost differences in each county or jurisdiction, including but not limited to rent, professional
42 membership dues, malpractice insurance and other insurance and other reasonable and usual oper-
43 ating costs.

44 [(d)] (c) Establish operational and contracting systems that allow for oversight, ensure trans-
45 parency and stakeholder engagement and promote equity, inclusion and culturally specific repre-

1 sentation.

2 [(e)] (d) Review the caseload policies described in paragraph [(c)(A)] (b)(A) of this subsection
3 annually, and revise the policies as necessary and at least every four years.

4 [(f)] (e) Adopt a statewide workload plan, based on the caseload policies described in paragraph
5 [(c)(A)] (b)(A) of this subsection, that takes into account the needs of each county or jurisdiction,
6 practice structure and type of practice overseen by the [office of public defense services]
7 **commission**.

8 [(g)] (f) Submit the budget of the commission [and the office of public defense services] to the
9 Legislative Assembly after the budget is submitted to the commission by the **executive** director and
10 approved by the **voting members of the** commission. The Chief Justice of the Supreme Court and
11 the chairperson of the commission shall present the budget to the Legislative Assembly.

12 [(h) Review and approve any public defense services contract negotiated by the director before the
13 contract can become effective.]

14 [(i)] (g) Adopt a compensation plan, classification system and [personnel] **affirmative action**
15 plan for the [office of public defense services] **commission** that are commensurate with other state
16 agencies.

17 [(j)] (h) Adopt policies, procedures, standards and guidelines regarding:

18 (A) The determination of financial eligibility of persons entitled to be represented by appointed
19 counsel at state expense;

20 (B) The appointment of counsel, including the appointment of counsel at state expense regard-
21 less of financial eligibility in juvenile delinquency matters;

22 (C) The fair compensation of counsel appointed to represent a person financially eligible for
23 appointed counsel at state expense;

24 (D) Appointed counsel compensation disputes;

25 (E) [Any other] **The** costs associated with the representation of a person by appointed counsel
26 in the state courts that are required to be paid by the state [under ORS 34.355, 135.055, 138.500,
27 138.590, 161.346, 161.348, 161.365, 419A.211, 419B.201, 419B.208, 419B.518, 419B.908, 419C.206,

31 [(F) Professional qualifications for counsel appointed to represent public defense clients;]

32 [(G) Performance for legal representation;]

33 [(H) The contracting of public defense services;]

34 [(I) Contracting with expert witnesses to allow contracting with out-of-state expert witnesses only
35 if in-state expert witnesses are not available or are more expensive than out-of-state expert witnesses;
36 and]

37 **(F) The types of fees and expenses subject to a preauthorization requirement.**

38 [(J) Any other matters necessary to carry out the duties of the commission.]

39 [(k) Establish a peer review system for the approval of nonroutine fees and expenses incurred in
40 cases involving aggravated murder and the crimes listed in ORS 137.700 and 137.707. The review shall
41 be conducted by a panel of attorneys who practice in the area of criminal defense.]

42 [(L) Establish a complaint process that allows district attorneys, criminal defense counsel and the
43 public to file complaints concerning the payment from public funds of nonroutine fees and expenses
44 incurred in cases.]

45 [(m)] (i) Reimburse the State Court Administrator from funds deposited in the Public Defense

1 Services Account established by ORS 151.225 for the costs of personnel and other costs associated
2 with location of eligibility verification and screening personnel pursuant to ORS 151.489 by the State
3 Court Administrator.

4 **(j) Develop, adopt and oversee the implementation, enforcement and modification of pol-**
5 **icies, procedures, minimum standards and guidelines to ensure that public defense providers**
6 **are providing effective assistance of counsel consistently to all eligible persons in this state**
7 **as required by statute and the Oregon and United States Constitutions. The policies, proce-**
8 **dures, standards and guidelines described in this paragraph apply to employees of the com-**
9 **mission and to any person or entity that contracts with the commission to provide public**
10 **defense services in this state.**

11 **(k) Set minimum standards by which appointed counsel are trained and supervised.**

12 **(L) Establish a system, policies and procedures for the mandatory collection of data**
13 **concerning the operation of the commission and all public defense providers.**

14 **(m) Enter into contracts and hire attorneys to bring the delivery of public defense ser-**
15 **vices into and maintain compliance with the minimum policies, procedures, standards and**
16 **guidelines described in this subsection. All contracts for the provision of public defense ser-**
17 **vices to which the commission is a party must include a requirement for collection by the**
18 **commission of data determined by the commission to be qualitatively necessary for any re-**
19 **port required to be submitted to the Legislative Assembly.**

20 **(n) At least once every two years, report to the interim committees of the Legislative**
21 **Assembly related to the judiciary, in the manner provided in ORS 192.245, and to the Gover-**
22 **nor and Chief Justice, concerning compliance metrics for the minimum standards described**
23 **in this subsection and recommendations for legislative changes.**

24 **(o) Develop standard operating expectations for persons and entities providing public de-**
25 **fense services.**

26 **(p) In consultation with the Judicial Department, ensure the existence of policies that**
27 **create a standardized process for determining and verifying financial eligibility for appointed**
28 **counsel under ORS 151.485.**

29 **(q) Ensure access to systematic and comprehensive training programs for attorneys for**
30 **the purpose of meeting statewide standards set by the commission.**

31 **(r) Enter into contracts or interagency agreements with the Oregon Department of Ad-**
32 **ministrative Services for the purpose of supporting state public defense population forecasts**
33 **and other related forecasts.**

34 **(s) Pay invoices submitted to the commission within 45 days of receipt or in accordance**
35 **with statewide accounting policies established by the Oregon Department of Administrative**
36 **Services.**

37 **(t) Establish any other policies, procedures, standards and guidelines for the conduct of**
38 **the commission's affairs and promulgate policies necessary to carry out all powers and du-**
39 **ties of the commission.**

40 **(2) When establishing the minimum policies, procedures, standards and guidelines de-**
41 **scribed in this section, the commission shall adhere to the following principles:**

42 **(a) Appointed counsel shall be provided sufficient time and a space where attorney-client**
43 **confidentiality is safeguarded for meetings with clients.**

44 **(b) The workload of appointed counsel must be controlled to permit effective represen-**
45 **tation. Economic disincentives or incentives that impair the ability of appointed counsel to**

1 provide effective assistance of counsel must be avoided. The commission may develop work-
2 load controls to enhance appointed counsel's ability to provide effective representation.

3 (c) The ability, training and experience of appointed counsel must match the nature and
4 complexity of the case to which the counsel is appointed.

5 (d) The same appointed counsel shall continuously represent a client throughout the
6 pendency of the case and shall appear at every court appearance other than ministerial
7 hearings.

8 (e) The commission shall establish continuing legal education requirements for public
9 defense providers who are employed by or contract with the commission that are specific to
10 the subject matter area and practice of each type of court-appointed counsel.

11 (f) The commission and public defense providers shall systematically review appointed
12 counsel for efficiency and for effective representation according to commission standards.

13 (3) The commission shall be organized in a manner for the effective delivery of public
14 defense services as prescribed by the policies and procedures created pursuant to statute to
15 financially eligible persons and consistent with the budgetary structure established for the
16 commission by the Legislative Assembly.

17 (4) The commission shall hire attorneys to serve as appointed counsel, including at the
18 trial level in Oregon circuit courts, and may establish a trial division within the commission
19 consisting of attorneys employed by the commission who are trial-level public defense pro-
20 viders.

21 (5) The policies, procedures, standards and guidelines adopted by the commission must
22 be made available in an accessible manner to the public on the commission's website.

23 [(2)] (6) Policies, procedures, standards and guidelines adopted by the commission supersede any
24 conflicting rules, policies or procedures of the Public Defender Committee, State Court Administra-
25 tor, circuit courts, the Court of Appeals, the Supreme Court and the Psychiatric Security Review
26 Board related to the exercise of the commission's administrative responsibilities under this section
27 and transferred duties, functions and powers as they occur.

28 [(3)] (7) The commission may accept gifts, grants or contributions from any source, whether
29 public or private. However, the commission may not accept a gift, grant or contribution if accept-
30 ance would create a conflict of interest. Moneys accepted under this subsection shall be deposited
31 in the Public Defense Services Account established by ORS 151.225 and expended for the purposes
32 for which given or granted.

33 [(4) *The commission may not:*]

34 [(a) *Make any decision regarding the handling of any individual case;*]

35 [(b) *Have access to any case file; or*]

36 [(c) *Interfere with the director or any member of the staff of the director in carrying out profes-*
37 *sional duties involving the legal representation of public defense clients.*]

38 **SECTION 4.** ORS 151.219 is amended to read:

39 151.219. (1) The [*public defense services*] executive director **of the Oregon Public Defense**
40 **Commission** shall:

41 (a) **Designate a deputy director of the commission who serves at the pleasure of the**
42 **executive director.**

43 (b) **Hire necessary staff for the commission.**

44 [(a)] (c) Recommend to the [*Public Defense Services*] commission how to establish and maintain,
45 in a cost-effective manner, the delivery of legal services to persons entitled to, and, where applica-

1 ble, financially eligible for, appointed counsel at state expense under Oregon statutes, the Oregon
2 Constitution, the United States Constitution and consistent with Oregon and national standards of
3 justice.

4 [(b)] (d) Implement and ensure compliance with contracts, policies, procedures, standards and
5 guidelines adopted by the commission or required by statute.

6 [(c)] (e) Prepare and submit to the commission for its approval the biennial budget of the com-
7 mission [*and the office of public defense services*].

8 [(d)] (f) Negotiate contracts, as appropriate, for providing legal services to persons eligible for
9 appointed counsel at state expense. [*No contract so negotiated is binding or enforceable until the*
10 *contract has been reviewed and approved by the commission as provided in ORS 151.216.*]

11 [(e)] (g) Employ personnel or contract for services as necessary to carry out the responsibilities
12 of the **executive** director and the [*office of public defense services*] **commission**.

13 [(f)] (h) Supervise the personnel, operation and activities of the [*office of public defense*
14 *services*] **commission**.

15 [(g)] (i) Provide services, facilities and materials necessary for the performance of the duties,
16 functions and powers of the [*Public Defense Services*] commission.

17 [(h)] (j) Pay the expenses of the commission [*and the office of public defense services*].

18 [(i)] (k) Prepare and submit to the **members of the** commission an annual report of the activ-
19 ities of the [*office of public defense services*] **commission**.

20 [(j) Prepare and submit to the Legislative Assembly a biennial report on the activities of the office
21 of public defense services.]

22 [(k)] (L) Provide for legal representation, advice and consultation for the commission, its mem-
23 bers, the **executive** director and staff of the [*office of public defense services*] **commission** who re-
24 quire such services or who are named as defendants in lawsuits arising from their duties, functions
25 and responsibilities. If requested by the **executive** director, the Attorney General may also provide

39 **SECTION 6.** ORS 151.225 is amended to read:

40 151.225. (1) The Public Defense Services Account is established in the State Treasury, separate
41 and distinct from the General Fund. The Public Defense Services Account is continuously appropri-
42 ated to the [*Public Defense Services Commission*] **Oregon Public Defense Commission** for:

43 (a) Administration and support of the public defense system;

44 (b) Reimbursement of the State Court Administrator under ORS 151.216 [(1)(m)] (1)(i); and

45 (c) Legal representation of parents and children involved in foster care for which matching

16 in a county or justice court.

17 (b) By the [public defense services] executive director **of the Oregon Public Defense Commis-**
18 **sion** from funds available for the purpose, in a proceeding in a circuit court.

19 (2) Except for counsel appointed pursuant to contracts or counsel employed by the [public de-
20 fense services executive director] **Oregon Public Defense Commission**, compensation payable to
21 appointed counsel under subsection (1) of this section:

22 (a) In a proceeding in a county or justice court may not be less than \$30 per hour.

23 (b) In a proceeding in a circuit court is subject to the applicable compensation established under
24 ORS 151.216.

25 (3)(a) A person determined to be eligible for appointed counsel is entitled to necessary and
26 reasonable fees and expenses for investigation, preparation and presentation of the case for trial,
27 negotiation and sentencing. The person or the counsel for the person shall upon written request
28 secure preauthorization to incur fees and expenses that [are not routine to representation but] are
29 necessary and reasonable in the investigation, preparation and presentation of the case **and that**
30 **require preauthorization under a policy of the Oregon Public Defense Commission**, including
31 but not limited to [nonroutine] travel, photocopying or other reproduction of [nonroutine] documents,
32 necessary costs associated with obtaining the attendance of witnesses for the defense, investigator
33 fees and expenses, expert witness fees and expenses and fees for interpreters and assistive commu-
34 nication devices necessary for the purpose of communication between counsel and a client or wit-
35 ness in the case. Preauthorization to incur a fee or expense does not guarantee that a fee or
36 expense incurred pursuant to the preauthorization will be determined to be necessary or reasonable
37 when the fee or expense is submitted for payment.

38 (b) In a county or justice court, the request must be in the form of a motion to the court. The
39 motion must be accompanied by a supporting affidavit that sets out in detail the purpose of the re-
40 quested expenditure, the name of the service provider or other recipient of the funds, the dollar
41 amount of the requested expenditure that may not be exceeded without additional authorization and
42 the date or dates during which the service will be rendered or events will occur for which the ex-
43 penditure is requested.

44 (c) In a circuit court, the request must be in the form and contain the information that is re-
45 quired by the policies, procedures, standards and guidelines of the [Public Defense Services Com-

1 *mission*] **Oregon Public Defense Commission**. If the [*public defense services*] executive director of
 2 **the commission** denies a request for preauthorization to incur [*nonroutine*] fees and expenses
 3 **subject to a preauthorization requirement**, the person making the request may appeal the deci-
 4 sion to the presiding judge of the circuit court. The presiding judge has final authority to preau-
 5 thorize incurring [*nonroutine*] fees and expenses under this paragraph.

6 (d) Entitlement under subsection (7) of this section to payment for fees and expenses in circuit
 7 court is subject to the policies, procedures, standards and guidelines adopted under ORS 151.216.
 8 Entitlement to payment of [*nonroutine*] fees and expenses **subject to a preauthorization require-**
 9 **ment** is dependent upon obtaining preauthorization from the court, if the case is in county or justice
 10 court, or from the [*public defense services*] executive director of **the Oregon Public Defense Com-**
 11 **mission**, if the case is in circuit court, except as otherwise provided in paragraph (c) of this sub-
 12 section and in the policies, procedures, standards and guidelines adopted under ORS 151.216. Fees
 13 and expenses shall be paid:

14 (A) By the county, in respect to a proceeding in a county or justice court.

15 (B) By the [*public defense services*] executive director **of the commission** from funds available
 16 for the purpose, in respect to a proceeding in a circuit court.

17 (C) By the city, in respect to a proceeding in municipal court.

18 (4) Upon completion of all services by the counsel of a person determined to be eligible for ap-
 19 pointed counsel, the counsel shall submit a statement of all necessary and reasonable fees and ex-
 20 penses of investigation, preparation and presentation and, if counsel was appointed by the court, a
 21 statement of all necessary and reasonable fees and expenses for legal representation, supported by
 22 appropriate receipts or vouchers and certified by the counsel to be true and accurate.

23 (5) In a county or justice court, the total fees and expenses payable under this section must be
 24 submitted to the court by counsel or other providers and are subject to the review of the court. The
 25 court shall certify that such amount is fair reimbursement for fees and expenses for representation
 26 in the case as provided in subsection (6) of this section. Upon certification and any verification as
 27 provided under subsection (6) of this section, the amount of the fees and expenses approved by the
 28 court and not already paid shall be paid by the county.

29 (6) In a county or justice court, the court shall certify to the administrative authority respon-
 30 sible for paying fees and expenses under this section that the amount for payment is reasonable and
 31 that the amount is properly payable out of public funds.

32 (7) In a circuit court, the total fees and expenses payable under this section must be submitted
 33 to and are subject to review by the [*public defense services*] executive director **of the Oregon Public**
 34 **Defense Commission**. The [*public defense services*] executive director **of the commission** shall
 35 determine whether the amount is necessary, reasonable and properly payable from public funds for
 36 fees and expenses for representation in the case as provided by the policies, procedures, standards
 37 and guidelines of the [*Public Defense Services Commission*] **commission**. The [*public defense*
 38 *services*] executive director **of the commission** shall pay the amount of the fees and expenses de-
 39 termined necessary, reasonable and properly payable out of public funds. The court shall provide
 40 any information identified and requested by the [*public defense services*] executive director **of the**
 41 **commission** as needed for audit, statistical or any other purpose pertinent to ensure the proper
 42 disbursement of state funds or pertinent to the provision of appointed counsel compensated at state
 43 expense.

44 (8) If the [*public defense services*] executive director **of the Oregon Public Defense Commis-**
 45 **sion** denies, in whole or in part, fees and expenses submitted for review and payment, the person

1 who submitted the payment request may appeal the decision to the presiding judge of the circuit
2 court. The presiding judge or the designee of the presiding judge shall review the [*public defense*
3 *services*] executive director’s decision for abuse of discretion. The decision of the presiding judge
4 or the designee of the presiding judge is final.

5 (9) The following may not be disclosed to the district attorney prior to the conclusion of a case:

6 (a) Requests and administrative or court orders for preauthorization to incur [*nonroutine*] fees
7 and expenses **subject to a preauthorization requirement** in the investigation, preparation and
8 presentation of the case; and

9 (b) Billings for such fees and expenses submitted by counsel or other providers.

10 (10) Notwithstanding subsection (9) of this section, the total amount of moneys determined to
11 be necessary and reasonable for [*nonroutine*] fees and expenses **subject to a preauthorization re-**
12 **quirement** may be disclosed to the district attorney at the conclusion of the trial in the circuit
13 court.

14 (11) As used in this section unless the context requires otherwise, “counsel” includes a legal
15 advisor appointed under ORS 135.045.

16 **SECTION 7a. (1) The Oregon Department of Administrative Services shall issue state**
17 **public defense population forecasts including, but not limited to, expected populations of**
18 **adults and juveniles eligible for appointed counsel, to be used by:**

19 (a) **The Oregon Public Defense Commission, in preparing budget requests or for any other**
20 **purpose determined necessary by the commission; or**

21 (b) **Any other state agency concerned with the effect of public defense populations or**
22 **policy developments on budgeting.**

23 (2) **The department shall issue state public defense population forecasts on April 15 and**
24 **October 15 of each year.**

25 (3) **When the department issues a state public defense population forecast, the forecast**
26 **must:**

27 (a) **Discretely identify adult and juvenile populations that are eligible for appointed**
28 **counsel categorized by either circuit or appellate court;**

29 (b) **Identify the forecast’s margin of error for adult and juvenile populations; and**

30 (c) **Attribute growth or decline in the forecast, relative to previously issued forecasts,**
31 **to specific policies or to specific components of the baseline underlying the forecast.**

32 (4) **The Oregon Public Defense Commission, the Oregon Criminal Justice Commission, the**
33 **Judicial Department and, if requested by the Oregon Department of Administrative Services,**
34 **any other state agency, shall provide the Oregon Department of Administrative Services with**
35 **any information necessary for the department to prepare the forecasts described in this**
36 **section.**

37 (5) **As used in this section, “baseline underlying the forecast” includes population demo-**
38 **graphics and crime trends.**

40 (Transfer of Duties)

41
42 **SECTION 8. (1) The Public Defense Services Commission is abolished. On the operative**
43 **date of this section, the tenure of office of the members of the Public Defense Services**
44 **Commission ceases.**

45 (2) **All of the duties, functions and powers of the Public Defense Services Commission,**

1 except as those duties, functions and powers are modified by the amendments to ORS 151.213,
2 151.216 and 151.219 by sections 2 to 4 of this 2023 Act, are imposed upon, transferred to and
3 vested in the Oregon Public Defense Commission.

4 **SECTION 9.** (1) The chairperson of the Public Defense Services Commission and the
5 public defense services executive director shall:

6 (a) Deliver to the Oregon Public Defense Commission all records and property within the
7 jurisdiction of the chairperson and executive director that relate to the duties, functions and
8 powers transferred by section 8 of this 2023 Act; and

9 (b) Transfer to the Oregon Public Defense Commission those employees engaged prima-
10 rily in the exercise of the duties, functions and powers transferred by section 8 of this 2023
11 Act.

12 (2) The executive director of the Oregon Public Defense Commission shall take possession
13 of the records and property, and shall take charge of the employees and employ them in the
14 exercise of the duties, functions and powers transferred by section 8 of this 2023 Act, without
15 reduction of compensation but subject to change or termination of employment or compen-
16 sation as provided by law.

17 **SECTION 10.** (1) The unexpended balances of amounts authorized to be expended by the
18 Public Defense Services Commission for the biennium beginning July 1, 2023, from revenues
19 dedicated, continuously appropriated, appropriated or otherwise made available for the pur-
20 pose of administering and enforcing the duties, functions and powers transferred by section
21 8 of this 2023 Act are transferred to and are available for expenditure by the Oregon Public
22 Defense Commission for the biennium beginning July 1, 2023, for the purpose of administer-

24 (2) The expenditure classifications, if any, established by Acts authorizing or limiting
25 expenditures by the Public Defense Services Commission remain applicable to expenditures

27 **SECTION 11.** The transfer of duties, functions and powers to the Oregon Public Defense
28 Commission by section 8 of this 2023 Act does not affect any action, proceeding or prose-
29 cution involving or with respect to such duties, functions and powers begun before and
30 pending at the time of the transfer, except that the Oregon Public Defense Commission is
31 substituted for the Public Defense Services Commission in the action, proceeding or prose-
32 cution.

33 **SECTION 12.** (1) Nothing in this 2023 Act relieves a person of a liability, duty or obli-
34 gation accruing under or with respect to the duties, functions and powers transferred by
35 section 8 of this 2023 Act. The Oregon Public Defense Commission may undertake the col-
36 lection or enforcement of any such liability, duty or obligation.

37 (2) The rights and obligations of the Public Defense Services Commission legally incurred
38 under contracts, leases and business transactions executed, entered into or begun before the

40 mission. For the purpose of succession to these rights and obligations, the Oregon Public
41 Defense Commission is a continuation of the Public Defense Services Commission and not a
42 new authority.

43 **SECTION 13.** For the purpose of harmonizing and clarifying statutory law, the Legislative
44 Counsel may substitute for words designating the “Public Defense Services Commission” or
45 its officers, or the office of public defense services, wherever they occur in statutory law,

1 words designating the “Oregon Public Defense Commission” or its officers.

2 **SECTION 14.** (1) Sections 7a to 13 of this 2023 Act and the amendments to ORS 151.211,
3 151.213, 151.216, 151.219, 151.221, 151.225 and 135.055 by sections 1 to 7 of this 2023 Act become
4 operative on January 1, 2024.

5 (2) Notwithstanding subsection (1) of this section:

6 (a) No later than November 1, 2023, the Chief Justice of the Supreme Court shall by order
7 appoint four nonvoting members and nine new voting members to the Oregon Public Defense
8 Commission as provided in ORS 151.213 (2). Except as provided in subsection (3) of this sec-
9 tion, the appointments described in this subsection take effect on January 1, 2024.

10 (b) The Chief Justice, Governor, President of the Senate and Speaker of the House of
11 Representatives may take any action before the operative date specified in subsection (1) of
12 this section that is necessary to effectuate the appointment process described in this sub-
13 section and ORS 151.213 (2).

14 (3)(a) Notwithstanding ORS 151.213 (6)(b), and subject to the provisions of sections 92 (3)
15 and 102 (2) of this 2023 Act, on January 1, 2024, the public defense services executive director
16 shall begin a four-year term as executive director of the Oregon Public Defense Commission,
17 and is subject to termination or reappointment as described in ORS 151.213 (6)(b).

18 (b) The public defense services executive director and the members of the commission
19 may take any action before the operative date specified in subsection (1) of this section that
20 is necessary to enable the executive director and the members to exercise, on and after the
21 operative date specified in subsection (1) of this section, the duties, functions and powers
22 conferred on the executive director and the members by sections 7a to 13 of this 2023 Act
23 and the amendments to ORS 151.211, 151.213, 151.216, 151.219, 151.221, 151.225 and 135.055 by

25 (4) Notwithstanding ORS 151.213 (3), and subject to the provisions of sections 92 (3) and
26 102 (2) of this 2023 Act, the initial terms of persons appointed as voting members to the
27 Oregon Public Defense Commission under this section shall be staggered as follows:

28 (a) The initial term of one of the voting members described in ORS 151.213 (2)(a)(A), one
29 of the voting members described in ORS 151.213 (2)(a)(B) and the voting member described
30 in ORS 151.213 (2)(a)(E) shall be four years.

31 (b) The initial term of one of the voting members described in ORS 151.213 (2)(a)(A) and
32 the voting member described in ORS 151.213 (2)(a)(C) shall be three years.

33 (c) The initial term of one of the voting members described in ORS 151.213 (2)(a)(B) and
34 the voting member described in ORS 151.213 (2)(a)(D) shall be two years.

37 (5) A person who is a member of the Public Defense Services Commission on November
38 1, 2023, is eligible for appointment to the Oregon Public Defense Commission if the person
39 meets the requirements described in ORS 151.213 (2).

41 to practice law in any state or nation.

42 (d) "Lawyer referral service" means an entity that, as a regular part of its business, refers po-
43 tential clients to lawyers, including but not limited to a public nonprofit entity sponsored or oper-
44 ated by the Oregon State Bar.

45 (e) "Representative of the client" means:

1 (A) A principal, an officer or a director of the client; or

2 (B) A person who has authority to obtain professional legal services, or to act on legal advice
3 rendered, on behalf of the client, or a person who, for the purpose of effectuating legal represen-
4 tation for the client, makes or receives a confidential communication while acting in the person's
5 scope of employment for the client.

6 (f) "Representative of the lawyer" means one employed to assist the lawyer in the rendition of
7 professional legal services, but does not include a physician making a physical or mental examina-
8 tion under ORCP 44.

9 (2) A client has a privilege to refuse to disclose and to prevent any other person from disclosing
10 confidential communications made for the purpose of facilitating the rendition of professional legal
11 services to the client:

12 (a) Between the client or the client's representative and the client's lawyer or a representative
13 of the lawyer;

14 (b) Between the client's lawyer and the lawyer's representative or the client's lawyer referral
15 service;

16 (c) By the client or the client's lawyer to a lawyer representing another in a matter of common
17 interest;

18 (d) Between representatives of the client or between the client and a representative of the cli-
19 ent;

20 (e) Between lawyers representing the client; or

21 (f) Between the client or a representative of the client and a lawyer referral service.

22 (3) The privilege created by this section may be claimed by the client, a guardian or conservator

26 the communication is presumed to have authority to claim the privilege but only on behalf of the

26 suitable counsel for such a proceeding. The affidavit shall contain a brief statement of the
27 petitioner's assets and liabilities and income during the previous year. If the circuit court is satisfied
28 that the petitioner is unable to pay such expenses or to employ suitable counsel, it shall order that
29 the petitioner proceed as a financially eligible person. If the court finds that a petitioner who has
30 been sentenced to death is not competent to decide whether to accept or reject the appointment of
31 counsel, the court shall appoint counsel to represent the petitioner. However, when a circuit court
32 orders petitioner's case transferred to another circuit court as provided in ORS 138.560 (4), the
33 matter of petitioner's proceeding as a financially eligible person shall be determined by the latter
34 court.

35 (3) If a petitioner who has been sentenced to death qualifies for the appointment of counsel un-
36 der this section but rejects the appointment, the court shall determine, after a hearing if necessary,
37 whether the petitioner rejected the offer of counsel and made the decision with an understanding
38 of its legal consequences. The court shall make appropriate findings on the record.

39 (4) In the order to proceed as a financially eligible person, the circuit court shall appoint suit-

6 (8)(a) Except as otherwise provided in this subsection, the appellant shall serve and file the no-

23 counsel represents. If the party requesting an appeal is represented by court-appointed counsel,
24 court-appointed counsel may discharge the duty to commence an appeal under this subsection by
25 complying with policies and procedures established by the [*office of public defense services*] **Oregon**
26 **Public Defense Commission** for appeals of juvenile court judgments.

27 (5)(a) Upon motion of a person, other than the state, entitled to appeal under subsection (1) of
28 this section, the appellate court shall grant the person leave to file a notice of appeal after the time
29 limits described in subsection (3) of this section if:

30 (A) The person shows a colorable claim of error in the proceeding from which the appeal is
31 taken; and

32 (B) The person shows that the failure to file a timely notice of appeal is not personally attrib-
33 utable to the person.

34 (b) A person other than the state is not entitled to relief under this subsection for failure to file
35 timely notice of cross-appeal when the state appeals pursuant to ORS 419A.208.

36 (c) The request for leave to file a notice of appeal after the time limits prescribed in subsection
37 (3) of this section must be filed no later than 90 days after entry of the judgment being appealed and

(Appointment and Duties)

SECTION 77. ORS 151.213, as amended by section 2 of this 2023 Act, is amended to read:

151.213. (1) The Oregon Public Defense Commission is established in the *[judicial]* **executive** branch of state government. Except for the appointment or removal of commission members, the commission and employees of the commission are not subject to the exercise of administrative authority and supervision by the *[Chief Justice of the Supreme Court as the administrative head of the Judicial Department]* **Governor**.

(2)(a) Nine voting members and four nonvoting members shall be appointed to the commission by *[order of the Chief Justice]* **the Governor** as follows:

(A) The Governor shall appoint:

(i) One voting member who has been represented by a public defense provider.

(ii) Two additional voting members, one of whom has experience as a public defense provider in juvenile delinquency or dependency cases.

(iii) Two nonvoting members who are currently employed as public defense providers in this state, one of whom is from an urban area and one of whom is from a rural area.

[(A)] **(B) The Governor shall appoint, from among persons recommended by the Chief Justice *[shall appoint]* of the Supreme Court:**

(i) One voting member who is a retired judge.

(ii) Two additional voting members, one of whom has experience as a public defense provider in criminal cases.

[(B) The Chief Justice shall appoint, from among persons recommended by the Governor:]

[(i) One voting member who has been represented by a public defense provider.]

[(ii) Two additional voting members, one of whom has experience as a public defense provider in juvenile delinquency or dependency cases.]

[(iii) Two nonvoting members who are currently employed as public defense providers in this state, one of whom is from an urban area and one of whom is from a rural area.]

(C) The *[Chief Justice]* Governor shall appoint, from among persons recommended by the President of the Senate:

(i) One voting member who is a current dean or faculty member of an Oregon law school.

(ii) One nonvoting member who is a member of the Senate at the time of appointment.

(D) The *[Chief Justice]* Governor shall appoint, from among persons recommended by the Speaker of the House of Representatives:

(i) One voting member who has expertise in juvenile law and criminal defense, or who is a juvenile justice or criminal justice reform advocate.

(ii) One nonvoting member who is a member of the House of Representatives at the time of appointment.

(E) The *[Chief Justice]* Governor shall appoint one voting member from among persons jointly recommended by the President of the Senate and the Speaker of the House of Representatives.

(b) When recommending and appointing members of the commission, the *[Chief Justice,]* Governor, **Chief Justice**, President of the Senate and Speaker of the House of Representatives shall:

(A) Consider input from individuals and organizations with an interest in the delivery of public defense services.

(B) Consider geographic, racial, ethnic and gender diversity.

1 (C) Ensure that members appointed to the commission have significant experience with issues
2 related to public defense or in the case types subject to representation by public defense providers.

3 (D) Ensure that members appointed to the commission have demonstrated a strong commitment
4 to quality public defense representation.

5 (c) The following persons may not be appointed to and may not serve as members of the com-
6 mission:

7 (A) A prosecuting attorney.

8 (B) A judge, magistrate or other person who performs judicial functions.

9 (C) An employee of a law enforcement agency or the Department of Human Services.

10 (d) A person who is primarily engaged in providing public defense services and who has a fi-
11 nancial interest in the delivery of public defense services at the state level may not serve as a
12 voting member of the commission.

13 (e) As used in this subsection, "law enforcement agency" means an entity that employs cor-
14 rections officers, parole and probation officers, police officers, certified reserve officers or reserve

44 [(C)] (A) Approve by majority vote the policies, procedures, standards and guidelines required
45 by ORS 151.216 before those policies, procedures, standards and guidelines may take effect.

1 [(D)] **(B)** Approve by majority vote the budget of the commission before submission to the Leg-
2 islative Assembly.

3 (7) The members of the commission may not:

4 (a) Make any decision regarding the handling of any individual case;

5 (b) Have access to any case file; or

6 (c) Interfere with the executive director or any member of the staff of the executive director in
7 carrying out professional duties involving the legal representation of public defense clients.

8 (8) A member of the commission is entitled to compensation for services as a member, and to
9 expenses, as provided in ORS 292.495.

10 **(9)(a) The Governor shall appoint an executive director of the commission, subject to**

12 **appointed as executive director must be well qualified by training and experience to perform**

3 *[(s) Pay invoices submitted to the commission within 45 days of receipt or in accordance with*
4 *statewide accounting policies established by the Oregon Department of Administrative Services.]*

5 *[(t)]* (s) Establish any other policies, procedures, standards and guidelines for the conduct of the
6 commission's affairs and promulgate policies necessary to carry out all powers and duties of the
7 commission.

8 (2) When establishing the minimum policies, procedures, standards and guidelines described in
9 this section, the commission shall adhere to the following principles:

10 (a) Appointed counsel shall be provided sufficient time and a space where attorney-client
11 confidentiality is safeguarded for meetings with clients.

12 (b) The workload of appointed counsel must be controlled to permit effective representation.
13 Economic disincentives or incentives that impair the ability of appointed counsel to provide effective
14 assistance of counsel must be avoided. The commission may develop workload controls to enhance
15 appointed counsel's ability to provide effective representation.

16 (c) The ability, training and experience of appointed counsel must match the nature and com-
17 plexity of the case to which the counsel is appointed.

18 (d) The same appointed counsel shall continuously represent a client throughout the pendency

17 (ii) One nonvoting member who is a member of the House of Representatives at the time of ap-
18 pointment.

19 (E) The Governor shall appoint one voting member from among persons jointly recommended
20 by the President of the Senate and the Speaker of the House of Representatives.

21 (b) When recommending and appointing members of the commission, the Governor, Chief Justice,
22 President of the Senate and Speaker of the House of Representatives shall:

23 (A) Consider input from individuals and organizations with an interest in the delivery of public
24 defense services.

25 (B) Consider geographic, racial, ethnic and gender diversity.

26 (C) Ensure that members appointed to the commission have significant experience with issues
27 related to public defense or in the case types subject to representation by public defense providers.

28 (D) Ensure that members appointed to the commission have demonstrated a strong commitment
29 to quality public defense representation.

30 (c) The following persons may not be appointed to and may not serve as members of the com-
31 mission:

32 (A) A prosecuting attorney.

33 (B) A judge, magistrate or other person who performs judicial functions.

34 (C) An employee of a law enforcement agency or the Department of Human Services.

35 (d) A person who is primarily engaged in providing public defense services and who has a fi-
36 nancial interest in the delivery of public defense services at the state level may not serve as a
37 voting member of the commission.

38 (e) As used in this subsection, "law enforcement agency" means an entity that employs cor-
39 rections officers, parole and probation officers, police officers, certified reserve officers or reserve
40 officers, as those terms are defined in ORS 181A.355.

41 (3) The term of a member is four years beginning on the effective date of the Governor's
42 appointment[, *but members serve at the pleasure of the Governor*]. A member is eligible for reap-
43 pointment if qualified for membership at the time of reappointment, but may serve no more than two
44 consecutive four-year terms. The Governor may remove any member of the commission at any time
45 **for inefficiency, neglect of duty or malfeasance in office.** If a vacancy occurs for any cause be-

1 fore the expiration of the term of a member, the Governor shall make an appointment to fill the
2 vacancy, in the same manner as an appointment to a full term, to become immediately effective for
3 the unexpired term.

4 (4) A chairperson and a vice chairperson shall be elected by the voting members of the com-
5 mission every two years with such functions as the commission may determine. A member is eligible
6 for reelection as chairperson or vice chairperson.

7 (5) A majority of the voting members constitutes a quorum for the transaction of business.

8 (6)(a) All members of the commission shall:

9 (A) Review the policies, procedures, standards and guidelines required by ORS 151.216 and pro-
10 vide input before the approval vote described in paragraph (b) of this subsection.

11 (B) Review the budget of the commission and provide input before the approval vote described
12 in paragraph (b) of this subsection.

13 (C) Meet as needed to carry out the duties described in this subsection.

14 (b) The voting members of the commission shall:

15 **(A) Appoint an executive director of the commission. The term of office of the executive**
16 **director is four years, but the executive director serves at the pleasure of the voting mem-**
17 **bers of the commission.**

18 [(A)] (B) Approve by majority vote the policies, procedures, standards and guidelines required
19 by ORS 151.216 before those policies, procedures, standards and guidelines may take effect.

20 [(B)] (C) Approve by majority vote the budget of the commission before submission to the Leg-
21 islative Assembly.

22 (7) The members of the commission may not:

23 (a) Make any decision regarding the handling of any individual case;

24 (b) Have access to any case file; or

25 (c) Interfere with the executive director or any member of the staff of the executive director in
26 carrying out professional duties involving the legal representation of public defense clients.

27 (8) A member of the commission is entitled to compensation for services as a member, and to
28 expenses, as provided in ORS 292.495.

29 [(9)(a) *The Governor shall appoint an executive director of the commission, subject to confirmation*
30 *by the Senate in the manner prescribed by ORS 171.562 and 171.565. The person appointed as executive*
31 *director must be well qualified by training and experience to perform the functions of the office.*]

32 [(b) *The term of office of the executive director is four years, but the executive director serves at*
33 *the pleasure of the Governor.*]

34 [(c) *Before the expiration of the executive director's term, the Governor shall appoint a successor*
35 *to take office upon the date of the expiration. The executive director is eligible for reappointment. If*
36 *there is a vacancy for any cause, the Governor shall make an appointment to become immediately ef-*
37 *fective for the unexpired term.*]

38 **SECTION 101.** ORS 151.216, as amended by sections 3, 78 and 94 of this 2023 Act, is amended
39 to read:

40 151.216. (1) The Oregon Public Defense Commission shall:

41 (a) Establish and maintain a public defense system that ensures the provision of public defense
42 services consistent with the Oregon Constitution, the United States Constitution and Oregon and
43 national standards of justice.

44 (b) Adopt policies for public defense providers that:

45 (A) Ensure compensation, resources and caseloads are in accordance with national and regional

- 1 best practices;
- 2 (B) Ensure all public defense provider contracts provide for compensation that is commensurate
- 3 with the character of service performed;
- 4 (C) Ensure funding and resources to support required data collection and training requirements;
- 5 and
- 6 (D) Recognize the need to consider overhead costs that account for the cost of living and busi-
- 7 ness cost differences in each county or jurisdiction, including but not limited to rent, professional
- 8 membership dues, malpractice insurance and other insurance and other reasonable and usual oper-
- 9 ating costs.
- 10 (c) Establish operational and contracting systems that allow for oversight, ensure transparency
- 11 and stakeholder engagement and promote equity, inclusion and culturally specific representation.
- 12 (d) Review the caseload policies described in paragraph (b)(A) of this subsection annually, and
- 13 revise the policies as necessary and at least every four years.
- 14 (e) Adopt a statewide workload plan, based on the caseload policies described in paragraph
- 15 (b)(A) of this subsection, that takes into account the needs of each county or jurisdiction, practice
- 16 structure and type of practice overseen by the commission.
- 17 (f) Submit the budget of the commission to the Legislative Assembly after the budget is submit-
- 18 ted to the commission by the executive director and approved by the voting members of the com-
- 19 mission. The chairperson of the commission shall present the budget to the Legislative Assembly.
- 20 (g) Adopt a compensation plan, classification system and affirmative action plan for the com-
- 21 mission that are commensurate with other state agencies.
- 22 (h) Adopt policies, procedures, standards and guidelines regarding:
- 23 (A) The determination of financial eligibility of persons entitled to be represented by appointed
- 24 counsel at state expense;
- 25 (B) The appointment of counsel, including the appointment of counsel at state expense regard-
- 26 less of financial eligibility in juvenile delinquency matters;
- 27 (C) The fair compensation of counsel appointed to represent a person financially eligible for
- 28 appointed counsel at state expense;
- 29 (D) Appointed counsel compensation disputes;
- 30 (E) The costs associated with the representation of a person by appointed counsel in the state
- 31 courts that are required to be paid by the state; and
- 32 (F) The types of fees and expenses subject to a preauthorization requirement.
- 33 (i) Reimburse the State Court Administrator from funds deposited in the Public Defense Services
- 34 Account established by ORS 151.225 for the costs of personnel and other costs associated with lo-
- 35 cation of eligibility verification and screening personnel pursuant to ORS 151.489 by the State Court
- 36 Administrator.
- 37 (j) Develop, adopt and oversee the implementation, enforcement and modification of policies,
- 38 procedures, minimum standards and guidelines to ensure that public defense providers are providing
- 39 effective assistance of counsel consistently to all eligible persons in this state as required by statute
- 40 and the Oregon and United States Constitutions. The policies, procedures, standards and guidelines
- 41 described in this paragraph apply to employees of the commission and to any person or entity that
- 42 contracts with the commission to provide public defense services in this state.
- 43 (k) Set minimum standards by which appointed counsel are trained and supervised.
- 44 (L) Establish a system, policies and procedures for the mandatory collection of data concerning
- 45 the operation of the commission and all public defense providers.

1 (m) Enter into contracts and hire attorneys to bring the delivery of public defense services into
2 and maintain compliance with the minimum policies, procedures, standards and guidelines described
3 in this subsection. All contracts for the provision of public defense services to which the commission
4 is a party must include a requirement for collection by the commission of data determined by the
5 commission to be qualitatively necessary for any report required to be submitted to the Legislative
6 Assembly.

7 (n) At least once every two years, report to the interim committees of the Legislative Assembly
8 related to the judiciary, in the manner provided in ORS 192.245, and to the Governor and Chief
9 Justice, concerning compliance metrics for the minimum standards described in this subsection and
10 recommendations for legislative changes.

11 (o) Develop standard operating expectations for persons and entities providing public defense
12 services.

13 (p) In consultation with the Judicial Department, ensure the existence of policies that create a
14 standardized process for determining and verifying financial eligibility for appointed counsel under
15 ORS 151.485.

16 (q) Ensure access to systematic and comprehensive training programs for attorneys for the
17 purpose of meeting statewide standards set by the commission.

18 (r) Enter into contracts or interagency agreements with the Oregon Department of Administra-
19 tive Services for the purpose of supporting state public defense population forecasts and other re-
20 lated forecasts.

21 (s) Establish any other policies, procedures, standards and guidelines for the conduct of the
22 commission's affairs and promulgate policies necessary to carry out all powers and duties of the
23 commission.

24 (2) When establishing the minimum policies, procedures, standards and guidelines described in
25 this section, the commission shall adhere to the following principles:

26 (a) Appointed counsel shall be provided sufficient time and a space where attorney-client
27 confidentiality is safeguarded for meetings with clients.

28 (b) The workload of appointed counsel must be controlled to permit effective representation.
29 Economic disincentives or incentives that impair the ability of appointed counsel to provide effective
30 assistance of counsel must be avoided. The commission may develop workload controls to enhance
31 appointed counsel's ability to provide effective representation.

32 (c) The ability, training and experience of appointed counsel must match the nature and com-
33 plexity of the case to which the counsel is appointed.

34 (d) The same appointed counsel shall continuously represent a client throughout the pendency
35 of the case and shall appear at every court appearance other than ministerial hearings.

36 (e) The commission shall establish continuing legal education requirements for public defense
37 providers who are employed by or contract with the commission that are specific to the subject
38 matter area and practice of each type of court-appointed counsel.

39 (f) The commission and public defense providers shall systematically review appointed counsel
40 for efficiency and for effective representation according to commission standards.

41 (3) The commission shall be organized in a manner for the effective delivery of public defense
42 services as prescribed by the policies and procedures created pursuant to statute to financially eli-
43 gible persons and consistent with the budgetary structure established for the commission by the
44 Legislative Assembly.

45 (4) The commission shall hire attorneys to serve as appointed counsel, including at the trial

1 level in Oregon circuit courts, and shall establish a trial division within the commission consisting
2 of attorneys employed by the commission who are trial-level public defense providers.

3 (5)(a) The commission shall establish, supervise and maintain a panel of qualified counsel who
4 contract with the commission and are directly assigned to cases. The commission shall develop a
5 process for certification of attorneys to the panel with periodic eligibility and case review. Panel
6 attorneys are not employees of the commission.

7 (b) The payment of panel counsel:

8 (A) May not be lower than the hourly rate established by the commission.

9 (B) Shall be adjusted to reflect the same percentage amount of any positive cost of living ad-
10 justment granted to employees in the management service in other executive branch agencies.

11 (C) May not provide a financial conflict of interest or economic incentives or disincentives that
12 impair an attorney's ability to provide effective representation.

13 (6)(a) The commission may enter into contracts for the provision of public defense services with
14 nonprofit public defense organizations.

15 *[(b) The commission may enter into contracts with entities that subcontract with other entities or*
16 *persons for the provision of public defense services.]*

17 *[(c)]* (b) The commission may not enter into a contract or agreement that pays appointed counsel
18 a flat fee per case.

19 (7) The policies, procedures, standards and guidelines adopted by the commission must be made
20 available in an accessible manner to the public on the commission's website.

21 (8) Policies, procedures, standards and guidelines adopted by the commission supersede any
22 conflicting rules, policies or procedures of the Public Defender Committee, State Court Administra-
23 tor, circuit courts, the Court of Appeals, the Supreme Court and the Psychiatric Security Review
24 Board related to the exercise of the commission's administrative responsibilities under this section
25 and transferred duties, functions and powers as they occur.

26 (9) The commission may accept gifts, grants or contributions from any source, whether public
27 or private. However, the commission may not accept a gift, grant or contribution if acceptance
28 would create a conflict of interest. Moneys accepted under this subsection shall be deposited in the
29 Public Defense Services Account established by ORS 151.225 and expended for the purposes for
30 which given or granted.

31 (10) With the approval of a majority of the voting members of the commission, the commission
32 may advocate for or against legislation before the Legislative Assembly or policies or budgets being
33 considered by the Legislative Assembly.

34 (11) The commission shall request that the Governor include in the Governor's requested budget,
35 for each fiscal period, at a minimum, the amount of funds identified by the commission as being
36 necessary to carry out the duties and activities of the commission.

37 (12) The commission may adopt rules pursuant to ORS chapter 183.

41 **SECTION 102. (1)(a) The amendments to ORS 151.211, 151.216 and 151.219 by sections 93**
42 **to 95 of this 2023 Act become operative on July 1, 2025.**

43 **(b) The amendments to ORS 151.213 and 151.216 by sections 100 and 101 of this 2023 Act**
44 **become operative on July 1, 2027.**

45 **(2)(a) A person who is a member of the Oregon Public Defense Commission on July 1,**

1 2027, may finish the person's term as a commission member and is eligible for reappoint-
2 ment, but, beginning July 1, 2027, may be removed by the Governor only for inefficiency,
3 neglect of duty or malfeasance in office.

4 (b) The person serving as executive director of the Oregon Public Defense Commission
5 on July 1, 2027, may finish the person's term as executive director and is eligible for reap-
6 pointment, but, beginning on July 1, 2027, serves at the pleasure of the voting members of
7 the commission.

8 (3) The Oregon Public Defense Commission, the Oregon Department of Administrative
9 Services and the Governor may take any action before the operative dates specified in sub-
10 section (1) of this section that is necessary to enable the commission to exercise, on and
11 after the operative dates specified in subsection (1) of this section, all of the duties, functions
12 and powers conferred on those entities by the amendments to ORS 151.211, 151.213, 151.216
13 and 151.219 by sections 93 to 95, 100 and 101 of this 2023 Act.

24 peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
