SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Oregon Public Defense Commission within judicial branch. Specifies appointment process for and qualification of commission members and duties of executive director and commission. Abolishes Public Defense Services Commission and transfers duties, functions and powers of commission to Oregon Public Defense Commission.

Transfers Oregon Public Defense Commission to executive branch effective January 1, 2025. Provides that Governor appoints executive director of commission, and executive director and commission members serve at pleasure of Governor until July 1, 2027. Directs Oregon Department of Administrative Services to issue state public defense population forecasts.

Directs Oregon Public Defense Commission to conduct survey and economic analysis to calculate minimum hourly pay for appointed counsel who are not employed by commission for contracts entered beginning July 1, 2027. Specifies required percentage of trial-level appointed counsel who must be employees of commission by January 1, 2031, and January 1, 2035. Effective July 1, 2025, directs commission to establish panel of qualified counsel who may be directly assigned to cases. Specifies types of contracts commission may enter into for purposes of providing public defense services. Provides that commission members appoint executive director of commission beginning July 1, 2027.

Directs Oregon Public Defense Commission to provide, to interim committees of Legislative Assembly related to judiciary, no later than May 15, 2024, comprehensive report on plan for providing public defense services. Directs commission to provide updated report on December 1, 2025, December 1, 2026, and December 1, 2027, and biennially thereafter until January 2, 2036.

Directs presiding judge of each judicial district to develop and implement coordinated public safety unrepresented defendant crisis plan, and submit plan to Oregon Criminal Justice Commission, by September 1, 2023. Directs presiding judge of judicial district of certain population to convene crisis team to assist in developing and implementing plan.

Directs Public Defense Services Commission to promulgate and disseminate guidance on crisis plans by August 15, 2023, develop training plan concerning unrepresented defendant crisis by September 1, 2023, and report to committees of Legislative Assembly by October 1, 2023.

Directs Oregon Criminal Justice Commission to report to committees of Legislative Assembly on crisis plan findings by October 1, 2023.

Appropriates moneys to Public Defense Services Commission and Judicial Department to carry out provisions of Act.

Declares emergency, effective on passage.

8 **SECTION 1.** ORS 151.211 is amended to read:

9 151.211. For purposes of ORS 151.211 to 151.221:

10 [(1) “Bar member” means an individual who is an active member of the Oregon State Bar.]

11 [(2)] (1) “Chief Justice” means the Chief Justice of the Supreme Court.

12 [(3)] (2) “Commission” means the [Public Defense Services Commission] **Oregon Public Defense**
13 **Commission.**

14 [(4) “Director” means the public defense services executive director appointed under ORS
15 151.216.]

16 [(5) “Office of public defense services” means the office established by the commission under the
17 director to handle the cases assigned and to carry out the administrative policies and procedures for
18 the public defense system.]

19 **SECTION 2.** ORS 151.213 is amended to read:

20 151.213. (1) The [Public Defense Services Commission] **Oregon Public Defense Commission** is
21 established in the judicial branch of state government. Except for the appointment or removal of
22 commission members, the commission and employees of the commission are not subject to the exer-
23 cise of administrative authority and supervision by the Chief Justice of the Supreme Court as the
24 administrative head of the Judicial Department.

25 (2)(a) [The commission consists of] Nine **voting members and four nonvoting members shall**
26 **be appointed to the commission** by order of the Chief Justice[. In addition to the nine appointed
27 members, the Chief Justice serves as a nonvoting, ex officio member. The Chief Justice shall appoint
28 at least three persons who are not bar members, at least one person who was formerly engaged in the
29 provision of public defense services and at least one person who has been formerly represented by a
30 public defense provider in this state. All members must have a demonstrated record of commitment to
31 public defense. Except for the Chief Justice or a senior judge under ORS 1.300, a member may not
32 serve concurrently as a judge, a prosecuting attorney or an employee of a law enforcement agency. A
33 person who is primarily engaged in providing public defense services may not serve as a member of
34 the commission.] **as follows:**

35 **(A) The Chief Justice shall appoint:**

36 **(i) One voting member who is a retired judge.**

37 **(ii) Two additional voting members, one of whom has experience as a public defense**
38 **provider in criminal cases.**

39 **(B) The Chief Justice shall appoint, from among persons recommended by the Governor:**

40 **(i) One voting member who has been represented by a public defense provider.**

41 **(ii) Two additional voting members, one of whom has experience as a public defense**
42 **provider in juvenile delinquency or dependency cases.**

43 **(iii) Two nonvoting members who are currently employed as public defense providers in**
44 **this state, one of whom is from an urban area and one of whom is from a rural area.**

45 **(C) The Chief Justice shall appoint, from among persons recommended by the President**

22 (c) **The following persons may not be appointed to and may not serve as members of the**

24 (A) **A prosecuting attorney.**

25 (B) **A judge, magistrate or other person who performs judicial functions.**

26 (C) **An employee of a law enforcement agency or the Department of Human Services.**

27 (d) **A person who is primarily engaged in providing public defense services and who has**
28 **a financial interest in the delivery of public defense services at the state level may not serve**
29 **as a voting member of the commission.**

30 (e) **As used in this subsection, “law enforcement agency” means an entity that employs**
31 **corrections officers, parole and probation officers, police officers, certified reserve officers**
32 **or reserve officers, as those terms are defined in ORS 181A.355.**

33 (3) **The term of a member is four years beginning on the effective date of the order of the Chief**
34 **Justice appointing the member. A member is eligible for reappointment if qualified for membership**
35 **at the time of reappointment, but may serve no more than two consecutive four-year terms.**
36 *[A member may be removed from the commission by order of the Chief Justice.]* **The Chief Justice**
37 **may remove any member of the commission at any time for cause. If a vacancy occurs for any**
38 **cause before the expiration of the term of a member, the Chief Justice shall make an appointment**
39 **to fill the vacancy, in the same manner as an appointment to a full term, to become imme-**
40 **diately effective for the unexpired term. If the Chief Justice has not filled a vacancy within 45**
41 **days after the vacancy occurs, the remaining voting members of the commission shall, by a**
42 **majority vote, select a member to fill the vacancy for the remainder of the term. The se-**
43 **lected member must meet the requirements for membership described in this section.**

44 (4) **A chairperson and a vice chairperson shall be** *[appointed by order of the Chief Justice]*
45 **elected by the voting members of the commission every two years with such functions as the**

1 commission may determine. A member is eligible for *[reappointment]* **reelection** as chairperson or
2 vice chairperson.

28 *[(6)]* **(8) A member of the commission is [not] entitled to compensation for services as a member,**
29 **[but is entitled] and to expenses, as provided in ORS 292.495 [(2)].**

30 **SECTION 3. ORS 151.216 is amended to read:**

31 **151.216. (1) The *[Public Defense Services Commission]* **Oregon Public Defense Commission****
32 **shall:**

33 **(a) Establish and maintain a public defense system that ensures the provision of public defense**
34 **services consistent with the Oregon Constitution, the United States Constitution and Oregon and**
35 **national standards of justice.**

36 ***[(b) Establish an office of public defense services and appoint a public defense services executive***
37 ***director who serves at the pleasure of the commission.]***

38 ***[(c)]* **(b) Adopt policies for *[contracting for]* public defense providers *[not employed by the office*****
39 ***of public defense services]* that:**

40 **(A) Ensure compensation, resources and caseloads are in accordance with national and regional**
41 **best practices;**

42 **(B) *[Promote policies for public defense provider compensation and resources that are comparable***
43 ***to prosecution compensation and resources]* **Ensure all public defense provider contracts provide**
44 **for compensation that is commensurate with the character of service performed;****

45 **(C) Ensure funding and resources to support required data collection and training requirements;**

2 (D) Recognize the need to consider overhead costs that account for the cost of living and busi-
3 ness cost differences in each county or jurisdiction, including but not limited to rent, professional
4 membership dues, malpractice insurance and other insurance and other reasonable and usual oper-
5 ating costs.

6 [(d)] (c) Establish operational and contracting systems that allow for oversight, ensure trans-
7 parency and stakeholder engagement and promote equity, inclusion and culturally specific repre-
8 sentation.

9 [(e)] (d) Review the caseload policies described in paragraph [(c)(A)] (b)(A) of this subsection
10 annually, and revise the policies as necessary and at least every four years.

11 [(f)] (e) Adopt a statewide workload plan, based on the caseload policies described in paragraph
12 [(c)(A)] (b)(A) of this subsection, that takes into account the needs of each county or jurisdiction,
13 practice structure and type of practice overseen by the *[office of public defense services]*
14 **commission**.

15 [(g)] (f) Submit the budget of the commission *[and the office of public defense services]* to the
16 Legislative Assembly after the budget is submitted to the commission by the **executive** director and

45 *[(J) Any other matters necessary to carry out the duties of the commission.]*

1 *[(k) Establish a peer review system for the approval of nonroutine fees and expenses incurred in*
2 *cases involving aggravated murder and the crimes listed in ORS 137.700 and 137.707. The review shall*
3 *be conducted by a panel of attorneys who practice in the area of criminal defense.]*

4 *[(L) Establish a complaint process that allows district attorneys, criminal defense counsel and the*
5 *public to file complaints concerning the payment from public funds of nonroutine fees and expenses*
6 *incurred in cases.]*

7 *[(m)] (i) Reimburse the State Court Administrator from funds deposited in the Public Defense*
8 *Services Account established by ORS 151.225 for the costs of personnel and other costs associated*
9 *with location of eligibility verification and screening personnel pursuant to ORS 151.489 by the State*
10 *Court Administrator.*

11 **(j) Develop, adopt and oversee the implementation, enforcement and modification of pol-**
12 **icies, procedures, minimum standards and guidelines to ensure that public defense providers**

26 **port required to be submitted to the Legislative Assembly.**

27 **(n) At least once every two years, report to the interim committees of the Legislative**
28 **Assembly related to the judiciary, in the manner provided in ORS 192.245, and to the Gover-**
29 **nor and Chief Justice, concerning compliance metrics for the minimum standards described**
30 **in this subsection and recommendations for legislative changes.**

31 **(o) Develop standard operating expectations for persons and entities providing public de-**
32 **fense services.**

33 **(p) In consultation with the Judicial Department, ensure the existence of policies that**
34 **create a standardized process for determining and verifying financial eligibility for appointed**
35 **counsel under ORS 151.485.**

36 **(q) Ensure access to systematic and comprehensive training programs for attorneys for**
37 **the purpose of meeting statewide standards set by the commission.**

38 **(r) Enter into contracts or interagency agreements with the Oregon Department of Ad-**
39 **ministrative Services for the purpose of supporting state public defense population forecasts**
40 **and other related forecasts.**

41 **(s) Pay invoices submitted to the commission within 45 days of receipt or in accordance**
42 **with statewide accounting policies established by the Oregon Department of Administrative**
43 **Services.**

44 **(t) Establish any other policies, procedures, standards and guidelines for the conduct of**
45 **the commission's affairs and promulgate policies necessary to carry out all powers and du-**

1 **ties of the commission.**

2 **(2) When establishing the minimum policies, procedures, standards and guidelines de-**
3 **scribed in this section, the commission shall adhere to the following principles:**

4 **(a) Appointed counsel shall be provided sufficient time and a space where attorney-client**
5 **confidentiality is safeguarded for meetings with clients.**

6 **(b) The workload of appointed counsel must be controlled to permit effective represen-**
7 **tation. Economic disincentives or incentives that impair the ability of appointed counsel to**
8 **provide effective assistance of counsel must be avoided. The commission may develop work-**
9 **load controls to enhance appointed counsel's ability to provide effective representation.**

10 **(c) The ability, training and experience of appointed counsel must match the nature and**
11 **complexity of the case to which the counsel is appointed.**

12 **(d) The same appointed counsel shall continuously represent a client throughout the**
13 **pendency of the case and shall appear at every court appearance other than ministerial**
14 **hearings.**

15 **(e) The commission shall establish continuing legal education requirements for public**
16 **defense providers who are employed by or contract with the commission that are specific to**
17 **the subject matter area and practice of each type of court-appointed counsel.**

18 **(f) The commission and public defense providers shall systematically review appointed**
19 **counsel for efficiency and for effective representation according to commission standards.**

20 **(3) The commission shall be organized in a manner for the effective delivery of public**
21 **defense services as prescribed by the policies and procedures created pursuant to statute to**
22 **financially eligible persons and consistent with the budgetary structure established for the**
23 **commission by the Legislative Assembly.**

24 **(4) The commission shall hire attorneys to serve as appointed counsel, including at the**
25 **trial level in Oregon circuit courts, and may establish a trial division within the commission**
26 **consisting of attorneys employed by the commission who are trial-level public defense pro-**
27 **viders.**

28 **(5) The policies, procedures, standards and guidelines adopted by the commission must**
29 **be made available in an accessible manner to the public on the commission's website.**

30 **[(2)] (6) Policies, procedures, standards and guidelines adopted by the commission supersede any**
31 **conflicting rules, policies or procedures of the Public Defender Committee, State Court Administra-**
32 **tor, circuit courts, the Court of Appeals, the Supreme Court and the Psychiatric Security Review**
33 **Board related to the exercise of the commission's administrative responsibilities under this section**
34 **and transferred duties, functions and powers as they occur.**

35 **[(3)] (7) The commission may accept gifts, grants or contributions from any source, whether**
36 **public or private. However, the commission may not accept a gift, grant or contribution if accept-**
37 **ance would create a conflict of interest. Moneys accepted under this subsection shall be deposited**
38 **in the Public Defense Services Account established by ORS 151.225 and expended for the purposes**
39 **for which given or granted.**

1 151.219. (1) The *[public defense services]* executive director **of the Oregon Public Defense**

5 **(b) Hire necessary staff for the commission.**

6 *[(a)] (c)* Recommend to the *[Public Defense Services]* commission how to establish and maintain,
 7 in a cost-effective manner, the delivery of legal services to persons entitled to, and, where applica-
 8 ble, financially eligible for, appointed counsel at state expense under Oregon statutes, the Oregon
 9 Constitution, the United States Constitution and consistent with Oregon and national standards of
 10 justice.

11 *[(b)] (d)* Implement and ensure compliance with contracts, policies, procedures, standards and
 12 guidelines adopted by the commission or required by statute.

13 *[(c)] (e)* Prepare and submit to the commission for its approval the biennial budget of the com-

1 **SECTION 6.** ORS 151.225 is amended to read:

2 151.225. (1) The Public Defense Services Account is established in the State Treasury, separate
3 and distinct from the General Fund. The Public Defense Services Account is continuously appropri-
4 ated to the [*Public Defense Services Commission*] **Oregon Public Defense Commission** for:

5 (a) Administration and support of the public defense system;

6 (b) Reimbursement of the State Court Administrator under ORS 151.216 [(1)(m)] **(1)(i)**; and

7 (c) Legal representation of parents and children involved in foster care for which matching
8 funds under 45 C.F.R. 1356.60(c) may be used.

9 (2) The following moneys shall be deposited in the Public Defense Services Account:

10 (a) Moneys received by the commission from the State Court Administrator under ORS 151.216
11 [(1)(m)] **(1)(i)**;

12 (b) Moneys received by the Judicial Department under ORS 135.050 (8), 151.487 (1), 419A.211 or
13 419B.198 (1);

14 (c) Federal matching funds received under 45 C.F.R. 1356.60(c); and

15 (d) Miscellaneous revenues and receipts of the commission.

16 (3) All gifts, grants or contributions accepted by the commission under ORS 151.216 shall be
17 deposited in a separate subaccount created in the Public Defense Services Account to be used by
18 the commission for the purpose for which the gift, grant or contribution was given or granted.

19 **SECTION 7.** ORS 135.055 is amended to read:

20 135.055. (1) Counsel appointed pursuant to ORS 135.045 or 135.050 shall be paid fair compen-
21 sation for representation in the case:

22 (a) By the county, subject to the approval of the governing body of the county, in a proceeding
23 in a county or justice court.

24 (b) By the [*public defense services*] executive director **of the Oregon Public Defense Commis-**
25 **sion** from funds available for the purpose, in a proceeding in a circuit court.

26 (2) Except for counsel appointed pursuant to contracts or counsel employed by the [*public de-*
27 *fense services executive director*] **Oregon Public Defense Commission**, compensation payable to
28 appointed counsel under subsection (1) of this section:

29 (a) In a proceeding in a county or justice court may not be less than \$30 per hour.

30 (b) In a proceeding in a circuit court is subject to the applicable compensation established under
31 ORS 151.216.

32 (3)(a) A person determined to be eligible for appointed counsel is entitled to necessary and
33 reasonable fees and expenses for investigation, preparation and presentation of the case for trial,
34 negotiation and sentencing. The person or the counsel for the person shall upon written request
35 secure preauthorization to incur fees and expenses that [*are not routine to representation but*] are
36 necessary and reasonable in the investigation, preparation and presentation of the case **and that**
37 **require preauthorization under a policy of the Oregon Public Defense Commission**, including
38 but not limited to [*nonroutine*] travel, photocopying or other reproduction of [*nonroutine*] documents,
39 necessary costs associated with obtaining the attendance of witnesses for the defense, investigator
40 fees and expenses, expert witness fees and expenses and fees for interpreters and assistive commu-
41 nication devices necessary for the purpose of communication between counsel and a client or wit-
42 ness in the case. Preauthorization to incur a fee or expense does not guarantee that a fee or
43 expense incurred pursuant to the preauthorization will be determined to be necessary or reasonable
44 when the fee or expense is submitted for payment.

45 (b) In a county or justice court, the request must be in the form of a motion to the court. The

1 motion must be accompanied by a supporting affidavit that sets out in detail the purpose of the re-
2 quested expenditure, the name of the service provider or other recipient of the funds, the dollar
3 amount of the requested expenditure that may not be exceeded without additional authorization and
4 the date or dates during which the service will be rendered or events will occur for which the ex-
5 penditure is requested.

6 (c) In a circuit court, the request must be in the form and contain the information that is re-

3 **SECTION 8.** (1) The Public Defense Services Commission is abolished. On the operative
4 date of this section, the tenure of office of the members of the Public Defense Services
5 Commission ceases.

(c) "Lawyer" means a person authorized, or reasonably believed by the client to be authorized,

1 to practice law in any state or nation.

2 (d) "Lawyer referral service" means an entity that, as a regular part of its business, refers po-
3 tential clients to lawyers, including but not limited to a public nonprofit entity sponsored or oper-
4 ated by the Oregon State Bar.

5 (e) "Representative of the client" means:

6 (A) A principal, an officer or a director of the client; or

7 (B) A person who has authority to obtain professional legal services, or to act on legal advice
8 rendered, on behalf of the client, or a person who, for the purpose of effectuating legal represen-
9 tation for the client, makes or receives a confidential communication while acting in the person's
10 scope of employment for the client.

11 (f) "Representative of the lawyer" means one employed to assist the lawyer in the rendition of
12 professional legal services, but does not include a physician making a physical or mental examina-
13 tion under ORCP 44.

14 (2) A client has a privilege to refuse to disclose and to prevent any other person from disclosing
15 confidential communications made for the purpose of facilitating the rendition of professional legal
16 services to the client:

17 (a) Between the client or the client's representative and the client's lawyer or a representative
18 of the lawyer;

19 (b) Between the client's lawyer and the lawyer's representative or the client's lawyer referral

14 consistent with the policies and notice requirements of the court or agency relating to the appoint-
15 ment and scheduling of interpreters. If the substitution of another interpreter will delay the pro-
16 ceeding, the person making the request must show good cause for the substitution. Any party may
17 object to use of any interpreter for good cause. Unless the court, hearing officer or the designee of

14 (7) The provisions of this section shall apply in favor of the defendant in a criminal action or
15 the petitioner in a proceeding pursuant to ORS 138.510 to 138.680 when the person is respondent in
16 an appeal taken by the state in a criminal action or by the defendant in a proceeding pursuant to
17 ORS 138.510 to 138.680.

18 (8) As used in this section, "criminal action" does not include an action that involves only vio-
19 lations.

20 (9) As used in subsection (4) of this section, "counsel" includes a legal advisor appointed under
21 ORS 138.504.

22 **SECTION 31.** ORS 138.590 is amended to read:

23 138.590. (1) Any petitioner who is unable to pay the expenses of a proceeding pursuant to ORS
24 138.510 to 138.680 or to employ suitable counsel possessing skills and experience commensurate with

11 (8)(a) Except as otherwise provided in this subsection, the appellant shall serve and file the no-

13 (4) of this section within seven days after the date the trial court entered the order being appealed.

14 (b) An appellant who seeks to appeal an order issued under ORS 147.530 and who was not pro-

12 branch of state government. Except for the appointment or removal of commission members, the
13 commission and employees of the commission are not subject to the exercise of administrative au-
14 thority and supervision by the *[Chief Justice of the Supreme Court as the administrative head of the*
15 *Judicial Department]* **Governor**.

16 (2)(a) Nine voting members and four nonvoting members shall be appointed to the commission
17 by *[order of the Chief Justice]* **the Governor** as follows:

18 **(A) The Governor shall appoint:**

19 **(i) One voting member who has been represented by a public defense provider.**

20 **(ii) Two additional voting members, one of whom has experience as a public defense**
21 **provider in juvenile delinquency or dependency cases.**

22 **(iii) Two nonvoting members who are currently employed as public defense providers in**
23 **this state, one of whom is from an urban area and one of whom is from a rural area.**

24 *[(A)]* **(B) The Governor shall appoint, from among persons recommended by the Chief**

26 (i) One voting member who is a retired judge.

27 (ii) Two additional voting members, one of whom has experience as a public defense provider in

29 *[(B) The Chief Justice shall appoint, from among persons recommended by the Governor:]*

31 *[(ii) Two additional voting members, one of whom has experience as a public defense provider in*
32 *juvenile delinquency or dependency cases.]*

33 *[(iii) Two nonvoting members who are currently employed as public defense providers in this state,*

35 **(C) The** *[Chief Justice]* **Governor** shall appoint, from among persons recommended by the Presi-
36 dent of the Senate:

37 (i) One voting member who is a current dean or faculty member of an Oregon law school.

39 **(D) The** *[Chief Justice]* **Governor** shall appoint, from among persons recommended by the

41 (i) One voting member who has expertise in juvenile law and criminal defense, or who is a ju-

8 lated forecasts.

9 *[(s) Pay invoices submitted to the commission within 45 days of receipt or in accordance with*
10 *statewide accounting policies established by the Oregon Department of Administrative Services.]*

11 *[(t)]* (s) Establish any other policies, procedures, standards and guidelines for the conduct of the
12 commission's affairs and promulgate policies necessary to carry out all powers and duties of the
13 commission.

14 (2) When establishing the minimum policies, procedures, standards and guidelines described in
15 this section, the commission shall adhere to the following principles:

16 (a) Appointed counsel shall be provided sufficient time and a space where attorney-client
17 confidentiality is safeguarded for meetings with clients.

18 (b) The workload of appointed counsel must be controlled to permit effective representation.
19 Economic disincentives or incentives that impair the ability of appointed counsel to provide effective
20 assistance of counsel must be avoided. The commission may develop workload controls to enhance

44 **(b) The commission may conduct the survey and economic analysis internally or may**
45 **contract with an outside entity. The survey and economic analysis must be completed and**

1 the hourly pay rate calculated no later than July 1, 2025.

2 (c) After the hourly pay rate described in paragraph (a) of this subsection has been cal-
3 culated, and beginning with contracts entered into on or after July 1, 2027, the hourly pay
4 for appointed counsel who are not employees of the commission or a nonprofit public defense
5 organization may not be lower than that amount.

6 (d) The commission may conduct another survey and economic analysis as described in
7 this subsection to establish a new formula and calculate a new hourly pay rate.

8 (2)(a) By January 1, 2031, at least 20 percent of all appointed counsel at the trial level
9 must be attorneys employed by the Oregon Public Defense Commission.

10 (b) By January 1, 2035, at least 30 percent of all appointed counsel at the trial level must
11 be attorneys employed by the Oregon Public Defense Commission.

22 (i) One voting member who has expertise in juvenile law and criminal defense, or who is a ju-
23 venile justice or criminal justice reform advocate.

24 (ii) One nonvoting member who is a member of the House of Representatives at the time of ap-
25 pointment.

26 (E) The Governor shall appoint one voting member from among persons jointly recommended
27 by the President of the Senate and the Speaker of the House of Representatives.

28 (b) When recommending and appointing members of the commission, the Governor, Chief Justice,
29 President of the Senate and Speaker of the House of Representatives shall:

30 (A) Consider input from individuals and organizations with an interest in the delivery of public
31 defense services.

32 (B) Consider geographic, racial, ethnic and gender diversity.

33 (C) Ensure that members appointed to the commission have significant experience with issues
34 related to public defense or in the case types subject to representation by public defense providers.

35 (D) Ensure that members appointed to the commission have demonstrated a strong commitment
36 to quality public defense representation.

37 (c) The following persons may not be appointed to and may not serve as members of the com-
38 mission:

39 (A) A prosecuting attorney.

40 (B) A judge, magistrate or other person who performs judicial functions.

41 (C) An employee of a law enforcement agency or the Department of Human Services.

42 (d) A person who is primarily engaged in providing public defense services and who has a fi-
43 nancial interest in the delivery of public defense services at the state level may not serve as a
44 voting member of the commission.

45 (e) As used in this subsection, "law enforcement agency" means an entity that employs cor-

1 rections officers, parole and probation officers, police officers, certified reserve officers or reserve
2 officers, as those terms are defined in ORS 181A.355.

3 (3) The term of a member is four years beginning on the effective date of the Governor's
4 appointment[, *but members serve at the pleasure of the Governor*]. A member is eligible for reap-
5 pointment if qualified for membership at the time of reappointment, but may serve no more than two
6 consecutive four-year terms. The Governor may remove any member of the commission at any time
7 **for inefficiency, neglect of duty or malfeasance in office**. If a vacancy occurs for any cause be-
8 fore the expiration of the term of a member, the Governor shall make an appointment to fill the

21 (e) Adopt a statewide workload plan, based on the caseload policies described in paragraph

25 ted to the commission by the executive director and approved by the voting members of the com-

44 (j) Develop, adopt and oversee the implementation, enforcement and modification of policies,
45 procedures, minimum standards and guidelines to ensure that public defense providers are providing

1 effective assistance of counsel consistently to all eligible persons in this state as required by statute
2 and the Oregon and United States Constitutions. The policies, procedures, standards and guidelines
3 described in this paragraph apply to employees of the commission and to any person or entity that
4 contracts with the commission to provide public defense services in this state.

5 (k) Set minimum standards by which appointed counsel are trained and supervised.

6 (L) Establish a system, policies and procedures for the mandatory collection of data concerning
7 the operation of the commission and all public defense providers.

8 (m) Enter into contracts and hire attorneys to bring the delivery of public defense services into
9 and maintain compliance with the minimum policies, procedures, standards and guidelines described
10 in this subsection. All contracts for the provision of public defense services to which the commission
11 is a party must include a requirement for collection by the commission of data determined by the
12 commission to be qualitatively necessary for any report required to be submitted to the Legislative
13 Assembly.

14 (n) At least once every two years, report to the interim committees of the Legislative Assembly
15 related to the judiciary, in the manner provided in ORS 192.245, and to the Governor and Chief
16 Justice, concerning compliance metrics for the minimum standards described in this subsection and
17 recommendations for legislative changes.

18 (o) Develop standard operating expectations for persons and entities providing public defense
19 services.

20 (p) In consultation with the Judicial Department, ensure the existence of policies that create a
21 standardized process for determining and verifying financial eligibility for appointed counsel under
22 ORS 151.485.

23 (q) Ensure access to systematic and comprehensive training programs for attorneys for the
24 purpose of meeting statewide standards set by the commission.

25 (r) Enter into contracts or interagency agreements with the Oregon Department of Administra-
26 tive Services for the purpose of supporting state public defense population forecasts and other re-
27 lated forecasts.

28 (s) Establish any other policies, procedures, standards and guidelines for the conduct of the
29 commission's affairs and promulgate policies necessary to carry out all powers and duties of the
30 commission.

31 (2) When establishing the minimum policies, procedures, standards and guidelines described in
32 this section, the commission shall adhere to the following principles:

33 (a) Appointed counsel shall be provided sufficient time and a space where attorney-client
34 confidentiality is safeguarded for meetings with clients.

35 (b) The workload of appointed counsel must be controlled to permit effective representation.
36 Economic disincentives or incentives that impair the ability of appointed counsel to provide effective
37 assistance of counsel must be avoided. The commission may develop workload controls to enhance
38 appointed counsel's ability to provide effective representation.

39 (c) The ability, training and experience of appointed counsel must match the nature and com-
40 plexity of the case to which the counsel is appointed.

41 (d) The same appointed counsel shall continuously represent a client throughout the pendency
42 of the case and shall appear at every court appearance other than ministerial hearings.

43 (e) The commission shall establish continuing legal education requirements for public defense
44 providers who are employed by or contract with the commission that are specific to the subject
45 matter area and practice of each type of court-appointed counsel.

1 (f) The commission and public defense providers shall systematically review appointed counsel
2 for efficiency and for effective representation according to commission standards.

3 (3) The commission shall be organized in a manner for the effective delivery of public defense
4 services as prescribed by the policies and procedures created pursuant to statute to financially eli-
5 gible persons and consistent with the budgetary structure established for the commission by the
6 Legislative Assembly.

7 (4) The commission shall hire attorneys to serve as appointed counsel, including at the trial
8 level in Oregon circuit courts, and shall establish a trial division within the commission consisting
9 of attorneys employed by the commission who are trial-level public defense providers.

10 (5)(a) The commission shall establish, supervise and maintain a panel of qualified counsel who
11 contract with the commission and are directly assigned to cases. The commission shall develop a
12 process for certification of attorneys to the panel with periodic eligibility and case review. Panel
13 attorneys are not employees of the commission.

14 (b) The payment of panel counsel:

15 (A) May not be lower than the hourly rate established by the commission.

16 (B) Shall be adjusted to reflect the same percentage amount of any positive cost of living ad-
17 justment granted to employees in the management service in other executive branch agencies.

18 (C) May not provide a financial conflict of interest or economic incentives or disincentives that
19 impair an attorney's ability to provide effective representation.

20 (6)(a) The commission may enter into contracts for the provision of public defense services with
21 nonprofit public defense organizations.

22 *[(b) The commission may enter into contracts with entities that subcontract with other entities or*
23 *persons for the provision of public defense services.]*

24 *[(c)]* (b) The commission may not enter into a contract or agreement that pays appointed counsel
25 a flat fee per case.

26 (7) The policies, procedures, standards and guidelines adopted by the commission must be made
27 available in an accessible manner to the public on the commission's website.

28 (8) Policies, procedures, standards and guidelines adopted by the commission supersede any
29 conflicting rules, policies or procedures of the Public Defender Committee, State Court Administra-
30 tor, circuit courts, the Court of Appeals, the Supreme Court and the Psychiatric Security Review
31 Board related to the exercise of the commission's administrative responsibilities under this section
32 and transferred duties, functions and powers as they occur.

33 (9) The commission may accept gifts, grants or contributions from any source, whether public
34 or private. However, the commission may not accept a gift, grant or contribution if acceptance
35 would create a conflict of interest. Moneys accepted under this subsection shall be deposited in the
36 Public Defense Services Account established by ORS 151.225 and expended for the purposes for
37 which given or granted.

38 (10) With the approval of a majority of the voting members of the commission, the commission
39 may advocate for or against legislation before the Legislative Assembly or policies or budgets being
40 considered by the Legislative Assembly.

SECTION 102. (1)(a) The amendments to ORS 151.211, 151.216 and 151.219 by sections 93 to 95 of this 2023 Act become operative on July 1, 2025.

(3) The Oregon Public Defense Commission, the Oregon Department of Administrative Services and the Governor may take any action before the operative dates specified in subsection (1) of this section that is necessary to enable the commission to exercise, on and after the operative dates specified in subsection (1) of this section, all of the duties, functions and powers conferred on those entities by the amendments to ORS 151.211, 151.213, 151.216 and 151.219 by sections 93 to 95, 100 and 101 of this 2023 Act.

UNREPRESENTED DEFENDANT CRISIS PLANS

SECTION 103. The Legislative Assembly finds that:

(1) Oregonians accused of a crime are entitled, under the Sixth and Fourteenth Amendments of the United States Constitution, and Article I, section 11, of the Oregon Constitution, to have an attorney provided at government expense whenever the person is facing the potential loss of liberty and is unable to afford an attorney.

(2) The current unrepresented defendant crisis represents a threat to the constitutional rights of Oregonians and must be resolved.

SECTION 104. (1)(a) The presiding judge of each judicial district shall immediately develop and implement a coordinated public safety unrepresented defendant crisis plan, and submit the plan to the Oregon Criminal Justice Commission, as soon as practicable and no later than September 1, 2023.

(b) The plan described in this subsection must first prioritize the resolution of the cases of unrepresented defendants who are in custody, and then the cases of unrepresented defendants who are out of custody.

(2) The presiding judge of a judicial district with a total population of over 100,000 shall immediately convene a crisis team to assist in the development of the plan and to coordinate the implementation of the plan described in subsection (1) of this section. The team shall be composed of at least the following persons:

(a) The presiding judge of the judicial district;

(b) District attorneys within the judicial district; and

(c) The public defense services executive director, or the director's designee.

(3) The Chief Justice of the Supreme Court may issue orders related to resolving the

1 unrepresented defendant crisis.

2 (4) The presiding judge of a judicial district may enter standing orders related to resolv-
3 ing the unrepresented defendant crisis that are consistent with the orders of the Chief Jus-
4 tice described in subsection (3) of this section and the plan of the judicial district described
5 in subsection (1) of this section.

6 **SECTION 105.** The Public Defense Services Commission shall:

7 (1) By no later than August 15, 2023, promulgate and disseminate guidance for the judicial
8 district coordinated public safety unrepresented defendant crisis plans described in section
9 104 of this 2023 Act.

10 (2) By no later than September 1, 2023, develop a training plan for public defense pro-
11 viders specific to the unrepresented defendant crisis, in consultation and cooperation with
12 public defense provider associations and organizations.

13 (3) By no later than October 1, 2023, report to the Joint Interim Committee on Ways and
14 Means and the interim committees of the Legislative Assembly related to the judiciary, in
15 the manner provided in ORS 192.245, on the commission's progress in carrying out the pro-
16 visions described in subsections (1) and (2) of this section.

17 **SECTION 106.** The Oregon Criminal Justice Commission shall conduct a review of each
18 judicial district's coordinated public safety unrepresented defendant crisis plan submitted to
19 the commission under section 104 of this 2023 Act. The commission shall report the
20 commission's findings to the Joint Interim Committee on Ways and Means and the interim
21 committees of the Legislative Assembly related to the judiciary, in the manner provided in
22 ORS 192.245, no later than October 1, 2023.

23 **SECTION 107.** All agencies of state government, as defined in ORS 174.111, are directed
24 to assist the presiding judges of judicial districts, the Public Defense Services Commission
25 and the Oregon Criminal Justice Commission in the performance of their duties under
26 sections 104 to 106 of this 2023 Act and, to the extent permitted by laws relating to
27 confidentiality, to furnish such information and advice to the judges and commissions nec-
28 essary to perform their duties.

EMERGENCY CLAUSE

SECTION 123. This 2023 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect on its passage.
