

HOUSE AMENDMENTS TO RESOLVE CONFLICTS TO A-ENGROSSED SENATE BILL 406

1 On page 4 of the printed A-engrossed bill, after line 26, insert:

2 “**SECTION 4a. If House Bill 2889 becomes law, section 4 of this 2023 Act (amending sec-**
3 **tion 1, chapter 13, Oregon Laws 2023 (Enrolled House Bill 2001)) is repealed and section 1,**
4 **chapter 13, Oregon Laws 2023 (Enrolled House Bill 2001), as amended by section 1, chapter**
5 **___, Oregon Laws 2023 (Enrolled House Bill 2889), is amended to read:**

6 “**Sec. 1.** (1) There is established within the Oregon Department of Administrative Services the
7 Oregon Housing Needs Analysis. The purposes of the Oregon Housing Needs Analysis are to further
8 the:

9 “(a) Production of housing to meet the need of Oregonians at all levels of affordability; and

10 “(b) Production of housing in a way that creates more housing choice by affirmatively furthering
11 fair housing, as defined in ORS 197.290.

12 “(2) The Oregon Housing Needs Analysis consists of three components as follows:

13 “(a) The annual statewide housing analysis under section 2 (1), chapter 13, Oregon Laws 2023
14 (Enrolled House Bill 2001);

15 “(b) The allocated housing need under section 2 (2), chapter 13, Oregon Laws 2023 (Enrolled
16 House Bill 2001); and

17 “(c) The housing production targets under section 3, chapter 13, Oregon Laws 2023 (Enrolled
18 House Bill 2001).

19 “(3) Actions taken by the department under sections 1 to 3, chapter 13, Oregon Laws 2023 (En-
20 rolled House Bill 2001), are not subject to ORS 197.180 and are not land use decisions.

21 “(4) The Department of Land Conservation and Development and the Housing and Community
22 Services Department:

23 “(a) Shall assist the Oregon Department of Administrative Services with its duties under
24 sections 1 to 3, chapter 13, Oregon Laws 2023 (Enrolled House Bill 2001).

25 “(b) May study and recommend methodological changes to the Oregon Department of Adminis-
26 trative Services to improve the Oregon Housing Needs Analysis’ functions and suitability for its
27 purposes under subsection (1) of this section. The departments shall solicit written and oral public
28 testimony to inform their recommendations.

29 “(5) As used in sections 1 to 3, chapter 13, Oregon Laws 2023 (Enrolled House Bill 2001), ‘city’
30 or ‘city with a population of 10,000 or greater’ includes **cities, as defined in ORS 197.286, and ur-**
31 **ban unincorporated communities in Metro, as defined in ORS 197.015.”.**

32 After line 45, insert:

33 “**SECTION 5a. If House Bill 2889 becomes law, section 5 of this 2023 Act (amending sec-**
34 **tion 4, chapter 13, Oregon Laws 2023 (Enrolled House Bill 2001)) is repealed.”.**
