A-Engrossed Senate Bill 491

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires health insurance coverage of specified fertility services and treatments with exemption for certain insurers.

Requires Oregon Health Authority to contract with health insurance carrier or third party administrator to provide infertility coverage to enrollees in exempt plans. Imposes fee on exempt plans to pay for cost of coverage.

Directs Oregon Health Authority and Department of Consumer and Business Services to study access to fertility and reproductive endocrinology services and report findings to interim committees of Legislative Assembly related to health.

Declares emergency, effective on passage.

2 Relating to infertility; creating new provisions; amending ORS 646A.628, 731.804 and 743B.005; and

4 Whereas according to the federal Centers for Disease Control and Prevention, over 12 percent

5 of women in the United States who are of reproductive age have difficulty becoming pregnant or

6 carrying a pregnancy to term; and

7 Whereas infertility is evenly divided between men and women and approximately one-third of 8 cases of infertility involve both partners being diagnosed or are unexplained; and

9 Whereas increasing accessibility for infertility treatment will expand health services in this 10 state and improve the short-term and long-term outcomes for the resulting children and mothers,

11 which may also reduce health care costs by reducing adverse outcomes; and

12 Whereas access to insurance coverage reduces health disparities for racial and ethnic minorities

13 as well as for lesbian, gay, bisexual, transgender and queer individuals; now, therefore,

14 Be It Enacted by the People of the State of Oregon:

<u>SECTION 1.</u> Section 2 of this 2023 Act is added to and made a part of the Insurance Code.
 SECTION 2. (1) As used in this section, "infertility" means:

(a) A disease, condition or status that results in a failure to establish a pregnancy or to
 carry a pregnancy to a live birth after regular, unprotected sexual intercourse for:

- 19 (A) Twelve months for a woman under the age of 35; or
- 20 (B) Six months for a woman 35 years of age or older; or

21 (b) An individual's inability, without medical intervention, to reproduce either as a single

22 person or with the person's partner.

23 (2) Health benefit plans offered in this state to large or small employers and individual

health benefit plans offered in this state shall reimburse the cost of: 1 2 (a) Procedures and medications to address infertility recommended by a licensed treating practitioner that are: 3 (A) Based on the practitioner's physical findings and diagnostic testing and an 4 individual's medical history, sexual history, reproductive history and age; and 5 (B) Consistent with established, published or approved medical practices or professional 6 guidelines from the American College of Obstetricians and Gynecologists or the American 7 Society for Reproductive Medicine, or a successor organization. 8 9 (b) Procedures recommended by a licensed treating practitioner, including but not limited to the storage of reproductive specimens for the period of time deemed medically necessary 10 by the practitioner, that are: 11 12 (A) Based on the practitioner's physical findings and diagnostic testing and an 13 individual's medical history, sexual history, reproductive history and age; and (B) Consistent with established medical practices or professional guidelines published by 14 15 the American Society for Reproductive Medicine or the American Society of Clinical 16 Oncology, or a successor organization, for an individual who is at risk of infertility due to: 17 (i) A medical condition; or 18 (ii) An expected medication therapy, surgery, radiation, chemotherapy or other medical treatment that is recognized by medical professionals to cause a risk of infertility. 19 20(3) The coverage required by subsection (2) of this section: (a) Includes, but is not limited to: 21 22(A) A minimum of three completed oocyte retrievals with unlimited embryo transfers in accordance with guidelines of the American Society for Reproductive Medicine, or a succes-23sor organization, using single embryo transfer if recommended by a licensed treating prac-24 25titioner and medically effective. (B) Intrauterine insemination. 2627(C) Assisted hatching. (D) Cryopreservation and thawing of eggs, sperm and embryos. 28(E) Cryopreservation of ovarian tissue. 2930 (F) Cryopreservation of testicular tissue. 31 (G) Embryo biopsy. (H) Consultation and diagnostic testing. 32(I) Fresh and frozen embryo transfers. 33 34 (J) Six completed egg retrievals per lifetime, with unlimited embryo transfers in accord-35 ance with the guidelines of the American Society for Reproductive Medicine, using single embryo transfer when recommended and medically appropriate. 36 37 (K) In vitro fertilization, including in vitro fertilization using donor eggs, sperm or 38 embryos, and in vitro fertilization in which the embryo is transferred to a gestational carrier or surrogate. 39 40 (L) Intra-cytoplasmic sperm injection. (M) Medications. 41 (N) Ovulation induction. 42 (O) Storage of oocytes, sperm, embryos and tissue. 43 (P) Surgery, including microsurgical sperm aspiration. 44

45 (Q) Medical and laboratory services that reduce excess embryo creation through egg

cryopreservation and thawing. 1 2 (b) Must be provided to all beneficiaries under the health benefit plan policy or certificate, including a covered spouse and covered dependents other than spouses, to the same 3 extent as other pregnancy-related benefits under the plan. 4 (4) The health benefit plan may not impose exclusions, limitations or other restrictions 5 on coverage of: 6 (a) Medications for the treatment of infertility described in subsection (2) of this section 7 that are not imposed on other prescription benefits under the plan. 8 9 (b) Procedures described in subsections (2) and (3) of this section: (A) Based on an enrollee's participation in fertility services provided by or to a third 10 11 party. 12(B) That do not apply to other covered procedures under the plan. 13 (5) Subsection (4) of this section does not permit a health benefit plan to require step therapy for services described in subsections (2) and (3) of this section that are determined 14 15 by a treating practitioner to be medically necessary. 16(6) Subject to ORS 746.021, this section does not require a health benefit plan offered by an insurer described in ORS 743A.067 (7)(e) to reimburse the cost of: 17 18 (a) Procedures described in subsection (3)(a)(C), (G), (I), (K) or (L) of this section; or (b) Embryo transfer, cryopreservation or storage procedures described in subsection 19 (3)(a)(A), (D), (J) or (O) of this section. 20(7) This section is exempt from ORS 743A.001. 2122SECTION 3. (1) The Oregon Health Authority, in collaboration with the Department of Consumer and Business Services, shall study access to fertility and reproductive 23endocrinology services by residents of this state, including: 24 25(a) Availability and utilization of fertility and reproductive endocrinology services in the commercial health insurance markets, self-insured health plans and the state medical as-2627sistance program; (b) Financial and access barriers to obtaining fertility and reproductive endocrinology 28services including assisted reproductive technology; and 2930 (c) Inequities in access to fertility and reproductive endocrinology services based on race, 31 ethnicity, gender identity, sexual orientation, income, marital status, immigration status and disability. 32(2) No later than September 15, 2024, the authority shall report to the interim commit-33 34 tees of the Legislative Assembly related to health, in the manner provided in ORS 192.245, the findings of the study described in subsection (1) of this section and recommendations for: 35 (a) Reducing financial and access barriers to fertility and reproductive endocrinology 36 37 services for residents of this state; 38 (b) Strategies to promote equal access to fertility and reproductive endocrinology services, including protections against discrimination in the provision of fertility and reproduc-39 tive endocrinology services; 40 (c) A plan to provide equitable access to assisted reproductive technology for all residents 41 of this state; 42 (d) The feasibility of obtaining federal financial participation in or other federal resources 43 to support the plan described in paragraph (c) of this subsection; and 44 (e) Legislative changes necessary to implement the recommendations under this sub-45

1 section.

2 <u>SECTION 4.</u> (1) The Oregon Health Authority shall contract with a third party adminis-3 trator or a health insurance carrier to provide to enrollees in health benefit plans described 4 in section 2 (6) of this 2023 Act reimbursement for the costs of:

(a) Procedures described in section 2 (3)(a)(C), (G), (I), (K) or (L) of this 2023 Act.

6 (b) Embryo transfer, cryopreservation or storage procedures described in section 2 7 (3)(a)(A), (D), (J) or (O) of this 2023 Act.

8 (2) The authority shall establish application processes and procedures for enrollees to 9 access the coverage under subsection (1) of this section.

(3) The authority may adopt rules necessary to carry out the provisions of this section.

11 <u>SECTION 5.</u> The Market Equity Fund is established in the State Treasury, separate and 12 distinct from the General Fund, consisting of fees paid to the Director of the Department 13 of Consumer and Business Services that are described in ORS 731.804 (3)(e). Moneys in the 14 Market Equity Fund are continuously appropriated to the Oregon Health Authority to carry 15 out the provisions of section 4 of this 2023 Act.

22 SECTION 7. ORS 731.804 is amended to read:

23731.804. (1) Except as otherwise provided in this section, each authorized insurer doing business in this state shall pay assessments that the Director of the Department of Consumer and Business 24Services determines are necessary to support the legislatively authorized budget of the Department 25of Consumer and Business Services with respect to functions of the department under the Insurance 2627Code. The director shall determine the assessments according to one or more percentage rates established by the director by rule. The director shall specify in the rule when assessments shall be 28made and payments shall be due. The premium-weighted average of the percentage rates may not 2930 exceed nine-hundredths of one percent of the gross amount of premiums received by an insurer or 31 the insurer's insurance producers from and under the insurer's policies covering direct domestic 32risks, after deducting the amount of return premiums paid and the amount of dividend payments made to policyholders with respect to such policies. (c) Nothing in this section limits the authority of the director to enforce the provisions of ORS
 chapter 743A if an insurer unlawfully fails to comply.

 fees paid in accordance with paragraph (a) of this subsection shall be deposited in the General Fund
 to become available for general governmental expenses.

(e) Fees paid under this subsection by insurers for health benefit plans described in sec tion 2 (6) of this 2023 Act shall be deposited in the Market Equity Fund established in section
 5 of this 2023 Act.

(4) Establishment and amendment of the schedule of fees under subsection (2) of this section are
subject to prior approval of the Oregon Department of Administrative Services and a report to the
Emergency Board prior to adopting the fees and shall be within the budget authorized by the Legislative Assembly as that budget may be modified by the Emergency Board.

(5) The director may not collect an assessment under subsection (1) of this section from any ofthe following persons:

(1) "Actuarial certification" means a written statement by a member of the American Academy of Actuaries or other individual acceptable to the Director of the Department of Consumer and Business Services that a carrier is in compliance with the provisions of ORS 743B.012 based upon the person's examination, including a review of the appropriate records and of the actuarial assumptions and methods used by the carrier in establishing premium rates for small employer health benefit plans.

(2) "Affiliate" of, or person "affiliated" with, a specified person means any carrier who, directly

2 (18) "Initial enrollment period" means a period of at least 30 days following commencement of 3 the first eligibility period for an individual.

4 (19) "Late enrollee" means an individual who enrolls in a group health benefit plan subsequent 5 to the initial enrollment period during which the individual was eligible for coverage but declined 6 to enroll. However, an eligible individual shall not be considered a late enrollee if:

(a) The individual qualifies for a special enrollment period in accordance with 42 U.S.C. 300gg
or as prescribed by rule by the Department of Consumer and Business Services;

(b) The individual applies for coverage during an open enrollment period;

(c) A court issues an order that coverage be provided for a spouse or minor child under an
employee's employer sponsored health benefit plan and request for enrollment is made within 30
days after issuance of the court order;

(d) The individual is employed by an employer that offers multiple health benefit plans and the
 individual elects a different health benefit plan during an open enrollment period; or

(e) The individual's coverage under Medicaid, Medicare, TRICARE, Indian Health Service or a publicly sponsored or subsidized health plan, including, but not limited to, the medical assistance program under ORS chapter 414, has been involuntarily terminated within 63 days after applying for coverage in a group health benefit plan.

(20) "Multiple employer welfare arrangement" means a multiple employer welfare arrangement
as defined in section 3 of the federal Employee Retirement Income Security Act of 1974, as amended,
29 U.S.C. 1002, that is subject to ORS 750.301 to 750.341.

(21) "Preexisting condition exclusion" means a limitation or exclusion of benefits or a denial of coverage based on a medical condition being present before the effective date of coverage or before the date coverage is denied, whether or not any medical advice, diagnosis, care or treatment was recommended or received for the condition before the date of coverage or denial of coverage.

(22) "Premium" includes insurance premiums or other fees charged for a health benefit plan,
 including the costs of benefits paid or reimbursements made to or on behalf of enrollees covered by
 the plan.

(23) "Rating period" means the 12-month calendar period for which premium rates established
by a carrier are in effect, as determined by the carrier.

(24) "Representative" does not include an insurance producer or an employee or authorized
 representative of an insurance producer or carrier.

(25)(a) "Short term health insurance policy" means a policy of health insurance that is in effect
 for a period of three months or less, including the term of a renewal of the policy.

(b) As used in this subsection, "term of a renewal" includes the term of a new short term health
insurance policy issued by an insurer to a policyholder no later than 60 days after the expiration
of a short term health insurance policy issued by the insurer to the policyholder.

(26) "Small employer" means an employer who employed an average of at least one but not more than 50 full-time equivalent employees on business days during the preceding calendar year and who employs at least one full-time equivalent employee on the first day of the plan year, determined in accordance with a methodology prescribed by the Department of Consumer and Business Services by rule.

43 <u>SECTION 9.</u> Section 2 of this 2023 Act applies to policies or certificates issued, renewed 44 or extended on or after January 1, 2024.

SECTION 10. The amendments to ORS 646A.628, 731.804 and 743B.005 by sections 6 to 8

1 of this 2023 Act become operative on January 1, 2024.

2 SECTION 11. Section 3 of this 2023 Act is repealed on January 2, 2025.

3 <u>SECTION 12.</u> This 2023 Act being necessary for the immediate preservation of the public

4 peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
 5 on its passage.
