**Senate Bill 5524**

Introduced and printed pursuant to House Concurrent Resolution 23 (2023) (at the request of Oregon Department of Administrative Services)

CHAPTER .....

AN ACT

Relating to the financial administration of the Oregon Business Development Department; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1.** There are appropriated to the Oregon Business Development Department, for the biennium beginning July 1, 2023, out of the General Fund, the following amounts for the following purposes:

- (1) Arts..... \$ 4,376,546
- (2) Debt service..... \$ 90,722,590

**SECTION 2.** In addition to and not in lieu of any other appropriation, there are appropriated to the Oregon Business Development Department, for the biennium beginning July 1, 2023, out of the General Fund, for infrastructure, the following amounts for the following purposes:

- (1) Rivoli theater restoration..... \$ 750,000
- (2) Port of Coos Bay navigation channel..... \$ 10,000,000
- (3) St. Helens waterfront redevelopment..... \$ 684,000
- (4) Municipal building departments financial assistance grants ..... \$ 1,000,000
- (5) Sweet Home wastewater treatment plan upgrade..... \$ 3,500,000
- (6) Warm Springs water and wastewater systems..... \$ 5,737,479

**SECTION 3.** In addition to and not in lieu of any other appropriation, there are appropriated to the Oregon Business Development Department, for the biennium beginning July 1, 2023, out of the General Fund, for business, innovation and trade, the following amounts for the following purposes:

- (1) Emerging Opportunities Program..... \$ 13,500,000
- (2) Municipal wildfire assistance.... \$ 1,000,000

**SECTION 4.** Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2023, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-

cluding lottery funds and federal funds, collected or received by the Oregon Business Development Department, for the following purposes:

- (1) Operations..... \$ 4,253,298
- (2) Business, innovation and trade..... \$245,344,891
- (3) Infrastructure..... \$215,788,458
- (4) Arts..... \$ 18,228,924

**SECTION 5.** Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2023, as the maximum limits for payment of expenses by the Oregon Business Development Department, from American Rescue Plan Act Coronavirus State Fiscal Recovery Fund moneys received by the Oregon Department of Administrative Services and transferred to the Oregon Business Development Department, for the following purposes:

- (1) Operations..... \$ 360,477
- (2) Business, innovation and trade..... \$ 408,641

**SECTION 6.** Notwithstanding any other law limiting expenditures, the amount of \$267,642,183 is established for the biennium beginning July 1, 2023, as the maximum limit for payment of expenses by the Oregon Business Development Department, from American Rescue Plan Act Coronavirus State Fiscal Recovery Fund moneys received by the Oregon Department of Administrative Services and transferred to the Oregon Business Development Department, for infrastructure, for grants approved in section 196, chapter 669, Oregon Laws 2021.

**SECTION 7.** Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2023, as the maximum limits for payment of expenses by the Oregon Business Development Department, from the Broadband Fund established by section 4, chapter 17, Oregon Laws 2020, for the following purposes:

- (1) Operations..... \$ 380,782
- (2) Infrastructure..... \$106,619,218

**SECTION 8.** Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2023, as the maximum limits for payment of expenses from lottery moneys allocated from the Administrative Services Economic Development Fund to the Oregon Business Development Department, for the following purposes:

- (1) Operations..... \$ 15,436,848
- (2) Business, innovation and trade..... \$ 77,456,902
- (3) Infrastructure..... \$ 4,591,498
- (4) Oregon Film and Video Office .. \$ 1,479,463
- (5) Lottery bond debt service..... \$ 47,504,550

**SECTION 9.** Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2023, as the maximum limits for payment of expenses from federal funds collected or received by the Oregon Business Development Department, for the following purposes:

- (1) Operations..... \$ 633,078
- (2) Business, innovation and trade..... \$ 37,258,810
- (3) Infrastructure..... \$ 57,803,364
- (4) Arts..... \$ 2,208,982

**SECTION 10.** For the biennium beginning July 1, 2023, expenditures by the Oregon Business Development Department are not limited for:

- (1) Loans from the following funds:

(a) Oregon Business Development Fund (ORS 285B.092), Oregon Entrepreneurial Development Loan Fund (ORS 285B.758), Credit Enhancement Fund (ORS 285B.215) and Small Business Expansion Loan Fund (ORS 285B.133).

(b) Special Public Works Fund (ORS 285B.455), Water Fund (ORS 285B.563), Marine Navigation Improvement Fund (ORS 777.267), Oregon Port Revolving Fund (ORS 285A.708), Safe Drinking Water Revolving Loan Fund (ORS 285A.213), Brownfields Redevelopment Fund (ORS 285A.188) and Oregon Brownfield Properties Revitalization Fund (ORS 285A.198).

(2) Debt service, excluding debt service on lottery revenue bonds and general obligation bonds.

**SECTION 11.** This 2023 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect July 1, 2023.
