## Senate Bill 5532

Introduced and printed pursuant to House Concurrent Resolution 23 (2023) (at the request of Oregon Department of Administrative Services)

## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Appropriates moneys from General Fund to Public Defense Services Commission for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by commission.

Declares emergency, effective July 1, 2023.

## A BILL FOR AN ACT

Relating to the financial administration of the Public Defense Services Commission; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

<u>SECTION 1.</u> There are appropriated to the Public Defense Services Commission, for the biennium beginning July 1, 2023, out of the General Fund, the following amounts, for the following purposes:

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2023, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Public Defense Services Commission, for the following purposes:

- 23 (1) Court Mandated Expenses ...... \$ 3,937,116
- 24 (2) Juvenile Division...... \$ 14,000,000

<u>SECTION 3.</u> There is appropriated to the Public Defense Services Commission, for the biennium beginning July 1, 2023, out of the General Fund, the amount of \$584,516 to implement the provisions of chapter 400, Oregon Laws 2021.

SECTION 4. This 2023 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
