

# A-Engrossed Senate Bill 5534

Ordered by the Senate May 9  
Including Senate Amendments dated May 9

Introduced and printed pursuant to House Concurrent Resolution 23 (2023) (at the request of Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Public Utility Commission of Oregon.

Limits biennial expenditures by commission from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2023.

## A BILL FOR AN ACT

2 Relating to the financial administration of the Public Utility Commission of Oregon; and declaring  
3 an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Notwithstanding any other law limiting expenditures, the following amounts**  
6 **are established for the biennium beginning July 1, 2023, as the maximum limits for payment**  
7 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**  
8 **cluding lottery funds and federal funds, collected or received by the Public Utility Commis-**  
9 **sion of Oregon, for the following purposes:**

10 (1) Utility program..... \$ 40,839,567

11 (2) Residential Service

12 Protection Fund..... \$ 10,589,606

13 (3) Administration..... \$ 10,316,913

14 (4) Oregon Board of Maritime

15 Pilots..... \$ 1,008,414

16 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**  
17 **\$1,213,146 is established for the biennium beginning July 1, 2023, as the maximum limit for**  
18 **payment of expenses from federal funds collected or received by the Public Utility Commis-**  
19 **sion of Oregon.**

20 **SECTION 3. For the biennium beginning July 1, 2023, expenditures by the Public Utility**  
21 **Commission of Oregon from the universal service fund established in ORS 759.425 are not**  
22 **limited.**

23 **SECTION 4. This 2023 Act being necessary for the immediate preservation of the public**  
24 **peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect**  
25 **July 1, 2023.**
