

Senate Bill 735

Sponsored by Senator GIROD (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Restores offense levels for unlawful possession of controlled substance offenses to levels that existed prior to enactment of House Bill 2355 (2017) and Drug Addiction Treatment and Recovery Act of 2020 (Ballot Measure 110 (2020)).

Refers Act to people for their approval or rejection at next regular general election.

POSSESSION OF CONTROLLED SUBSTANCE OFFENSE LEVELS

12 **SECTION 1.** ORS 475.752 is amended to read:

13 475.752. (1) Except as authorized by ORS 475.005 to 475.285 and 475.752 to 475.980, it is unlawful
14 for any person to manufacture or deliver a controlled substance. Any person who violates this sub-
15 section with respect to:

16 (a) A controlled substance in Schedule I, is guilty of a Class A felony, except as otherwise pro-
17 vided in ORS 475.886 and 475.890.

18 (b) A controlled substance in Schedule II, is guilty of a Class B felony, except as otherwise
19 provided in ORS 475.878, 475.880, 475.882, 475.904 and 475.906.

20 (c) A controlled substance in Schedule III, is guilty of a Class C felony, except as otherwise
21 provided in ORS 475.904 and 475.906.

22 (d) A controlled substance in Schedule IV, is guilty of a Class B misdemeanor.

23 (e) A controlled substance in Schedule V, is guilty of a Class C misdemeanor.

24 (2) Except as authorized in ORS 475.005 to 475.285 and 475.752 to 475.980, it is unlawful for any
25 person to create or deliver a counterfeit substance. Any person who violates this subsection with
26 respect to:

27 (a) A counterfeit substance in Schedule I, is guilty of a Class A felony.

28 (b) A counterfeit substance in Schedule II, is guilty of a Class B felony.

29 (c) A counterfeit substance in Schedule III, is guilty of a Class C felony.

30 (d) A counterfeit substance in Schedule IV, is guilty of a Class B misdemeanor.

1 (e) A counterfeit substance in Schedule V, is guilty of a Class C misdemeanor.

4 practitioner while acting in the course of professional practice, or except as otherwise authorized
5 by ORS 475.005 to 475.285 and 475.752 to 475.980. Any person who violates this subsection with re-
6 spect to:

7 (a) A controlled substance in Schedule I, is guilty of a Class *[E violation]* **B felony**, except as
8 otherwise provided in ORS *[475.854, 475.874 and]* 475.894 *[and subsection (7) of this section]*.

9 (b) A controlled substance in Schedule II, is guilty of a *[Class E violation, except as otherwise*
10 *provided in ORS 475.814, 475.824, 475.834 or 475.884 or subsection (8) of this section]* **Class C**
11 **felony**.

12 (c) A controlled substance in Schedule III, is guilty of a Class *[E violation]* **A misdemeanor**.

13 (d) A controlled substance in Schedule IV, is guilty of a Class *[E violation]* **C misdemeanor**.

14 (e) A controlled substance in Schedule V, is guilty of a violation.

15 (4) It is an affirmative defense in any prosecution under this section for manufacture, possession
16 or delivery of the plant of the genus *Lophophora* commonly known as peyote that the peyote is being
17 used or is intended for use:

18 (a) In connection with the good faith practice of a religious belief;

19 (b) As directly associated with a religious practice; and

20 (c) In a manner that is not dangerous to the health of the user or others who are in the prox-
21 imity of the user.

41 (a) The violation constitutes delivery or manufacture of a controlled substance and involves
 42 substantial quantities of a controlled substance. For purposes of this paragraph, the following
 43 amounts constitute substantial quantities of the following controlled substances:

44 (A) Five grams or more of a mixture or substance containing a detectable amount of heroin;

45 (B) Five grams or more of a mixture or substance containing a detectable amount of fentanyl,

1 or any substituted derivative of fentanyl as defined by the rules of the Oregon Board of Pharmacy;

2 (C) Ten grams or more of a mixture or substance containing a detectable amount of cocaine;

8 or psilocin; or

9 (G) Five grams or more or 25 or more pills, tablets or capsules of a mixture or substance con-

12 (ii) 3,4-methylenedioxymethamphetamine; or

13 (iii) 3,4-methylenedioxy-N-ethylamphetamine.

14 (b) The violation constitutes possession, delivery or manufacture of a controlled substance and
15 the possession, delivery or manufacture is a commercial drug offense. A possession, delivery or
16 manufacture is a commercial drug offense for purposes of this subsection if it is accompanied by at
17 least three of the following factors:

18 (A) The delivery was of heroin, cocaine, methamphetamine, lysergic acid diethylamide,
19 psilocybin or psilocin and was for consideration;

20 (B) The offender was in possession of \$300 or more in cash;

21 (C) The offender was unlawfully in possession of a firearm or other weapon as described in ORS
22 166.270 (2), or the offender used, attempted to use or threatened to use a deadly or dangerous
23 weapon as defined in ORS 161.015, or the offender was in possession of a firearm or other deadly
24 or dangerous weapon as defined in ORS 161.015 for the purpose of using it in connection with a
25 controlled substance offense;

26 (D) The offender was in possession of materials being used for the packaging of controlled sub-
27 stances such as scales, wrapping or foil, other than the material being used to contain the substance
28 that is the subject of the offense;

29 (E) The offender was in possession of drug transaction records or customer lists;

30 (F) The offender was in possession of stolen property;

31 (G) Modification of structures by painting, wiring, plumbing or lighting to facilitate a controlled
32 substance offense;

33 (H) The offender was in possession of manufacturing paraphernalia, including recipes, precursor
34 chemicals, laboratory equipment, lighting, ventilating or power generating equipment;

35 (I) The offender was using public lands for the manufacture of controlled substances;

36 (J) The offender had constructed fortifications or had taken security measures with the potential
37 of injuring persons; or

38 (K) The offender was in possession of controlled substances in an amount greater than:

39 (i) Three grams or more of a mixture or substance containing a detectable amount of heroin;

40 (ii) Three grams or more of a mixture or substance containing a detectable amount of fentanyl,
41 or any substituted derivative of fentanyl as defined by the rules of the Oregon Board of Pharmacy;

42 (iii) Eight grams or more of a mixture or substance containing a detectable amount of cocaine;

12 of:

13 (A) A chemical reaction involving one or more precursor substances for the purpose of manu-
14 facturing methamphetamine; or

15 (B) Grinding, soaking or otherwise breaking down a precursor substance for the purpose of
16 manufacturing methamphetamine.

17 (e) The violation constitutes a violation of ORS 475.906 (1) or (2) that is not described in ORS
18 475.907.

19 (2) A violation of ORS 475.752 or 475.806 to 475.894 shall be classified as crime category 6 of
20 the sentencing guidelines grid of the Oregon Criminal Justice Commission if:

21 (a) The violation constitutes delivery of heroin, cocaine, methamphetamine or
22 3,4-methylenedioxyamphetamine, 3,4-methylenedioxymethamphetamine or
23 3,4-methylenedioxy-N-ethylamphetamine and is for consideration.

24 (b) The violation constitutes possession of substantial quantities of a controlled substance. For
25 purposes of this paragraph, the following amounts constitute substantial quantities of the following
26 controlled substances:

27 (A) Five grams or more of a mixture or substance containing a detectable amount of heroin;

28 (B) Five grams or more of a mixture or substance containing a detectable amount of fentanyl,
29 or any substituted derivative of fentanyl as defined by the rules of the Oregon Board of Pharmacy;

30 (C) Ten grams or more of a mixture or substance containing a detectable amount of cocaine;

31 (D) Ten grams or more of a mixture or substance containing a detectable amount of metham-
32 phetamine;

33 (E) Two hundred or more user units of a mixture or substance containing a detectable amount
34 of lysergic acid diethylamide;

35 (F) Sixty grams or more of a mixture or substance containing a detectable amount of psilocybin
36 or psilocin; or

37 (G) Five grams or more or 25 or more pills, tablets or capsules of a mixture or substance con-
38 taining a detectable amount of:

39 (i) 3,4-methylenedioxyamphetamine;

40 (ii) 3,4-methylenedioxymethamphetamine; or

41 (iii) 3,4-methylenedioxy-N-ethylamphetamine.

42 (3) Any felony violation of ORS 475.752 or 475.806 to 475.894 not contained in subsection (1) or
43 (2) of this section shall be classified as:

44 (a) Crime category 4 of the sentencing guidelines grid of the Oregon Criminal Justice Commis-
45 sion if the violation involves delivery or manufacture of a controlled substance[.]; **or**

1 (c) Allocations to the Department of Corrections for the purpose of planning, operating and
2 maintaining county juvenile and adult corrections programs and facilities and drug and alcohol
3 programs.

4 (d) Allocations to the Oregon Health Authority for the purpose of grants under ORS 430.345 for
5 the establishment, operation and maintenance of alcohol and drug abuse prevention, early inter-
6 vention and treatment services provided through a county.

7 (e) Allocations to the Oregon State Police for the purpose of the enforcement of the laws relat-
8 ing to driving under the influence of intoxicants.

9 (f) Allocations to the Arrest and Return Account established under ORS 133.865.

10 (g) Allocations to the Intoxicated Driver Program Fund established under ORS 813.270.

12 *[(4) Notwithstanding subsections (2) and (3) of this section, the Legislative Assembly shall allocate*
13 *all moneys deposited into the Criminal Fine Account as payment of fines on Class E violations to the*
14 *Drug Treatment and Recovery Services Fund established under ORS 430.384.]*

15 [(5)] (4) It is the intent of the Legislative Assembly that allocations from the Criminal Fine
16 Account under subsection (3) of this section be consistent with historical funding of the entities,
17 programs and accounts listed in subsection (3) of this section from monetary obligations imposed in
18 criminal proceedings. Amounts that are allocated under subsection (3)(c) of this section shall be
19 distributed to counties based on the amounts that were transferred to counties by circuit courts
20 during the 2009-2011 biennium under the provisions of ORS 137.308, as in effect January 1, 2011.

21 [(6)] (5) Moneys in the Criminal Fine Account may not be allocated for the payment of debt

37 (2) The maximum reduction under this section may not exceed 50 percent of the period of pro-
38 bation or post-prison supervision imposed.

28 (B) The annual increase, if any, in moneys distributed pursuant to ORS 475C.726 (3)(b).

29 **SECTION 26.** ORS 430.388 is amended to read:

30 430.388. (1)(a) The Director of the Oregon Health Authority shall establish an Oversight and
 31 Accountability Council for the purpose of determining how funds will be distributed to grant appli-
 32 cants and to oversee the implementation of the Behavioral Health Resource Networks pursuant to
 33 ORS 430.389. The council shall be formed on or before February 1, 2021.

34 (b) The council shall consist of qualified individuals with experience in substance use disorder
 35 treatment and other addiction services. The council shall consist of at least one member from each
 36 of the following categories only:

37 (A) A representative of the Oregon Health Authority, Health Systems Division Behavioral
 38 Health Services as a nonvoting member;

39 (B) Three members of communities that have been disproportionately impacted by arrests,
 40 prosecution or sentencing for [*conduct that has been classified or reclassified as a Class E violation*]
 41 **unlawful possession of a controlled substance offenses;**

42 (C) A physician specializing in addiction medicine;

43 (D) A licensed clinical social worker;

44 (E) An evidence-based substance use disorder provider;

45 (F) A harm reduction services provider;

1 (G) A person specializing in housing services for people with substance use disorder or a diag-
2 nosed mental health condition;

3 (H) An academic researcher specializing in drug use or drug policy;

4 (I) At least two people who suffered or suffer from substance use disorder;

5 (J) At least two recovery peers;

6 (K) A mental or behavioral health care provider;

7 (L) A representative of a coordinated care organization;

8 (M) A person who works for a nonprofit organization that advocates for persons who experience
9 or have experienced substance use disorder; and

10 (N) The Director of the Alcohol and Drug Policy Commission or the director's designated staff
11 person, as a nonvoting member.

12 (2) A quorum consists of two-thirds of the members of the council, rounded up to the next odd
13 number of members.

14 (3) The term of office for a member of the council is four years. Vacancies shall be appointed
15 for the unexpired term.

16 (4)(a) To the extent permissible by law, a member of the council performing services for the
17 council may receive compensation from the member's employer for time spent performing services
18 as a council member.

19 (b) If a member of the council is not compensated by the member's employer as set forth in
20 paragraph (a) of this subsection, that member shall be entitled to compensation and expenses as
21 provided in ORS 292.495.

22 (5) Members of the council are subject to and must comply with the provisions of ORS chapter
23 244, including ORS 244.045 (4), 244.047, 244.120 and 244.130.

24 **SECTION 27.** ORS 430.389 is amended to read:

25 430.389. (1) The Oversight and Accountability Council shall oversee and approve grants and
26 funding to implement Behavioral Health Resource Networks and increase access to community care,
27 as set forth below. A Behavioral Health Resource Network is an entity or collection of entities that
28 individually or jointly provide some or all of the services described in subsection (2)(d) of this sec-
29 tion.

30 (2)(a) The Oversight and Accountability Council, in consultation with the Oregon Health Au-
31 thority, shall provide grants and funding to agencies or organizations, whether government or com-
32 munity based, to establish Behavioral Health Resource Networks for the purposes of immediately
33 screening the acute needs of people who use drugs and assessing and addressing any ongoing needs
34 through ongoing case management, harm reduction, treatment, housing and linkage to other care
35 and services. Recipients of grants or funding to provide substance use disorder treatment or ser-
36 vices must be licensed, certified or credentialed by the state, including certification under ORS
37 743A.168 (8), or meet criteria prescribed by rule by the Oversight and Accountability Council under
38 ORS 430.390. A recipient of a grant or funding under this subsection may not use the grant or
39 funding to supplant the recipient's existing funding.

40 (b) The council and the authority shall ensure that residents of each county have access to all
41 of the services described in paragraph (d) of this subsection.

42 (c) Applicants for grants and funding may apply individually or jointly with other network par-
43 ticipants to provide services in one or more counties.

44 (d) A network must have the capacity to provide the following services and any other services
45 specified by the council by rule:

1 (A) Screening by certified addiction peer support or wellness specialists or other qualified per-
2 sons designated by the council to determine a client's need for immediate medical or other treatment
3 to determine what acute care is needed and where it can be best provided, identify other needs and
4 link the client to other appropriate local or statewide services, including treatment for substance
5 abuse and coexisting health problems, housing, employment, training and child care. Networks shall
6 provide this service 24 hours a day, seven days a week, every calendar day of the year.
7 Notwithstanding paragraph (b) of this subsection, only one grantee in each network within each
8 county is required to provide the screenings described in this subparagraph.

9 (B) Comprehensive behavioral health needs assessment, including a substance use disorder
10 screening by a certified alcohol and drug counselor or other credentialed addiction treatment pro-
11 fessional. The assessment shall prioritize the self-identified needs of a client.

12 (C) Individual intervention planning, case management and connection to services. If, after the
13 completion of a screening, a client indicates a desire to address some or all of the identified needs,
14 a case manager shall work with the client to design an individual intervention plan. The plan must
15 address the client's need for substance use disorder treatment, coexisting health problems, housing,
16 employment and training, child care and other services.

17 (D) Ongoing peer counseling and support from screening and assessment through implementation
18 of individual intervention plans as well as peer outreach workers to engage directly with
19 marginalized community members who could potentially benefit from the network's services.

20 (E) Assessment of the need for, and provision of, mobile or virtual outreach services to:

21 (i) Reach clients who are unable to access the network; and

22 (ii) Increase public awareness of network services.

23 (F) Harm reduction services and information and education about harm reduction services.

24 (G) Low-barrier substance use disorder treatment.

25 (H) Transitional and supportive housing for individuals with substance use disorders.

26 (e) If an applicant for a grant or funding under this subsection is unable to provide all of the
27 services described in paragraph (d) of this subsection, the applicant may identify how the applicant
28 intends to partner with other entities to provide the services, and the Oregon Health Authority and
29 the council may facilitate collaboration among applicants.

30 (f) All services provided through the networks must be evidence-informed, trauma-informed,
31 culturally specific, linguistically responsive, person-centered and nonjudgmental. The goal shall be
32 to address effectively the client's substance use and any other social determinants of health.

33 (g) The networks must be adequately staffed to address the needs of people with substance use
34 disorders within their regions as prescribed by the council by rule, including, at a minimum, at least
35 one person qualified by the Oregon Health Authority in each of the following categories:

36 (A) Certified alcohol and drug counselor or other credentialed addiction treatment professional;

37 (B) Case manager; and

38 (C) Certified addiction peer support or wellness specialist.

39 (h) Verification of a screening by a certified addiction peer support specialist, wellness specialist
40 or other person in accordance with subsection (2)(d)(A) of this section shall promptly be provided
41 to the client by the entity conducting the screening. If the client executes a valid release of infor-
42 mation, the entity shall provide verification of the screening to the Oregon Health Authority or a
43 contractor of the authority [*and the authority or the authority's contractor shall forward the verifi-*
44 *cation to the court, in the manner prescribed by the Chief Justice of the Supreme Court, to satisfy the*
45 *conditions for dismissal under ORS 153.062 or 475.237*].

1 (3)(a) If moneys remain in the Drug Treatment and Recovery Services Fund after the council
 2 has committed grants and funding to establish behavioral health resource networks serving every
 3 county in this state, the council shall provide grants and funding to other agencies or organizations,
 4 whether government or community based, and to the nine federally recognized tribes in this state
 5 and service providers that are affiliated with the nine federally recognized tribes in this state to
 6 increase access to one or more of the following:

7 (A) Low-barrier substance use disorder treatment that is evidence-informed, trauma-informed,
 8 culturally specific, linguistically responsive, person-centered and nonjudgmental;

9 (B) Peer support and recovery services;

 18 supplant the recipient's existing funding.

19 (4) In awarding grants and funding under subsections (2) and (3) of this section, the council
 20 shall:

21 (a) Distribute grants and funding to ensure access to:

22 (A) Historically underserved populations; and

23 (B) Culturally specific and linguistically responsive services.

24 (b) Consider any inventories or surveys of currently available behavioral health services.

25 (c) Consider available regional data related to the substance use disorder treatment needs and
 26 the access to culturally specific and linguistically responsive services in communities in this state.

27 (d) Consider the needs of residents of this state for services, supports and treatment at all ages.

28 (5) The council shall require any government entity that applies for a grant to specify in the

19 relationship between the council and recipients of grants or funding and the structural integrity of
20 ORS [293.665 and 305.231 and] 430.383 to 430.390, including but not limited to assessing:

21 (A) Whether the organizational structure of the council contains conflicts or problems.

22 (B) Whether the rules adopted by the council are clear and functioning properly.

23 (C) Whether the council has sufficient authority and independence to achieve the council's
24 mission.

25 (D) Whether the authority is fulfilling the authority's duties under ORS 430.384, 430.387, 430.388,

27 (E) Whether there are conflicts of interest in the process of awarding grants or funding.

28 (F) Whether there are opportunities to expand collaboration between the council and state
29 agencies.

30 (G) Whether barriers exist in data collection and evaluation mechanisms.

31 (H) Who is providing the data.

32 (I) Other areas identified by the division.

33 (b) Financial review, which shall include an assessment of the following:

34 (A) The functioning of the grants and funding systems between the council, the authority and
35 recipients of grants or funding, including by gathering information on who is receiving what grants
36 and funding, the process of applying for the grants and funding and whether that process is con-
37 ducive to obtaining qualified applicants and applicants from communities of color.

38 (B) Whether grants and funding are going to organizations that are culturally responsive and
39 linguistically specific, including an assessment of:

40 (i) The barriers that exist for grant and funding applicants who are Black, Indigenous or People
41 of Color.

42 (ii) The applicants that were denied and why.

43 (iii) Whether grants and other funding are being disbursed based on the priorities specified in
44 ORS 430.389.

45 (iv) For government entities receiving grants or funding under ORS 430.389, the government

1 entities' subgrantees and whether the governmental entity supplanted or decreased any local funding
 2 dedicated to the same services after receiving grants or funds under ORS 430.389.

3 (v) Whether the authority has stayed within its administrative spending cap.

4 (vi) What proportion of grants or funds received by grantees and others under ORS 430.389, was
 5 devoted to administrative costs.

6 (C) The organizations and agencies receiving grants or funding under ORS 430.389 and:

7 (i) Which of the organizations and agencies are Behavioral Health Resource Network entities.

8 (ii) The amount each organization and agency received.

9 (iii) The total number of organizations and agencies that applied for grants or funding.

10 (iv) The amount of moneys from the fund that were used to administer the programs selected
 11 by the council.

12 (v) The moneys that remained in the Drug Treatment and Recovery Services Fund after grants
 13 and funding were disbursed.

14 (vi) A performance assessment of each grant or funding recipient.

15 (D) Other areas identified by the division.

16 (5) No later than December 31, 2024, the division shall conduct a performance audit, which must
 17 include an assessment of the following:

18 (a) All relevant data regarding the implementation of ORS [153.062 and] 430.391[, *including de-*
 19 *mographic information on individuals who receive citations subject to ORS 153.062 and 430.391 and*
 20 *whether the citations resulted in connecting the individuals with treatment*].

21 (b) The functioning of:

22 [(A) *Law enforcement and the courts in relation to Class E violation citations;*]

23 [(B)] (A) The telephone hotline operated by the authority; and

24 [(C)] (B) Entities providing verification of screenings under ORS 430.389.

25 (c) Disparities shown by demographic data and whether the citation data reveals a dispropor-
 26 tionate use of citations in communities most impacted by the war on drugs.

27 (d) Whether ORS [153.062,] 430.389 and 430.391 reduce the involvement in the criminal justice
 28 system of individuals with substance use disorder.

29 (e) Outcomes for individuals receiving treatment and other social services under ORS 430.389,
 30 including, but not limited to, the following:

31 (A) Whether access to care increased since December 3, 2020, and, if data is available, whether,
 32 since December 3, 2020:

33 (i) The number of drug and alcohol treatment service providers increased.

34 (ii) The number of culturally specific providers increased.

35 (iii) Overdose rates have decreased.

36 (iv) Access to harm reduction services has increased.

37 (v) More individuals are accessing treatment than they were before December 3, 2020.

38 (vi) Access to housing for individuals with substance use disorder has increased.

39 (B) Data on Behavioral Health Resource Networks and recipients of grants and funding under
 40 ORS 430.389, including:

41 (i) The outcomes of each network or recipient, including but not limited to the number of clients
 42 with substance use disorder receiving services from each network or recipient, the average duration
 43 of client participation and client outcomes.

44 (ii) The number of individuals seeking assistance from the network or recipients who are denied
 45 or not connected to substance use disorder treatment and other services, and the reasons for the

14 (1) "Abuse" means the repetitive excessive use of a drug short of dependence, without legal or
15 medical supervision, which may have a detrimental effect on the individual or society.

16 (2) "Administer" means the direct application of a controlled substance, whether by injection,
17 inhalation, ingestion or any other means, to the body of a patient or research subject by:

18 (a) A practitioner or an authorized agent thereof; or

19 (b) The patient or research subject at the direction of the practitioner.

20 (3) "Administration" means the Drug Enforcement Administration of the United States Depart-
21 ment of Justice, or its successor agency.

22 (4) "Agent" means an authorized person who acts on behalf of or at the direction of a man-
23 ufacturer, distributor or dispenser. It does not include a common or contract carrier, public
24 warehouseman or employee of the carrier or warehouseman.

25 (5) "Board" means the State Board of Pharmacy.

26 (6) "Controlled substance":

27 (a) Means a drug or its immediate precursor classified in Schedules I through V under the fed-
28 eral Controlled Substances Act, 21 U.S.C. 811 to 812, as modified under ORS 475.035. The use of the
29 term "precursor" in this paragraph does not control and is not controlled by the use of the term
30 "precursor" in ORS 475.752 to 475.980.

31 (b) Does not include:

32 (A) The plant Cannabis family Cannabaceae;

33 (B) Any part of the plant Cannabis family Cannabaceae, whether growing or not;

34 (C) Resin extracted from any part of the plant Cannabis family Cannabaceae;

35 (D) The seeds of the plant Cannabis family Cannabaceae;

36 (E) Any compound, manufacture, salt, derivative, mixture or preparation of a plant, part of a
37 plant, resin or seed described in this paragraph; or

38 (F) Psilocybin or psilocin, but only if and to the extent that a person manufactures, delivers[,]
39 or possesses psilocybin, psilocin[,] or psilocybin products in accordance with the provisions of ORS
40 475A.210 to 475A.722 and rules adopted under ORS 475A.210 to 475A.722.

41 (7) "Counterfeit substance" means a controlled substance or its container or labeling, which,
42 without authorization, bears the trademark, trade name, or other identifying mark, imprint, number
43 or device, or any likeness thereof, of a manufacturer, distributor or dispenser other than the person
44 who in fact manufactured, delivered or dispensed the substance.

45 (8) "Deliver" or "delivery" means the actual, constructive or attempted transfer, other than by

1 administering or dispensing, from one person to another of a controlled substance, whether or not
2 there is an agency relationship.

3 (9) "Device" means instruments, apparatus or contrivances, including their components, parts
4 or accessories, intended:

5 (a) For use in the diagnosis, cure, mitigation, treatment or prevention of disease in humans or
6 animals; or

7 (b) To affect the structure of any function of the body of humans or animals.

8 (10) "Dispense" means to deliver a controlled substance to an ultimate user or research subject
9 by or pursuant to the lawful order of a practitioner, and includes the prescribing, administering,
10 packaging, labeling or compounding necessary to prepare the substance for that delivery.

11 (11) "Dispenser" means a practitioner who dispenses.

12 (12) "Distributor" means a person who delivers.

13 (13) "Drug" means:

14 (a) Substances recognized as drugs in the official United States Pharmacopoeia, official
15 Homeopathic Pharmacopoeia of the United States or official National Formulary, or any supplement
16 to any of them;

17 (b) Substances intended for use in the diagnosis, cure, mitigation, treatment or prevention of
18 disease in humans or animals;

19 (c) Substances (other than food) intended to affect the structure or any function of the body of
20 humans or animals; and

21 (d) Substances intended for use as a component of any article specified in paragraph (a), (b) or
22 (c) of this subsection; however, the term does not include devices or their components, parts or ac-
23 cessories.

24 (14) "Electronically transmitted" or "electronic transmission" means a communication sent or
25 received through technological apparatuses, including computer terminals or other equipment or
26 mechanisms linked by telephone or microwave relays, or any similar apparatus having electrical,
27 digital, magnetic, wireless, optical, electromagnetic or similar capabilities.

28 (15) "Manufacture" means the production, preparation, propagation, compounding, conversion
29 or processing of a controlled substance, either directly or indirectly by extraction from substances
30 of natural origin, or independently by means of chemical synthesis, or by a combination of extraction
31 and chemical synthesis, and includes any packaging or repackaging of the substance or labeling or
32 relabeling of its container, except that this term does not include the preparation or compounding
33 of a controlled substance:

34 (a) By a practitioner as an incident to administering or dispensing of a controlled substance in
35 the course of professional practice; or

36 (b) By a practitioner, or by an authorized agent under the practitioner's supervision, for the
37 purpose of, or as an incident to, research, teaching or chemical analysis and not for sale.

38 (16) "Person" includes a government subdivision or agency, business trust, estate, trust or any
39 other legal entity.

40 (17) "Practitioner" means physician, dentist, veterinarian, scientific investigator, licensed nurse
41 practitioner, physician assistant or other person licensed, registered or otherwise permitted by law
42 to dispense, conduct research with respect to or to administer a controlled substance in the course
43 of professional practice or research in this state but does not include a pharmacist or a pharmacy.

44 (18) "Prescription" means a written, oral or electronically transmitted direction, given by a
45 practitioner for the preparation and use of a drug. When the context requires, "prescription" also

1 means the drug prepared under such written, oral or electronically transmitted direction. Any label
 2 affixed to a drug prepared under written, oral or electronically transmitted direction shall promi-
 3 nently display a warning that the removal thereof is prohibited by law.

4 (19) "Production" includes the manufacture, planting, cultivation, growing or harvesting of a
 5 controlled substance.

6 (20) "Research" means an activity conducted by the person registered with the federal Drug
 7 Enforcement Administration pursuant to a protocol approved by the United States Food and Drug
 8 Administration.

9 (21) "Ultimate user" means a person who lawfully possesses a controlled substance for the use
 10 of the person or for the use of a member of the household of the person or for administering to an
 11 animal owned by the person or by a member of the household of the person.

12 [(22) "Usable quantity" means:]

13 [(a) An amount of a controlled substance that is sufficient to physically weigh independent of its
 14 packaging and that does not fall below the uncertainty of the measuring scale; or]

15 [(b) An amount of a controlled substance that has not been deemed unweighable, as determined by
 16 a Department of State Police forensic laboratory, due to the circumstances of the controlled
 17 substance.]

18 [(23)] (22) "Within 1,000 feet" means a straight line measurement in a radius extending for 1,000
 19 feet or less in every direction from a specified location or from any point on the boundary line of
 20 a specified unit of property.

21 **SECTION 30.** ORS 475.235 is amended to read:

22 475.235. (1) It is not necessary for the state to negate any exemption or exception in ORS
 23 475.005 to 475.285 and 475.752 to 475.980 in any complaint, information, indictment or other pleading
 24 or in any trial, hearing or other proceeding under ORS 475.005 to 475.285 and 475.752 to 475.980.
 25 The burden of proof of any exemption or exception is upon the person claiming it.

26 (2) In the absence of proof that a person is the duly authorized holder of an appropriate regis-
 27 tration or order form issued under ORS 475.005 to 475.285 and 475.752 to 475.980, the person is
 28 presumed not to be the holder of the registration or form. The burden of proof is upon the person
 29 to rebut the presumption.

30 (3)(a) When a controlled substance is at issue in a criminal proceeding before a grand jury, at
 31 a preliminary hearing, in a proceeding on a district attorney's information[, *during a proceeding on*
 32 *a Class E violation*] or for purposes of an early disposition program, it is prima facie evidence of the
 33 identity of the controlled substance if:

34 (A) A sample of the controlled substance is tested using a presumptive test for controlled sub-
 35 stances;

36 (B) The test is conducted by a law enforcement officer trained to use the test or by a forensic
 37 scientist; and

38 (C) The test is positive for the particular controlled substance.

39 (b) When the identity of a controlled substance is established using a presumptive test for pur-

 3 analysis shall be admitted as prima facie evidence of the results of the analytical findings unless the
 4 defendant has provided notice of an objection in accordance with subsection (5) of this section.

5 (5) If the defendant intends to object at trial to the admission of a certified copy of an analytical
 6 report as provided in subsection (4) of this section, not less than 15 days prior to trial the defendant
 7 shall file written notice of the objection with the court and serve a copy on the district attorney.

8 (6) As used in this section:

9 (a) "Analyst" means a person employed by the Department of State Police to conduct analysis
 10 in forensic laboratories established by the department under ORS 181A.150.

11 (b) "Presumptive test" includes, but is not limited to, chemical tests using Marquis reagent,
 12 Duquenois-Levine reagent, Scott reagent system or modified Chen's reagent.

13 **SECTION 31.** ORS 670.280 is amended to read:

14 670.280. (1) As used in this section:

15 (a) "License" includes a registration, certification or permit.

16 (b) "Licensee" includes a registrant or a holder of a certification or permit.

17 (2) Except as provided in ORS 342.143 (3) or 342.175 (3), a licensing board, commission or agency
 18 may not deny, suspend or revoke an occupational or professional license solely for the reason that
 19 the applicant or licensee has been convicted of a crime, but it may consider the relationship of the
 20 facts which support the conviction and all intervening circumstances to the specific occupational
 21 or professional standards in determining the fitness of the person to receive or hold the license.
 22 *[There is a rebuttable presumption as to each individual applicant or licensee that an existing or prior*
 23 *conviction for conduct that has been classified or reclassified as a Class E violation does not make an*
 24 *applicant for an occupational or professional license or a licensee with an occupational or professional*
 25 *license unfit to receive or hold the license.]*

26 (3) Except as provided in ORS 342.143 (3) and 342.175 (3), a licensing board, commission or
 27 agency may deny an occupational or professional license or impose discipline on a licensee based
 28 on conduct that is not undertaken directly in the course of the licensed activity, but that is sub-
 29 stantially related to the fitness and ability of the applicant or licensee to engage in the activity for
 30 which the license is required. In determining whether the conduct is substantially related to the
 31 fitness and ability of the applicant or licensee to engage in the activity for which the license is re-
 32 quired, the licensing board, commission or agency shall consider the relationship of the facts with
 33 respect to the conduct and all intervening circumstances to the specific occupational or professional
 34 standards. *[There is a rebuttable presumption as to each individual applicant or licensee that an ex-*
 35 *isting or prior conviction for conduct that has been classified or reclassified as a Class E violation is*
 36 *not related to the fitness and ability of the applicant or licensee to engage in the activity for which the*
 37 *license is required.]*
