SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Department of Human Services to find public education program responsible for founded reports of abuse in specified circumstances. Modifies definition of "abuse" for purposes of child abuse to include violations of existing laws prohibiting infliction of corporal punishment on students. Modifies definition of "abuse" for purposes of child abuse to include violations of existing laws prohibiting use of restraint and seclusion on students. Restores definition on July 1, 2028.

Directs department to submit quarterly reports to Legislative Assembly regarding investigations of abuse involving child and school employee, contractor, agent or volunteer. Prohibits department in specified circumstances from substantiating allegation of abuse against

personnel of public education program who have not been appropriately trained. Repeals prohibition on June 30, 2028.

Declares emergency, effective on passage.
