SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Amends statutes relating to housing laws and to authority of Housing and Community Services Department and Oregon Housing Stability Council, including changes to department's procurement authority and ability to provide down payment assistance.

Declares emergency, effective on passage.

40 <u>SECTION 30.</u> ORS 317.097, as amended by section 25, chapter 83, Oregon Laws 2022, is 41 amended to read:

42 317.097. (1) As used in this section:

(a) "Annual rate" means the yearly interest rate specified on the note, and not the annual per centage rate, if any, disclosed to the applicant to comply with the federal Truth in Lending Act.

45 (b) "Bonds" means a bond, as defined in ORS 286A.001, if issued on behalf of the Housing and

1 Community Services Department, or bonds, as defined in ORS 456.055, if issued by a housing au-2 thority.

3 (c) "Finance charge" means the total of all interest, loan fees, interest on any loan fees financed
4 by the lending institution, and other charges related to the cost of obtaining credit.

5 (d) "Lending institution" means any insured institution, as that term is defined in ORS 706.008, 6 any mortgage banking company that maintains an office in this state or any community development 7 corporation that is organized under the Oregon Nonprofit Corporation Law.

(e) "Manufactured dwelling park" has the meaning given that term in ORS 446.003.

9 (f) "Nonprofit corporation" means a corporation that is exempt from income taxes under section 10 501(c)(3) or (4) of the Internal Revenue Code as amended and in effect on December 31, 2021.

(g) "Preservation project" means housing that was previously developed as affordable housing with a contract for rent assistance from the United States Department of Housing and Urban Development or the United States Department of Agriculture and that is being acquired by a sponsoring entity.

(h) "Qualified assignee" means any investor participating in the secondary market for real es-tate loans.

(i) "Qualified borrower" means any borrower that is a sponsoring entity that has a controlling
interest in the real property that is financed by a qualified loan. A controlling interest includes a
controlling interest in the general partner of a limited partnership that owns the real property.

20 (j) "Qualified loan" means:

(A) A loan that meets the criteria stated in subsection (5) of this section or that is made to re finance a loan that meets the criteria described in subsection (5) of this section; or

(B) The purchase by a lending institution of bonds, the proceeds of which are used to finance
or refinance a loan that meets the criteria described in subsection (5) of this section.

(k) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state governmental entity, local unit of government as defined in ORS 466.706, housing authority or any other person, provided that the person has agreed to restrictive covenants imposed by a nonprofit corporation, nonprofit cooperative, state governmental entity, local unit of government or housing authority.

(2) The Department of Revenue shall allow a credit against taxes otherwise due under this chapter for the tax year to a lending institution that makes a qualified loan certified by the Housing and Community Services Department as provided in subsection (7) of this section. The amount of the credit is equal to the difference between:

(a) The amount of finance charge charged by the lending institution during the tax year at an
 annual rate less than the market rate for a qualified loan that is made before January 1, 2026, that
 complies with the requirements of this section; and

(b) The amount of finance charge that would have been charged during the tax year by the lending institution for the qualified loan for housing construction, development, acquisition or rehabilitation measured at the annual rate charged by the lending institution for nonsubsidized loans made under like terms and conditions at the time the qualified loan for housing construction, development, acquisition or rehabilitation is made.

(3) The maximum amount of credit for the difference between the amounts described in subsection (2)(a) and (b) of this section may not exceed four percent of the average unpaid balance of

(4) Any tax credit allowed under this section that is not used by the taxpayer in a particular
 year may be carried forward and offset against the taxpayer's tax liability for the next succeeding

(9) The tax credit provided for in this section may be taken whether or not:

(a) The financial institution is eligible to take a federal income tax credit under section 42 of
