

Senate Bill 892

Sponsored by COMMITTEE ON HOUSING AND DEVELOPMENT (at the request of Housing and Community Services Department)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Amends statutes relating to housing laws and to authority of Housing and Community Services Department and Oregon Housing Stability Council, including changes to department's procurement authority and ability to provide down payment assistance.

Declares emergency, effective on passage.

A BILL FOR AN ACT

Relating to housing; creating new provisions; amending ORS 183.534, 270.100, 279A.025, 279A.050, 317.097, 456.270, 456.548, 456.555, 456.559, 456.571, 456.574, 456.579, 456.608, 456.625, 456.627, 456.710, 456.720, 458.210, 458.225, 458.310, 458.415, 458.485, 458.610 and 458.735; repealing ORS 456.505, 456.576 and 458.377; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

TRIBAL ACCESS TO HOUSING FUNDS

SECTION 1. ORS 458.210 is amended to read:

458.210. For the purposes of ORS 456.550 and 458.210 to 458.240, a community development corporation is:

(1) An organization that:

[*1*] (a) Is established under the provisions of ORS chapter 65;

[*2*] (b) Has qualified for tax exempt status under section 501(c)(3) of the Internal Revenue Code;

[*3*] (c) Has a purpose, stated in the articles of incorporation, to serve low and moderate income people's need for community development and community self-help;

[*4*] (d) Has a board of directors, of not fewer than five members, that is locally controlled by including 51 percent of the board members from the service area; and

[*5*] (e) Has a defined geographic service area[.]; **or**

(2) A housing entity or housing authority designated by a tribe, as defined in ORS 182.162, to receive funds and administer housing programs.

SECTION 2. ORS 458.225 is amended to read:

458.225. (1) In carrying out the provisions of ORS 456.550 and 458.210 to 458.240, the Housing and Community Services Department shall give preference to a community development corporation **described in ORS 458.210 (2) or** that:

(a) Has a defined geographic service area outside an entitlement community or county;

(b) Has a defined geographic service area inside an entitlement community or county but does not include more than 50,000 people in the service area;

(c) Has a defined geographic service area that includes five or fewer nonentitlement counties;

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

2 (d) Can demonstrate support from the community.

3 (2) As used in this section, “entitlement community or county” means any area within the state
4 that is:

5 (a) A “metropolitan city” as defined in 42 U.S.C. 5302(4) (1995); or

6 (b) An “urban county” as defined in 42 U.S.C. 5302(6) (1995).

10 **SECTION 3.** ORS 456.555 is amended to read:

11 456.555. (1) The Housing and Community Services Department is established.

12 (2) The department [*shall be under the supervision and control of*] **is supervised and controlled**
13 **by** a director who is responsible for the performance of the duties imposed upon the department.
14 The Governor shall appoint the Director of the Housing and Community Services Department. The
15 director shall hold office at the pleasure of the Governor. The person appointed as director [*shall*]
16 **must** be a person who, by training and experience, is well qualified to perform the duties of the
17 office.

18 (3) The director shall receive such salary as may be provided by law, or, if not so provided, as
19 may be fixed by the Governor. In addition to the salary of the director, the director shall, subject
20 to the limitations otherwise provided by law, be reimbursed for all expenses actually and necessarily
21 incurred by the director in the performance of official duties.

22 (4) The director may establish department divisions including but not limited to divisions for
23 administration, housing programs and community services programs.

24 [*(5) The Oregon Housing Stability Council shall:*]

25 [*(a) With the advice of the director, set policy and approve or disapprove rules and standards for*
26 *housing programs;]*

27 [*(b) Approve or disapprove loans, grants and other funding award proposals under ORS*
28 *456.561;*]

29 [*(c) Provide policy direction and oversight to the department regarding the department’s financial*
30 *planning and biennial budget proposal prior to its submittal to the Oregon Department of Adminis-*
31 *trative Services; and]*

32 [*(d) Carry out the provisions of ORS 456.571.*]

33 [(6)] **(5)** The [*Housing and Community Services*] department [*and the council*] shall consider ad-
34 vice on housing and community service programs from:

35 (a) Persons who have experienced housing instability;

36 (b) Tribes;

37 (c) The Community Action Partnership of Oregon;

38 (d) Continuums of care, as defined in 24 C.F.R. part 578;

39 (e) Local governments;

40 (f) Nonprofit organizations;

41 (g) Homeless services providers;

42 (h) Culturally specific organizations;

43 (i) Housing providers;

44 (j) Veterans’ services organizations; and

45 (k) Other entities identified by the department by rule.

1 [(7)] (6) The director shall report regularly to the **Oregon Housing Stability** Council to keep
 2 the council informed on progress made by the department in carrying out the department's respon-
 3 sibilities for housing programs.

4 [(8)] (7) The department shall administer federal programs [*with advice from the council*]. Federal
 5 funds for housing stabilization must, to the extent consistent with federal law, be allocated statewide
 6 in a manner proportionate to a needs-based and geographically based formula.

7 [(9)] (8) The department may adopt rules to carry out the programs that the department is
 8 charged with administering, including, but not limited to, rules regarding:

9 (a) Administration and enforcement.

10 (b) Criteria for the granting of benefits.

11 (c) The establishment of fees and charges.

12 (d) The identification of housing programs and community services programs.

13 (e) The distinguishing of housing programs from community services programs.

14 **(9) When a statute authorizes or requires that the department or the director adopt rules**
 15 **or policies or administer programs, the director may, at any stage in the process, consult**
 16 **with or seek the approval of the council.**

17 (10) [*Subject to the approval of the council,*] The department shall establish by rule one or more
 18 threshold property purchase prices above which a housing loan proposed by the department requires
 19 council review and approval under ORS 456.561. In establishing or modifying a threshold property
 20 purchase price under this subsection, the department shall consider any maximum acquisition cost
 21 set forth in the Internal Revenue Code or federal rules and regulations implementing the code.

22 (11) [*Subject to the approval of the council,*] The department shall establish by rule one or more
 23 threshold amounts above which a housing grant or other housing funding award proposal requires
 24 council review and approval under ORS 456.561.

25 **SECTION 4.** ORS 456.559 is amended to read:

26 456.559. (1) The Housing and Community Services Department shall:

27 (a) Maintain current housing data and information concerning available programs, status of
 28 funding, programs planned or undertaken which might conflict with, overlap, duplicate or supersede
 29 other planned or existing programs and call these to the attention of appropriate state agencies,
 30 governmental bodies and public or private housing sponsors.

31 (b) Maintain current data from local, state and federal sources concerning publicly supported
 32 housing as that term is defined in ORS 456.250, the status of existing affordability restrictions as
 33 that term is defined in ORS 456.250 and rental assistance contracts at publicly supported housing.

34 (c) Provide to appropriate state agencies, governmental bodies and public or private housing
 35 sponsors such advisory and educational services as will assist them in the development of housing
 36 plans and projects.

37 (d) Subject to the approval of the Oregon Housing Stability Council, make noninterest bearing
 38 advances, in accordance with ORS 456.710 and the policies of the department, to qualified nonprofit
 39 sponsors for development costs of housing projects until mortgage funds are released to repay the
 40 advances as provided in ORS 456.710.

41 (e) Advise and assist appropriate state agencies, governmental bodies and public or private
 42 housing sponsors, cities and counties, in all programs and activities which are designed or might
 43 tend to fulfill the purposes of ORS 456.548 to 456.725 and ORS chapter 458.

44 (f) Encourage and assist in the planning, development, construction, rehabilitation and conser-
 45 vation of dwelling units for persons and families of lower income.

1 (g) Be the central state department to apply for, receive and distribute, on behalf of appropriate
2 state agencies, governmental bodies and public or private housing sponsors in the state, grants, gifts,
3 contributions, loans, credits or assistance from the federal government or any other source for
4 housing programs except when the donor, grantor, or lender of such funds specifically directs some
5 other agency to administer them. Moneys received under this section shall be deposited with the
6 State Treasurer in an account separate and distinct from the General Fund. Interest earned by the
7 account shall be credited to the account.

8 (h) For the purposes of acquiring moneys, credits or other assistance from any agency or
9 instrumentality of the United States or from any public corporation chartered by the United States,
10 comply with any applicable agreements or restrictions for the receipt of such assistance and become
11 a member of any such association or public corporation chartered by the United States.

12 (i) Assist individuals, appropriate state agencies, governmental bodies and public or private
13 housing sponsors through a program which provides housing information, planning, educational
14 services and technical assistance.

15 (j) Comply with the requirements of ORS 443.225 in assisting in the development of any housing
16 for residential care, training or treatment for persons with intellectual or developmental disabilities
17 or mental or emotional disturbances.

18 (2) Except as otherwise provided in ORS 456.255 to 456.265, 456.625 (7) and 458.480 to 458.490,
19 the department may not itself develop, construct, rehabilitate or conserve housing units; and neither
20 the department nor any housing sponsor, including but not limited to any association, corporation,
21 cooperative housing authority or urban renewal agency organized to provide housing and other fa-
22 cilities under ORS 456.548 to 456.725, may own, acquire, construct, purchase, lease, operate or
23 maintain utility facilities, including facilities for the generation of electricity, for the distribution
24 of gas and electricity, and for the conveyance of telephone and telegraph messages.

25 (3) In accordance with the provisions of this section and with the advice of the council, the
26 department shall establish statewide priorities for housing programs. State agencies shall coordinate
27 their housing programs with the department. All state agencies intending to apply for federal funds
28 for use in planning, developing or managing housing, or rendering assistance to governmental bodies
29 or sponsors or individuals involved therein shall submit a description of the proposed activity to the
30 department for review not less than 30 days prior to the intended date of submission of the appli-
31 cation to the federal agency. The department shall determine whether the proposal would result in
32 a program that would overlap, duplicate or conflict with any other housing program in the state. If
33 the department finds overlapping or duplication or conflict, it shall recommend modifications in the
34 application. The Oregon Department of Administrative Services shall consider these recommen-
35 dations in making its decision to approve or disapprove the application. The department shall com-
36 plete its review and forward its recommendations within 15 working days after receipt of the
37 notification. Failure of the department to complete the review within that time shall constitute ap-
38 proval of the application by the department.

39 (4) The Director of the Housing and Community Services Department may participate in dis-
40 cussions and deliberations of the council. The director may suggest policies [*and rules*] to the
41 council, including those necessary to stimulate and increase the supply of housing for persons and
42 families of lower income.

43 **SECTION 5.** ORS 456.571 is amended to read:

44 456.571. (1) The Oregon Housing Stability Council shall, with the advice of the Director of the
45 Housing and Community Services Department, develop policies to:

1 (a) Aid in stimulating and increasing the supply of housing for persons and families of lower
2 income;

3 (b) Address geographic and racial disparities; and

4 (c) Ensure funds distributed by the Housing and Community Services Department contribute to
5 addressing other state priorities.

6 (2) The council shall make special effort to respond to both private and public actions that may
7 raise the cost of the housing supply in the open market, as the open market is the source of housing
8 for the preponderance of lower income households.

9 (3) The council is responsible for studying and commenting upon, and advising the department,
10 Governor, Legislative Assembly, other state agencies and local governments concerning, local, state
11 and federal legislation or rules that affect the cost and supply of housing, both before and after the
12 legislation and rules are enacted. For purposes of this subsection, "legislation or rules that affect
13 the cost and supply of housing" includes but is not limited to legislation or rules that would:

14 (a) Provide financing for the construction or rehabilitation of housing;

15 (b) Subsidize new or existing housing costs for lower income households by income support, tax
16 credit, or support service methods;

17 (c) Regulate the division of land;

18 (d) Regulate the use of land;

19 (e) Regulate building construction standards;

20 (f) Regulate fees and charges for inspection services, permits, or professional services related
21 to housing;

22 (g) Encourage alternatives that increase housing choices;

23 (h) Create or avert overlapping jurisdictional functions and the concomitant increased costs that
24 are reflected in housing prices;

25 (i) Create or avoid conflicting state and federal regulations that deprive lower income house-
26 holds of assistance; and

27 (j) Help or hinder compliance with the housing goals established by the Land Conservation and
28 Development Commission under ORS 197.240.

29 (4) The council, with the approval of the Governor, may initiate legal proceedings in the name
30 of the council to further the council's purposes under this section.

31 (5) The council shall exercise the responsibilities and powers of the council in a manner that
32 expedites the acquisition, construction, improvement or rehabilitation of housing.

33 (6) With respect to the Community Development Incentive Project Fund established under ORS
34 458.720, the council shall develop program guidelines, including specific project criteria and financ-
35 ing mechanisms, review applications seeking funding from the fund and make recommendations for
36 funding approval to the director and review proposals for cooperative agreements or joint projects
37 between the department and other state agencies to facilitate the goals of the fund.

38 (7) The council[, *in conjunction with the Community Action Partnership of Oregon,*] shall advise
39 and assist the department, **at the director's request**, with rules, policies and programs [*regarding*
40 *low income home energy assistance under ORS 458.515.*] **under ORS 456.555 (9). In providing advice**
41 **and assistance, the council shall consider advice on housing and community service pro-**
42 **grams from entities listed under ORS 456.555 (5) and other entities identified by the depart-**
43 **ment by rule.**

44 (8) **The council shall approve or disapprove loans, grants and other funding award pro-**
45 **posals under ORS 456.561.**

1 [(8)] (9) The council, in conjunction with the Community Action Partnership of Oregon, shall
2 ensure the coordination of state agency homelessness relief efforts.

3 **SECTION 6.** ORS 456.608 is amended to read:

4 456.608. (1) The Housing and Community Services Department shall develop and implement the
5 Rent Guarantee Program for the purpose of providing incentives and financial assistance to land-
6 lords that rent to low income households by guaranteeing payments to landlords for unpaid rent and
7 for eviction and property damage costs as described in this section. [*Department administration of*
8 *the program is subject to Oregon Housing Stability Council policy, rules and standards.*]

9 (2) A tenant is eligible to participate in the program if the tenant:

10 (a) Resides in a low income household;

11 (b) Experiences barriers to obtaining housing, including but not limited to:

12 (A) Poor credit history or ratings;

13 (B) A criminal history;

14 (C) That the tenant has been a ward, as defined in ORS 419A.004, within the past 10 years and
15 is at least 16 years of age and less than 27 years of age; or

16 (D) A history of housing evictions; and

17 (c) Successfully completes the tenant training and certification process implemented by the de-
18 partment under subsection (3) of this section.

19 (3) As part of the program implemented under this section, the department shall provide training
20 to, and a certification process for, tenants from low income households for the purposes of providing
21 tenants with information on how to achieve and maintain a successful tenancy and providing reli-
22 able accreditation of tenants to landlords that are considering renting to tenants from low income
23 households.

24 (4) A landlord may submit a request for financial assistance to the department in accordance
25 with rules adopted by the [*council*] **department**. Financial assistance to landlords under the program
26 is limited as follows:

27 (a) Reimbursement for unpaid rent and payment of eviction and damage costs are limited to
28 circumstances involving rental or lease agreements entered into with tenants determined to be eli-
29 gible under subsection (2) of this section;

30 (b) Financial assistance is limited to reimbursement for unpaid rent and eviction and damage
31 costs incurred during the first 12 months of any single rental or lease agreement;

32 (c) Financial assistance paid under the program to a landlord is limited to a maximum of \$5,000
33 per eligible request; and

34 (d) Payment of financial assistance is contingent on the landlord's submission of a complete and
35 accurate reimbursement request, verification of unpaid rent and eviction or damage claims by the
36 department or program provider described in subsection (6) of this section and cooperation with the
37 collection of data to measure program performance outcomes as described in subsection (6) of this
38 section.

39 (5) Before receipt of payments of financial assistance under the program, a landlord must pro-
40 vide to the department or the program provider described in subsection (6) of this section a report
41 containing information required by rule [*adopted by the council*]. The report must contain, at a min-
42 imum, the following:

43 (a) Information regarding eligible tenants with whom the landlord entered into tenancy agree-
44 ments including, but not limited to, the length of tenancy and reason for termination of tenancy, if
45 applicable; and

1 (b) The amounts of unpaid rent and eviction and damage costs not reimbursed by financial as-
2 sistance received by the landlord under the program.

3 (6)(a) The department may contract with a public or private provider to administer the program
4 within an individual county or region of this state and to distribute financial assistance to eligible
5 landlords as provided in this subsection. The department is not subject to the provisions of ORS
6 chapter 279A or 279B in awarding a contract under the provisions of this subsection. The depart-
7 ment shall, in consultation with the **Oregon Housing Stability Council**, establish criteria for pro-
8 posals, prepare and publish requests for proposals, receive proposals and award contracts to eligible
9 providers. Eligible providers must, at a minimum:

10 (A) Have experience providing tenant readiness education sufficient to provide tenant training
11 and certification as described in subsection (3) of this section;

12 (B) Have experience placing persons in low income households into permanent housing;

13 (C) Have experience working collaboratively with local landlords and service providers; and

14 (D) Demonstrate the organizational capacity to administer the program, including the ability to
15 track data and performance measure outcomes and to timely process requests for and payments of
16 financial assistance.

17 (b) Program providers shall, in accordance with rules adopted by the [council] **department**:

18 (A) Provide reports regarding the number of landlords and program eligible tenants participating
19 in the program, demographic information about tenants, identified tenant risk factors and the num-
20 ber and amount of requests for financial assistance made under the program;

21 (B) Review and verify requests for financial assistance and make payments in accordance with
22 established department processes for distributing funds; and

23 (C) Collect data to measure the following program performance outcomes:

24 (i) Increased housing stability, as measured by the percentage of total program participants who
25 reside in and maintain permanent housing for a minimum of 12 months;

26 (ii) Increased landlord participation, as measured by the percentage increase in the number of
27 landlords participating in the program; and

28 (iii) Successful tenant readiness education, as measured by the percentage of tenants success-
29 fully completing the tenant training and receiving certification as described in subsection (3) of this
30 section.

31 (7) Nothing in this section prohibits a landlord from participating in the Housing Choice Land-
32 lord Guarantee Program under ORS 456.375 to 456.390 or the Housing Choice Voucher Program
33 under 42 U.S.C. 1437f(o).

34 (8) The department may not pay financial assistance under the Rent Guarantee Program from
35 any source other than available funds in the Rent Guarantee Program Fund established in ORS
36 456.609. Amounts due and payable under the program shall not constitute a debt of the state or a
37 lending of the credit of the state within the meaning of any constitutional or statutory limitation.

38 (9) The department shall submit an annual report to the interim legislative committees of the
39 Legislative Assembly related to housing no later than September 15th of each year regarding the
40 implementation and status of the program, the number of participants in the program, amounts of
41 financial assistance requested and paid and the performance outcomes measured by the program.

42 (10) [The council, in consultation with] The department[,] shall adopt rules to implement the
43 provisions of this section.

44 **SECTION 7.** ORS 458.310 is amended to read:

45 458.310. (1) The [Oregon Housing Stability Council] **Housing and Community Services De-**

1 **partment** shall adopt rules to develop and administer a housing revitalization program for low and
2 moderate income housing.

3 (2) Applicants for revitalization program funds shall be:

4 (a) A unit of local government;

5 (b) A housing authority;

6 (c) A nonprofit corporation; or

7 (d) An applicant eligible under paragraph (a), (b) or (c) of this subsection who contracts with
8 another entity, including a private for-profit corporation.

9 (3) Housing revitalization projects shall bring into use vacant and abandoned property or reha-
10 bilitate substandard property, or both. Eligible project activities include, but are not limited to:

11 (a) Purchase of property;

12 (b) Rehabilitation of housing units;

13 (c) New construction to replace units for which rehabilitation is infeasible;

14 (d) Mortgage interest subsidies or reduction of principal loan amounts; or

15 (e) Other activities that have the effect of making properties available to and occupied by per-
16 sons of lower income, such as loan guarantees.

17 (4) Projects funded by the housing revitalization program shall be rental or owner-occupied
18 single or multifamily housing.

19 (5) The housing rehabilitation program shall create affordable housing in which rent levels are
20 no higher than 30 percent of 80 percent of median income levels.

21 (6) Priority shall be given to projects applied for under subsections (1) to (5) of this section that
22 provide opportunities for low and moderate income persons to own their housing units.

23 (7) Priority among rental housing projects shall be given to projects applied for under sub-
24 sections (1) to (5) of this section that:

25 (a) Have rent levels no higher than 30 percent of 50 percent of the median income level, or less;

26 (b) Are owned and operated by a nonprofit or a governmental unit; and

27 (c) Demonstrate a coordinated local effort to integrate housing, job placement and social ser-
28 vices.

29 (8) In implementing this section and ORS 458.305, the [council] **department** shall work to ensure
30 a reasonable geographic distribution of funds among different regions of the state and shall place
31 special emphasis on ensuring that funds are available to projects in rural areas.

32 **SECTION 8. ORS 458.480 to 458.490 are added to and made a part of ORS chapter 458.**

33 **SECTION 9.** ORS 458.485 is amended to read:

34 458.485. (1) The Housing and Community Services Department shall, [with the advice and consent
35 of] **after consultation with** the Oregon Housing Stability Council, develop and implement the Local
36 Innovation and Fast Track Housing Program for the purpose of expanding the state's supply of af-
37 fordable housing for low income households.

38 (2) The department may use funds available pursuant to Article XI-Q of the Oregon Constitution
39 and deposited in the Local Innovation and Fast Track Housing Program Fund established under ORS
40 458.490 to:

41 (a) Acquire, construct, remodel, repair, equip or furnish qualified property that is or will be
42 owned or operated by the State of Oregon for the purpose of providing affordable housing in this
43 state for low income households; and

44 (b) Pay development costs to develop qualified property that may be considered part of the cost
45 of a capital asset under generally accepted accounting principles.

1 (3) Interests in real property acquired by the State of Oregon or the department under this
2 section are limited to the following:

3 (a) A fee simple interest in land or improvements;

4 (b) A leased fee interest, meaning an ownership interest with the rights of use and occupancy
5 conveyed by lease to others;

6 (c) A tenancy in common for which the state's or department's interest in the property is
7 proportionate to the contribution of the state or department to the property's purchase price;

8 (d) A fee simple interest in a condominium; or

9 (e) An easement, right of way, license or similar interest functionally related to and necessary
10 for the use of qualified property acquired by the state or department.

11 (4) In funding the acquisition, construction, remodeling, repairing, equipping or furnishing of
12 qualified property under the program, the department[, *with the advice and consent of the council,*]
13 may:

14 (a) Adopt criteria that:

15 (A) Provide the greatest number of affordable housing units for the amount of funding provided;

16 (B) Ensure the longest possible use of the qualified property as affordable housing units;

17 (C) Optimize the function and duration of the affordable housing project; and

18 (D) Take into account the means to reduce the cost of the affordable housing project while
19 considering factors such as the quality of construction, durability, location and local design re-
20 quirements;

21 (b) Create restrictive covenants and other encumbrances or lien interests, create entities, co-
22 operate or participate with persons or entities and contract with persons and entities; and

23 (c) Operate qualified property.

24 (5) Moneys made available through the program must be distributed or used statewide and
25 concentrated in areas of this state with the greatest need for affordable housing, as determined by
26 the department with the advice and consent of the council.

27 (6) For purposes of implementing the program, the council shall develop strategies to:

28 (a) Reach historically underserved communities, including communities of color and rural com-
29 munities;

30 (b) Reduce the cost of acquiring, constructing, remodeling, repairing, equipping or furnishing
31 qualified property that is owned or operated by the state for the purpose of providing affordable
32 housing; and

33 (c) Involve Department of Human Services child welfare and self-sufficiency programs.

34 (7) The Director of the Housing and Community Services Department shall report regularly to
35 the council regarding the status and progress of the program and of the Housing and Community
36 Services Department's responsibilities for implementing and administering the program.

37 (8) The department[, *with the advice and consent of the council,*] shall adopt rules to implement
38 the provisions of this section, including but not limited to prescribing requirements for acquiring,
39 constructing, remodeling, repairing, equipping or furnishing qualified property that is owned or op-
40 erated by the state for the purpose of providing affordable housing under the program.

41 **SECTION 10.** ORS 458.610 is amended to read:

42 458.610. For purposes of ORS 458.600 to 458.665:

43 (1) "Area median income" means the area median income, subject to adjustment for areas with
44 unusually high or low incomes or housing costs, all as determined by the [*Oregon Housing Stability*
45 *Council*] **Housing and Community Services Department** based on information from the United

1 States Department of Housing and Urban Development.

27 or enforce any right conferred upon the department by any law, mortgage, security, agreement,
28 contract or other agreement and to bid for and purchase property that is subject to such mortgage
29 or security interest at any foreclosure or other sale; acquire or take possession of any such property
30 and complete, administer, conserve, improve and otherwise use the property to accomplish the
31 department's purposes, pay the principal and interest on any obligations incurred in connection with
32 such property and dispose of such property in such manner as the department determines necessary
33 to protect its interests under ORS 456.515 to 456.725 and ORS chapter 458.

34 (8) Unless specifically exempted by the State Treasurer, deposit with the State Treasurer any
35 funds held in reserve or sinking funds under ORS 456.515 to 456.725 and ORS chapter 458 and any
36 other moneys not required for immediate use or disbursement by the department, subject to the
37 provisions of any agreement with holders of bonds entered into prior to October 15, 1983.

38 (9) Advise and assist in the creation of any nonprofit housing corporation, consumer housing
39 cooperative or limited dividend housing sponsor and give approval of the articles of incorporation
40 and bylaws of any such organization in carrying out ORS 456.515 to 456.725.

41 (10) Cooperate with and exchange services, personnel and information with any federal, state
42 or local governmental agency.

43 (11) With the approval of the State Treasurer, contract for the services of and consultation with
44 trustees, investment and financial advisors, paying agents, remarketing agents and other profes-
45 sional persons or organizations in carrying out ORS 456.515 to 456.725 and ORS chapter 458.

1 (12) Contract for, act on or perform any other duties that the department considers necessary
2 or appropriate to carry out housing programs and community services programs, including but not
3 limited to contracting to provide compliance monitoring or other administrative functions with re-
4 spect to housing developments and affordable housing, whether or not the housing developments or
5 affordable housing receives department funding and whether or not the housing developments or
6 affordable housing is located within this state. For purposes of this subsection, "affordable
7 housing" has the meaning given that term in ORS 456.055.

8 (13) Purchase, service, sell and make commitments to purchase, service and sell residential loans
9 to the extent permitted by ORS 456.635 and 456.640 (1) to (3).

10 (14) Initiate or assist appropriate state agencies, governmental bodies and public or private
11 housing sponsors in the development, construction, acquisition, ownership, leasing, rehabilitation or
12 management of housing to carry out the purposes of ORS 456.515 to 456.725 and ORS chapter 458
13 where such housing is not otherwise affordable or available in the area.

14 (15) Execute and record written instruments that contain terms, including but not limited to
15 restrictive covenants or equitable servitudes, pertaining to the use and enjoyment of housing
16 projects. Notwithstanding any other provision of law, the executed instruments shall constitute and
17 create restrictive covenants affecting and running with the property according to the terms of the
18 instruments when recorded in the records of the county where the property is located. County clerks
19 shall accept the instruments for recording when presented by or on behalf of the department.

20 (16) Subject to the provisions of any agreement then existing with bondholders, make available
21 funds by contract, grant, loan or otherwise, including loan guarantees, insurance or other financial
22 leveraging techniques, from moneys made available by the department to carry out the purposes of
23 ORS 456.515 to 456.725, if such moneys are not needed for the operations of the department or oth-
24 erwise determined by the Director of the Housing and Community Services Department to be a
25 necessary or prudent reserve.

26 (17) With the approval of the Oregon Housing Stability Council, award grants to private or
27 public entities to support or develop programs that build on successful strategies that help individ-
28 uals obtain and retain housing, including through:

29 (a) Tenant education services for low-income tenants, including Rent Guarantee Program train-
30 ing under ORS 456.608 (3);

31 (b) Fair housing training for tenants and landlords;

32 (c) Technological innovations that help low-income individuals find and access available rental
33 housing; and

34 (d) Other education, services or resources for low-income tenants and prospective tenants and
35 for landlords who serve low-income tenants.

36 **(18) Procure and supervise the procurement of goods, services and personal services that**
37 **are acquired in connection with the exercise of the department's duties prescribed in this**
38 **chapter and ORS chapter 458.**

39 **(19) For goods, services and personal services that are unrelated to the duties prescribed**
40 **in this chapter and ORS chapter 458, subject to any rule that may be adopted by the de-**
41 **partment for the administration of such procurements:**

42 **(a) Procure and supervise the procurement of goods, services and personal services that**
43 **relate to information technology products or systems; and**

44 **(b) Conduct sole-source procurements as provided under ORS 279B.075, and special pro-**
45 **curements as provided under ORS 279B.085, except that the Director of the Housing and**

1 **Community Services Department may take any action that the Director of the Oregon De-**
 2 **partment of Administrative Services is authorized to take under ORS 279B.075 and 279B.085.**

 6 **SECTION 17.** ORS 456.627 is amended to read:

7 456.627. Notwithstanding the provisions of ORS 456.625 (7) **and except for loans made solely**
 8 **to provide assistance with down payments or closing costs,** the Housing and Community Ser-
 9 vices Department *[shall]* **may** not make any single-family residential loan directly to any individual
 10 unless the Legislative Assembly or Emergency Board finds that private lending institutions are un-
 11 willing or unable to participate in the department’s single-family residential loan programs or
 12 portions of those programs under ORS 456.548 to 456.725.

13 **SECTION 18.** ORS 456.548 is amended to read:

14 456.548. As used in ORS 456.548 to 456.725, unless the context requires otherwise:

15 (1) “Bonds” means any bonds, as defined in ORS 286A.001, or any other evidence of indebt-
 16 edness, issued under ORS 456.515 to 456.725 or issued in anticipation of bonds and payable from the
 17 proceeds of bonds issued.

18 (2) “Capital reserve account” or “capital reserve accounts” means one or more of the special
 19 trust accounts that may be established by the Housing and Community Services Department within
 20 the Housing Finance Fund.

21 (3) “Consumer housing cooperative” means a cooperative corporation formed under ORS chapter
 22 62 and whose articles of incorporation provide, in addition to the other requirements of ORS chapter
 23 62, that:

24 (a) The consumer housing cooperative has been organized exclusively to provide housing facili-
 25 ties for persons and families of lower income and such social, recreational, commercial and com-
 26 munal facilities as may be incidental to such housing facilities.

27 (b) All income and earnings of the consumer housing cooperative shall be used exclusively for
 28 consumer housing cooperative purposes and that no unreasonable part of the net income or net
 29 earnings of the cooperative shall inure to the benefit or profit of any private individual, firm, cor-
 30 poration, partnership or association.

31 (c) The consumer housing cooperative is in no manner controlled or under the direction of or
 32 acting in the substantial interest of any private individual, firm, corporation, partnership or associ-
 33 ation seeking to derive profit or gain therefrom or seeking to eliminate or minimize losses in any
 34 transaction therewith, except that such limitation shall apply to the members of the cooperative only
 35 to the extent provided by rules of the department.

36 (d) The operations of the consumer housing cooperative may be supervised by the department
 37 and that the consumer housing cooperative shall enter into such agreements with the department
 38 as the department may require to provide regulation by the department of the planning, development
 39 and management of any housing project undertaken by the cooperative and the disposition of the

6 [(5) "*Federally insured security*" means an evidence of indebtedness insured or guaranteed as to
7 repayment of principal and interest by the United States or an agency or instrumentality thereof.]

8 [(6)] (5) "Housing development" means a development that contains housing units for persons
9 or families of lower income and such other incidental elements of residential, commercial, recre-
10 ational, industrial, communal or educational facilities as the department determines improve the
11 quality of the development as it relates to housing for persons or families of lower income and the
12 financial feasibility of the development.

13 [(7)] (6) "Housing finance bond declaration" means a written instrument signed by the Director
14 of the Housing and Community Services Department or the designee of the director and on file with
15 and bearing the certificate of approval of the State Treasurer or the designee of the State Treasurer,
16 and all housing finance bond declarations supplemental to that instrument.

17 [(8)] (7) "Housing Finance Fund" means the Housing Finance Fund established in ORS 456.720
18 (1).

19 [(9)] (8) "Lending institution" means any bank, mortgage banking company, trust company,
20 savings bank, credit union, national banking association, federal savings and loan association or
21 federal credit unit maintaining an office in this state, or any insurance company authorized to do
22 business in this state.

23 [(10)] (9) "Limited dividend housing sponsor" means a corporation, trust, partnership, association
24 or other entity, or an individual that is a mortgagor.

25 [(11)] (10) "Manufactured dwelling park nonprofit cooperative" has the meaning given that term
26 in ORS 62.803.

27 [(12)] (11) "Manufactured housing" means a dwelling unit manufactured off-site having a mini-
28 mum width of 10 feet and a minimum area of 400 square feet built on a permanent chassis and de-
29 signed to be used for permanent residential occupancy whether or not on a permanent foundation,
30 and that contains permanent eating, cooking, sleeping and sanitary facilities and meets such stan-
31 dards as the department determines, by rule, are reasonable to maintain the quality, safety and du-
32 rability of the dwelling, the sanitary requirements of the communities in which they are located and
33 the security of the loans that the department may finance for the purchase of the dwellings.

34 [(13)] (12) "Nonprofit housing corporation" means an organization formed under ORS chapter
35 65 and whose articles of incorporation provide, in addition to the other requirements of ORS chapter
36 65, that:

37 (a) The corporation has been organized exclusively to provide housing facilities for persons and
38 families of lower income and such other social, recreational, commercial and communal facilities as
39 may be incidental to such housing facilities.

40 (b) All the income and earnings of the corporation shall be used exclusively for corporation
41 purposes and that no part of the net income or net earnings of the corporation may inure to the
42 benefit of any private individual, firm, corporation, partnership or association.

43 (c) The corporation is in no manner controlled or under the direction or acting in the substan-
44 tial interest of any private individual, firm, partnership or association seeking to derive profit or
45 gain therefrom or seeking to eliminate or minimize losses in transactions therewith.

1 (d) The operations of the corporation may be supervised by the department and that the corpo-
 2 ration shall enter into such agreements with the department as the department may require to reg-
 3 ulate the planning, development and management of any housing project undertaken by the
 4 corporation and the disposition of the property and other interests of the corporation.

5 [(14)] (13) "Person of lower income" or "family of lower income" means:

6 (a) A person or family residing in this state whose income is not more than 80 percent of area
 7 median income, adjusted for family size, as determined by the [*Oregon Housing Stability Council*]
 8 **Housing and Community Services Department** based [*upon*] **on** information from the United
 9 States Department of Housing and Urban Development;

10 (b) A person or family residing in this state whose income, adjusted for family size, is below the
 11 level the Housing and Community Services Department has determined to be necessary in order to
 12 obtain in the open market decent, safe and sanitary housing, including the cost of utilities and taxes,
 13 for not more than 25 percent of the gross income of the person or family; or

14 (c) Any person or family the department determines is appropriate to treat as a person of lower
 15 income or a family of lower income incidental to the accomplishment of department programs for
 16 persons and families of lower income described in paragraphs (a) and (b) of this subsection.

17 [(15)] (14) "Project cost" or "costs of the project" means the sum of all reasonable expenses in-
 18 curred by a qualified housing sponsor in undertaking and completing a housing project approved by
 19 the department. "Project costs" or "costs of the project" include but are not limited to the expenses
 20 incurred by a qualified housing sponsor for:

21 (a) Studies and surveys;

22 (b) Plans, specifications, architectural and engineering services;

23 (c) Legal, organizational and other special services;

24 (d) Financing, acquisition, demolition, construction, equipment and site development of new and
 25 rehabilitated housing units;

26 (e) Movement of existing buildings to new sites; the cost of acquisition, or estimated fair market
 27 value, of land and other interests in real estate;

28 (f) Rehabilitation, reconstruction, repair or remodeling of existing buildings;

30 (h) Placement of tenants or occupants and relocation services in connection with the housing

32 (i) Reasonable builder's or sponsor's profit and risk allowance; and

33 (j) Development costs not otherwise included in this subsection.

34 [(16)] (15) "Qualified housing sponsor" means[, *subject to the approval of*] **the following entities**
 35 **if approved by** the department under ORS 456.620 (2):

36 (a) A consumer housing cooperative;

37 (b) A limited dividend housing sponsor;

38 (c) A nonprofit housing corporation;

39 (d) A for-profit housing sponsor;

40 (e) A housing authority;

41 (f) An urban renewal agency created by ORS 457.035; and

42 (g) Any city or county governing body or agency or department designated by the governing
 43 body.

44 [(17)] (16)(a) "Residential housing" means a specific work or improvement within this state
 45 undertaken primarily to provide dwelling accommodations, including land development and acqui-

tion, construction or rehabilitation of buildings and improvements thereto, for residential housing, and such other nonhousing facilities as may be incidental or appurtenant thereto and as the department determines improve the quality of the development as it relates to housing for persons or families of lower income and the financial feasibility of the development.

(a) A loan that is for the acquisition, construction, improvement or rehabilitation of residential housing and, if the loan is for acquisition or construction of residential housing, that is secured by a first lien on real property located in the state and:

(A) Improved by a newly constructed, existing or rehabilitated residential structure for persons or families of lower income; or

(B) Unimproved if the proceeds of such loan shall be used for the erection of a residential structure thereon, whether or not such loan is insured or guaranteed by the United States or any instrumentality or agency thereof.

(b) An insured or guaranteed loan for the acquisition of manufactured housing or for the acquisition of a lot described in ORS 92.840 by a manufactured dwelling park tenant.

(c) A loan for the purchase of a proprietary lease and related cooperative shares in a housing cooperative formed under ORS chapter 62 secured by a security interest of first priority and a pledge or an assignment of proprietary leases and related cooperative shares.

(d) A loan, secured by such lien as may be approved by the department, made for the acquisition of a residential structure and made solely to provide down payment or closing cost assistance to allow low and moderate income households to qualify for a first position purchase loan on the structure.

[(19) “Revolving account” means the Housing and Community Services Department Revolving Account created in ORS 456.574.]

FUNDS AND ACCOUNTS

SECTION 19. ORS 456.574 is amended to read:

456.574. (1) There is created in the General Fund of the State Treasury the Housing and Community Services Department [Revolving Account] **Fund**. All moneys deposited in the [account] **fund** are continuously appropriated for the purposes of carrying out the programs which the Housing and Community Services Department is charged with administering subject to limitations otherwise prescribed by law.

(2) The [Housing and Community Services] department may transfer to the [Housing and Community Services Department Revolving Account] **fund** amounts not to exceed \$250,000 from funds available to the department. [Such funds hereby] **Moneys in the fund** are continuously appropriated [for] **to the department to:**

(a) [The making of] **Make** advances under ORS 456.559 (1)(d) or 456.710; and

(b) [The use by the department in the payment of] **Pay** expenses incurred by the department in carrying out ORS 456.548 to 456.725; however, any such funds expended by the department under

1 this paragraph [*shall*] **must** be repaid by the department into the [*revolving account*] **fund** from the
2 fees and charges collected under ORS 456.625 (3) and from any other moneys available for such re-
3 payment in accordance with ORS 456.548 to 456.725.

4 **SECTION 20.** ORS 456.710 is amended to read:

5 456.710. (1) The Housing and Community Services Department may use moneys in the [*revolving*
6 *account*] **Housing and Community Services Department Fund** to make noninterest-bearing ad-
7 vances to qualified nonprofit housing sponsors or interest-bearing advances to other qualified hous-
8 ing sponsors for use in payment by such sponsors of the development costs of proposed housing units
9 or projects. The department may not make any advance under this subsection unless the department

22 456.720. (1) The Housing Finance Fund is established, separate and distinct from the General
23 Fund. The **Housing Finance** Fund shall consist of the proceeds from the sale of bonds issued under
24 ORS 456.645 and related refunding bonds, fees and other moneys received by the Housing and
25 Community Services Department under ORS 456.548 to 456.725, moneys appropriated by the state for

1 (4) Except as otherwise provided in existing agreements with bondholders, any income or inter-
 2 est earned by or accruing to the capital reserve account because of the investment by the depart-
 3 ment of moneys within the account may be retained by the department in the fund to apply to any
 4 future deficiency that may occur or may be used by the department for the repayment of moneys in
 5 the [revolving account] **Housing and Community Services Department Fund** that were expended
 6 by the department pursuant to ORS 456.574 (2)(b).

7 (5)(a) In order to assure the continual operation and maintenance of the capital reserve account
 8 in the Housing Finance Fund and to carry out ORS 456.548 to 456.725, if the amount of money on
 9 deposit in the capital reserve account in any year is less than the debt service reserves described

 11 to the Governor and the Legislative Assembly or, during the interim, to the Emergency Board the
 12 amount needed to restore the account to its required debt service reserves. The amount so certified

36 (4) “Low income household” means a household with income less than or equal to 80 percent
 37 of the area median income.

38 (5) “Moderate income household” means a household with income less than or equal to 120
 39 percent and greater than 80 percent of the area median income.

40 (6) “Subsidy” includes, but is not limited to:

41 (a) A grant, loan or contract made by a federal agency, a federally recognized Indian tribe or
 42 a public body, as defined in ORS 174.109;

43 (b) A grant, loan or contract made by a nonprofit corporation or a limited liability company the
 44 sole member of which is a nonprofit corporation;

45 (c) A subsidized loan from a lending institution that makes loans for residential housing; or

1 (d) A subsidized private transaction.

2 (7) “Third-party right of enforcement” means a right provided in an affordable housing covenant
 3 to a third party to enforce the terms of the covenant.

4 **SECTION 27. ORS 456.505 is repealed.**

6 458.415. In carrying out ORS 458.405 to 458.460, the state shall act by and through its duly

- 26 (I) Nonprofit organizations; and

- 28 (ii) Political subdivisions, as defined in ORS 271.005.

29 (B) The state agency responsible for selling or transferring the property or the equitable interest
 30 may require at the time of the sale or transfer that a political subdivision must use state real
 31 property or an equitable interest in real property sold or transferred to the political subdivision for
 32 a public purpose or benefit, and that the political subdivision may not resell the real property or the
 33 equitable interest to a private purchaser.

34 (c) If a state agency that intends to sell or transfer real property or an equitable interest in real
 35 property has not disposed of the real property or the equitable interest under paragraph (a) or (b)
 36 of this subsection, the state agency shall cause the real property to be appraised by one or more
 37 competent and experienced appraisers in accordance with rules the department adopts. Except as
 38 provided in ORS 273.825, if the property has an appraised value exceeding \$5,000, the property or
 39 an equitable interest in the property may not be sold to any private person except after notice
 40 calling for such proposals as set forth in ORS 270.130.

41 (d) The department shall adopt rules to carry out the provisions of this section.

42 (2) Before a state agency acquires any real property or interest in real property, except for
 43 highway right of way that the Department of Transportation acquires, park properties that the State
 44 Parks and Recreation Department acquires and property within the approved projected campus
 45 boundaries for public universities listed in ORS 352.002, the state agency shall report to the Oregon

1 Department of Administrative Services that the state agency intends to acquire the real property
 2 or the interest in real property. The department shall notify other state agencies that own land that
 3 the state agency intends to acquire real property or an interest in real property to determine
 4 whether another state agency desires to sell or transfer property that would meet the needs of the
 5 acquiring agency. In accordance with rules the Oregon Department of Administrative Services
 6 adopts, if no other state agency desires to sell or transfer property that would meet the needs of the
 7 agency that intends to acquire real property or an interest in real property, the agency may acquire
 8 the real property or interest in real property, consistent with applicable provisions of law.

9 (3) Before any terminal disposition of real property or an interest in real property, the state
 10 agency acting for the state in the transaction must secure approval of the transaction from the
 11 Oregon Department of Administrative Services.

12 (4) Subsection (3) of this section does not apply to terminal disposition of the following real
 13 property:

- 14 (a) Property that the State Department of Fish and Wildlife controls;
- 15 (b) State forestlands that the State Forestry Department controls;
- 16 (c) Property that the Department of Transportation controls;
- 17 (d) Property that the Department of State Lands controls;
- 18 (e) Property that public universities listed in ORS 352.002 control;
- 19 (f) Property that the legislative branch of state government controls;

 34 **OREGON AFFORDABLE HOUSING TAX CREDIT**

 36 **SECTION 30.** ORS 317.097, as amended by section 25, chapter 83, Oregon Laws 2022, is
 37 amended to read:

38 317.097. (1) As used in this section:

- 39 (a) "Annual rate" means the yearly interest rate specified on the note, and not the annual per-
 40 centage rate, if any, disclosed to the applicant to comply with the federal Truth in Lending Act.
- 41 (b) "Bonds" means a bond, as defined in ORS 286A.001, if issued on behalf of the Housing and
 42 Community Services Department, or bonds, as defined in ORS 456.055, if issued by a housing au-
 43 thority.
- 44 (c) "Finance charge" means the total of all interest, loan fees, interest on any loan fees financed
 45 by the lending institution, and other charges related to the cost of obtaining credit.

1 (d) "Lending institution" means any insured institution, as that term is defined in ORS 706.008,
2 any mortgage banking company that maintains an office in this state or any community development
3 corporation that is organized under the Oregon Nonprofit Corporation Law.

4 (e) "Manufactured dwelling park" has the meaning given that term in ORS 446.003.

5 (f) "Nonprofit corporation" means a corporation that is exempt from income taxes under section
6 501(c)(3) or (4) of the Internal Revenue Code as amended and in effect on December 31, 2021.

7 (g) "Preservation project" means housing that was previously developed as affordable housing
8 with a contract for rent assistance from the United States Department of Housing and Urban De-
9 velopment or the United States Department of Agriculture and that is being acquired by a spon-
10 soring entity.

11 (h) "Qualified assignee" means any investor participating in the secondary market for real es-
12 tate loans.

13 (i) "Qualified borrower" means any borrower that is a sponsoring entity that has a controlling
14 interest in the real property that is financed by a qualified loan. A controlling interest includes a
15 controlling interest in the general partner of a limited partnership that owns the real property.

16 (j) "Qualified loan" means:

17 (A) A loan that meets the criteria stated in subsection (5) of this section or that is made to re-
18 finance a loan that meets the criteria described in subsection (5) of this section; or

19 (B) The purchase by a lending institution of bonds, the proceeds of which are used to finance
20 or refinance a loan that meets the criteria described in subsection (5) of this section.

21 (k) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state governmental
22 entity, local unit of government as defined in ORS 466.706, housing authority or any other person,
23 provided that the person has agreed to restrictive covenants imposed by a nonprofit corporation,
24 nonprofit cooperative, state governmental entity, local unit of government or housing authority.

25 (2) The Department of Revenue shall allow a credit against taxes otherwise due under this
26 chapter for the tax year to a lending institution that makes a qualified loan certified by the Housing
27 and Community Services Department as provided in subsection (7) of this section. The amount of the
28 credit is equal to the difference between:

29 (a) The amount of finance charge charged by the lending institution during the tax year at an
30 annual rate less than the market rate for a qualified loan that is made before January 1, 2026, that
31 complies with the requirements of this section; and

32 (b) The amount of finance charge that would have been charged during the tax year by the
33 lending institution for the qualified loan for housing construction, development, acquisition or re-
34 habilitation measured at the annual rate charged by the lending institution for nonsubsidized loans
35 made under like terms and conditions at the time the qualified loan for housing construction, de-
36 velopment, acquisition or rehabilitation is made.

37 (3) The maximum amount of credit for the difference between the amounts described in sub-
38 section (2)(a) and (b) of this section may not exceed four percent of the average unpaid balance of
39 the qualified loan during the tax year for which the credit is claimed.

40 (4) Any tax credit allowed under this section that is not used by the taxpayer in a particular
41 year may be carried forward and offset against the taxpayer's tax liability for the next succeeding
42 tax year. Any credit remaining unused in the next succeeding tax year may be carried forward and
43 used in the second succeeding tax year, and likewise, any credit not used in that second succeeding
44 tax year may be carried forward and used in the third succeeding tax year, and any credit not used
45 in that third succeeding tax year may be carried forward and used in the fourth succeeding tax year,

1 and any credit not used in that fourth succeeding tax year may be carried forward and used in the
2 fifth succeeding tax year, but may not be carried forward for any tax year thereafter.

3 (5) To be eligible for the tax credit allowable under this section, a lending institution must make
4 a qualified loan by either purchasing bonds, the proceeds of which are used to finance or refinance
5 a loan that meets the criteria stated in this subsection, or making a loan directly to:

6 (a) An individual or individuals who own a dwelling, participate in an owner-occupied commu-
7 nity rehabilitation program and are certified by the local government or its designated agent as
8 having an income level when the loan is made of [*less than*] 80 percent of the area median income
9 **or less**;

10 (b) A qualified borrower who:

11 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
12 of housing; and

13 (B) Provides a written certification executed by the Housing and Community Services Depart-
14 ment that the:

15 (i) Housing created by the loan is or will be occupied by households earning [*less than*] 80 per-
16 cent of the area median income **or less**; and

17 (ii) Full amount of savings from the reduced interest rate provided by the lending institution is
18 or will be passed on to the tenants in the form of reduced housing payments;

19 (c) Subject to subsection (14) of this section, a qualified borrower who:

20 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
21 of housing consisting of a manufactured dwelling park; and

22 (B) Provides a written certification executed by the Housing and Community Services Depart-
23 ment that the housing will continue to be operated as a manufactured dwelling park during the pe-
24 riod for which the tax credit is allowed;

25 (d) A qualified borrower who:

26 (A) Uses the loan proceeds to finance acquisition or rehabilitation of housing consisting of a
27 preservation project; and

28 (B) Provides a written certification executed by the Housing and Community Services Depart-
29 ment that the housing preserved by the loan:

30 (i) Is or will be occupied by households earning [*less than*] 80 percent of the area median income
31 **or less**; and

32 (ii) Is the subject of a rent assistance contract with the United States Department of Housing
33 and Urban Development or the United States Department of Agriculture that will be maintained by
34 the qualified borrower; or

35 (e) A qualified borrower who:

36 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
37 of housing; and

38 (B) Provides a written certification executed by the Housing and Community Services Depart-
39 ment or the governmental party to the rent assistance contract that the housing preserved by the
40 loan:

41 (i) Is or will be occupied by households earning [*less than*] 80 percent of the area median income
42 **or less**; and

43 (ii) Is the subject of a rent assistance contract with the federal government or with a state or
44 local government that will be maintained by the qualified borrower and that limits a tenant's rent
45 to no more than 30 percent of their income.

1 (6) A loan made to refinance a loan that meets the criteria stated in subsection (5) of this sec-
2 tion must be treated the same as a loan that meets the criteria stated in subsection (5) of this sec-
3 tion.

4 (7) For a qualified loan to be eligible for the tax credit allowable under this section, the Housing
5 and Community Services Department must execute a written certification for the qualified loan that:

6 (a) States that the qualified loan is within the limitation imposed by subsection (8) of this sec-
7 tion; and

8 (b) Specifies the period, as determined by the Housing and Community Services Department,
9 during which the tax credit is allowed for the qualified loan, not to exceed:

10 (A) 30 years, for a qualified loan with a contract for rent assistance or financing resources from
11 the United States Department of Agriculture, for new housing construction, acquisition of housing
12 or a preservation project; or

13 (B) 20 years, for any other type of qualified loan.

14 (8) The Housing and Community Services Department may certify qualified loans that are eligi-
15 ble under subsection (5) of this section if the total credits attributable to all qualified loans eligible
16 for credits under this section and then outstanding do not exceed \$35 million for any fiscal year. In
17 making loan certifications under subsection (7) of this section, the Housing and Community Services
18 Department shall attempt to distribute the tax credits statewide, but shall concentrate the tax
19 credits in those areas of the state that are determined by the Oregon Housing Stability Council to
20 have the greatest need for affordable housing.

21 (9) The tax credit provided for in this section may be taken whether or not:

22 (a) The financial institution is eligible to take a federal income tax credit under section 42 of
23 the Internal Revenue Code with respect to the project financed by the qualified loan; or

24 (b) The project receives financing from bonds, the interest on which is exempt from federal
25 taxation under section 103 of the Internal Revenue Code.

26 (10) For a qualified loan defined in subsection (1)(j)(B) of this section financed through the pur-
27 chase of bonds, the interest of which is exempt from federal taxation under section 103 of the
28 Internal Revenue Code, the amount of finance charge that would have been charged under sub-
29 section (2)(b) of this section is determined by reference to the finance charge that would have been
30 charged if the federally tax exempt bonds had been issued and the tax credit under this section did
31 not apply.

32 (11) A lending institution may sell a qualified loan for which a certification has been executed
33 to a qualified assignee whether or not the lending institution retains servicing of the qualified loan
34 so long as a designated lending institution maintains records, annually verified by a loan servicer,
35 that establish the amount of tax credit earned by the taxpayer throughout each year of eligibility.

36 (12) Notwithstanding any other provision of law, a lending institution that is a community de-
37 velopment corporation organized under the Oregon Nonprofit Corporation Law may transfer all or
38 part of a tax credit allowed under this section to one or more other lending institutions that are
39 stockholders or members of the community development corporation or that otherwise participate
40 through the community development corporation in the making of one or more qualified loans for
41 which the tax credit under this section is allowed.

42 (13) The lending institution shall file an annual statement with the Housing and Community
43 Services Department, specifying that it has conformed with all requirements imposed by law to
44 qualify for a tax credit under this section.

45 (14) Notwithstanding subsection (1)(i) and (k) of this section, a qualified borrower on a loan to

1 finance the construction, development, acquisition or rehabilitation of a manufactured dwelling park
2 under subsection (5)(c) of this section must be:

3 (a) A nonprofit corporation, manufactured dwelling park nonprofit cooperative, state govern-
4 mental entity, local unit of government as defined in ORS 466.706 or housing authority; or

5 (b) A nonprofit corporation or housing authority that has a controlling interest in the real
6 property that is financed by a qualified loan. A controlling interest includes a controlling interest
7 in the general partner of a limited partnership that owns the real property.

8 (15) The Department of Revenue may require that a lending institution that has earned the
9 credit and a lending institution that intends to claim the credit jointly file a notice, as prescribed
10 by the Department of Revenue. The notice must comply with ORS 315.056 (2) or 315.058 (2).

11 (16) The Housing and Community Services Department shall provide information to the Depart-
12 ment of Revenue about all certifications executed under this section, if required by ORS 315.058.

13 (17) The Housing and Community Services Department and the Department of Revenue may
14 adopt rules to carry out the provisions of this section.
