

# Senate Concurrent Resolution 7

10       Whereas Curt and Eva Benefiel enjoyed the adventure of traveling and teaching in new places  
11 that were interesting to them, including Guam and rural districts all over Oregon; and

12       Whereas Curt Benefiel was a wonderful teacher, coach, bus driver, counselor, principal and su-  
13 perintendent; and

14       Whereas Curt Benefiel was a role model for thousands of students; and

15       Whereas Curt Benefiel loved University of Oregon Ducks athletics, playing dominoes and pool,  
16 hunting and fishing; and

17       Whereas Curt Benefiel was a caring and compassionate man with a competitive spirit; and

18       Whereas Curt Benefiel had a huge zest for life and loved spending time with his large family;

20       Whereas Curt Benefiel died on June 16, 2015, at his home in Stayton, Oregon, surrounded by  
21 loved ones; and

22       Whereas Curt Benefiel was preceded in death by his parents and his two brothers, Kearney and  
23 Ben; and

24       Whereas Curt Benefiel was followed in death by Eva, his beloved wife of 66 years, and his  
25 daughter Anita; and

26       Whereas Curt and Eva Benefiel are survived by their children, Annie, Kelly and Rex, as well  
27 as numerous grandchildren, great-grandchildren, nieces and nephews; and

28       Whereas Curt Benefiel will be forever remembered as a dedicated educator who touched count-  
29 less lives and made his community a better place; now, therefore,
