**PROPOSED AMENDMENTS TO
SENATE BILL 615**

1 On page 1 of the printed bill, delete lines 5 through 29 and delete pages
2 2 through 6 and insert:

3 **“SECTION 1.** ORS 811.127 is amended to read:

4 “811.127. *[(1) Except as provided in subsection (3) of this section, a person*
5 *commits the offense of organizing a speed racing event if the person in any*
6 *manner organizes a speed racing event.]*

7 “[2) As used in this section, ‘speed racing event’ means an event that:]

8 “[a) Is preplanned and coordinated and involves two or more vehicles;]

9 “[b) Includes any of the activities described in ORS 811.125 (1); and]

10 “[c) Takes place on a highway.]

11 **“(1) Except as provided in subsection (2) of this section, a person**
12 **commits the offense of organizing a speed racing event if the person,**
13 **to facilitate or aid another individual who is participating in an ac-**
14 **tivity described in ORS 811.125 or 811.140 (1)(b):**

15 **“(a) Obstructs or places a barricade on a highway; or**

16 **“(b) Assists in placing an obstruction or barricade upon a highway.**

17 “[3) (2) A person who organizes a speed racing event is not in violation
18 of this section if the person has a permit from the road authority for the
19 highway on which the event takes place.

20 “[4) The offense described in this section, organizing a speed racing event,
21 is a Class C felony.]

1 “(3) The offense described in this section, organizing a speed racing
2 event, is:

3 “(a) Except as provided in paragraph (b) of this subsection, a Class
4 A misdemeanor.

5 “(b) For a person’s second or subsequent conviction within a five-
6 year period preceding the date of the person’s current conviction, a
7 Class C felony.

8 “SECTION 2. ORS 811.140 is amended to read:

9 “811.140. (1) A person commits the offense of reckless driving if the
10 person:

11 “(a) Recklessly drives a vehicle upon a highway or [*other*] premises **open**
12 **to the public** [*described in this section*] in a manner that endangers the
13 safety of persons or property[.]; or

14 “(b) Operates a vehicle on a highway or premises open to the public
15 and, in the presence of two or more persons assembled for the purpose
16 of spectating the conduct, intentionally:

17 “(A) Breaks the traction of the vehicle’s rear tires; or

18 “(B) Spins the vehicle’s rear tires continuously by pressing the ac-
19 celerator and increasing the engine speed in a manner that leaves
20 marks on the surface upon which the vehicle is being driven.

21 “[(2) *The use of the term ‘recklessly’ in this section is as defined in ORS*
22 *161.085.*]

23 “(2) As used in this section, ‘intentionally’ and ‘recklessly’ have the
24 meanings given those terms in ORS 161.085.

25 “(3) The offense described in this section, reckless driving, is a Class A
26 misdemeanor [*and is applicable upon any premises open to the public*].

27 **by sections 1 to 3 of this 2023 Act apply to conduct occurring on or**
28 **after the effective date of this 2023 Act.**

29 “**SECTION 5. This 2023 Act takes effect on the 91st day after the**
30 **date on which the 2023 regular session of the Eighty-second Legislative**

1 **Assembly adjourns sine die.”.**
