**PROPOSED AMENDMENTS TO
HOUSE BILL 3488**

1 On page 1 of the printed bill, line 2, after “homeownership” delete the rest
2 of the line and line 3 and insert “; and declaring an emergency.”.

3 Delete lines 5 through 26 and delete pages 2 through 5 and insert:

4 **“SECTION 1. In addition to and not in lieu of any other appropri-
5 ation, there is appropriated to the Housing and Community Services
6 Department, for the biennium beginning July 1, 2023, out of the Gen-
7 eral Fund, the amount of \$73,000,000, to support the department’s
8 homeownership programs.**

9 **“SECTION 2. In addition to and not in lieu of any other appropri-
10 ation, there is appropriated to the Housing and Community Services
11 Department, for the biennium beginning July 1, 2023, out of the Gen-
12 eral Fund:**

13 **“(1) The amount of \$10,000,000, for deposit into the Home Ownership
14 Assistance Account to provide grants under ORS 458.655 (2)(a) to cul-
15 turally responsive, culturally specific or tribal organizations.**

16 **“(2) The amount of \$25,000,000, for deposit into the Home Ownership
17 Assistance Account to provide flexible loans to home purchasers.**

18 **“SECTION 3. In addition to and not in lieu of any other appropri-
19 ation, there is appropriated to the Housing and Community Services
20 Department, for the biennium beginning July 1, 2023, out of the Gen-
21 eral Fund, the amount of \$4,000,000, to provide grants to each of the**

1 **nine federally recognized tribes in Oregon, to be used to support low**
2 **income individuals' homeownership needs, including through down**
3 **payment assistance, home purchasers' education and home repair**
4 **programs.**

5 **“SECTION 4. In addition to and not in lieu of any other appropri-**
6 **ation, there is appropriated to the Housing and Community Services**
7 **Department, for the biennium beginning July 1, 2023, out of the Gen-**
8 **eral Fund, the amount of \$4,800,000, to provide grants to up to 24 cul-**
9 **turely responsive or culturally specific organizations to expand**
10 **homeownership services.**

11 **“SECTION 5. In addition to and not in lieu of any other appropri-**
12 **ation, there is appropriated to the Bureau of Labor and Industries, for**
13 **the biennium beginning July 1, 2023, out of the General Fund:**

14 **“(1) The amount of \$2,400,000, to provide a grant to the Fair Housing**
15 **Council of Oregon to support fair housing in this state.**

16 **“(2) The amount of \$2,300,000, to support the bureau's housing dis-**
17 **crimination investigations and fair housing education and outreach.**

18 **“SECTION 6. In addition to and not in lieu of any other appropri-**
19 **ation, there is appropriated to the Department of Justice, for the**
20 **biennium beginning July 1, 2023, out of the General Fund, the amount**
21 **of \$500,000, to enforce fair housing laws.**

22 **“SECTION 7. This 2023 Act being necessary for the immediate**
23 **preservation of the public peace, health and safety, an emergency is**
24 **declared to exist, and this 2023 Act takes effect on July 1, 2023.”.**
