PROPOSED AMENDMENTS TO HOUSE BILL 3272

1 On page 2 of the printed bill, delete lines 18 through 45 and insert:

² "SECTION 2. ORS 56.185 is amended to read:

3 "56.185. (1) As used in this section:

"(a) 'Local agency' means every county, city, school district, municipal
organization, district or political subdivision, or any board, commission or
agency thereof, or any other local public agency.

"[(b) 'Small business' means a prospective, new or established business with
100 or fewer employees that is or will be located in Oregon.]

9 "[(c)] (b) 'State agency' means every state office, department, division,
10 bureau, board or commission or any other state agency.

"(2) The Secretary of State shall collect from local agencies and state 11 agencies the information specified in subsection (3) of this section and 12 shall create and maintain the Oregon License Directory as a searchable, 13 statewide database containing information regarding licenses, permits and 14 registrations for which local agencies and state agencies impose fees and 15fee-related regulations [are imposed on small businesses by local agencies and 16 state agencies in Oregon] on businesses in this state. Except as provided 17 in subsection (4) of this section, the Secretary of State shall make the 18 Oregon License Directory available on the Internet to the public free of 19 20 charge.

"(3) All local agencies and state agencies that have functions related to

[the issuance of] issuing licenses, permits and registrations [for which] and
that impose fees and fee-related regulations [are imposed on small businesses
must] on businesses in this state shall:

"(a) Collect and report information in a manner [to be designated by] the
Secretary of State specifies by rule for inclusion in the Oregon License Directory, including but not limited to:

"(A) Information regarding the average time to process and issue licenses,
permits and registrations for which fees are imposed on [*small*] businesses
and the number of active licenses, permits and registrations; and

"(B) The ethnicity, domicile, veteran status and street address or
 electronic mail address of each owner and principal of a business that
 applies for or renews a license, permit or registration; and

"(b) Review and update the information required under paragraph (a) of
this subsection on or before July 1, but not later than September 1, of each
year.

16 "(4)(a) The Secretary of State may not make the information that 17 local agencies and state agencies report under subsection (3)(a)(B) of 18 this section available or searchable on the Internet unless the person 19 to whom the information pertains has given explicit written consent 20 to make the information available and searchable.

"(b) The Secretary of State may share or communicate with organizations described in ORS 56.180 (2)(d), by electronic means or otherwise, the information that local agencies and state agencies report under subsection (3)(a)(B) of this section.

²⁵ "[(4)] (5) The Secretary of State may adopt rules necessary to implement ²⁶ the provisions of this section.".
