## PROPOSED AMENDMENTS TO HOUSE BILL 3288

(1) The State Board of Education shall adopt by rule uniform standards, based on local, statewide and national best practices, for the collection of data on race, ethnicity and preferred spoken and written languages for public school students in kindergarten through grade 12. The board shall review and update the standards at least once every two years to ensure that the standards are efficient, uniform and consistent with best practices.
