**PROPOSED AMENDMENTS TO
HOUSE BILL 3488**

1 On page 1 of the printed bill, line 2, after “homeownership” delete the rest
2 of the line and line 3 and insert “; and declaring an emergency.”.

3 Delete lines 5 through 26 and delete pages 2 through 5 and insert:

4 **“SECTION 1. In addition to and not in lieu of any other appropri-
5 ation, there is appropriated to the Housing and Community Services
6 Department, for the biennium beginning July 1, 2023, out of the Gen-
7 eral Fund:**

8 **“(1) The amount of \$10,000,000, for deposit into the Housing and
9 Community Services Department Revolving Account to provide grants
10 to culturally responsive, culturally specific or tribal organizations to
11 provide down payment assistance.**

12 **“(2) The amount of \$25,000,000, for deposit into the Housing Finance
13 Fund to provide flexible loans to home purchasers.**

14 **“SECTION 2. In addition to and not in lieu of any other appropri-
15 ation, there is appropriated to the Housing and Community Services
16 Department, for the biennium beginning July 1, 2023, out of the Gen-
17 eral Fund, the amount of \$4,000,000, to provide grants to each of the
18 nine federally recognized tribes in Oregon, to be used to support low-
19 income individuals’ homeownership needs, including through down
20 payment assistance, home purchasers’ education and home repair
21 programs.**

1 **“SECTION 3. In addition to and not in lieu of any other appropri-**
2 **ation, there is appropriated to the Housing and Community Services**
3 **Department, for the biennium beginning July 1, 2023, out of the Gen-**
4 **eral Fund, the amount of \$4,800,000, to provide grants to up to 24 cul-**
5 **turally responsive or culturally specific organizations to expand**
6 **homeownership services.**

7 **“SECTION 4. In addition to and not in lieu of any other appropri-**
8 **ation, there is appropriated to the Bureau of Labor and Industries, for**
9 **the biennium beginning July 1, 2023, out of the General Fund:**

10 **“(1) The amount of \$2,400,000, to provide a grant to the Fair Housing**
11 **Council of Oregon to support fair housing in this state.**

12 **“(2) The amount of \$2,300,000, to support the bureau’s housing dis-**
13 **crimination investigations and fair housing education and outreach.**

14 **“SECTION 5. In addition to and not in lieu of any other appropri-**
15 **ation, there is appropriated to the Department of Justice, for the**
16 **biennium beginning July 1, 2023, out of the General Fund, the amount**
17 **of \$500,000, to enforce fair housing laws.**

18 **“SECTION 6. This 2023 Act being necessary for the immediate**
19 **preservation of the public peace, health and safety, an emergency is**
20 **declared to exist, and this 2023 Act takes effect on July 1, 2023.”.**
