**PROPOSED AMENDMENTS TO
HOUSE BILL 2283**

1 On page 9 of the printed bill, line 1, delete “and”.

2 In line 4, delete the period and insert “; and

3 “(F) The full amount of required employee contributions under ORS
4 657B.150 that are paid by the employer on behalf of its employees under ORS
5 657B.150 (5).”.

6 On page 12, after line 11, insert:

7 “(H) The full amount of required employee contributions under ORS
8 657B.150 that are paid by the employer on behalf of its employees under ORS
9 657B.150 (5).”.

10 In line 12, delete “(H)” and insert “(I)”.

11 On page 25, after line 45, insert:

15 **“SECTION 20. Section 21 of this 2023 Act is added to and made a
16 part of ORS chapter 238.**

17 **“SECTION 21. (1) Notwithstanding any other provision of this
18 chapter or ORS chapter 238A, and except as provided in subsection (2)
19 of this section, benefits received by a member under ORS 657.370 to
20 657.390 or ORS chapter 657B shall be treated as salary, and a member
21 receiving benefits under ORS chapter 657B shall receive creditable**

1 service for the period for which the benefits are received.

2 “(2) A member may not receive creditable service under this section
3 if the member will otherwise receive creditable service under this
4 chapter or ORS chapter 238A.

5 “(3) Creditable service received under this section shall be treated
6 as if the member performed service in the qualifying position for
7 which the benefits are received.

8 “SECTION 22. Section 23 of this 2023 Act is added to and made a
9 part of ORS chapter 238A.

10 “SECTION 23. (1) Notwithstanding any other provision of this
11 chapter or ORS chapter 238, and except as provided in subsection (2)
12 of this section, benefits received by a member under ORS 657.370 to
13 657.390 or ORS chapter 657B shall be treated as salary, and a member
14 receiving benefits under ORS chapter 657B shall receive retirement
15 credit for the period for which the benefits are received.

16 “(2) A member may not receive retirement credit under this section
17 if the member will otherwise receive retirement credit under this
18 chapter or ORS chapter 238.

19 “(3) Retirement credit received under this section shall be treated
20 as if the member performed service in the qualifying position for
21 which the benefits are received.”.

22 On page 26, line 3, delete “20” and insert “24”.

23 After line 10, insert:

24 “(4) Sections 21 and 23 of this 2023 Act apply to shared work benefits paid
25 under ORS 657.370 to 657.390 on or after March 1, 2020.”.

26 In line 14, delete “21” and insert “25”.

27 On page 27, line 5, delete “22” and insert “26”.
