**PROPOSED AMENDMENTS TO

3 chapter 673, Oregon Laws 2017, and section 7, chapter 98, Oregon Laws  
4 2018”.

5 Delete lines 4 through 10 and insert:

6 **“SECTION 1.** Section 56, chapter 649, Oregon Laws 2013, as amended by  
7 section 19, chapter 78, Oregon Laws 2022, is amended to read:

8 **“Sec. 56.** Sections 52 and 53, chapter 649, Oregon Laws 2013, are repealed  
9 on July 1, [2024] **2033.**

10 **“SECTION 2.** Section 7, chapter 98, Oregon Laws 2018, as amended by  
11 section 21, chapter 78, Oregon Laws 2022, is amended to read:

12 **“Sec. 7.** Section 5, chapter 98, Oregon Laws 2018, is repealed on July 1,  
13 [2024] **2033.**

14 **“SECTION 3.** Section 8, chapter 649, Oregon Laws 2013, as amended by  
15 section 22, chapter 78, Oregon Laws 2022, is amended to read:

16 **“Sec. 8.** (1) The amendments to ORS 137.717 by section 7, chapter 649,  
17 Oregon Laws 2013, become operative on July 1, [2024] **2033.**

18 **“(2)** The amendments to ORS 137.717 by section 7, chapter 649, Oregon  
19 Laws 2013, apply to crimes committed on or after July 1, [2024] **2033.**

20 **“SECTION 4.** Section 12, chapter 649, Oregon Laws 2013, as amended by  
21 section 23, chapter 78, Oregon Laws 2022, is amended to read:

1       “**Sec. 12.** (1) ORS 475.934 becomes operative on July 1, [2024] **2033.**

2       “(2) ORS 475.934 applies to crimes committed on or after July 1, [2024]  
3 **2033.**

4       “**SECTION 5.** Section 33, chapter 649, Oregon Laws 2013, as amended by  
5 section 24, chapter 78, Oregon Laws 2022, is amended to read:

6       “**Sec. 33.** Section 29, chapter 649, Oregon Laws 2013, is repealed on July  
7 1, [2024] **2033.**

8       “**SECTION 6.** Section 38, chapter 649, Oregon Laws 2013, as amended by  
9 section 25, chapter 78, Oregon Laws 2022, is amended to read:

10       “**Sec. 38.** (1) The amendments to ORS 40.015, 144.096, 144.101 and 144.106  
11 by sections 34 to 37, chapter 649, Oregon Laws 2013, become operative on  
12 July 1, [2024] **2033.**

13       “(2) The repeal of section 29, chapter 649, Oregon Laws 2013, by section  
14 33, chapter 649, Oregon Laws 2013, and the amendments to ORS 40.015,  
15 144.096, 144.101 and 144.106 by sections 34 to 37, chapter 649, Oregon Laws  
16 2013, do not affect the jurisdiction of a reentry court over a person sentenced  
17 under section 29, chapter 649, Oregon Laws 2013.

18       “**SECTION 7.** Section 12, chapter 673, Oregon Laws 2017, is amended to  
19 read:

20       “**Sec. 12.** (1) The amendments to ORS 137.717 and 421.168 by sections 4  
21 and 5, [*of this 2017 Act*] **chapter 673, Oregon Laws 2017**, and the repeal of  
22 section 16, chapter 649, Oregon Laws 2013, by section 3, [*of this 2017 Act*]  
23 **chapter 673, Oregon Laws 2017**, become operative on January 1, 2018.

24       “(2) The amendments to ORS 137.717 by section 6, [*of this 2017 Act*]  
25 **chapter 673, Oregon Laws 2017**, become operative on July 1, [2023] **2033.**

26       “**SECTION 8.** Section 13, chapter 673, Oregon Laws 2017, is amended to  
27 read:

28       “**Sec. 13.** (1) The amendments to section 1, chapter 830, Oregon Laws 2015,  
29 by section 2, [*of this 2017 Act*] **chapter 673, Oregon Laws 2017**, apply to  
30 sentences imposed on or after [*the effective date of this 2017 Act*] **August 8,**

1 **2017.**

2 “(2) The amendments to ORS 137.717 and 421.168 by sections 4 and 5, [*of*  
3 *this 2017 Act*] **chapter 673, Oregon Laws 2017**, apply to sentences imposed  
4 on or after January 1, 2018.

5 “(3) The amendments to ORS 137.717 by section 6, [*of this 2017 Act*]  
6 **chapter 673, Oregon Laws 2017**, apply to sentences imposed on or after July  
7 1, [*2023*] **2033**.”
