**PROPOSED AMENDMENTS TO  
SENATE BILL 1060**

1 On page 1 of the printed bill, line 2, after “ORS” delete the rest of the  
2 line and delete line 3 and insert “161.005.”.

3 Delete lines 5 through 30 and delete pages 2 through 5 and insert:

4 **“SECTION 1. (1) In a prosecution for an offense that includes, as  
5 an element, causing physical injury to another person, evidence of  
6 physical injury may include but is not limited to:**

7 **“(a) Testimony by the person alleged to have been injured;**

8 **“(b) Evidence of physical trauma;**

9 **“(c) Testimony from witnesses indicating that the person alleged to  
10 have been injured experienced substantial pain or impairment of  
11 physical condition; or**

12 **“(d) Expert testimony addressing the effect of the type and amount  
13 of force used by the defendant.**

14 **“(2) As used in this section, ‘physical trauma’ includes but is not  
15 limited to fractures, cuts, punctures, bruises, burns or other observa-  
16 ble effects.**
