**PROPOSED AMENDMENTS TO
A-ENGROSSED SENATE BILL 523**

1 On page 1 of the printed A-engrossed bill, line 2, after “ORS” insert
2 “341.005 and”.

3 On page 2, after line 3, insert:

4 **“SECTION 2.** ORS 341.005 is amended to read:

5 “341.005. As used in this chapter, unless the context otherwise requires:

6 “(1) ‘Academic year’ means the year beginning July 1 of each year and
7 ending June 30 of the following year running concurrently with the fiscal
8 year.

9 “(2) ‘Board’ means the board of education of a community college district.

10 “(3) ‘Board member’ means a member of the board of education of a
11 community college district.

12 “(4)(a) Except as provided in paragraph (b) of this subsection, ‘community
13 college’ means a public institution operated by a community college district
14 for the purposes of providing courses of study limited to not more than two
15 years’ full-time attendance and designed to meet the needs of a geographical
16 area by providing educational services, including but not limited to career
17 and technical education programs or lower division collegiate programs.

18 “(b) The two-year limitation described in paragraph (a) of this subsection
19 does not apply to:

20 “(A) Technical programs in which the curriculum may require more than
21 two years of attendance but less than four years; [*or*]

1 “(B) Applied baccalaureate degree programs approved under ORS
2 341.013; or

3 **“(C) Bachelor of Science: Nursing degree programs approved under**
4 **ORS 341.013.**

5 “(5) ‘Community college district’ or ‘district’ means a district formed un-
6 der this chapter to operate one or more community colleges or to secure
7 educational services available at a community college. ‘Community college
8 district’ includes a community college service district.

9 “(6) ‘Director’ means the Director of the Office of Community Colleges
10 and Workforce Development appointed under ORS 350.160 by the executive
11 director of the Higher Education Coordinating Commission.

12 “(7) ‘Full-time equivalent student’ means a student or combination of se-
13 veral students who carries or carry among them, within a single academic
14 year, a minimum number of clock hours of instruction, in any program, to
15 be specified by rule by the Higher Education Coordinating Commission.

16 “(8) ‘Paying agent and registrar’ means the county treasurer or county
17 fiscal officer of the county in which the chief administrative officer of the
18 community college district maintains the administrative office.

19 “(9) ‘Petitioning territory’ means a community college district petitioning
20 to have an area outside the district included in the district or to have an
21 area inside the district excluded from the district, or an area outside the
22 district petitioning to be included within the district.

23 “(10) ‘Principal county’ means the county in which the chief administra-
24 tive officer of the community college district maintains the administrative
25 office.”.
