PROPOSED AMENDMENTS TO A-ENGROSSED SENATE BILL 769

1 On page 1 of the printed A-engrossed bill, line 6, after the period insert 2 "(1)".

3 After line 11, insert:

"(2) Nothing in this section prohibits the department from disclosing a
substantiated or founded allegation of abuse, as defined in ORS 418.257 or
419B.005, to the Central Background Registry, established under ORS
329A.030, or a professional licensing board.".

8 On page 2, line 10, delete "finding" and insert "determination".

9 On page 4, line 30, delete "finding" and insert "determination".

10 On page 9, delete line 16 and insert:

"(a) A child's parent, guardian, custodian, caregiver or other person to
whom responsibility for the child is temporarily delegated;".

13 On page 12, delete line 11 and insert:

"(a) A child's parent, guardian, custodian, caregiver or other person to
 whom responsibility for the child is temporarily delegated;".

In line 25, after "abuse" insert "allegedly committed".

17 On page 13, delete lines 43 through 45 and delete page 14 and insert:

"SECTION 7. Section 8 of this 2023 Act is added to and made a part
 of ORS 419B.005 to 419B.050.

²⁰ "<u>SECTION 8.</u> (1) If the Department of Human Services receives a ²¹ report of child abuse allegedly committed by a person who is not a qualified subject solely by reason of the person having not attained 18
years of age, and the reported abuse involves an allegation of rape of
a child, sexual abuse or sexual exploitation, as described in ORS
419B.005 (1)(a)(C), (D) or (E), the department shall immediately:

5 "(a) Notify a law enforcement agency of the reported abuse as pro6 vided in ORS 419B.015 (1)(b);

7 "(b) Conduct a safety assessment of the situations of the alleged
8 victim and the person alleged to have committed the abuse; and

9 "(c) Take necessary action to ensure the safety of the alleged victim
10 and of the person alleged to have committed the abuse.

"(2) The department shall, by rule, establish policies and procedures
 for conducting the safety assessments under this section.

"SECTION 9. (1) Section 1 of this 2023 Act and the amendments to
 ORS 329A.030 by sections 2 and 3 of this 2023 Act apply to background
 checks completed on or after the effective date of this 2023 Act.

"(2) Section 8 of this 2023 Act and the amendments to ORS 419B.005
and 419B.020 by sections 4 to 6 of this 2023 Act apply to reports of abuse
arising from acts occurring on or after the effective date of this 2023
Act.

20 "SECTION 10. This 2023 Act being necessary for the immediate 21 preservation of the public peace, health and safety, an emergency is 22 declared to exist, and this 2023 Act takes effect on its passage.".
