**PROPOSED AMENDMENTS TO
HOUSE BILL 2100**

1 In line 2 of the printed bill, after “funding” insert “; creating new pro-
2 visions; and amending ORS 803.215, 803.415, 803.420, 803.570, 803.575, 805.250,
3 807.370 and 807.410”.

4 Delete lines 4 through 8 and insert:

5 **“SECTION 1.** ORS 807.370 is amended to read:

6 “807.370. (1) Fees for issuance of or application for a driving privilege are
7 as follows:

8 “(a) Class C driver license or restricted Class C driver license, [~~\$54~~] **\$58.**

9 “(b) Class C limited term driver license or restricted Class C limited term
10 driver license, \$23.

11 “(c) Commercial driver license, whether or not the driver license contains
12 endorsements, [~~\$75~~] **\$160.**

13 “(d) Limited term commercial driver license, whether or not the driver
14 license contains endorsements, \$45.

15 “(e) Instruction driver permit, [~~\$23~~] **\$30.**

16 “(f) Commercial learner driver permit, [~~\$23~~] **\$40.**

17 “(g) Limited term commercial learner driver permit, \$23.

18 “(h) Special student driver permit, \$23.

19 “(i) Emergency driver permit, \$23.

20 “(j) Special limited vision condition learner’s permit, \$13.

21 “(k) Disability golf cart driver permit, \$44.

1 “(L) Hardship driver permit application, [~~\$50~~] **\$75**.

2 “(2) In addition to paying a fee under this section for issuance of a com-
3 mercial driver license of any class, when the Department of Transportation
4 accepts skills test results from a driver competency tester certified under
5 ORS 807.080, the person shall pay a fee of \$40.

6 “(3) Fees for a motorcycle endorsement are as follows:

7 “(a) In addition to any fee for the endorsed driver license, for an original
8 motorcycle endorsement added at the time of an original issuance of a driv-
9 ing privilege or with a renewal or replacement of an existing driving privi-
10 lege, [~~\$46~~] **\$60**.

11 “(b) For an original motorcycle endorsement added without an original
12 issuance of a driving privilege or without a renewal or replacement of an
13 existing driving privilege, [~~\$49~~] **\$60**.

14 “(c) A Motorcycle Safety Subaccount fee:

15 “(A) Upon original issuance of a motorcycle endorsement, \$38.

16 “(B) Upon renewal of a driver license with a motorcycle endorsement, \$28.

17 “(4) Fees for a farm endorsement are as follows:

18 “(a) In addition to any fee for the endorsed driver license, for an original
19 farm endorsement added at the time of an original issuance of a driving
20 privilege or with a renewal or replacement of an existing driving privilege,
21 \$26.

22 “(b) For an original farm endorsement added without an original issuance
23 of a driving privilege or without a renewal or replacement of an existing
24 driving privilege, \$29.

25 “(5) Fees for renewal of a driving privilege are as follows:

26 “(a) Class C driver license, [~~\$34~~] **\$48**.

27 “(b) Class C limited term driver license, \$8.

28 “(c) Commercial driver license, [~~\$55~~] **\$98**.

29 “(d) Limited term commercial driver license, \$14.

30 “(e) Instruction driver permit, [~~\$23~~] **\$26**.

1 “(f) Disability golf cart driver permit, \$32.

2 “(6) Fee to replace a driver license or driver permit, [~~\$26~~] **\$30**.

3 “(7) Fees to take tests required for driving privileges or to remove re-
4 strictions are as follows:

5 “(a) The knowledge test for a Class C driver license or Class C limited
6 term driver license, [~~\$5~~] **\$7**.

7 “(b) The knowledge test for a motorcycle endorsement, [~~\$5~~] **\$7**.

8 “(c) The knowledge test for any commercial driver license or commercial
9 learner driver permit, to remove a commercial driving privilege restriction
10 or to add a commercial driving privilege endorsement, \$10.

11 “(d) The skills test for a Class C driver license or Class C limited term
12 driver license, [~~\$9~~] **\$45**.

13 “(e) The skills test for any commercial driver license, to remove a re-
14 striction or to add any commercial driver license endorsement, [~~\$70~~] **\$145**.

15 “(8) Student Driver Training Fund eligibility fee, \$6.

16 “(9) Limited term Student Driver Training Fund eligibility fee, \$2.

17 “(10) Fee for reinstatement of revoked driving privileges under ORS
18 809.390 or reinstatement of suspended driving privileges under ORS 809.380,
19 [~~\$75~~] **\$85**.

20 “(11) The department may adopt rules to provide for the assessment or
21 retention of the skills test fee when a test is scheduled but the applicant fails
22 to appear at the scheduled time.

23 **“SECTION 2.** ORS 807.410 is amended to read:

24 “807.410. (1) The following fees apply to identification cards unless oth-
25 erwise provided by ORS 807.400 or otherwise provided by law:

26 “(a) For issuance of an original identification card, [~~\$44.50~~] **\$47**.

27 “(b) For renewal of an identification card, [~~\$40.50~~] **\$43**.

28 “(c) For replacement of an identification card, [~~\$39.50~~] **\$40**.

29 “(d) For reinstatement of an identification card after suspension, [~~\$75~~]
30 **\$85**.

1 “(e) For issuance of an original limited term identification card, \$20.

2 “(f) For renewal of a limited term identification card, \$18.

3 “(g) For replacement of a limited term identification card, [~~\$39.50~~] **\$40**.

4 “(2) The Department of Transportation may not charge a fee for issuing,
5 renewing or replacing a parking identification card.

6 “(3) The department may not charge a fee for issuing or renewing an
7 identification card, or providing two replacement identification cards before
8 the expiration of the current identification card, for an individual who is
9 experiencing homelessness. The individual shall present a form that indicates
10 the individual qualifies for the fee waiver, as determined by a nonprofit or-
11 ganization **or state agency** that provides services to individuals experienc-
12 ing homelessness. Before a nonprofit organization **or state agency** issues
13 documentation under this subsection, the organization **or state agency** must
14 first meet the standards established by the department by rule. The depart-
15 ment, by rule, shall prescribe the form.

16 “(4) **As used in this section, ‘state agency’ means an agency of the**
17 **executive department, as defined in ORS 174.112.**

18 “**SECTION 3.** ORS 803.215 is amended to read:

19 “803.215. A fee of [~~\$7~~] **\$9** shall be charged for an inspection of a vehicle
20 required by ORS 803.210.

21 “**SECTION 4.** ORS 803.420 is amended to read:

22 “803.420. (1) The vehicle registration fees imposed under this section shall
23 be based on the classifications determined by the Department of Transpor-
24 tation by rule. The department may classify a vehicle to ensure that regis-
25 tration fees for the vehicle are the same as for other vehicles the department
26 determines to be comparable.

27 “(2) Except as otherwise provided in this section, or unless the vehicle is
28 registered quarterly, the fees described in this section are for an entire reg-
29 istration period for the vehicle as described under ORS 803.415. For a vehicle
30 registered for a quarterly registration period under ORS 803.415, the depart-

1 ment shall apportion any fee under this section to reflect the number of
2 quarters registered.

3 “(3) Vehicle registration fees are due when a vehicle is registered and
4 when the registered owner renews the registration.

5 “(4) In addition to the registration fees listed in this section, a county
6 or a district may impose an additional registration fee as provided under
7 ORS 801.041 and 801.042.

8 “(5) A rental or leasing company, as defined in ORS 221.275, that elects
9 to initially register a vehicle for an annual or biennial registration period
10 shall pay a fee of \$2 in addition to the vehicle registration fee provided under
11 this section.

12 “(6) The registration fees for each year of the registration period for ve-
13 hicles subject to biennial registration are as follows:

14 “(a) Passenger vehicles not otherwise provided for in this section or ORS
15 821.320, \$43.

16 “(b) Utility trailers or light trailers, as those terms are defined by rule
17 by the department, \$63.

18 “(c) Mopeds and motorcycles, \$44.

19 “(d) Low-speed vehicles, \$63.

20 “(e) Medium-speed electric vehicles, \$63.

21 “(7) The registration fees for vehicles that are subject to biennial regis-
22 tration and that are listed in this subsection are as follows:

23 “(a) State-owned vehicles registered under ORS 805.045 and undercover
24 vehicles registered under ORS 805.060, \$10 upon registration or renewal.

25 “(b) Fixed load vehicles:

26 “(A) If a declaration of weight described under ORS 803.435 is submitted
27 establishing the weight of the vehicle at 3,000 pounds or less, \$61.

28 “(B) If no declaration of weight is submitted or if the weight of the ve-
29 hicles is in excess of 3,000 pounds, \$82.

30 “(c) Travel trailers, special use trailers, campers and motor homes, based

1 on length as determined under ORS 803.425:

2 “(A) Trailers or campers that are 6 to 10 feet in length, \$81.

3 “(B) Trailers or campers over 10 feet in length, \$81 plus [~~\$6.75~~] **\$7** a foot
4 for each foot of length over the first 10 feet.

5 “(C) Motor homes that are 6 to 14 feet in length, \$86.

6 “(D) Motor homes over 14 feet in length, \$126 plus [~~\$7.50~~] **\$8** a foot for
7 each foot of length over the first 10 feet.

8 “(8) The registration fee for trailers for hire that are equipped with
9 pneumatic tires made of an elastic material and that are not travel trailers
10 or trailers registered under permanent registration is \$30.

11 “(9) The registration fees for vehicles subject to ownership registration
12 are as follows:

13 “(a) Government-owned vehicles registered under ORS 805.040, \$5.

14 “(b) Vehicles registered with special registration for disabled veterans
15 under ORS 805.100 or for former prisoners of war under ORS 805.110, \$15.

16 “(c) School vehicles registered under ORS 805.050, \$5.

17 “(10) The registration fees for vehicles subject to permanent registration
18 are as follows:

19 “(a) Antique vehicles registered under ORS 805.010, \$100.

20 “(b) Vehicles of special interest registered under ORS 805.020, \$100.

21 “(c) Racing activity vehicles registered under ORS 805.035, \$100.

22 “(d) Trailers, \$10.

23 “(e) State-owned vehicles registered under ORS 805.045 and undercover
24 vehicles registered under ORS 805.060, \$10.

25 “(11) The registration fee for trailers registered as part of a fleet under
26 an agreement reached pursuant to ORS 802.500 is the same fee as the fee for
27 vehicles of the same type registered under other provisions of the Oregon
28 Vehicle Code.

29 “(12) The registration fee for vehicles with proportional registration un-
30 der ORS 826.009, or proportional fleet registration under ORS 826.011, is the

1 same fee as the fee for vehicles of the same type under this section except
2 that the fees shall be fixed on an apportioned basis as provided under the
3 agreement established under ORS 826.007.

4 “(13) In addition to any other registration fees charged for registration
5 of vehicles in fleets under ORS 805.120, the department may charge the fol-
6 lowing fees:

7 “(a) Service charge for each vehicle entered into a fleet, \$3.

8 “(b) Service charge for each vehicle in the fleet at the time of renewal,
9 \$2.

10 “(14)(a) The registration fee for motor vehicles required to establish a
11 registration weight under ORS 803.430 or 826.013, tow vehicles used to
12 transport property for hire other than as described in ORS 822.210 and com-
13 mercial buses is as provided in the following chart, based upon the weight
14 submitted in the declaration of weight prepared under ORS 803.435 or
15 826.015:

 2 “(C) The owner of a vehicle described in subparagraph (A) or (B) of this
 3 paragraph must certify at the time of initial registration, in a manner de-
 4 termined by the department by rule, that the motor vehicle will be used ex-
 5 clusively to transport manufactured structures or exclusively as described in
 6 ORS 822.210, unless the motor vehicle is registered under paragraph (a) of
 7 this subsection, or as described in ORS 825.015 or 825.017 (13). Registration
 8 of a vehicle described in subparagraph (A) or (B) of this paragraph is invalid
 9 if the vehicle is operated in any manner other than that described in the
 10 certification under this subparagraph.

11 “(c) Subject to paragraph (d) of this subsection, the registration fee for
 12 motor vehicles registered as farm vehicles under ORS 805.300 is as provided
 13 in the following chart, based upon the registration weight given in the dec-
 14 laration of weight submitted under ORS 803.435:

8 “(d) For any vehicle that is registered under a quarterly registration pe-
9 riod, the registration fee is a minimum of \$15 for each quarter registered plus
10 an additional fee of \$2.

11 “(15) The registration and renewal fees for vehicles specified in this sub-
12 section that are required to establish a registration weight under ORS
13 803.430 or 826.013 are as follows:

14 “(a) State-owned vehicles registered under ORS 805.045, \$10.

15 “(b) Undercover vehicles registered under ORS 805.060, \$10.

16 “**SECTION 5.** ORS 803.570 is amended to read:

17 “803.570. Except as otherwise specifically provided by law, the Department
18 of Transportation shall collect the fee described by this section each time the
19 department issues a registration plate upon the registration of a vehicle or
20 at other times when a registration plate is issued by the department. The
21 following all apply to the fee established by this section:

22 “(1) The fee shall be in addition to any other fee collected upon issuance
23 of a registration plate.

24 “(2) The fee for each registration plate issued and for each pair of plates
25 issued shall be determined by the department and shall be established by the
26 department by rule. The department shall establish fees for a single plate and
27 for a pair of plates under this section by:

28 “(a) Determining the cost of manufacturing a single plate or a pair of
29 plates and rounding the cost to the next higher [*half-dollar*] **dollar**; and

30 “(b) Adding \$10 for a single plate and \$20 for a pair of plates.

1 **SECTION 6.** ORS 803.575 is amended to read:

2 “803.575. (1) The fee for issuance of a duplicate or replacement registra-
3 tion card under ORS 803.510 is \$5.

4 “(2) The fee for issuance of a replacement or duplicate registration plate
5 under ORS 803.530 is the fee established under ORS 803.570, together with
6 a fee of **\$12** [*\$5 if the plate is issued at the time of renewal of registration or*
7 *a fee of \$10 if the plate is issued at any other time*].

8 “(3) The fee for transfer of registration plate under ORS 803.530 is [~~\$6~~
9 **\$30**].

10 “(4) The fee for issuance of replacement registration stickers under ORS
11 803.555 is \$10.

12 “(5) The fee for issuance of both replacement or duplicate registration
13 plates and replacement registration stickers, when issued at the same time,
14 is the fee established under ORS 803.570, together with a fee of **\$12** [*\$5 if the*
15 *plate and stickers are issued at the time of renewal of registration or a fee of*
16 *\$10 if the plate and stickers are issued at any other time*].

17 “(6) A fee paid under subsection (2), (4) or (5) of this section includes the
18 cost of any duplicate or replacement registration card issued.

19 **SECTION 7.** ORS 805.250 is amended to read:

20 “805.250. This section establishes fees for issuance of registration plates
21 authorized under ORS 805.200. If a fee for plates authorized in ORS 805.200
22 is not established in this section, the fee is the same fee as established under
23 ORS 803.570. Where a fee is established under this section, the fee is in
24 addition to the fee established under ORS 803.570 unless otherwise provided
25 in the following:

26 “(1) Amateur radio operator registration plates issued under ORS 805.230,
27 \$5.

28 “(2) Customized registration plates issued under ORS 805.240:

29 “(a) For original issuance or renewal, \$50 annual fee.

30 “(b) For issuance of a duplicate or replacement plate, **\$12** [*\$5 when the*

1 *plate is issued at the time of renewal of registration or \$10 when the plate is*
2 *issued at any other time].*

3 “(3) Special interest registration plates approved under ORS 805.210 are
4 approved without cost except as provided in this subsection, including with-
5 out payment of the fee established under ORS 803.570. If identifying stickers
6 are required, \$1 per sticker or pair of stickers.

7 “(4) Dealer plates issued under ORS 822.020 and 822.040 are as follows:

8 “(a) For the original dealer plate, no fee except the fee established under
9 ORS 803.570.

10 “(b) For replacement dealer plates, \$10 for each plate except that persons
11 dealing exclusively in motorcycles, mopeds, snowmobiles or any combination
12 of those vehicles shall pay only \$3 for each replacement plate.

13 “(c) For additional plates, or for renewal of registration, \$42, except that
14 persons dealing exclusively in motorcycles, mopeds or snowmobiles or any
15 combination of those vehicles shall pay only \$9 for each additional plate, or
16 for renewal of registration.

17 “(5) Special vehicle transporter plates or devices issued under ORS
18 822.310, \$5 for each plate or device.

19 **“SECTION 8.** ORS 803.415 is amended to read:

20 “803.415. This section establishes registration periods for vehicles. The
21 registration periods are periods described under ORS 803.400. Except as pro-
22 vided in the following, the registration period for any vehicle registered in
23 this state by the Department of Transportation is a biennial registration
24 period:

25 “(1) The following vehicles have permanent registration:

26 “(a) Antique vehicles registered under ORS 805.010.

27 “(b) Vehicles of special interest registered under ORS 805.020.

28 “(c) Trailers that will be operated on the highways at a loaded weight of
29 more than 8,000 pounds and are not travel trailers, fixed load vehicles or
30 special use trailers.

1 “(2) Government-owned vehicles registered under ORS 805.040 have own-
2 ership registration.

3 “(3) The following vehicles may be registered under annual or quarterly
4 registration unless the vehicles are registered under proportional registra-
5 tion under ORS 826.009 or proportional fleet registration under ORS 826.011:

6 “(a) Vehicles required to establish a registration weight under ORS
7 803.430.

8 “(b) Commercial buses.

9 “(c) Vehicles registered as farm vehicles under ORS 805.300.

10 “(4) Snowmobiles are registered as provided in ORS 821.080.

11 “(5) Vehicles operated by dealers who hold certificates under ORS 822.020
12 are as provided under ORS 822.040.

13 “(6) Trailers for hire that will be operated at a loaded weight of 8,000
14 pounds or less may be registered as follows:

15 “(a) Annual registration; or

16 “(b) If registered under an agreement pursuant to ORS 802.500, for a pe-
17 riod of time determined as specified in the agreement or as determined by
18 the department.

19 “(7) Except as otherwise provided in subsection (10) of this section, the
20 registration period for electric vehicles and hybrid vehicles that use elec-
21 tricity and another source of motive power is a biennial registration period
22 except that the registration period for the following electric or hybrid vehi-
23 cles is an annual registration period:

24 “(a) Commercial buses.

25 “(b) Electric or hybrid vehicles registered as farm vehicles under ORS
26 805.300.

27 “(c) Vehicles required to establish registration weight under ORS 803.430.

28 “(8) Vehicles registered under ORS 805.100 have an ownership registration
29 period.

30 “(9) School vehicles registered under ORS 805.050 have ownership regis-

1 tration except that the registration shall continue to be valid if ownership
2 of the vehicle is transferred to a person who continues to use the vehicle for
3 purposes authorized by ORS 805.050.

4 “(10) The following vehicles have a four-year registration period:

5 “(a) New vehicles registered under ORS 803.420 (6)(a) for which new reg-
6 istration plates will be issued; **and**

7 “[*(b) New mopeds or motorcycles registered under ORS 803.420 (6)(c) for*
8 *which new registration plates will be issued; and*]

9 “[*(c)*] **(b)** New trailers registered under ORS 803.420 (6)(b), for which new
10 registration plates will be issued.

11 “(11) A rental or leasing company, as defined in ORS 221.275, may elect
12 an annual, a biennial or a four-year registration period for the initial regis-
13 tration of a new vehicle registered under ORS 803.420 (6)(a) for which new
14 registration plates will be issued if the company owns the vehicle that is
15 being registered. The subsequent renewal or reregistration periods for the
16 vehicle are biennial.

17 “(12) Vehicles registered under ORS 805.110 have ownership registration
18 except that the registration shall continue to be valid if ownership of the
19 vehicle is transferred to a spouse who is authorized to retain the former
20 prisoner of war registration plates under ORS 805.110.

21 **“SECTION 9. (1) The amendments to ORS 803.215, 803.420, 803.570,**
22 **803.575, 805.250, 807.370 and 807.410 by sections 1 to 7 of this 2023 Act**
23 **apply to amounts imposed on or after the effective date of this 2023**
24 **Act.**

25 **“(2) The amendments to ORS 803.415 by section 8 of this 2023 Act**
26 **apply to new mopeds or motorcycles registered on or after the effective**
27 **date of this 2023 Act.”.**
