On behalf of the government entities, small business, medical professionals, businesses, and undersigned organizations representing thousands of members, we would like to express our support for HB 3043, the Toxic Free Kids Act Modernization bill.

Thousands of chemicals lurk in products our kids use every day, and children are far more vulnerable to toxic chemicals than adults. And parents should not have to be expert chemists or have to shop in specialty stores in order to obtain safer products. In 2015, a bipartisan Oregon Legislature stepped up, in the absence of strong federal protections, and voted overwhelmingly in favor of the Toxic Free Kids Act (TFKA), requiring manufacturers of children's products to disclose—and eventually phase out—some of the worst chemicals in kid's products. And in 2021, a Bipartisan House overwhelmingly passed HB 3043 (then HB 2495), 48-7.

**We've made great progress, but our kids need us to do more.** HB 3043 builds on the success of Oregon's 2015 Toxic Free Kids Act by strengthening protections for children's health and streamlining business reporting requirements.

A modernized Toxic Free Kids Act will:

- Modernize OHA's ability to regulate classes of chemicals instead of regulating them one-by-one. This will prevent harmful chemicals from being phased out, only to be replaced with similar and equally harmful ones. The bill still gives manufacturers a way to continue using an individual chemical that may not be as harmful as the rest of its class.
- Remove limits on designating high priority chemicals of concern for children's health. Currently, OHA is limited to adding five chemicals for regulation every three years. According to the EPA, more than 1,500 new chemicals are introduced into commerce each year. And currently, we are out of alignment with Washington.
- Limit exemptions granted to manufacturers to 3 years, rather than in perpetuity. New products are developed every year, and materials updates can and should be made when safer alternatives are available.
- Make it easier for consumers to avoid products containing toxics by adding brand name and model to reporting requirements.
- Streamline manufacturer reporting requirements and reduce program costs by aligning definitions and data management systems with Washington. It also makes reporting easier for companies.

We recognize that safer and healthier products are better for the environment, human health, and generally good business practice. **We urge your support and vote on HB 3043.**
