**Re: Letter of Support for Senate Bill 576**

Dear Chair Gelsler Blouin, Vice Chair Robinson, and Members of the Senate Committee on Human Services:

Thank you for the opportunity to offer Health Share's support for Senate Bill 576. Health Share is a Coordinated Care Organization (CCO) serving over 440,000 Oregon Health Plan (OHP) members in Clackamas, Multnomah, and Washington Counties, including over 50,000 members with a disability. We proudly endorse the expansion of Medicaid so that gainfully employed people with disabilities may continue to maintain employer-sponsored insurance coverage and access vital health care and long-term services and supports (LTSS) through OHP.

Under current law, employed Oregonians face a difficult choice. Many require Medicaid for essential healthcare and access to LTSS, but cannot advance their career, accept pay raises and promotions, or meaningfully grow their personal assets without losing their vital OHP coverage. People with disabilities should not be confronted with the choice of advancing their careers or keeping critical health coverage through OHP. We believe that requiring people to make that choice is both an injustice and an impediment to advancing health equity.

SB 576 will help eliminate a major barrier to care for Oregonians – and it comes at a pivotal time. According to the CDC, one in four Oregonians have a disability<sup>1</sup>, and rates are expected to increase due to an aging population, rising rates of chronic conditions, and the effects of long COVID<sup>2</sup>. People with disabilities disproportionately experience health disparities and barriers to care. SB 576 would eliminate a problematic systemic barrier to care and ensure that working people with disabilities can get the care and supports they need while pursuing a fulfilling career. For these reasons, we are honored to endorse SB 576.
