WHAT IS THE REAL COSTS TO GET THIS OFF THE GROUND? WE HAVE THE OHA, WHY NOT USE THEM FOR MANAGEMENT GOT SINCE 2017 A 37% PAY RAISE AND SOME MAY NOT LIVE IN OUR STATE? . DO WE NEED ANOTHER AGENCY? FOR WITH THE CURRENT SYSTEM, IS THIS NOT WHY WE HAVE VARIOUS HEALTH CARE INSURANCE PLACES LIKE ATRIO,AETNA, PROVIDENCE, KAISER THAT PROVIDES THE SERVICES AND CAN DO THIS FOR LESS? ARE WE NOT LOOKING AT A \$500 MILLION DEFICIT PLUS WITH COMPANIES LIKE INTEL THAT MOVED THEIR NEW OPERATIONS TO AUSTIN, TEXAS, SCOTTSDALE,ARIZONA AND 2 FACILITIES TO OHIO BECAUSE OF THE CAT TAX AND OTHER CONSTRAINTS, WHICH WE LOST 10,000+ GOOD WAGE JOBS AND POSSIBLE REVENUES OF AT LEAST \$10 BILLION? IN CANADA AND THE BRITISH ISLES THEY HAVE UNIVERSAL HEALTHCARE. WHY DO THEY COME TO OUR COUNTRY AND MEXICO TO GET THEIR HEALTHCARE? THEY COME BECAUSE THEIR CARE IS A MONOPOLY AT AN UNREALISTIC COST, WHICH CREATES DELAYS THAT IS LIFE THREATENING WHEN WAITING. REMEMBER BABY ALFIE EVANS FROM ENGLAND, AND DIED BECAUSE GOVERNMENT DID NOT WANT TO PAY FOR AND TOOK CUSTODY FROM PARENTS THROUGH THE HEALTH DEPT. THERE IN 2016 , COULD HAVE GOT TREATED IN OUR COUNTRY BUT THE KID DIED BECAUSE GOVERNMENT AND COURTS TOOK THE PARENTAL CHOICE AWAY EVEN WITH \$5MILLION RAISED ON GOFUNDME PLUS POPE FRANCIS'S PLEA FOR GETTING THE CHILD TREATED. IS THIS AGENCY GONNA FORCE MANY HEALTHCARE PROVIDERS,DOCTORS, SPECIALISTS,NURSES AND TECHNICIANS LEAVE OUR STATE WHICH SHALL MAKE OUR STATE HAVE THE SAME PROBLEMS AS CANADA OUR NEIGHBOR CREATING PROBLEMS THAT WE EXPERIENCED IN THE COVID YEARS? .WE PAY OVER AN ESTIMATED \$2 BILLION FOR ILLEGAL VISITORS AND THEIR CHILDREN FOR HEALTH SERVICES. HOW ARE THEY GONNA PAY THEIR FAIR SHARE OF THE EXPENSE? WHAT ABOUT US VETERANS, THAT HAS TO USE OUTPATIENT CARE BECAUSE OUR SERVICES ARE 2 1/2 TO 5 MONTHS OUT ON MANY SERVICES WE CANNOT GET FROM THE V.A. DIRECTLY IN A TIMELY FASHION. WE ADDED THE AFFORDABLE CARE PROVISIONS AND IT COST US, THE PEOPLE OF OREGON \$300 MILLION EXTRA THAT HAD LITTL OR NO ACCOUNTABILITY TO THOSE THAT WAS IN CHARGE. AGAIN I ASK YOU SENATORS RESPECTFULLY, ARE YOU GUYS GONNA USE THE SAME

SYSTEM AS US, THE PEOPLE OR IS THIS GONNA MAKE IT A SEGREGATED SYSTEM FOR THOSE OF ECONOMIC MEANS BE ABLE TO GET TIMELY TREATMENT COMPARED TO THOSE THAT WORK 2 JOBS TO, KEEP THE LIGHTS AND HAVE A FAMILY? WHAT INCENTIVES ARE YE GONNA USE TO KEEP OUR MEDICAL PROFESSIONALS HERE IN OREGON INCLUDING THE NURSES? WHAT ABOUT LETTING EACH COUNTY HAS THE RIGHT TO CONTROL IF THEY WANT TO OPT IN TO THE UNIVERSAL PLAN AND LET THE REAL TEST OF FREE ENTERPRISE/COMPETITION WORK ? NOW SENATORS MY LAST QUESTION, ARE YOU GONNA APPLY THE SAME HEALTHCARE TO ALL THE STATE, COUNTY,CITY WORKERS, UNION AND NON UNION ALONG WITH YOURSELVES WITHOUT LEGISLATIVE CARVEOUTS,AMENDMENTS OR ANY OTHER EXCEPTIONS? IN MY ANALYSIS PERSONALLY, I AM GONNA HAVE TO GO OUT OF STATE FOR THE V.A.CARE DUE TO THE POTENTIAL HIGH DEMAND AND LIMITED PROFESSIONALS THAT MAY CONTINUE THEIR EXODUS FROM OUR STATE. ALSO SENATORS, IS THERE A REAL ANALYSIS ON HOW IT SHALL AFFECT THE BUSINESSES,JOBS AND INFRASTRUCTURE IF THIS IS IMPLEMENTED? IF IT WAS ME I WOULD REALLY LEAVE IT UP TO THE 36 COUNTIES AND NOT USE THE PROPERTY TAX TO PAY FOR THIS SYSTEM.
