RE: Support for House Bill 2001

Chair Dexter, Co-Vice Chair Gamba, Co-Vice Chair Helfrich, and Members of the Committee:

I write to you today on behalf of Community Partners for Affordable Housing (CPAH) **to urge you to support of HB 2001**, which addresses our state's urgent housing needs and long-term housing supply challenges with immediate action on several fronts.

HB 2001, incorporating the amendments being considered by your committee on February 23, includes several important elements of the response to our statewide housing crisis. The bill will:

- Provide essential and reasonable negotiated improvements to Oregon's eviction statutes to promote stability and payment rather than displacement and eviction.
- Expand investments in youth homelessness prevention, prioritizing services for school-aged children who are homeless or at risk of homelessness, and their families.
- Provide \$20 million in grant/loan funds for the construction of low-cost modular housing in wildfire-affected areas and for low- and moderate-income households.
- Provide \$3 million in seed financing for the construction of affordable workforce rental housing.
- Address our long-term housing production challenges by establishing enforceable standards for local jurisdictions to promote the production of abundant, equitable, affordable and diverse housing options.
