

Good morning, Chair Dexter and all members of the Housing and Homelessness Committee:

Addressing the root cause of homelessness, WHAT HAPPENED TO ALL THE DESTROYED JOBS that actually paid for living under shelter in Oregon??

Government is not a solution; over-regulation and commensurate taxation by the public sector parasite *IS* the problem. Seeing that the Committee for Housing and Homelessness is toying with the insanity of allocating hundreds of millions of taxpayer dollars to cover and conceal this abysmal economic symptom is childish myopic. Where are the adults on this committee, those who understand root-cause analysis?!

- **It takes jobs to pay for housing.** Simple math shows that this is the way it's always been, but this axiom is how Oregon has arrived at the so-called "Homelessness Emergency." Governor KB/TK thinks that they can magically swoop in and demand that tons of private sector money be dropped from Salem proverbial helicopter via unconstitutional 'executive' allocations, but the executive branch is sorely mistaken. Firstly, it's not her money to spend; transferring wealth from those who barely meet monthly expenses to those who - thanks to **Senate Bill 100** and its reckless derivatives (i.e. DLCD, et al.) - impedes the same employment opportunities that were filled when Natural Resources and Manufacturing jobs in Oregon were plentiful. In a nutshell, over-regulations have destroyed the need to retain skilled workers in an economy that has (thanks to the neoEnviro lawyers) rapidly evaporated resource-based careers.
