We have heard many concerns from our residents about the Confined Animal Feeding Operations (CAFO) being proposed in the area and we strongly support a moratorium on all new mega size Tier-2 CAFOs until the impacts of these facilities on air quality, climate, water quality, water supplies, small- and medium-sized livestock farms, community and worker health and animal welfare is studied and addressed.
