SENATORS, HAVE YE EVER GONE TO THESE FACILITIES YOURSELVES AND ASKED QUESTIONS INSTEAD OF RELYING ON GROUPS OR ADVOCATES? WILL THIS COST US, THE TAXPAYERS AN EXTRA 28% TO 36% TO COVER SNAP OR TANF FOR LOW INCOME FAMILIES OR SENIOR CITIZENS LIKE IN CALIFORNIA , TO THE POINT FOR 1 RELATIVE OF MINES, INSULIN AND HEART MEDS OR FOOD? HE USE TO BE ABLE TO KEEP \$1200 TO \$1600 A MONTH IN THE BANK/EMERGENCY MONEY IN 2019. IF THIS POLICY IS PASSED, AM I AM GONNA TO HAVE TO PAY \$6-\$10 A DOZEN FOR EGGS LIKE IN CALIFORNIA AND COLORADO? MY COSTS IN OREGON FOR FOOD HAD COST ME AN EXTRA \$4000 IN THE LAST 2 YEARS. ARE YE GONNA HAVE ME PAY AN EXTRA \$1800 A YEAR MORE LIKE IN CALIFORNIA OR WASHINGTON, FOR THE BEEF, PORK, CHICKEN AND LAMB? IT TAKES ONLY 4 PEOPLE TO COLLECT 30,000 EGGS A DAY WITH CURRENT MEANS. CAGE FREE COLLECTION TAKES 3 TIMES THE LABOR AND NOT ERGONOMICLY GOOD ON THE BACK, DID YOU KNOW THAT? WILL THIS EXPONENTIALLY CAUSE WORKMANS COMP/UNEMPLOYMENT OR DISABILITY CLAIMS TO RISE AND WE.THE PEOPLE WILL HAVE TO PAY FOR THIS TOO? WITH THE CAT TAX HURTING BUSINESSES AND EXPANSION OPPORTUNITIES PLUS INFLATION, ARE YOU GUYS TRYING TO MAKE US MORE DEPENDENT THAN INDEPENDENT ON HAVING THE ABILITY TO SUPPLY OUR STATE WITH FOOD GROWN AND RAISED HERE? IS GEORGE ORWELL'S BOOK, " ANIMAL FARM" GONNA BE A REALITY FROM A BILL LIKE THIS?
