RE: Jackson County's Opposition of Oregon Senate Bill 907 (2023)

Dear Chair Taylor, Vice-Chair Bonham, and Members of the Senate Committee on Labor and Business:

We, the Jackson County Board of Commissioners, strongly oppose Oregon Senate Bill (SB) 907. This legislation is problematic for public employers, such as Jackson County. The very meaning of public service is, "a service rendered in the public interest." As we review SB 907, in its current form, we struggle to identify how this legislation would ensure that Jackson County employees perform the work our residents require when disasters strike.

The September 2020 wildfires, in our County, including the South Obenchain and Almeda Fires, required Jackson County employees to respond to the incident, not run from it. County staff set up emergency operation centers, constructed emergency evacuation sites, performed mass evacuations, and assisted in immediate response to disaster survivors. Many of these employees did so while their own homes were under evacuation orders, with many providing aid in areas that were actively being evacuated. This type of response is required of public servants for, without them, who else will do the work in times of need. SB 907 allows employees to choose whether they want to respond or flee from emergencies, which is likely to have a severely negative impact on emergency response at all levels in Oregon.

If SB 907 passes, what would the outcome be of the Cascadia Subduction Zone event, which all levels of government are actively planning for response to. If the majority of our collective public employees at the State, county, and city levels left work during the Cascadia Subduction Zone event, who would respond to save lives, property, and ensure the health and safety of all Oregonians?

The Oregon Occupational Safety and Health Division (OSHA) has the ability to utilize existing tools and authorities granted to them in the Oregon Revised Statutes and Oregon Administrative Rules to ensure employers provide a safe work place for their employees. SB 907 goes far beyond current workplace safety standards, and grants employees the right to leave when the public needs them the most.
