TO THE CHAIRMAN AND MEMBERS OF THIS COMMITTEE, I AM TROUBLED BY THE VARIOUS BILLS THAT IS GOING THROUGH THIS LEGISLATURE. THE LEGAL AGE FOR AN ADULT IS 18, YET YE HAVE BILLS BEING PROPOSED THAT LOWERS THE AGE TO REGISTER TO VOTE AT 16. SECTION 1 OF THE 26TH AMENDMENT BASICLY SPECIFY THAT THE AGE TO VOTE IS 18 PLUS SHALL NOT BE DENIED OR ABRIDGED BY THE UNITED STATES OR BY ANY STATE ON ACCOUNT OF AGE. SO BASED ON THIS AMENDMENT, IF THEY HAVE TO REGISTER FOR SELECTIVE SERVICE OR ENLIST FOR ANY OF MILITARY SERVICE, AS LONG AS THEY HAD NOT COMMIT A FELONY, WHY NOT LET THESE OREGONIANS BE ABLE TO OWN A FIREARM? YE HAVE A BILL IN HB 2002 ALLOWS A MINOR TO GET, IF THE LAW IS PASSED, GENDER MODIFICATIONS, UNDER THE GUISE OF REPRODUCTION HEALTH, TO BE ACCEPTABLE EVEN THOUGH FROM AGE 12 TO 17 IS THE TIME OF PUBERTY WITHOUT PARENTAL CONSENT NOR NOTIFICATION IF A FEMALE MINOR HAD AN ABORTION? WE USE TO HAVE MANY SPORTSMAN CLUBS THAT MINORS COMPETE IN ALL OVER THE WESTERN STATES. WE EVEN HAD A FEW YOUNG ADULTS COMPETE IN PAST OLYMPICS FROM SUCH A YOUNG AGE. SOME OF OUR MOST DECORATED SOLDIERS WHO FOUGHT IN VARIOUS WARS WAS BETWEEN 16 AND 20 INCLUDING OREGON'S OWN SSGT.
